

House Bill 2376

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Pre-session filed (at the request of House Interim Committee on Health Care)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes Department of Consumer and Business Services to enforce health insurance requirements of federal law. Modifies definition of "health benefit plan" and includes student health insurance within definition. Prohibits health insurer from canceling, rescinding or refusing to renew policy on or after September 23, 2010, except for fraud or intentional misrepresentation of material fact. Requires health insurers to notify covered persons and department regarding rescinded policies on or after September 23, 2010. Prohibits preexisting condition exclusion for insureds under 19 years of age who are enrolled in certain types of health insurance. Requires coverage of federally specified preventive health services and limited cost-sharing for preventive services in health benefit plans issued on or after September 23, 2010. Prohibits health insurers from offering rate differentials for highly compensated employees. Removes exception for association health plans from specified provisions of Insurance Code. Prohibits lifetime dollar limits on essential health benefits covered by health insurance. Imposes new requirements for internal and external review of adverse benefit determinations in health benefit plans offered or renewed on or after September 23, 2010. Allows enrollee to seek external review through Director of Department of Consumer and Business Services. Requires insurers to allow female enrollee access to obstetrical or gynecological care without referral or prior authorization.

Abolishes Health Insurance Reform Advisory Committee.

Declares emergency, effective on passage.

12 **SECTION 1. As used in ORS 743.730 to 743.773, "grandfathered health plan" has the**
13 **meaning given that term in 29 C.F.R. 2590.715-1251.**

14 **SECTION 2. Section 3 of this 2011 Act is added to and made a part of ORS 743.730 to**
15 **743.773.**

16 **SECTION 3. (1) Notwithstanding any other provision of law, a health benefit plan must**
17 **provide coverage of preventive health services as prescribed by the United States Depart-**
18 **ment of Health and Human Services pursuant to 42 U.S.C. 300gg-13.**

19 **(2) A health benefit plan may not impose cost-sharing requirements on an enrollee for**
20 **preventive health services unless the preventive health services are provided by out-of-**
21 **network providers according to criteria prescribed by the Department of Consumer and**

2 **SECTION 4. Section 5 of this 2011 Act is added to and made a part of the Insurance Code.**

3 **SECTION 5. (1) An insurer may not rescind a health benefit plan or the coverage of any**
 4 **individual under a group or individual health insurance policy unless:**

5 (a)(A) **The individual or a person seeking coverage on behalf of the individual performs**
 6 **an act, practice or omission that constitutes fraud; or**

7 (B) **The individual makes an intentional misrepresentation of a material fact as prohib-**
 8 **ited by the terms of the plan or policy; and**

9 (b) **The insurer provides at least 30 days' advance written notice, in the form and manner**
 10 **prescribed by the Department of Consumer and Business Services, to each plan enrollee or**
 11 **primary subscriber who would be affected by the rescission of coverage.**

12 (2) **An insurer that rescinds a plan or policy must provide notice of the rescission to the**
 13 **department in the form and manner prescribed by the department no later than 30 days after**
 14 **the date that the rescission takes effect.**

15 (3) **As used in this section, "a person seeking coverage on behalf of the individual" does**
 16 **not include an insurance producer or an employee or authorized representative of an insur-**
 17 **ance producer or carrier.**

19 243.252. (1) **The state may pay none of the cost of making health benefit plan coverage available**
 20 **to a retired state employee who is an eligible employee and to family members or may agree, by**
 21 **collective bargaining agreement or otherwise, to pay part or all of that cost.**

22 (2) **Nothing in subsection (1) of this section or other law, except ORS 243.886, prohibits a col-**
 23 **lective bargaining unit from agreeing with an employer that is a public body, as defined in ORS**

 15 health care reform in Oregon and to provide comparative cost and quality information to consumers,
 16 providers and purchasers of health care about Oregon's health care systems and health plan net-
 17 works in order to provide comparative information to consumers.

18 (b) Develop uniform contracting standards for the purchase of health care, including the fol-
 19 lowing:

20 (A) Uniform quality standards and performance measures;

21 (B) Evidence-based guidelines for major chronic disease management and health care services
 22 with unexplained variations in frequency or cost;

23 (C) Evidence-based effectiveness guidelines for select new technologies and medical equipment;

26 (c) Submit directly to the Legislative Counsel, no later than October 1 of each even-numbered

 29 prior to the beginning of the legislative session in accordance with the rules of the House of Rep-
 30 resentatives and the Senate.

45 731.232. (1) For the purpose of an investigation or proceeding under the Insurance Code **or**

1 **pursuant to federal health insurance laws**, the Director of the Department of Consumer and
2 Business Services may administer oaths and affirmations, subpoena witnesses, compel their attend-
3 ance, take evidence and require the production of books, papers, correspondence, memoranda,
4 agreements or other documents or records which the director considers relevant or material to the
5 inquiry. Each witness who appears before the director under a subpoena shall receive the fees and
6 mileage provided for witnesses in ORS 44.415 (2).

7 (2) If a person fails to comply with a subpoena so issued or a party or witness refuses to testify
8 on any matters, the judge of the circuit court for any county, on the application of the director, shall

28 shall extend, modify or conflict with the Insurance Code, **federal health insurance laws** or the

31 731.248. (1) Orders of the Director of the Department of Consumer and Business Services shall
32 be effective only when in writing and signed by the director or by the authority of the director.

35 (a) Its effective date;

36 (b) Its intent or purpose;

2 731.252. (1) Whenever the Director of the Department of Consumer and Business Services has
 3 reason to believe that any person has been engaged or is engaging or is about to engage in any
 4 violation of the Insurance Code **or federal health insurance laws**, the director may issue an order,
 5 directed to such person, to discontinue or desist from such violation or threatened violation. The
 6 copy of the order forwarded to the person involved shall set forth a statement of the specific charges
 7 and the fact that the person may request a hearing within 20 days of the date of mailing. Where a
 8 hearing is requested, the director shall set a date for the hearing to be held within 30 days after
 9 receipt of the request, and shall give the person involved written notice of the hearing date at least
 10 seven days prior thereto. The person requesting the hearing must establish to the satisfaction of the
 11 director that such order should not be complied with. The order shall become final 20 days after the

36 731.264. (1) A complaint made to the Director of the Department of Consumer and Business
 37 Services against any person regulated by the Insurance Code **or federal health insurance laws**,
 38 and the record thereof, shall be confidential and may not be disclosed except as provided in ORS
 39 705.137. No such complaint, or the record thereof, shall be used in any action, suit or proceeding
 40 except to the extent considered necessary by the director in the prosecution of apparent violations
 41 of the Insurance Code or other law.

42 (2) Data gathered pursuant to an investigation by the director of a complaint shall be confi-

6 731.300. (1) The Director of the Department of Consumer and Business Services shall examine
 7 every authorized insurer, including an audit of the financial affairs of such insurer, as often as the
 8 director determines an examination to be necessary but at least once each five years. An examina-
 9 tion shall be conducted for the purpose of determining the financial condition of the insurer, its
 10 ability to fulfill its obligations and its manner of fulfillment, the nature of its operations and its
 11 compliance with the Insurance Code **and federal health insurance laws**. The director may also
 12 make such an examination of any surplus lines insurance producer or any person holding the capital
 13 stock of an authorized insurer or surplus lines insurance producer for the purpose of controlling the
 14 management thereof as a voting trustee or otherwise, or both.

29 731.302. (1) When the Director of the Department of Consumer and Business Services determines
 30 that an examination should be conducted, the director shall appoint one or more examiners to per-
 31 form the examination and instruct them as to the scope of the examination. In conducting the ex-
 32 amination, each examiner shall consider the guidelines and procedures in the examiner handbook,
 33 or its successor publication, adopted by the National Association of Insurance Commissioners. The
 34 director may prescribe the examiner handbook or its successor publication and employ other
 35 guidelines and procedures that the director determines to be appropriate.

36 (2) When making an examination, the director may retain appraisers, independent actuaries, in-
 37 dependent certified public accountants or other professionals and specialists as needed. The cost of

45 731.358. Upon application, a domestic insurer shall be granted a certificate of authority to

1 transact any class of insurance permitted by the Insurance Code and provided for in its articles of
2 incorporation upon its compliance with all the laws of this state [and], the rules of the Department

33 *[(b) Nothing in this subsection shall require a small employer carrier to resubmit small employer*
 34 *health benefit plans that were approved by the director prior to October 1, 1996, nor shall small em-*
 35 *ployer carriers be required to reinitiate new plan selection procedures for currently enrolled small em-*
 36 *ployers prior to the small employer's next health benefit plan coverage anniversary date.]*

37 *[(c)] (2) A carrier that offers a health benefit plan in the small employer market only through*
 38 *one or more bona fide associations is not required to offer that health benefit plan to small em-*
 39 *ployers that are not members of the bona fide association.*

40 *[(5)] (3) [A small employer] **A carrier shall issue to a small employer any [small employer] health***
 41 ***benefit plan, including a basic health benefit plan, that is offered by the carrier if the small em-***
 42 ***ployer applies for the plan and agrees to make the required premium payments and to satisfy the***
 43 ***other provisions of the health benefit plan.***

44 *[(6)] (4) A multiple employer welfare arrangement, professional or trade association or other*
 45 *similar arrangement established or maintained to provide benefits to a particular trade, business,*

1 profession or industry or their subsidiaries shall not issue coverage to a group or individual that is
 2 not in the same trade, business, profession or industry as that covered by the arrangement. The
 3 arrangement shall accept all groups and individuals in the same trade, business, profession or in-

 9 of this section, [offer coverage to or accept applications from a] **accept applications from and offer**
 10 **coverage to a small employer** group covered under an existing [*small employer*] health benefit plan
 11 **regardless of** whether [*or not*] a prospective enrollee is excluded from coverage under the existing
 12 plan because of late enrollment. When a [*small employer*] carrier accepts an application for [*such*]
 13 a **small employer** group, the carrier may continue to exclude the prospective enrollee excluded
 14 from coverage by the replaced plan until the prospective enrollee would have become eligible for
 15 coverage under that replaced plan.

16 [(8)] (6) [No *small employer carrier shall be required to offer coverage or accept applications pur-*
 17 *suant to subsections (4) and (5)] **A carrier is not required to accept applications from and offer***
 18 **coverage pursuant to subsection (3)** of this section if the director finds that acceptance of an
 19 application or applications would endanger the carrier's ability to fulfill its contractual obligations
 20 or result in financial impairment of the carrier.

21 [(9)] (7) [Every *small employer*] **A carrier shall market fairly all [*small employer*] health benefit**
 22 **plans in which a small employer is legally eligible to enroll and that are not grandfathered**
 23 **health plans, including basic health benefit plans, that are** offered by the carrier to small em-
 24 ployers in the geographical areas in which the carrier makes coverage available or provides bene-
 25 fits.

26 [(10)(a)] (8)(a) [No *small employer carrier shall be*] **A carrier is not required to accept appli-**
 27 **cations from or offer coverage [or accept applications] pursuant to [subsections (4) and (5)] sub-**
 28 **section (3)** of this section [*in the case of any of the following*]:

29 (A) To a small employer if the small employer is not physically located in the carrier's approved
 30 service area;

31 (B) To an employee **of a small employer** if the employee does not work or reside within the
 32 carrier's approved service areas; or

33 (C) Within an area where the carrier reasonably anticipates, and demonstrates to the satisfac-
 34 tion of the director, that it will not have the capacity in its network of providers to deliver services
 35 adequately to the enrollees of those groups because of its obligations to existing group contract
 36 holders and enrollees.

37 (b) A carrier that does not offer coverage pursuant to paragraph (a)(C) of this subsection shall
 38 not offer coverage in the applicable service area to new employer groups other than small employers

40 [(11)] (9) For purposes of ORS 743.733 to 743.737, except as provided in this subsection, carriers
 41 that are affiliated carriers or that are eligible to file a consolidated tax return pursuant to ORS

 43 to 743.737 apply as if all health benefit plans delivered or issued for delivery to small employers in

 6 fering all of its [*small employer*] health benefit plans **to small employers** under ORS 743.737
 7 [(5)(e)] (6)(e), elects to discontinue renewing all such plans or elects to discontinue offering and re-
 8 newing all such plans is prohibited from offering health benefit plans [*in the small employer*
 9 *market*] **to small employers** in this state for a period of five years from one of the following dates:

10 (a) The date of notice to the director pursuant to ORS 743.737 [(5)(e)] (6)(e); or

11 (b) If notice is not provided under paragraph (a) of this subsection, from the date on which the
 12 director provides notice to the carrier that the director has determined that the carrier has effec-
 13 tively discontinued offering [*small employer*] health benefit plans **to small employers** in this state.

14 **SECTION 41.** ORS 743.737 is amended to read:

15 743.737. [*Health benefit plans covering small employers shall be subject to the following*
 16 *provisions:*]

17 (1) A preexisting [*conditions provision*] **condition exclusion** in a small employer health benefit
 18 plan shall apply only to a condition for which medical advice, diagnosis, care or treatment was re-
 19 commended or received during the six-month period immediately preceding the enrollment date of

 12 **tation of a material fact as prohibited by the terms of the plan.**

13 (c) *[When]* The number of enrollees covered under the plan is less than the number or percent-

15 (d) *[For noncompliance with]* The small employer *[carrier's employer]* **fails to comply with the**
 16 contribution requirements under the health benefit plan.

17 (e) *[When]* The carrier discontinues offering or renewing, or offering and renewing, all of its
 18 small employer health benefit plans in this state or in a specified service area within this state. In
 19 order to discontinue plans under this paragraph, the carrier:

20 (A) Must give notice of the decision to the *[Director of the]* Department of Consumer and Busi-
 21 ness Services and to all policyholders covered by the plans;

22 (B) May not cancel coverage under the plans for 180 days after the date of the notice required
 23 under subparagraph (A) of this paragraph if coverage is discontinued in the entire state or, except
 24 as provided in subparagraph (C) of this paragraph, in a specified service area;

25 (C) May not cancel coverage under the plans for 90 days after the date of the notice required
 26 under subparagraph (A) of this paragraph if coverage is discontinued in a specified service area
 27 because of an inability to reach an agreement with the health care providers or organization of
 28 health care providers to provide services under the plans within the service area; and

29 (D) Must discontinue offering or renewing, or offering and renewing, all health benefit plans
 30 issued by the carrier in the small employer market in this state or in the specified service area.

31 (f) *[When]* The carrier discontinues offering and renewing a small employer health benefit plan
 32 in a specified service area within this state because of an inability to reach an agreement with the
 33 health care providers or organization of health care providers to provide services under the plan

35 (A) Must give notice to the *[director]* **department** and to all policyholders covered by the plan;

36 (B) May not cancel coverage under the plan for 90 days after the date of the notice required

38 (C) Must offer in writing to each small employer covered by the plan, all other small employer
 39 health benefit plans **that a small employer is legally eligible to purchase and** that the carrier

 41 pursuant to the provisions of ORS 743.733 to 743.737. The carrier shall offer the plans at least 90

43 (g) *[When]* The carrier discontinues offering or renewing, or offering and renewing, a health
 44 benefit plan for all small employers in this state or in a specified service area within this state,
 45 other than a plan discontinued under paragraph (f) of this subsection **or a grandfathered health**

1 **plan.** With respect to plans that are being discontinued, the carrier must:

2 (A) Offer in writing to each small employer covered by the plan, all health benefit plans **that**
 3 **a small employer is legally eligible to purchase and** that the carrier offers **to small employers**
 4 in the specified service area.

5 (B) Issue any such plans pursuant to the provisions of ORS 743.733 to 743.737.

6 (C) Offer the plans at least 90 days prior to discontinuation.

7 (D) Act uniformly without regard to the claims experience of the affected policyholders or the
 8 health status of any current or prospective enrollee.

9 (h) [When] The Director **of the Department of Consumer and Business Services** orders the
 10 carrier to discontinue coverage in accordance with procedures specified or approved by the director
 11 upon finding that the continuation of the coverage would:

12 (A) Not be in the best interests of the enrollees; or

13 (B) Impair the carrier's ability to meet contractual obligations.

14 (i) [When,] In the case of a small employer health benefit plan that delivers covered services
 15 through a specified network of health care providers, there is no longer any enrollee who lives, re-
 16 sides or works in the service area of the provider network.

17 (j) [When,] In the case of a health benefit plan that is offered in the small employer market only
 18 through one or more bona fide associations, the membership of an employer in the association ceases
 19 and the termination of coverage is not related to the health status of any enrollee.

20 *[(k) For misuse of a provider network provision. As used in this paragraph, "misuse of a provider*
 21 *network provision" means a disruptive, unruly or abusive action taken by an enrollee that threatens the*
 22 *physical health or well-being of health care staff and seriously impairs the ability of the carrier or its*
 23 *participating providers to provide services to an enrollee. An enrollee under this paragraph retains the*
 24 *rights of an enrollee under ORS 743.804.]*

25 [(L)] **(6)** A [small employer] carrier may modify a small employer health benefit plan at the time
 26 of coverage renewal. The modification is not a discontinuation of the plan under [paragraphs (e) and
 27 (g) of this] subsection **(5)(e) and (g) of this section.**

28 [(6)] **(7)** Notwithstanding any provision of subsection [(5)] **(6)** of this section to the contrary, **a**
 29 **carrier may rescind** any small employer [carrier] health benefit plan, **or the coverage of an**
 30 **enrollee under a plan**, subject to the provisions of ORS 743.733 to 743.737 [may be rescinded by a
 31 small employer carrier for fraud, material misrepresentation or concealment by a small employer and
 32 the coverage of an enrollee may be rescinded for fraud, material misrepresentation or concealment by
 33 the enrollee.] **if the small employer or the enrollee:**

34 **(a) Performs an act, practice or omission that constitutes fraud; or**

23 (vi) The period of time during which a small employer retains uninterrupted coverage in force
24 with the same *[small employer]* carrier; and

25 (vii) Adjustments to reflect the provision of benefits not required to be covered by the basic
26 health benefit plan and differences in family composition.

27 (D)(i) The premium rates determined in accordance with this paragraph may be further adjusted
28 by a *[small employer]* carrier to reflect the expected claims experience of *[a]* **the covered** small
29 employer, but the extent of this adjustment may not exceed five percent of the annual premium rate
30 otherwise payable by the small employer. The adjustment under this subparagraph may not be cu-
31 mulative from year to year.

32 (ii) *[Except for small employers with 25 or fewer employees,]* The premium rates adjusted under
33 this subparagraph, **except rates for small employers with 25 or fewer employees**, are not subject
34 to the provisions of subparagraph (A) of this paragraph.

35 (E) A *[small employer]* carrier shall apply the carrier's schedule of premium rate variations as
36 approved by *[the Director of]* the department *[of Consumer and Business Services]* and in accordance

15 (a) The full array of health benefit plans that are offered to small employers by the carrier;

16 (b) The authority of the carrier to adjust rates, and the extent to which the carrier will consider
 17 age, family composition and geographic factors in establishing and adjusting rates;

18 (c) Provisions relating to renewability of policies and contracts; and

19 (d) Provisions affecting any preexisting [conditions provision] **condition exclusion**.

20 [(10)(a)] (11)(a) Each [small employer] carrier shall maintain at its principal place of business a
 21 complete and detailed description of its rating practices and renewal underwriting practices **relat-**
 22 **ing to its small employer health benefit plans**, including information and documentation that
 23 demonstrate that its rating methods and practices are based upon commonly accepted actuarial
 24 practices and are in accordance with sound actuarial principles.

25 (b) [Each small employer] A carrier **offering a small employer health benefit plan** shall file
 26 with the [director] **department** at least once every 12 months an actuarial certification that the
 27 carrier is in compliance with ORS 743.733 to 743.737 and that the rating methods of the [small em-
 28 ployer] carrier are actuarially sound. Each [such] certification shall be in a uniform form and manner

 42 ued shall be the anniversary date of the first issuance of the health benefit plan.

43 [(13)] (14) A [small employer] carrier must include a provision that offers coverage to all eligible
 44 employees **of a small employer** and to all dependents **of the eligible employees** to the extent the
 45 employer chooses to offer coverage to dependents.

1 [(14)] (15) All small employer health benefit plans shall contain special enrollment periods dur-
 2 ing which eligible employees and dependents may enroll for coverage, as provided in 42 U.S.C.
 3 300gg as amended and in effect on [July 1, 1997] **February 17, 2009**.

4 (16) **A group health benefit plan may not impose lifetime dollar limits on the essential**
 5 **health benefits prescribed by the United States Secretary of Health and Human Services**

7 **SECTION 42.** ORS 743.745 is amended to read:

8 743.745. (1) The Director of the Department of Consumer and Business Services shall [*appoint*
 9 *a Health Insurance Reform Advisory Committee. This committee shall consist of at least one insurance*
 10 *producer, one representative of a health maintenance organization, one representative of a health care*
 11 *service contractor, one representative of a domestic insurer, one representative of a labor organization*

 31 mendations to the director within the time period established by the director. The health benefit plans
 32 and other recommendations shall be deemed approved unless expressly disapproved by the director

34 (2) In order to ensure the broadest availability of small employer, **portability** and individual
 35 health benefit plans, [*the committee shall recommend for approval by*] the director **may approve**
