

# House Bill 2401

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Pre-session filed (at the request of House Interim Committee on Health Care for Oregon Academy of Family Physicians)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Area Health Education Center program to create family medicine residency network.  
Appropriates moneys from General Fund to Oregon Health and Science University for purposes of network.  
Declares emergency, effective on passage.

## A BILL FOR AN ACT

2 Relating to a family medicine residency network; appropriating money; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Area Health Education Center program created in ORS 353.450 shall**  
5 **create a family medicine residency network that:**

6 (a) **Facilitates an increase in the number of family medicine residency positions in this**  
7 **state in order to train more highly qualified family physicians who are likely to practice in**  
8 **this state.**

9 (b) **Supports and assists hospital systems in this state to work collaboratively with ex-**  
10 **isting family medicine residency programs to develop new family medicine residency pro-**  
11 **grams throughout this state.**

12 (c) **Helps family medicine residency programs in this state share resources through the**  
13 **creation of standardized curriculum, a common faculty development center, initiation of**  
14 **physician training in quality improvement, medical home development, chronic disease**  
15 **management, interprofessional team-based care and population care management, facili-**  
16 **tation of primary care research projects through joint regulatory monitoring and other**  
17 **support and provision of grant writing resources for outside funding.**

18 (2) **The Area Health Education Center program may accept gifts, grants or contributions**  
19 **from any public or private source for the purpose of carrying out this section.**

20 **SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-**  
21 **ated to the Oregon Health and Science University, for the biennium beginning July 1, 2011,**  
22 **out of the General Fund, the amount of \$1,000,000, which may be expended for purposes of**  
23 **carrying out the provisions of section 1 of this 2011 Act.**

24 **SECTION 3. This 2011 Act being necessary for the immediate preservation of the public**  
25 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**  
26 **on its passage.**
