

House Bill 2416

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health benefit plan to cover drug containing pseudoephedrine for allergy symptoms if plan covers prescription drugs for allergy symptoms.

2 Relating to health benefit plan coverage; creating new provisions; and amending ORS 750.055 and
3 750.333.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2011 Act is added to and made a part of the Insurance Code.**

6 **SECTION 2. (1) A health benefit plan, as defined in ORS 743.730, that provides coverage**
7 **for a drug prescribed for the relief of allergy symptoms must provide coverage for a drug**
8 **containing pseudoephedrine if:**

9 (a) **The drug containing pseudoephedrine is prescribed for the relief of allergy symptoms;**
10 **and**

11 (b) **Except for the prohibition in ORS 475.973, the drug could be sold over the counter**
12 **without a prescription.**

13 (2) **The coverage required under subsection (1) of this section is subject to the same**
14 **terms and conditions under the plan that apply to other prescription drug benefits under the**
15 **plan.**

16 (3) **This section is exempt from ORS 743A.001.**

24 (4) The Director of the Department of Consumer and Business Services may, after notice and
 25 hearing, adopt reasonable rules not inconsistent with this section and ORS 750.003, 750.005, 750.025
 26 and 750.045 that are deemed necessary for the proper administration of these provisions.

12 (3) The provision of health benefits under ORS 750.301 to 750.341 shall be considered to be the
13 transaction of health insurance.

14 **SECTION 5. Section 2 of this 2011 Act and the amendments to ORS 750.055 and 750.333**
15 **by sections 3 and 4 of this 2011 Act apply to health benefit plan policies or certificates issued**
16 **or renewed on or after the effective date of this 2011 Act.**
