SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies provisions relating to local budget law.

3 294.356, 294.371, 294.391, 294.401, 294.411, 294.416, 294.421, 294.430, 294.435, 294.440, 294.445,
4 294.450, 294.455, 294.480, 294.500, 294.555, 294.608, 294.910, 310.060 and 455.210; and repealing
5 ORS 294.386, 294.418 and 294.483.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 294.326 is amended to read:

8 294.326. (1) *[Except as provided in subsections (3) to (11) of this section, it is unlawful for any]* **A**
9 municipal corporation *[to]* **may not** expend money or *[to]* certify to the assessor an ad valorem tax
10 rate or estimated amount of ad valorem taxes to be imposed in any year unless the municipal cor-
11 poration has complied with ORS 294.305 to 294.565.

12 *[(2) To the extent that any of subsections (3) to (11) of this section apply in a given case, the mu-*
13 *nicipal corporation need not comply with ORS 294.305 to 294.565.]*

14 *[(3)]* **(2)** Subsection (1) of this section does not apply to the expenditure *[in the year of receipt]*
15 of grants, gifts, bequests or devises transferred to a municipal corporation in trust for specific pur-
16 poses or to other special purpose trust funds at the disposal of municipal corporations. *[However,*
17 *subsection (1) of this section does apply to the expenditure of grants, gifts, bequests or devises trans-*
18 *ferred to a municipal corporation for undesignated general purposes or to the expenditure of grants,*
19 *gifts, bequests or devises transferred to a municipal corporation in trust for specific purposes which*
20 *were received in a prior year. Expenditure of grants, gifts, bequests and devises exempt from subsection*
21 *(1) of this section by]* **A municipal corporation may not make an expenditure under** this sub-
22 section *[is lawful only after enactment by]* **unless** the governing body of the municipal corporation
23 *[of]* **enacts** appropriation ordinances or resolutions authorizing the expenditure.

24 *[(4)]* **(3)** Subsection (1) of this section does not apply *[whenever]:*

25 **(a) To the extent that maintenance, repair or self-insurance reserves authorized by ORS**
26 **294.366 or nontax funds are available or may be made available; and**

27 **(b) If** the governing body of a municipal corporation:

28 **(A) Adopts an ordinance or resolution to appropriate excess expenditures for a specific**

1 **purpose or purposes; and**

2 **(B)(i)** *[Has declared]* **Declares** the existence of an *[unforeseen]* occurrence or condition *[which]*
3 **that** could not have been foreseen at the time of the preparation of the budget for the current year
4 or current budget period *[or]*;

5 **(ii)** Could not have foreseen a pressing necessity for the expenditure *[or]* **at the time of the**
6 **preparation of the budget for the current year or current budget period; or**

7 **(iii)** *[Has received]* **Receives** a request for services or facilities, the cost of which is supplied by
8 a private individual, corporation or company or by another governmental unit necessitating a
9 greater expenditure of public money for any specific purpose or purposes than the amount budgeted
10 in order to provide the services for which the governing body of the municipal corporation was re-
11 sponsible. *[The governing body may make excess expenditures for the specific purpose or purposes be-*
12 *yond the amount budgeted and appropriated to the extent that maintenance, repair or self-insurance*
13 *reserves authorized by ORS 294.366 or nontax funds are available or may be made available. The*
14 *expenditures are lawful only after the enactment of appropriate appropriation ordinances or resolutions*
15 *authorizing the expenditures. The ordinance or resolution must state the need for the expenditure, the*
16 *purpose for the expenditure and the amount appropriated.]*

17 *[(5)]* **(4)** Subsection (1) of this section does not apply to the expenditure during the current year
18 or current budget period of the proceeds of the sale of the following bonds, as defined in ORS
19 287A.001, or to the expenditure during the current year or current budget period of other funds to
20 pay debt service on those bonds:

21 (a) Bonds that are issued under ORS 287A.150 and for which the referral period described in
22 ORS 287A.150 ended after the preparation of the budget of the current year or current budget pe-
23 riod;

24 (b) Bonds that were approved by the electors during the current year or current budget period;
25 or

26 (c) Bonds issued during the current year or current budget period to refund previously issued
27 bonds or obligations.

28 *[(6)]* **(5)** Subsection (1) of this section does not apply to:

29 (a) Expenditures of funds received from the sale of conduit revenue bonds or other borrowings
30 issued for private business entities or nonprofit corporations by public bodies, as defined in ORS
31 287A.001, or the State of Oregon or to pay debt service on the bonds;

32 (b) Expenditures of funds that have been irrevocably placed in escrow for the purpose of
33 defeasing and paying bonds;

34 (c) Expenditures of assessments or other revenues to redeem bonds that are payable from the
35 assessments or other revenues, when the assessments or other revenues are received as a result of
36 prepayments or other unforeseen circumstances; or

37 (d) Expenditures of funds that are held as debt service reserves for bonds if the expenditures
38 are made to:

39 (A) Pay debt service on the bonds;

40 (B) Redeem the bonds; or

41 (C) Fund an escrow or trust account to defease or pay the bonds.

42 *[(7)]* **(6)** Subsection (1) of this section does not apply to expenditures of funds received from as-
43 sessments against benefited property for local improvements as defined in ORS 223.001 to the extent
44 that the cost of the improvements is *[to be paid]* **payable** by owners of benefited property.

45 *[(8)]* **(7)** Subsection (1) of this section does not apply to the expenditure of funds accumulated

1 to pay deferred employee compensation.

2 [(9)] (8) Subsection (1) of this section does not apply to refunds or the interest on refunds
3 granted by counties under ORS 311.806.

4 [(10)] (9) Subsection (1) of this section does not apply to refunds received by a municipal cor-
5 poration when purchased items are returned after an expenditure has been made. **A municipal**
6 **corporation may not make an expenditure** [*of refunded amounts to which*] **under** this subsection
7 [*applies is lawful only after*] **unless** the governing body of the municipal corporation [*has enacted,*
8 *after public hearing,*] **enacts** appropriate appropriation ordinances or resolutions authorizing the
9 expenditure.

10 [(11)] (10) Subsection (1) of this section does not apply to a newly formed municipal corporation
11 during the fiscal year in which it was formed. If a new municipal corporation is formed between
12 March 1 and June 30, subsection (1) of this section does not apply to the municipal corporation
13 during the fiscal year immediately following the fiscal year in which it was formed.

14 **SECTION 2.** ORS 294.352 is amended to read:

15 294.352. (1) Each municipal corporation shall prepare estimates of expenditures **and other re-**
16 **quirements** for the ensuing year or [*ensuing*] budget period. **The estimates must be reconciled**
17 **so that the total amount of expenditures and other requirements in each fund equals the**
18 **total amount of resources in the fund for the same period.**

19 (2) [*The*] Estimates required [*by*] **under** subsection (1) of this section [*shall*] **must** be prepared
20 by organizational unit or by program. **For purposes of preparing the estimates, “organizational**
21 **unit” does not apply to hospitals, school districts or education service districts.**

22 (3) Estimates [*required by subsection (1) of this section and*] prepared by organizational unit
23 [*shall*] **pursuant to subsection (2) of this section must** be detailed under separate object classi-
24 fications of [*personal*] **personnel** services, materials and services and capital outlay. Separate esti-
25 mates [*shall*] **must** be made **for operating expenses and general capital outlays that cannot**
26 **reasonably be allocated to an organizational unit and** for special payments, debt service[,] **and**
27 interfund revenue transfers[, *operating expenses and general capital outlays which cannot reasonably*
28 *be allocated to an organizational unit*].

29 (4) Estimates [*required by subsection (1) of this section and*] prepared by program [*shall*] **pursu-**
30 **ant to subsection (2) of this section must** be arranged for each activity of a program. Estimates
31 under each activity [*shall*] **must** be detailed under separate object classifications of [*personal*] **per-**
32 **sonnel** services, materials and services and capital outlay. Separate estimates [*shall*] **must** be made
33 [*for each program*] **for operating expenses and general capital outlays that cannot reasonably**
34 **be allocated to an activity within a program and** for special payments, debt service[,] **and** inter-
35 fund revenue transfers[, *operating expenses and general capital outlays which cannot reasonably be*
36 *allocated to an activity within a function. For common and union high school districts and community*
37 *colleges, estimates required by this subsection shall be further detailed by object within each object*
38 *classification*].

39 (5) Estimates of expenditures for [*personal services, other than services of persons who receive an*
40 *hourly wage or who are hired on a part-time basis, shall list the salary for each officer and employee,*
41 *except that*] **personnel services must include for each organizational unit or activity the total**
42 **budgeted cost of all officers and employees and the number of related full-time equivalent**
43 **positions. Upon request, a municipal corporation shall make available the current salary of**
44 **each officer and employee, other than persons who receive an hourly wage or who are hired**
45 **on a part-time basis. For the purpose of preparing a list of salaries, employees of like classi-**

1 fication and salary range[, (*such range not to exceed that established by the governing body of the*
 2 *municipal corporation in accordance with its policy for setting salaries*) in each organizational unit or
 3 *activity*] may be listed by the number of [*those*] employees, the [*limits of each salary range*] **highest**
 4 **and lowest salaries** and the **total** amount of [*their combined*] **all salaries, in each salary range.**

5 [(6) *The general capital outlay estimate shall include separate amounts for land, buildings, im-*
 6 *provements to land other than buildings and machinery and equipment which cannot be reasonably*
 7 *allocated to an organizational unit or activity.*]

8 [(7) (6) [*The*] Debt service estimates [*shall*] **must** include separate amounts for principal and
 9 interest [*of*] **for** each bond issue in each fund.

10 [(8) (7) [*There may be included in each fund*] **The estimate for a fund may include** an estimate
 11 for general operating contingencies.

12 [(9) *If the estimates required by subsection (1) of this section are not prepared by fund, there shall*
 13 *be prepared a summary which cross-references programs or organizational units to the appropriations*
 14 *required by ORS 294.435.*]

15 **SECTION 3.** ORS 294.356 is amended to read:

16 294.356. (1) Each school district[,] **and** each education service district [*and each community col-*
 17 *lege district*] shall prepare [*its*] **the** estimates of expenditures required [*by*] **under** ORS 294.352 in
 18 accordance with the classification of revenue and expenditure accounts prescribed by [*rules of the*
 19 *State Board*] **the Department** of Education [*with the approval of*] **in consultation with** the De-
 20 partment of Revenue. The Department of Revenue [*shall be*] **is** responsible for determining **the**
 21 **district's compliance with this subsection.**

22 **(2) Each community college district shall prepare the estimates of expenditures required**
 23 **under ORS 294.352 in accordance with the classification of revenue and expenditure accounts**
 24 **prescribed by the Department of Community Colleges and Workforce Development in con-**
 25 **sultation with the Department of Revenue. The Department of Revenue is responsible for**
 26 **determining the district's compliance with this subsection.**

27 [(2) *The term "organizational unit" shall not apply to hospitals, school districts, education service*
 28 *districts and community colleges in preparing estimates of expenditures under ORS 294.352 or making*
 29 *appropriations under ORS 294.435. The term "organizational unit" shall not apply to hospitals in*
 30 *preparing the budget summary required by ORS 294.416.*]

31 (3) Notwithstanding ORS 294.352 [(5)] (2), each municipal corporation [*which*] **that** operates a
 32 public utility or hospital shall prepare [*its*] estimates for [*such*] **the operations of each public utility**
 33 **or hospital** in accordance with:

34 (a) The **applicable** generally accepted system of accounts for [*such operation*] **the operations;**
 35 or [*in accordance with*]

36 (b) The general system of accounts [*contained in ORS 294.311 to 294.520*] **in ORS 294.305 to**
 37 **294.565.**

38 **SECTION 4.** ORS 294.371 is amended to read:

39 294.371. A municipal corporation may include in its budget an estimate of unappropriated ending
 40 fund balance for each fund, for use in the fiscal period following that for which the budget is being
 41 prepared. The estimate authorized by this section represents cash or net working capital which will
 42 be carried over into the year following the ensuing fiscal year or ensuing budget period for which
 43 the budget is being prepared. It shall not in any way reduce the cash balance or net working capital
 44 which becomes part of the budget resources provided in ORS 294.361 (1) to (3). The unappropriated
 45 ending fund balance authorized by this section shall become a budget resource at the close of the

1 ensuing fiscal year or ensuing budget period for the succeeding year or budget period. Except as
 2 provided in ORS 294.326 [(3)] (2) and 294.455, no appropriation [*nor*] **or** expenditure shall be made
 3 in the year or budget period for which the budget is applicable for the amount estimated pursuant
 4 to this section.

5 **SECTION 5.** ORS 294.391 is amended to read:

6 294.391. A budget message shall be prepared by or under the direction of the executive officer
 7 of the municipal corporation or, where no executive officer exists, by or under the direction of the
 8 presiding officer of the governing body. The budget message shall be delivered at a meeting of the
 9 budget committee as provided in ORS 294.401 (1). The budget message shall:

10 (1) Explain the budget document;

11 (2) Contain a brief description of the proposed financial policies of the municipal corporation for
 12 the ensuing year or ensuing budget period;

13 (3) Describe in connection with the financial policies of the municipal corporation, the important
 14 features of the budget document;

15 (4) Set forth the reason for salient changes from the previous year or budget period in appro-
 16 priation and revenue items; [*and*]

17 (5) Explain the major changes in financial policy; **and**

18 (6) **Set forth any change contemplated in the municipal corporation's basis of accounting**
 19 **and explain the reasons for the change and the effect of the change on the operations of the**
 20 **municipal corporation.**

21 **SECTION 6.** ORS 294.401 is amended to read:

22 294.401. (1) The budget committee **established under ORS 294.336** shall hold one or more
 23 meetings for the following purposes:

24 (a) Receiving the budget message **prepared under ORS 294.391** and the budget document; and

25 (b) Providing members of the public with an opportunity to ask questions about and comment
 26 [*upon*] **on** the budget document.

27 (2)(a) [*When*] **If a budget committee holds** more than one meeting [*of the budget committee is*
 28 *held*] under subsection (1) of this section, **the budget message and the budget document must**
 29 **be received at** the first meeting[*shall be the meeting at which the budget message and the budget*
 30 *document are received by the budget committee*].

31 (b) **If** the budget committee [*may*] **does not** provide members of the public with an opportunity
 32 to ask questions about and comment [*upon*] **on** the budget document at the first meeting[*of the*
 33 *budget committee. If such opportunity is not provided at the first meeting*], the budget committee
 34 [*shall*] **must** provide the public with the opportunity [*to ask questions and make comments upon the*
 35 *budget document at subsequent meetings*] **at a subsequent meeting.**

36 (3)(a) **Except as provided in paragraph (b) of this subsection,** the budget officer **designated**
 37 **under ORS 294.331** shall publish prior notice of each meeting of the budget committee held [*for the*
 38 *purpose of satisfying the requirements of*] **pursuant to** subsection (1) of this section. The [*published*]
 39 notice [*shall*] **must** contain the information [*required under*] **described in** subsection (4) of this
 40 section **and must be published by one of the methods described in subsection (5) of this sec-**
 41 **tion.** [*However:*]

42 [(a)] (b)(A) **If the budget committee holds** more than one meeting [*of the budget committee is*
 43 *held for the purpose of meeting the requirements of subsection (1)*] **for the purposes described in**
 44 **subsection (1)** of this section, the budget officer may publish a [*single notice containing the required*
 45 *information*] **combined notice** for all [*of*] the meetings. [*to be held for the purpose of meeting the re-*

1 *quirements of subsection (1) of this section; and]*

2 *[(b)]* **(B)** If the budget committee holds *[two or more meetings under]* **more than one meeting**
 3 **for the purpose described in** subsection (1)(b) of this section, *[for the purpose of taking questions*
 4 *and comments from the public, then:]*

5 *[(A)]* **the budget officer may publish notice of** only *[notice of]* the first meeting *[held for the*
 6 *purpose of taking questions and comments from the public need be published in accordance with the*
 7 *requirements of this subsection, and notice of any subsequent meeting held for the purpose of taking*
 8 *questions and comments from the public].* **Notice of subsequent meetings** may be given as provided
 9 in ORS 294.406 (2)*]; and].*

10 *[(B)]* If notice is published for a meeting *[to be held for the purpose of taking questions and*
 11 *comments from the public]* **under this subparagraph** and it is subsequently determined that the
 12 meeting is *[not needed]* **unnecessary**, notice of cancellation of the meeting *[shall]* **must** be published
 13 as provided in ORS 294.406 (2).

14 (4) *[A notice meets the requirements of this subsection when it states]* **The notice required under**
 15 **subsection (3) of this section must state:**

16 (a) The purpose, time and place of the meeting or meetings *[to which the notice relates]* and the
 17 place where the budget document is available;

18 (b) That the meeting is a public meeting where deliberations of the budget committee will take
 19 place; and

20 (c) If the meeting described in the notice is a meeting at which the budget committee will re-
 21 ceive questions and comments from members of the public, that any person may ask questions about
 22 and comment on the budget document at that time.

23 (5)(a) *[When notice of a meeting of the budget committee]* **If the notice required under sub-**
 24 **section (3) of this section** is published **only** by publication in a newspaper, the notice *[satisfies the*
 25 *requirements of this section if the notice is published on not fewer than two occasions separated by at*
 26 *least five days, with the first publication not earlier]* **must be published at least two separate**
 27 **times, not more** than 30 days *[prior to]* **before** the meeting date and *[the final publication not*
 28 *later]* **not less** than five days *[prior to]* **before** the meeting date.

29 **(b) The notice may be published once in a newspaper, not more than 30 days before the**
 30 **meeting date and not less than five days before the meeting date, and once on the municipal**
 31 **corporation's Internet website, in a prominent manner and maintained on the website for**
 32 **at least 10 days before the meeting date. The newspaper notice must contain the Internet**
 33 **website address at which the notice is posted.**

34 (c) *[When notice of a meeting of the budget committee]* **If the notice** is published by mailing or
 35 *[by]* hand delivery, the notice *[satisfies the requirements of this section if the notice is]* **must be** placed
 36 with the United States Postal Service or hand delivered not *[later]* **less** than 10 days *[prior to]* **be-**
 37 **fore** the meeting date.

38 (6)(a) At any time *[prior to the meeting of the budget committee at which the budget committee*
 39 *will receive the budget message and the budget document]* **before the first meeting required under**
 40 **subsection (1) of this section**, the budget officer may provide *[a]* **one** copy of the budget document
 41 to each member of the budget committee **solely** for the information and use of the individual *[mem-*
 42 *ber]* **members. The budget committee may not deliberate on the budget document as a body**
 43 **before the first meeting.**

44 (7) (b) *[Except when copies of the budget document were provided to the members of the budget*
 45 *committee under subsection (6) of this section, the budget officer shall submit to the members of the*

1 *budget committee the budget document*] **If the budget officer does not provide copies of the budget**
 2 **document to the members of the budget committee under paragraph (a) of this subsection,**
 3 **the budget officer shall provide copies** at the first meeting *[held]* **required** under subsection (1)
 4 of this section *[for their use and consideration]*.

5 [(8)] (7) The budget officer shall file a copy of the budget document in the office of the governing
 6 body of the municipal corporation immediately following presentation of the budget document to the
 7 members of the budget committee under subsection (6) *[or (7)]* of this section. The copy *[shall*
 8 *become]* **is a public record of the municipal corporation.**

9 [(9)] (8) The governing body *[shall either provide the means of duplicating the budget or part*
 10 *thereof, in those situations where the budget document or portion thereof may be quickly reproduced,*
 11 *or shall provide copies of the budget document or part thereof so that a copy of the budget document*
 12 *or part thereof may be readily obtained by any individual interested in the affairs of the municipal*
 13 *corporation]* **of the municipal corporation must provide to individuals upon request a copy of**
 14 **the budget document or the means of readily obtaining a copy of the budget document.**

15 **SECTION 7.** ORS 294.411 is amended to read:

16 294.411. (1) A municipal corporation *[having]* **that has** a population not exceeding 200,000, **is**
 17 located in a county having a tax supervising and conservation commission, *[not making]* **has not**
 18 **made** an election under ORS 294.625 (2) and **has not** *[submitting]* **submitted** its **approved** budget
 19 document to the tax supervising and conservation commission for a public hearing pursuant to ORS
 20 294.430 (3) shall submit its approved budget document to the tax supervising and conservation
 21 commission in the county at least 30 days *[prior to]* **before** the date of the public hearing in ac-
 22 cordance with ORS 294.430.

23 **(2) A municipal corporation that has a population exceeding 200,000, or a municipal cor-**
 24 **poration that has a population not exceeding 200,000, has not made an election under ORS**
 25 **294.625 (2) and requests the tax supervising and conservation commission to conduct the**
 26 **public hearing described in ORS 294.430, shall submit its approved budget document to the**
 27 **tax supervising and conservation commission in the county at least 20 days before the date**
 28 **of the public hearing in accordance with ORS 294.430.**

29 **(3)** *[If its territory lies in two or more counties, the municipal corporation shall submit its budget*
 30 *to the commission]* If the real market value of all property subject to taxation by *[the]* **a municipal**
 31 **corporation in [the] a county having a tax supervising and conservation** commission is greater
 32 than the real market value of all property subject to taxation by the municipal corporation in any
 33 other county*]. Real market value is*, **the municipal corporation shall submit its approved budget**
 34 **document to the tax supervising and conservation commission pursuant to subsection (1) or**
 35 **(2) of this section. As used in this subsection, “real market value” means** the real market
 36 value computed according to ORS 308.207 from the assessment rolls last in the process of collection.

37 *[(2) Before adopting the budget, the governing body for a municipal corporation that submits its*
 38 *approved budget to the commission as described in subsection (1) of this section shall consider and take*
 39 *appropriate action on any orders, recommendations or objections made by the tax supervising and*
 40 *conservation commission.]*

41 **(4) Upon timely application in writing by a municipal corporation, a tax supervising and**
 42 **conservation commission may for good cause allow the municipal corporation to submit its**
 43 **approved budget document later than required under subsections (1) and (2) of this section.**

44 **SECTION 8.** ORS 294.416 is amended to read:

45 294.416. *[Except as provided in ORS 294.418, there shall be published, as provided in ORS*

1 294.421:]

2 [(1) A summary of the budget as approved by the budget committee and compared with the actual
3 expenditures and budget resources of the preceding year or preceding budget period and the budget
4 summary of the current year or current budget period in accordance with forms prescribed by the De-
5 partment of Revenue in the manner provided in ORS 294.413. The summary shall be of sufficient detail
6 to inform the citizens of the municipal corporation of the proposed financial plan for the ensuing year
7 or ensuing budget period. As a minimum requirement, the personnel services, the major expense items
8 under materials and services and capital outlay for each organizational unit or activity of each fund
9 and the major items for debt service, special payments, and operating contingencies for each fund shall
10 be listed separately. The summary shall show the major items of budget resources. As used in this
11 subsection, the term "program" may be substituted for the term "organizational unit" for municipal
12 corporations which prepare program budgets.]

13 [(2) The financial summary prepared under ORS 294.386 for the ensuing year or ensuing budget
14 period and for the current year or current budget period.]

15 [(3) A notice of the time and place at which the budget document as approved by the budget com-
16 mittee may be discussed with the governing body.]

17 [(4) A statement that the budget is prepared in accordance with the basis of accounting used in the
18 preceding year or preceding budget period unless a change in the basis of accounting is anticipated.
19 If a change in the basis of accounting is to be made, there shall be an explanation of the change and
20 the effects of the change.]

21 [(5) A notice of the place where the complete budget document is available for inspection by the
22 general public during regular business hours and where copies of the complete budget document may
23 be obtained.]

24 **(1) Not more than 30 days and not less than five days before the meeting of the governing**
25 **body of a municipal corporation under ORS 294.430, a notice of the meeting and a financial**
26 **summary of the budget as approved by the budget committee and compared with the actual**
27 **expenditures and budget resources of the preceding year or preceding budget period and the**
28 **budget summary of the current year or current budget period must be published at least**
29 **once. The notice and financial summary may be published in accordance with forms pre-**
30 **scribed by the Department of Revenue or in a narrative format that includes all the infor-**

22 *[(b) If there is no county clerk in a county to which a taxing district is required by paragraph (a)*
23 *of this subsection to submit a budget document, then the taxing district shall submit the budget docu-*
24 *ment to the county assessor in that county.]*

25 *[(c) If the taxing district is subject to the jurisdiction of a tax supervising and conservation com-*
26 *mission under ORS 294.625, then the taxing district shall submit a copy of its budget to the tax*
27 *supervising and conservation commission in lieu of filing a copy of the budget with the county clerk*
28 *of the county under paragraph (a) of this subsection or with the county assessor of the county under*
29 *paragraph (b) of this subsection.]*

30 (8) The Department of Revenue shall prescribe the form of notice required *[by]* **under** this sec-
31 tion. All amounts *[shall]* **contained in the notice must** be stated in dollars and cents or ad valorem
32 property tax rates in dollars and cents per thousand dollars of assessed value, as required by law.
33 If the notice is given to the assessor, clerk or tax supervising and conservation commission of more

43 corporation in the periods in which those transactions, events and circumstances occur, rather than
44 only in the periods in which cash is received or paid by the municipal corporation.

45 (2) "Activity" means a specific and distinguishable service performed by one or more organiza-

1 tional components of a municipal corporation to accomplish a function for which the municipal
2 corporation is responsible.

3 (3) "Appropriation" means an authorization granted by the governing body to make expenditures
4 and to incur obligations for specific purposes. An appropriation is limited to a single fiscal year for
5 municipal corporations preparing annual budgets, or to the budget period for municipal corporations
6 preparing biennial budgets.

7 (4) "Basis of accounting" means the cash basis, the modified accrual basis or the accrual basis.

8 (5) "Budget" means a plan of financial operation embodying an estimate of expenditures for a
9 given period or purpose and the proposed means of financing the estimated expenditures.

10 (6) "Budget document" means the estimates of expenditures and budget resources as set forth
11 on the estimate sheets, tax levy and the financial summary.

12 (7) "Budget period" means, for municipal corporations with the power to levy a tax upon prop-
13 erty, the two-year period commencing on July 1 and closing on June 30 of the second calendar year
14 next following, and for all other municipal corporations, an accounting period of 24 months ending
15 on the last day of any month.

16 (8) "Budget resources" means resources to which recourse can be had to meet obligations and
17 expenditures during the fiscal year or budget period covered by the budget.

18 (9) "Cash basis" means a basis of accounting under which transactions are recognized only in
19 the period during which cash is received or disbursed.

20 (10) "Current budget period" means the budget period in progress.

21 (11) "Current year" means the fiscal year in progress.

22 (12) "Encumbrance accounting" means the method of accounting under which outstanding
23 encumbrances are recognized as reductions of appropriations and the related commitments are car-
24 ried in a reserve for encumbrances until liquidated, either by replacement with an actual liability
25 or by cancellation. This method of accounting may be used as a modification to the accrual basis
26 of accounting in accordance with generally accepted accounting principles.

27 (13) "Encumbrances" means obligations in the form of purchase orders, contracts or salary
28 commitments which are chargeable to an appropriation and for which a part of the appropriation
29 is reserved. Obligations cease to be encumbrances when paid or when the actual liability is set up.

30 (14) "Ensuing budget period" means the budget period following the current budget period.

31 (15) "Ensuing year" means the fiscal year following the current year.

32 (16) "Expenditure" means, if the accounts are kept on the accrual basis or the modified accrual
33 basis, decreases in net financial resources and may include encumbrances. If the accounts are kept
34 on the cash basis, the term covers only actual disbursement, the drawing of the check or warrant
35 for these purposes and not encumbrances, except that deferred employee compensation shall be in-
36 cluded as a *[personal]* **personnel** service expenditure where an approved deferred employee com-
37 pensation plan is in effect for a municipal corporation.

38 (17) "Fiscal year" means for municipal corporations with the power to impose ad valorem
39 property taxes, the fiscal year commencing on July 1 and closing on June 30, and for all other mu-
40 nicipal corporations, an accounting period of 12 months ending on the last day of any month.

41 (18) "Fund balance" means the excess of the assets of a fund over its liabilities and reserves
42 except in the case of funds subject to budgetary accounting where, prior to the end of a fiscal pe-
43 riod, it represents the excess of the fund's assets and estimated revenues for the period over its li-
44 abilities, reserves and appropriations for the period.

45 (19) "General county resources" means resources from property taxes, state and federal shared

1 revenue, beginning balances available for expenditure and interest not required to be allocated to
2 specific programs or activities.

3 (20) "Governing body" means the city council, board of commissioners, board of directors,
4 county court or other managing board of a municipal corporation including a board managing a
5 municipally owned public utility or a dock commission.

6 (21) "Grant" means a donation or contribution of cash to a governmental unit by a third party.

7 (22) "Intergovernmental entity" means an entity created under ORS 190.010 (5). The term in-
8 cludes any council of governments created prior to the enactment of ORS 190.010 (5).

9 (23) "Internal service fund" means a fund properly authorized to finance, on a cost reimburse-
10 ment basis, goods or services provided by one organizational unit of a municipal corporation to
11 other organizational units of the municipal corporation.

12 (24) "Liabilities" means probable future sacrifices of economic benefits, arising from present
13 obligations of a municipal corporation to transfer assets or provide services to other entities in the
14 future as a result of past transactions or events. The term does not include encumbrances.

15 (25)(a) "Modified accrual basis" means the accrual basis of accounting adapted to the govern-
16 mental fund-type measurement focus. Under this basis of accounting, revenues and other financial
17 resource increments, such as bond proceeds, are recognized when they become susceptible to ac-
18 crual, that is, when they become both measurable and available to finance expenditures in the cur-
19 rent period.

20 (b) As used in this subsection, "available" means collectible in the current period or soon
21 enough thereafter to be used to pay liabilities of the current period. Under this basis of accounting,
22 expenditures are recognized when the fund liability is incurred except for:

23 (A) Inventories of material and supplies that may be considered expenditures either when pur-

34 ventories, supplies and prepaid expenses less current liabilities and, if encumbrance accounting is
35 adopted, reserve for encumbrances. The term is not applicable to the cash basis of accounting.

36 (28) "Object" means, as used in expenditure classification, articles purchased including, but not
37 limited to, land, buildings, equipment and vehicles, or services obtained including, but not limited
38 to, administrative services, clerical services, professional services, property services and travel, as
39 distinguished from the results obtained from expenditures.

40 (29) "Object classification" means a grouping of expenditures on the basis of goods or services
41 purchased, including, but not limited to, *[personal]* **personnel** services, materials, supplies and
42 equipment.

43 (30) "Operating taxes" has the meaning given that term in ORS 310.055.

44 (31) "Organizational unit" means any administrative subdivision of a municipal corporation, es-
45 pecially one charged with carrying on one or more functions or activities.

1 (32) "Population" means the number of inhabitants of a municipal corporation according to
2 certified estimates of population made by the State Board of Higher Education.

3 (33) "Program" means a group of related activities aimed at accomplishing a major service or
4 function for which the municipality is responsible.

5 (34) "Public utility" means those public utility operations authorized by ORS chapter 225.

6 (35) "Publish" or "publication" means any one or more of the following methods of giving notice
7 or making information or documents available to members of the general public:

8 (a) Publication in one or more newspapers of general circulation within the jurisdictional
9 boundaries of the municipal corporation.

10 (b) Posting through the United States Postal Service by first class mail, postage prepaid, to each
11 street address within the jurisdictional boundaries of the municipal corporation and to each post
12 office box and rural route number belonging to a resident within the jurisdictional boundaries of the
13 municipal corporation.

14 (c) Hand delivery to each street address within the jurisdictional boundaries of the municipal
15 corporation.

16 (36) "Receipts" means cash received unless otherwise qualified.

17 (37) "Reserve for encumbrances" means a reserve representing the segregation of a portion of
18 a fund balance to provide for unliquidated encumbrances.

19 (38) "Revenue" means the gross receipts and receivables of a governmental unit derived from
20 taxes, licenses, fees and from all other sources, but excluding appropriations, allotments and return
21 of principal from investment of surplus funds.

22 (39) "Special revenue fund" means a fund properly authorized and used to finance particular
23 activities from the receipts of specific taxes or other revenues.
