SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Extends deadline for filing nominating petition or declaration of nomination in event of untimely vacancy in partisan elective office. Also allows extension of deadline for filing candidate portrait and statement in voters' pamphlet.

Repeals provisions from elections laws relating to slate mailing.

Modifies provisions relating to appointment of treasurer by candidate or political com-

mittee. Applies those provisions to petition committees. Raises total amount of annual independent expenditures that require disclosure under elections laws from \$100 to \$750.

Provides for discontinuance of statement of organization for petition committee if committee does not properly file statement of contributions received or expenditures made. Modifies length of time that candidate, political committee and petition committee must

preserve written loan agreement to greater of two years or until repayment of loan.

Modifies means by which Secretary of State provides certain notices under elections laws and allows for electronic submission of testimony and evidence for certain hearings under elections laws.

SECTION 1. ORS 249.037 is amended to read: 5

6 249.037. (1) Except as otherwise provided in this section, a nominating petition or declaration

of candidacy shall be filed not sooner than the 250th day and not later than the 70th day before the 7 date of the primary election. 8

(2) If a vacancy occurs in a partisan elective office after the 80th day and before the 70th 9 day before the primary election, a nominating petition or declaration of candidacy for that 10 11 office may be filed not later than the 65th day before the primary election.

[(2)] (3) [Notwithstanding subsection (1) of this section,] A declaration of candidacy for the office 12 of precinct committeeperson may not be filed before February 1 immediately preceding the primary 13 election. 14

SECTION 2. ORS 251.065 is amended to read: 15

251.065. (1)(a) Except as provided in paragraph (b) of this subsection, not later than the 68th 16 day before the primary election, any candidate or agent on behalf of the candidate for nomination 17 or election at the primary election to the office of President or Vice President of the United States, 18 United States Senator, Representative in Congress or any state office as defined in ORS 249.002 may 19 file with the Secretary of State a portrait of the candidate and a printed or typewritten statement 20

(2) Not later than the 70th day before the general election, any candidate or agent on behalf 7 of the candidate for election at the general election to the office of President or Vice President of 8 9 the United States, United States Senator, Representative in Congress or any state office as defined in ORS 249.002 may file with the Secretary of State a portrait of the candidate and a printed or 10 typewritten statement of the reasons the candidate should be elected. A candidate or agent on behalf 11 12 of the candidate for election to any county or city office, or to an elected office of a metropolitan service district organized under ORS chapter 268, may file a portrait and statement under this sub-13 section if permitted under ORS 251.067. 14

(3) In the case of a special election to fill a vacancy as described in ORS 251.022, the Secretary
of State by rule shall set the deadline for filing with the secretary a portrait of the candidate and
a printed or typewritten statement of the reasons the candidate should be nominated or elected.

(4) Subject to subsections (1) to (3) of this section, the Secretary of State by rule shall establishthe format of the statements permitted under this section.

(5) A portrait or statement filed under this section shall be accompanied by a telephone or
 electronic facsimile transmission machine number where the candidate may be contacted for pur poses of ORS 251.087.

1 (10) "Independent expenditure" means an expenditure by a person for a communication in sup-2 port of or in opposition to a clearly identified candidate or measure that is not made with the co-3 operation or with the prior consent of, or in consultation with, or at the request or suggestion of, 4 a candidate or any agent or authorized committee of the candidate, or any political committee or 5 agent of a political committee supporting or opposing a measure. For purposes of this subsection:

6 (a) "Agent" means any person who has:

7 (A) Actual oral or written authority, either express or implied, to make or to authorize the 8 making of expenditures on behalf of a candidate or on behalf of a political committee supporting or 9 opposing a measure; or

10 (B) Been placed in a position within the campaign organization where it would reasonably ap-11 pear that in the ordinary course of campaign-related activities the person may authorize expen-12 ditures.

(B) The communication, as a whole, seeks action rather than simply conveying information; and(C) It is clear what action the communication advocates.

(d) "Made with the cooperation or with the prior consent of, or in consultation with, or at the
 request or suggestion of, a candidate or any agent or authorized committee of the candidate, or any
 political committee or agent of a political committee supporting or opposing a measure":

(A) Means any arrangement, coordination or direction by the candidate or the candidate's agent,
or by any political committee or agent of a political committee supporting or opposing a measure,
prior to the publication, distribution, display or broadcast of the communication. An expenditure
shall be presumed to be so made when it is:

(i) Based on information about the plans, projects or needs of the candidate, or of the political
committee supporting or opposing a measure, and provided to the expending person by the candidate
or by the candidate's agent, or by any political committee or agent of a political committee supporting or opposing a measure, with a view toward having an expenditure made; or

(ii) Made by or through any person who is or has been authorized to raise or expend funds, who is or has been an officer of a political committee authorized by the candidate or by a political committee or agent of a political committee supporting or opposing a measure, or who is or has been receiving any form of compensation or reimbursement from the candidate, the candidate's principal campaign committee or agent or from any political committee or agent of a political committee supporting or opposing a measure.

(11) "Initiative petition" means a petition to initiate a measure for which a prospective petition
has been filed but that is not yet a measure.

6 (13) "Mass mailing" means more than 200 substantially similar pieces of mail, but does not in-7 clude a form letter or other mail that is sent in response to an unsolicited request, letter or other 8 inquiry.

9 (14) "Measure" includes any of the following submitted to the people for their approval or re-10 jection at an election:

11 (a) A proposed law.

12 (b) An Act or part of an Act of the Legislative Assembly.

13 (c) A revision of or amendment to the Oregon Constitution.

15 (e) A proposition or question.

16 (15) "Occupation" means:
