

House Bill 2507

Sponsored by Representative HANNA; Representatives BENTZ, SPRENGER, THOMPSON, WEIDNER (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits person to use mobile communication device while operating motor vehicle in frontier counties.

Directs Department of Transportation to post on website names of counties that qualify as frontier counties.

A BILL FOR AN ACT

2 Relating to the use of a mobile communication device while operating a motor vehicle; creating new
3 provisions; and amending ORS 811.507.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 811.507 is amended to read:

6 811.507. (1) As used in this section:

7 (a) "Hands-free accessory" means an attachment or built-in feature for or an addition to a mo-
8 bile communication device, whether or not permanently installed in a motor vehicle, that when used
9 allows a person to maintain both hands on the steering wheel.

10 (b) "Mobile communication device" means a text messaging device or a wireless, two-way com-
11 munication device designed to receive and transmit voice or text communication.

12 (2) A person commits the offense of operating a motor vehicle while using a mobile communi-
13 cation device if the person, while operating a motor vehicle on a highway, uses a mobile communi-
14 cation device.

15 (3) This section does not apply:

16 (a) To a person who is summoning medical or other emergency help if no other person in the
17 vehicle is capable of summoning help;

18 (b) To a person using a mobile communication device for the purpose of farming or agricultural
19 operations;

20 (c) To a person operating an ambulance or emergency vehicle;

21 (d) To a person 18 years of age or older who is using a hands-free accessory;

22 (e) To a person operating a motor vehicle while providing public safety services or emergency
23 services as a volunteer;

24 (f) To a person operating a motor vehicle while acting in the scope of the person's employment
25 as a public safety officer, as defined in ORS 348.270;

26 (g) To a person operating a motor vehicle in the scope of the person's employment if operation
27 of the motor vehicle is necessary for the person's job;

28 (h) To a person activating or deactivating the mobile communication device or a function of the
29 device;

30 (i) To a person who holds a valid amateur radio operator license issued or any other license

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 issued by the Federal Communications Commission and is operating an amateur radio;

2 (j) To a person who operates a two-way radio device that transmits radio communication trans-
3 mitted by a station operating on an authorized frequency within the citizens' or family radio service
4 bands in accordance with rules of the Federal Communications Commission; [or]

5 (k) To a person using a function of the mobile communication device that allows for only one-
6 way voice communication while the person is:

7 (A) Operating a motor vehicle in the scope of the person's employment;

8 (B) Providing transit services to persons with disabilities or to senior citizens; or

9 (C) Participating in public safety or emergency service activities[.]; **or**

10 **(L) To a person operating a motor vehicle in a frontier county. As used in this paragraph,**
11 **"frontier county" means a county with a population that averages fewer than six people per**
12 **square mile.**

13 **(4) Each calendar year the Department of Transportation shall determine the counties**
14 **that are frontier counties, as defined in subsection (3)(L) of this section, and post the infor-**
15 **mation on the department's website.**

16 [(4)] (5) The offense described in this section, operating a motor vehicle while using a mobile
17 communication device, is a Class D traffic violation.

18 **SECTION 2. The amendments to ORS 811.507 by section 1 of this 2011 Act apply to of-**
19 **fenses committed on or after the effective date of this 2011 Act.**
