**Corrected Summary**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Replaces inheritance tax imposed on basis of former federal credit for state death tax with estate tax imposed as percentage of Oregon taxable estate **and modifies related provisions**. Establishes schedule of rates **for values above deduction**. Provides deduction of \$1.5 million for all estates. Updates connection date to federal Internal Revenue Code for Oregon estate tax purposes. **Creates procedures related to collection of estate taxes**. Clarifies provisions relating to elections made for state inheritance tax purposes. [*Replaces*] **Modifies provisions related to** tax credit for natural resource property [*with deduction and modifies related provisions*]. Removes references to "death tax."

**Repeals certain provisions, including obsolete provisions related to enforcement of nondomiciliary death taxes.**

Applies to estates of decedents who die on or after January 1, 2011.  
Takes effect on 91st day following adjournment sine die.

8 **Be It Enacted by the People of the State of Oregon:**

9 **SECTION 1.** ORS 118.005 is amended to read:

10 118.005. As used in ORS 118.005 to 118.840, unless the context requires otherwise:

11 (1) "Beneficiary" means the recipient of a beneficial interest in property or the income there-  
12 from transferred in a manner taxable under ORS 118.005 to 118.840.

13 (2) "Department" means the Department of Revenue.

14 (3) "Director" means the Director of the Department of Revenue.

15 (4) "Executor" means the executor, administrator, personal representative, fiduciary, or custo-  
16 dian of property of the decedent, or, if there is no executor, administrator, fiduciary or custodian  
17 appointed, qualified and acting, then any person who is in the actual or constructive possession of  
18 any property includable in the estate of the decedent for [*inheritance*] **estate** tax purposes whether  
19 or not such estate is subject to administration.

20 (5) **"Federal taxable estate" means the taxable estate as determined under subtitle B,**  
21 **chapter 11 of the Internal Revenue Code.**

22 [(5)] (6) "Gross estate" has the meaning given that term in section 2031 of the Internal Revenue

2 [(6) “Nonresident decedent” means an individual who is domiciled outside of Oregon at the time  
3 of death.]

4 (7) “Oregon taxable estate” means the federal taxable estate with the adjustments pro-  
5 vided by ORS 118.010 (3).

6 [(7)] (8) “Passes” includes any case where for the purposes of ORS 118.005 to 118.840 a taxable  
7 transfer takes place or is deemed to take place.

8 [(8)] (9) “Personal representative” means personal representative as defined in ORS 111.005.

9 [(9) “Resident decedent” means an individual who is domiciled in Oregon at the time of death.]

10 [(10) “Transfer” or “transfer of property” means a transfer that is subject to the federal estate tax  
11 imposed under subtitle B, chapter 11 of the Internal Revenue Code.]

12 **SECTION 2.** ORS 118.007 is amended to read:

13 118.007. Any term used in ORS 118.005 to 118.840 has the same meaning as when used in a  
14 comparable context in the laws of the federal Internal Revenue Code relating to federal estate taxes,  
15 unless a different meaning is clearly required or the term is specifically defined in ORS 118.005 to  
16 118.840. Any reference in ORS 118.005 to 118.840 to the Internal Revenue Code means the federal  
17 Internal Revenue Code as amended and in effect on December 31, [2000] **2010**, except where the  
18 Legislative Assembly has specifically provided otherwise.

19 **SECTION 3.** ORS 118.010 is amended to read:

20 118.010. [(1) A tax is imposed upon a transfer of property and any interest therein, within the ju-  
21 risdiction of the state, whether belonging to the inhabitants of this state or not, which passes to or vests  
22 in any person or persons, or any body or bodies politic or corporate, in trust or otherwise, or by reason  
23 whereof any person or body politic or corporate shall become beneficially entitled, in possession or ex-  
24 pectation, to any property or interest therein or income thereof.]

25 [(2) The tax imposed under this section shall equal the maximum amount of the state death tax  
26 credit allowable against the federal estate tax under section 2011 of the Internal Revenue Code.]

27 (1) **As used in this section:**

28 (a) “Nonresident decedent” means an individual who is domiciled outside of Oregon on  
29 the date the individual dies.

30 (b) “Resident decedent” means an individual who is domiciled in Oregon on the date the  
31 individual dies.

32 (2) **A tax is imposed upon a transfer of the property of each:**

33 (a) **Resident decedent; and**

34 (b) **Nonresident decedent whose estate includes any interest in:**

35 (A) **Real property located in Oregon; or**

36 (B) **Tangible personal property located in Oregon.**

37 (3) **The Oregon taxable estate to be used for purposes of computing the tax imposed un-  
38 der this section shall be the federal taxable estate:**

39 (a) **Increased by:**

40 (A) **The deduction for state estate, inheritance, legacy or succession taxes allowable un-  
41 der section 2058 of the Internal Revenue Code; and**

42 (B) **If the decedent is a surviving spouse owning the property at death, the value of the  
43 following property unless included in the federal taxable estate:**

44 (i) **Property for which a deduction for Oregon special marital property under ORS 118.016

1 (ii) Property for which a separate Oregon election under section 2056 or 2056A of the

8 (4) The tax imposed under this section shall be calculated by applying the rates in the  
9 following table. If the Oregon taxable estate is at least the amount in column 1, but less than  
10 the amount in column 2, the tax is the amount in column 3, increased by the excess above  
11 the amount in column 1 multiplied by the percentage in column 4:

25 [(3)] (5) In the case of a resident decedent owning *[property outside of the jurisdiction of this state*  
26 *at the time of death]*, **on the date of the decedent's death, real property located outside Oregon**  
27 **or tangible personal property located outside Oregon**, the tax imposed under this section shall  
28 be the amount determined under subsection [(2)] (4) of this section multiplied by a ratio. The nu-  
29 merator of the ratio shall be the sum of the *[appraised]* value of the decedent's real property located  
30 in Oregon, tangible personal property located in Oregon and intangible personal property *[located*  
31 *both in and outside of Oregon]*. **The numerator may not include any intangible personal property**  
32 **subject to a tax imposed, as a result of the death of the decedent, by another state or**  
33 **country.** The denominator of the ratio shall be the total *[appraised]* value of the decedent's gross  
34 estate.

35 [(4)(a)] (6) In the case of a nonresident decedent owning *[property within the jurisdiction of this*  
36 *state at the time of death]*, **on the date of the decedent's death, real property located in Oregon**  
37 **or tangible personal property located in Oregon**, the tax imposed under this section shall be the  
38 amount determined under subsection [(2)] (4) of this section multiplied by a ratio. The numerator  
39 of the ratio shall be the sum of the *[appraised]* value of the decedent's real property located in  
40 Oregon[,] **and** tangible personal property located in Oregon *[and intangible personal property located*  
41 *in Oregon]*. The denominator shall be the total *[appraised]* value of the decedent's gross estate.

42 (b) *Intangible personal property of a nonresident decedent shall not be included in the numerator*  
43 *of the ratio used to determine the tax under this subsection if a similar exemption is made by the laws*  
44 *of the state or country of the decedent's residence in favor of residents of this state.]*

45 [(5) *In the case of decedents dying before January 1, 2003, if federal estate tax credits other than*

1 *the state death tax credit result in no federal estate tax, no tax shall be imposed under this section.]*

2 [(6)] (7) Payment, in whole or in part, of [*inheritance and*] estate taxes from funds of an estate  
3 or trust on any benefit subject to tax under ORS 118.005 to 118.840 is not to be considered [*as*] a  
4 further taxable benefit, when such payment is directed by **the** decedent's will or by a trust agree-  
5 ment.

6 [(7)] (8)(a) If the federal taxable estate is determined by making an election under section [2032  
7 or 2056] **2031(c), 2032, 2032A, 2056 or 2056A** of the Internal Revenue Code or another provision of  
8 the Internal Revenue Code, or if a federal estate tax return is not required under the Internal Re-  
9 venue Code, [*the Department of Revenue may adopt rules providing for a separate election for state*  
10 *inheritance tax purposes.*] **an executor may make separate elections for state estate tax pur-**  
11 **poses under that same provision.**

16 118.013. [(1) *For purposes of computing the tax imposed under ORS 118.010, the taxable estate to*  
17 *be used for computing the maximum amount of the state death tax credit allowable under section 2011*  
18 *of the Internal Revenue Code shall be the taxable estate determined for federal estate tax purposes,*  
19 *reduced by the value on the date of death of the decedent of all Oregon special marital property in the*  
20 *estate.*]

21 **(1) As used in this section and ORS 118.016, "permissible distributee" has the meaning**  
22 **given that term in ORS 130.010.**

23 (2) Oregon special marital property consists of any trust or other property interest, or a portion  
24 of a trust or property interest:

25 (a) In which principal or income may be accumulated or distributed to or for the benefit of only  
26 the surviving spouse of the decedent during the lifetime of the surviving spouse;

27 (b) In which a person may not transfer or exercise a power to appoint any part of the trust or  
28 other property interest to a person other than the surviving spouse during the lifetime of the sur-  
29 viving spouse; and

30 (c) For which the executor of the estate of the decedent has made the election described in ORS  
31 118.016 (1).

32 (3) If a trust or other property interest would qualify as Oregon special marital property under  
33 subsection (2) of this section except that the trust or other property interest allows principal or  
34 income to be distributed to other persons in addition to the surviving spouse, the executor may elect  
35 to set aside a share of the trust or other property interest as a separate share of the trust or  
36 property interest or as a separate trust, which shall qualify as Oregon special marital property if:

37 (a) The executor makes the election described in ORS 118.016 (1);

38 (b) Each [*beneficiary who is living at the time the election is made and who may be entitled to a*  
39 *distribution from the share during the lifetime of the surviving spouse*] **permissible distributee** makes  
40 the election described in ORS 118.016 (2);

41 (c) The surviving spouse makes the election described in ORS 118.016 (2); and

42 (d) All [*elections*] **statements of election** are attached to the [*inheritance*] **estate** tax return  
43 filed with respect to the estate of the decedent, or are filed or maintained as records as otherwise  
44 prescribed by the Department of Revenue by rule.

45 **SECTION 5.** ORS 118.016 is amended to read:

1 118.016. (1) The executor of an estate containing property that the executor seeks to qualify as  
2 Oregon special marital property under ORS 118.013 shall make an election under this subsection in  
3 order for the property to be Oregon special marital property. The election shall be made:

4 (a) By attaching a statement to the [*inheritance*] **estate** tax return for the estate of the decedent  
5 that identifies the trust or other property interest that constitutes Oregon special marital property  
6 and that affirms that the identified property meets the requirements of Oregon special marital  
7 property under ORS 118.013 and will be administered as required under ORS 118.013; or

8 (b) In such other manner as the Department of Revenue prescribes by rule.

9 (2) For a trust or other property interest described in ORS 118.013 (3), in order for any portion  
10 of the trust or other property interest to be Oregon special marital property, in addition to the  
11 election of the executor described in subsection (1) of this section, the surviving spouse and each  
12 [*beneficiary who is living at the time of the election and*] **permissible distributee** who may be eligible  
13 for a distribution from the trust or other property interest [*during the lifetime of the surviving*  
14 *spouse*] shall make an election and **provide** written consent that is in substantially the following  
15 form:

19 (3) Elections made under this section are irrevocable.

20 (4) The custodial parent or court appointed guardian of a [*minor beneficiary*] **permissible**  
21 **distributee who is a minor, or any person who is authorized under ORS 130.110**, may sign the  
22 election on behalf of the [*minor beneficiary*] **permissible distributee** and the unborn lineal de-  
23 scendants of the [*minor beneficiary*] **permissible distributee**.

24 **SECTION 6.** ORS 118.100 is amended to read:

25 118.100. (1) The tax provided for in ORS 118.010 shall **take effect at and accrue upon the**  
26 **death of the decedent. A return shall be filed and the tax shall** be paid to the Department of  
27 Revenue on the date the federal estate tax is payable **or, if no federal estate tax return is re-**  
28 **quired, no later than nine months following the date of death of the decedent.** If [*interest is*  
29 *paid on federal estate tax installments resulting in a reduction of the federal estate tax, and*] the de-  
30 partment determines, pursuant to an amended return or refund claim, that the amount of tax im-  
31 posed by ORS 118.010 is less than the amount theretofore paid, the excess tax shall be refunded by  
32 the department with interest at the rate established by ORS 305.220 for each month or fraction  
33 thereof during a period beginning **45 days after the due date of the return or** on the date the  
34 amended return or refund claim is filed, **whichever is later, and ending at [to]** the time the refund  
35 is made.

36 (2) If the amount of federal estate tax reported on a [*United States*] **federal** estate tax return is  
37 changed or corrected by the Internal Revenue Service or other competent authority, resulting in a  
38 change in the [*maximum state death tax credit allowable under the federal estate tax law*] **Oregon**  
39 **taxable estate**, the executor shall report the change or correction in federal estate tax to the de-  
40 partment. If the federal change or correction results in a reduction of the [*allowable state death tax*  
41 *credit*] **Oregon taxable estate**, the report of the change or correction shall be treated by the de-  
42 partment as a claim for refund pursuant to ORS 305.270 and, notwithstanding the limitations of ORS  
43 305.270, shall be deemed timely if filed with the department within two years after the federal cor-  
44 rection was made. If the change or correction results in an increase in the [*state death tax credit*  
45 *allowable on the federal estate tax return*] **Oregon taxable estate**, the department may issue a notice

1 of deficiency within two years after the federal change or correction was made or within two years  
2 after receiving a report of the federal change or correction, whichever is the later. Any executor  
3 filing an amended federal estate tax return shall also file an amended return with the department  
4 within 90 days thereafter.

5 (3)(a) In the case of an estate that contains property that is valued under section 2032A of the  
6 Internal Revenue Code for federal estate tax purposes (relating to the valuation of certain farm or  
7 other property) and that ceases to qualify for valuation under section 2032A, an additional tax under  
8 ORS 118.005 to 118.840 shall be imposed[. *The additional tax shall equal the amount of any increase*  
9 *in the state death tax credit allowable under section 2011 of the Internal Revenue Code that is*] **in the**  
10 **amount** attributable to the change in the value of the estate resulting from the imposition of addi-  
11 tional federal estate tax under section 2032A.

12 (b) The department shall be notified of the disqualification of the property from valuation under  
13 section 2032A in the same time and manner as the federal Internal Revenue Service is notified of  
14 the disqualification.

15 (c) The period for assessment of the tax imposed under this subsection, including any penalty  
16 or interest, shall be two years from the date on which the department receives the notice described  
17 in paragraph (b) of this subsection.

18 (d) The other provisions of ORS 118.005 to 118.840 and ORS chapter 305 shall apply to the ad-  
19 ditional tax imposed under this subsection in the same manner in which those provisions apply to  
20 the tax imposed under ORS 118.010.

21 (4) For purposes of this section, a change or correction of a [*United States*] **federal** estate tax  
22 return is deemed to be made on the date of the federal audit report.

23 (5) The executor shall, upon request of the department, supply a copy of the [*United States*]  
24 **federal** estate tax return which the executor has filed or may file with the federal government, or  
25 a copy of any federal agent's report upon any audit or adjustment of the [*United States*] **federal**  
26 estate tax return.

27 **(6) The executor shall explain, on the return, how the reported values were determined**  
28 **and attach copies of any appraisals.**

30 118.140. [(1) *As used in this section, "natural resource property" means real property as defined*  
31 *in ORS 307.010 that at the decedent's death.*]

32 [(a) *Is in farm use, as defined in ORS 308A.056, or is used as one or more farm use homesites,*  
33 *as defined in ORS 308A.250, related to that real property; or]*

34 [(b) *Is used as forestland, as defined in ORS 321.201, or is used as one or more forestland*  
35 *homesites, as defined in ORS 308A.250, related to that real property, not to exceed 5,000 acres.*]

36 [(2)(a) *A credit against the taxes otherwise due under ORS 118.005 to 118.840 shall be allowed*  
37 *based upon the value of the following property:*]

38 [(A) *Natural resource property.*]

39 [(B) *If the decedent or a person described in subsection (3)(c) of this section was licensed under*  
40 *ORS chapter 508, property that is:*]

41 [(i) *Used in the conduct of a fishing business as defined in section 1301(b)(4) of the Internal Re-*  
42 *venue Code, including boats, gear, equipment, vessel licenses and permits and commercial fishing li-*

 3 *forestry purposes, including:]*

4 *[(i) Timber, trees and improvements;]*

5 *[(ii) Crops, both growing and stored; and]*

6 *[(iii) Forestry and farming equipment.]*

7 *[(D) Working capital of a farm, natural resource-based business or fishing business owned by the*  
 8 *decedent at the decedent's death.]*

9 *[(b) A taxpayer may:]*

10 *[(A) Elect not to claim the credit allowed under this section;]*

11 *[(B) Elect to claim less than the full amount of the credit allowed under this section; or]*

12 *[(C) Elect to claim the credit only for the value of certain assets.]*

13 *[(c) If the value of property for which the credit allowed under this section is claimed is at least*  
 14 *the amount in column 1, but less than the amount in column 2, the credit is the amount in column 3,*  
 15 *increased by the excess above the amount in column 1 multiplied by the percentage in column 4:]*

**(1) As used in this section:**

**(a) “Adjusted gross estate” means the value of the gross estate reduced by the sum of the amounts allowable under sections 2053 and 2054 of the Internal Revenue Code.**

**(b) “Family member” means a member of the family, as defined in section 2032A of the Internal Revenue Code, of the decedent.**

**(c) “Farm business” means a business operated for the primary purpose of obtaining a profit in money by:**

- (A) Raising, harvesting or selling fruit or crops;**
- (B) Feeding, breeding, managing or selling livestock, poultry, fur-bearing animals or bees, or the produce thereof;**
- (C) Dairying and selling dairy products;**
- (D) Breeding, stabling or training equines;**
- (E) Propagating, cultivating, maintaining or harvesting aquatic species, birds or animal species to the extent allowed by the rules adopted by the State Fish and Wildlife Commission;**
- (F) Raising nursery stock;**
- (G) Practicing animal husbandry; or**
- (H) Raising other agricultural or horticultural products.**

**(d) “Farm use” has the meaning given that term in ORS 308A.056.**

**(e) “Fishing business” has the meaning given that term in section 1301(b)(4) of the Internal Revenue Code.**

**(f) “Forestland” has the meaning given that term in ORS 321.201.**

**(g) “Forestry business” means a business operated for the primary purpose of obtaining a profit in money by the planting, cultivating, caring for, preparing, harvesting or cutting of timber or trees for market.**

**(h) “Homesite” has the meaning given that term in ORS 308A.250.**

**(i) “Natural resource property” means the following property, if on the date of the decedent’s death the property is owned by the decedent and used in the operation of a farm business, forestry business or fishing business owned by the decedent:**

- (A) Real property used as forestland or as forestland homesites, not to exceed 5,000 acres, or that is in farm use.**
- (B) Timber or trees.**
- (C) Crops, fruit or other horticultural products, both growing and stored.**
- (D) Forestry business or farm business equipment.**
- (E) Livestock, poultry, fur-bearing animals, bees, dairying animals, equines, aquatic species, birds or other animal species, including stored products or by-products.**
- (F) Nursery stock as defined in ORS 571.005.**
- (G) Boats, gear, equipment, vessel licenses or permits, commercial fishing licenses or permits and other real or personal property used in the operation of a fishing business.**
- (H) Real or personal property used to process and sell the catch of a fishing business in fresh, canned or smoked form directly to consumers, including a restaurant with seating capacity of fewer than 15 seats at which catch from the fishing business is prepared and sold.**
- (I) An operating allowance.**
- (J) Any other tangible and intangible personal property used in the operation of a farm**

1 **business, forestry business or fishing business.**

2 (j) **“Operating allowance” means cash or a cash equivalent that is spent, maintained, used**  
3 **or available for the operation of a farm business, forestry business or fishing business and**  
4 **not spent or used for any other purpose.**

5 (k) **“Qualified beneficiary” has the meaning given that term in ORS 130.010.**

6 (L) **“Real property” means real property, as defined in ORS 307.010, that is in this state.**

7 (2)(a) **An estate shall be allowed a credit for the value of natural resource property**  
8 **claimed. Any operating allowance claimed under this section may not exceed the lesser of**  
9 **\$1.5 million or 20 percent of the total value of natural resource property claimed, not in-**  
10 **cluding the operating allowance.**

11 (b) **The credit allowed under this section shall be computed by multiplying the tax that**  
12 **would be payable under this chapter absent the credit by a ratio, the numerator of which is**  
13 **an amount equal to the lesser of the amount of natural resource property claimed under this**  
14 **section or \$6 million, and the denominator of which is an amount equal to the total adjusted**

31 **purposes] or a family member operated a farm business, forestry business or fishing business**  
32 **and the property for which a credit is claimed under this section is part of the business.**

33 (4) **Property that otherwise meets the requirements of this section shall be allowed a credit un-**  
34 **der this section if:**

35 (a) **The property is the subject of a net cash lease to or from the decedent or a [transferee de-**  
36 **scribed in subsection (3)(c) of this section] qualified beneficiary who is a family member; [or]**

37 (b) **The property is held in trust for a [person described in subsection (3)(c) of this section.]**  
38 **qualified beneficiary who is a family member; or**

39 (c) **The property replaces natural resource property, and the replacement property would**  
40 **otherwise meet the definition of natural resource property except that it was acquired after**  
41 **the date of the decedent’s death but before the estate tax return is filed. In order to qualify**  
42 **under this paragraph, real property must be replaced with real property.**

43 (5) **A credit is allowed under this section for the following real property only if the real**  
44 **property was owned by the decedent or a family member during an aggregate period of five**  
45 **out of the eight years ending on the date of the decedent’s death and used in a business de-**

1 **scribed in subsection (3)(d) of this section:**

2 (a) **Real property used as forestland or as forestland homesites, not to exceed 5,000 acres.**

3 (b) **Real property used in farm use.**

4 (6) **A credit is allowed under this section for property used in the operation of a fishing**  
5 **business only if the decedent or a family member, during an aggregate period of five out of**  
6 **the eight years ending on the date of the decedent's death:**

7 (a) **Owned a vessel used in taking food fish or shellfish for commercial purposes as de-**  
8 **defined in ORS 506.006;**

9 (b) **Held a boat license as provided in ORS 508.260;**

10 (c) **Held a commercial fishing license under ORS 508.235; and**

11 (d) **Held one or more restricted fisheries permits as provided in ORS chapter 508 or an**  
12 **equivalent restricted vessel permit system under the laws of another state.**

13 (7) **For the purpose of meeting the requirements of subsection (5) of this section, in de-**  
14 **termining the period of time during which the decedent or a family member owned real**

16 **in an involuntary conversion under section 1033 of the Internal Revenue Code, the period**

20 [(5)] (8) **Property that otherwise meets the requirements of this section and that is owned indi-**

 40 **require tracking of each asset for which the credit has been claimed, with confirmation that**  
 41 **each asset falls into one of the following categories:**

4 118.160. (1) Except as provided in subsection (2) of this section:

5 (a) An inheritance tax return is not required with respect to the estates of decedents [*dying*]  
6 **who die** on or after January 1, 1987, and before January 1, 2003, unless a federal estate tax return  
7 is required to be filed; [*and*]

8 (b) An inheritance tax return is not required with respect to the estates of decedents [*dying*]  
9 **who die** on or after:

10 (A) January 1, 2003, and before January 1, 2004, unless the value of the gross estate is \$700,000  
11 or more;

12 (B) January 1, 2004, and before January 1, 2005, unless the value of the gross estate is \$850,000  
13 or more;

14 (C) January 1, 2005, and before January 1, 2006, unless the value of the gross estate is \$950,000

23 (a) An increase in the taxes due under ORS 118.005 to 118.840, the executor shall file an  
24 amended return accompanied by payment of the additional tax due.

25 (b) A decrease in the taxes due under ORS 118.005 to 118.840, the executor may file an  
26 amended return claiming a refund.

27 (4) If a deficiency is assessed under ORS 118.005 to 118.840, and the deficiency or any  
28 portion thereof is attributable to any retroactive treatment under the amendments to stat-  
29 utes by sections 1 to 15 and 25 of this 2011 Act, any interest or penalty assessed under ORS  
30 chapter 118, 305, 314, 315, 316, 317 or 318 with respect to the deficiency or portion thereof  
31 will not accrue until 60 days after the date provided for the filing of the return.

32 (5) If a refund of the tax imposed under ORS 118.005 to 118.840 is due, and the refund or  
33 any portion thereof is due on account of any retroactive treatment under the amendments  
34 to statutes by sections 1 to 15 and 25 of this 2011 Act, then notwithstanding ORS 305.270 or  
35 314.415, the refund or portion thereof shall be paid without interest.

36 **SECTION 30.** ORS 118.009, 118.019, 118.220, 118.240, 118.470, 118.810, 118.820, 118.830,  
37 118.840, 118.855, 118.860, 118.865, 118.870, 118.875 and 118.880 and section 3, chapter 806, Oregon  
38 Laws 2003, are repealed.

44 118.875 and 118.880 and section 3, chapter 806, Oregon Laws 2003, by section 30 of this 2011  
45 Act apply to estates of decedents who die on or after January 1, 2011.



1           **(2) The amendments to ORS 105.645 by section 16 of this 2011 Act apply to estates of**  
2 **decedents who die on or after January 1, 2010.**

3           **SECTION 32.** **This 2011 Act takes effect on the 91st day after the date on which the 2011**  
4 **regular session of the Seventy-sixth Legislative Assembly adjourns sine die.**
