

A-Engrossed House Bill 2600

Ordered by the House April 14

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Codifies Staley settlement agreement pertaining to provision of developmental disability services to eligible adults. Updates terminology.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1. As used in this section and sections 2 and 3 of this 2011 Act:**

9 **(1) "Adult" means an individual who is 18 years of age or older.**

10 **(2) "Community living and inclusion supports" means services that may or may not be**
11 **work-related and includes services designed to develop or maintain the individual's skills in**
12 **the following areas:**

13 **(a) Eating, bathing, dressing, personal hygiene, mobility and other personal needs;**

14 **(b) Self-awareness and self-control, social responsiveness, social amenities, interpersonal**
15 **skills, interpersonal relationships and social connections;**

16 **(c) Community participation, recreation and the ability to use available community ser-**
17 **vices, facilities or businesses;**

18 **(d) Expressive and receptive skills in verbal and nonverbal language, the functional ap-**
19 **plication of acquired reading and writing skills and other communication needs; and**

20 **(e) Planning and preparing meals, budgeting, laundering, housecleaning and other per-**
21 **sonal environmental needs.**

22 **(3) "Comprehensive services" means a package of services, other than support services**
23 **for adults, that is provided by or under the direction of a community developmental disabil-**
24 **ities program and that includes at least one of the following living arrangements licensed or**
25 **regulated by the Department of Human Services:**

26 **(a) Twenty-four-hour residential care, including but not limited to a group home, a foster**
27 **home or a supported living program.**

28 **(b) Assistance provided to maintain an individual in the individual's own home or the**

1 home of the individual's family and that costs more than an amount specified by the de-
2 partment by rule.

3 (4) "Employment services" means services provided to develop or maintain the skills
4 necessary for an individual to obtain and retain employment, including job assessment, job
5 exploration, job development, job training, job coaching, work skills, and ongoing supports.

6 (5) "Environmental accessibility adaptations" means physical modifications to an
7 individual's home that are necessary to ensure the health, welfare and safety of the individ-
8 ual in the home, or that enable the individual to function with greater independence in the
9 home.

10 (6) "Individualized written service plan" means a plan described in ORS 430.210 (1)(a), (b)
11 and (c) that identifies the resources, services and purchases necessary for an individual with
12 a developmental disability to achieve identified personal goals and maximize self-
13 determination.

14 (7) "Person-centered planning" means an informal or formal process for gathering and
15 organizing information that helps an individual to:

16 (a) Enhance self-determination by choosing personal goals and lifestyle preferences;

17 (b) Design strategies and networks of support to achieve personal goals and a preferred
18 lifestyle using individual strengths, relationships and resources; and

19 (c) Identify, use and strengthen naturally occurring opportunities for support in the
20 home and in the community.

21 (8) "Self-determination" means empowering individuals to:

22 (a) Select and plan, together with freely-chosen family members and friends, the support
23 services for adults that are necessary instead of purchasing a predefined program or package
24 of services;

25 (b) Control the expenditure of available financial assistance in order to purchase support
26 services for adults, with the help of a social support network if needed;

27 (c) Live an autonomous life in the community, rich in community affiliations, through
28 formal or informal arrangements of resources and personnel; and

29 (d) Have a valued role in the community through competitive employment, organizational
30 affiliations, personal development and general caring for others in the community, and to
31 be accountable for spending public dollars in ways that are life-enhancing for the individual.

32 (9)(a) "Specialized medical equipment and supplies" means:

33 (A) Devices, aids, controls, supplies or appliances that enable individuals:

34 (i) To increase their ability to perform activities of daily living; or

35 (ii) To perceive, control or communicate with the environment in which they live;

36 (B) Items necessary for life support, including ancillary supplies and equipment necessary
37 to the proper functioning of these items; and

38 (C) Medical equipment not available in the medical assistance program.

39 (b) "Specialized medical equipment and supplies" does not include items that have no di-
40 rect medical or remedial benefit to the individual.

41 (10) "Specialized supports" means treatment, training, consultation or other unique ser-
42 vices that are not available through the medical assistance program but are necessary to
43 achieve the goals identified in the individualized written service plan, or other support ser-
44 vices for adults prescribed by the department by rule.

45 (11) "Support service brokerage" means an entity that contracts with the department to

1 provide or to arrange for support services for adults.

2 (12) "Support services for adults" means the services for adults with developmental dis-
3 abilities provided by a support service brokerage under sections 2 and 3 of this 2011 Act.

4 **SECTION 2.** (1) Support services for adults are intended to meet the needs of adults with
5 developmental disabilities and to prevent or delay their need for comprehensive services. The
6 Department of Human Services shall establish by rule the application and eligibility deter-
7 mination processes for support services for adults.

8 (2) Support services for adults shall be provided through a support service brokerage and
9 pursuant to an individualized written service plan that is developed and reassessed at least
10 annually using a person-centered planning process.

11 (3) The department shall ensure that each individual receiving support services for adults
12 has an active role in choosing the services, activities and purchases that will best meet the
13 individual's needs and preferences and to express those choices verbally, using sign language
14 or by other appropriate methods of communication.

15 (4) The services, activities and purchases available as support services for adults include,
16 but are not limited to:

17 (a) Community living and inclusion supports that facilitate independence and promote
18 community integration by supporting the individual to live as independently as possible;

19 (b) Employment services;

20 (c) Environmental accessibility adaptations;

21 (d) Specialized supports; and

22 (e) Specialized medical equipment and supplies.

23 (5) Support services for adults must complement the existing formal and informal sup-
24 ports, services, activities and purchases available to an adult living in the adult's own home
25 or the home of the adult's family.

26 (6) The department shall ensure that each individual has the opportunity to confirm
27 satisfaction with the support services for adults that the individual receives and to makes
28 changes in the services as necessary.

29 **SECTION 3.** (1) The Department of Human Services shall enter into contracts with sup-
30 port service brokerages to deliver support services for adults in a manner that features re-
31 gional consolidation, administrative efficiency, cost-effectiveness and strong consumer and
32 family oversight.

33 (2) Individuals who receive support services for adults and their family members shall
34 have formal, significant, continuing roles in advising the department and support service
35 brokerages regarding the design, implementation and quality assurance of the support ser-
36 vices for adults delivery system.

37 **SECTION 4.** ORS 427.005 is amended to read:

38 427.005. As used in this chapter:

39 (1) "Adaptive behavior" means the effectiveness or degree with which an individual meets the
40 standards of personal independence and social responsibility expected for age and cultural group.

41 (2) "Care" means:

42 (a) Supportive services, including, but not limited to, provision of room and board;

43 (b) Supervision;

44 (c) Protection; and

45 (d) Assistance in bathing, dressing, grooming, eating, management of money, transportation or

1 recreation.

2 (3) "Community developmental disabilities program director" means the director of an entity
3 that provides services described in ORS 430.630 to persons with [*mental retardation*] **intellectual**
4 **disabilities** or other developmental disabilities.

5 (4) "**Developmental disability**" means **intellectual disability, autism, cerebral palsy,**
6 **epilepsy or other neurological condition diagnosed by a qualified professional that:**

7 (a) **Originates before an individual is 22 years of age, or 18 years of age for an intellectual**
8 **disability;**

9 (b) **Originates in and directly affects the brain and is expected to continue indefinitely;**

10 (c) **Results in a significant impairment in adaptive behavior as measured by a qualified**
11 **professional;**

12 (d) **Is not attributed primarily to other conditions including, but not limited to, a mental**
13 **or emotional disorder, sensory impairment, substance abuse, personality disorder, learning**
14 **disability or attention deficit hyperactivity disorder; and**

15 (e) **Requires training and support similar to that required by an individual with an intel-**
16 **lectual disability.**

17 [*(4) "Developmental period" means the period of time between birth and the 18th birthday.*]

18 (5) "Director of the facility" means the superintendent of a state training center, or the person
19 in charge of care, treatment and training programs at other facilities.

20 (6) "Facility" means a state training center, community hospital, group home, activity center,
21 intermediate care facility, community mental health clinic, or such other facility or program as the
22 Department of Human Services approves to provide necessary services to persons with [*mental re-*
23 *tardation*] **intellectual disabilities or other developmental disabilities.**

24 (7) "Incapacitated" means a person is unable, without assistance, to properly manage or take
25 care of personal affairs or is incapable, without assistance, of self-care.

26 (8) "Independence" means the extent to which persons with [*mental retardation or*] **intellectual**
27 **disabilities or other** developmental disabilities exert control and choice over their own lives.

28 (9) "Integration" means:

29 (a) Use by persons with [*mental retardation or*] **intellectual disabilities or other** developmental
30 disabilities of the same community resources that are used by and available to other persons;

31 (b) Participation by persons with [*mental retardation or*] **intellectual disabilities or other** de-
32 velopmental disabilities in the same community activities in which persons without disabilities par-
33 ticipate, together with regular contact with persons without disabilities; and

34 (c) Residence by persons with **intellectual disabilities or other** developmental disabilities in
35 homes or in home-like settings that are in proximity to community resources, together with regular
36 contact with persons without disabilities in their community.

37 (10)(a) "**Intellectual disability**" means **significantly subaverage general intellectual func-**
38 **tioning, defined as intelligence quotients under 70 as measured by a qualified professional and**
39 **existing concurrently with significant impairment in adaptive behavior, that is manifested**
40 **before the individual reaches 18 years of age.**

41 (b) **An individual with intelligence quotients of 70 through 75 may be considered to have**
42 **an intellectual disability if there is also significant impairment in adaptive behavior, as di-**
43 **agnosed and measured by a qualified professional.**

44 (c) **The impairment in adaptive behavior must be directly related to the intellectual dis-**
45 **ability.**

1 **(d) Intellectual disability is synonymous with mental retardation.**

2 [(10)] (11) "Intellectual functioning" means functioning as assessed by one or more of the indi-
3 vidually administered general intelligence tests developed for the purpose.

4 [(11) "*Mental retardation*" means significantly subaverage general intellectual functioning existing
5 concurrently with deficits in adaptive behavior and manifested during the developmental period. Per-
6 sons of borderline intelligence may be considered to have mental retardation if there is also serious
7 impairment of adaptive behavior. Definitions and classifications shall be consistent with the "*Manual*
8 *on Terminology and Classification in Mental Retardation*" of the American Association on Mental
9 *Deficiency*. Mental retardation is synonymous with mental deficiency.]

10 (12) "Minor" means an unmarried person under 18 years of age.

11 (13) "Physician" means a person licensed by the Oregon Medical Board to practice medicine and
12 surgery.

13 (14) "Productivity" means engagement in income-producing work by a person with [*mental re-*
14 *tardation*] **an intellectual disability** or [*a*] **another** developmental disability which is measured
15 through improvements in income level, employment status or job advancement or engagement by a
16 person with [*mental retardation*] **an intellectual disability** or [*a*] **another** developmental disability
17 in work contributing to a household or community.

18 (15) "Resident" means a person admitted to a state training center either voluntarily or after
19 commitment to the department.

20 (16) "Significantly subaverage" means a score on a test of intellectual functioning that is two
21 or more standard deviations below the mean for the test.

22 (17) "State training center" means [*Eastern Oregon Training Center and any other*] **a** facility
23 operated by the department for the care, treatment and training of persons with [*mental*
24 *retardation*] **intellectual disabilities or other developmental disabilities**.

25 (18) "Training" means:

26 (a) The systematic, planned maintenance, development or enhancement of self-care, social or
27 independent living skills; or

28 (b) The planned sequence of systematic interactions, activities, structured learning situations
29 or education designed to meet each resident's specified needs in the areas of physical, emotional,
30 intellectual and social growth.

31 (19) "Treatment" means the provision of specific physical, mental, social interventions and
32 therapies which halt, control or reverse processes that cause, aggravate or complicate malfunctions
33 or dysfunctions.

34 **SECTION 5.** ORS 427.007 is amended to read:

35 427.007. (1) The Legislative Assembly finds and declares that a significant number of persons
36 with [*mental retardation*] **intellectual disabilities** or other developmental disabilities currently re-
37 side in state-operated hospitals and training centers or lack needed services simply because appro-
38 priate community-based services, including residential facilities, day programs, home care and other
39 support, care and training programs, do not exist. The Legislative Assembly further finds that
40 families are the major providers of support, care, training and other services to their members with
41 [*mental retardation*] **intellectual disabilities** or other developmental disabilities who live at home,
42 and many of these families experience exceptionally high financial outlays and extraordinary phys-
43 ical and emotional challenges due to the unavailability of appropriate family support services. Such
44 services pertain to the needs of the person with a disability, the needs of other family members re-
45 lated to their care-giving and nurturing capacity, and specialized needs for environmental accom-

1 modulation to reduce dependency of the family member with [*mental retardation*] **an intellectual**
 2 **disability** or another developmental disability. Therefore, the Department of Human Services is di-
 3 rected to facilitate the development of appropriate community-based services, including family sup-
 4 port, residential facilities, day programs, home care and other necessary support, care and training
 5 programs, in an orderly and systematic manner. The role of state-operated hospitals and training
 6 centers in Oregon shall be as specialized back-up facilities to a primary system of community-based
 7 services for persons with [*mental retardation*] **intellectual disabilities** or other developmental disa-
 8 bilities.

9 (2) In carrying out the directive in subsection (1) of this section, the department shall develop
 10 a biennial plan in conjunction with the budgeting process for review by each Legislative Assembly.
 11 In developing this plan, the department shall meet with and consider the input of representatives
 12 from the following constituencies: Consumer organizations, parent-family organizations, advocacy
 13 organizations, unions representing workers in state-operated hospitals and training centers, commu-
 14 nity provider organizations, state and local education officials and community mental health de-
 15 partments or programs. Such plans shall include, where appropriate:

16 (a) Proposals for the decrease in the number of persons with [*mental retardation*] **intellectual**
 17 **disabilities** or other developmental disabilities to be served in state-operated hospitals and training
 18 centers at a steady and planned rate until such time that the Legislative Assembly shall determine
 19 that each person served in programs or facilities operated or supported by the department is being
 20 served according to the best contemporary professional practices in the least restrictive environ-
 21 ment, with preference given to the community-based setting over the institutional. However, no
 22 person shall be moved from any facility until a comprehensive assessment of the person's medical,
 23 treatment, training and support service needs has been completed, the move determined to be in the
 24 person's best interest and appropriate service alternatives procured.

25 (b) Proposals for the orderly development of community-based services, including family support,
 26 residential facilities, day programs, home care and other necessary support, care and training pro-
 27 grams, to accommodate persons coming out of state-operated hospitals and training centers and to
 28 serve persons already in the community waiting for services. The proposals shall include services
 29 developed for persons in the community waiting for services that are at least equal in number to
 30 those services developed for those coming out of state-operated hospitals and training centers, and
 31 shall include services for all persons who are leaving the public education system, in order to fur-
 32 ther prevent unnecessary institutionalization of persons with [*mental retardation*] **intellectual disa-**
 33 **bilities** or other developmental disabilities. Funding for these services shall be commensurate with
 34 individual need. These proposals may include provisions for an array of both publicly and privately
 35 operated services and shall include specific implementation plans requiring that new services de-
 36 veloped are designed to significantly increase the independence, productivity and integration into
 37 the community of persons with [*mental retardation or*] **intellectual disabilities or other** develop-
 38 mental disabilities.

39 (c) Proposals for the location of community-based services for persons with [*mental retardation*]
 40 **intellectual disabilities** or other developmental disabilities in proximity to family, friends, support-
 41 ive services and home communities whenever possible.

42 (3) In further carrying out the directive in subsection (1) of this section, the department shall
 43 develop monitoring and evaluation systems which ensure competent management, program quality
 44 and cost-effectiveness of community-based services. Such systems shall include, where appropriate:

45 (a) A comprehensive system of case management which assures an orderly movement of persons

1 with [*mental retardation*] **intellectual disabilities** or other developmental disabilities from state-
 2 operated hospitals and training centers to community-based services, and between community-based
 3 service alternatives, and assures an effective system of service delivery to persons with [*mental re-*
 4 *ardation*] **intellectual disabilities** or other developmental disabilities living in the community,
 5 based on individualized planning and close cooperation with consumers, families and guardians.

6 (b) An annual progress assessment of every person with [*mental retardation*] **an intellectual**
 7 **disability** or another developmental disability served in programs or facilities operated or supported
 8 by the department. This assessment shall measure the degree to which a family with a member with
 9 [*mental retardation*] **an intellectual disability** or another developmental disability demonstrates en-
 10 hanced care-giving and nurturing capacities, and the degree to which the independence, productivity
 11 and integration into the community of each person with [*mental retardation*] **an intellectual disa-**
 12 **bility** or another developmental disability has been increased as a result of receiving such services.
 13 The overall results of these assessments shall annually be aggregated and analyzed for each program
 14 or facility operated or supported by the department, and shall be made available for public in-
 15 spection and review by the Legislative Assembly.

16 (c) The development of specific standards for each component within the array of services, for
 17 persons with [*mental retardation*] **intellectual disabilities** or other developmental disabilities, either
 18 operated or supported by the department and assure the competent management, program quality
 19 and cost-effectiveness of such services.

20 (4) Subject to available funds, the department shall ensure that each family with a member with
 21 [*mental retardation*] **an intellectual disability** or another developmental disability has access to
 22 family support services, and that each person with [*mental retardation*] **an intellectual disability**
 23 or [*a*] **another** developmental disability living in the community, including those leaving the public
 24 education system, has access to community-based services necessary to enable the person to strive
 25 to achieve independence, productivity and integration. Specific services proposed for the person
 26 shall be identified in an individual habilitation plan or in a family support service plan.

27 (5) Subject to available funds, the department shall determine the content of individual habili-
 28 tation plans and family support service plans, and the process whereby such plans are developed and
 29 updated.

30 (6) The department shall establish grievance procedures for mediation of disputes concerning
 31 eligibility for or appropriateness of services in individual cases.

32 **SECTION 6.** ORS 427.010 is amended to read:

33 427.010. (1) Except as otherwise ordered by the Department of Human Services pursuant to ORS
 34 179.325, the Eastern Oregon Training Center in Pendleton, Umatilla County, shall be used for the
 35 care, treatment and training of persons with [*mental retardation*] **intellectual disabilities** who are
 36 assigned to the care of the institution by the department according to procedures defined in ORS
 37 427.185 or who were residents on October 3, 1979.

38 (2) Upon receipt of an application approved by the department or its designee, pursuant to its
 39 rules, a person with [*mental retardation*] **an intellectual disability** may be entitled to admission to
 40 the state training center for emergency, respite or part-time care. Part-time care means presence
 41 of the person at the facility less than 24 hours per day and may include day or night care. Admission
 42 for emergency care or respite care may not exceed 90 days. Admission for part-time care may exceed
 43 90 days. The fee schedule for such care, training and treatment in the training center shall be es-
 44 tablished by the department in the same manner as for other residents. The fees shall be charged
 45 and collected by the department in the same manner as charges are collected under ORS 179.610 to

1 179.770.

2 (3) The superintendent of the training center named in subsection (1) of this section shall be a
3 person the department considers qualified to administer the training center. If the superintendent
4 of the training center is a physician licensed by the Oregon Medical Board, the superintendent shall
5 serve as chief medical officer. If not a physician, the superintendent shall designate a physician to
6 serve as chief medical officer. The designated chief medical officer may be an appointed state em-
7 ployee in the unclassified service, a self-employed contractor or an employee of a public or private
8 entity that contracts with the department to provide chief medical officer services. Unless the des-
9 ignated chief medical officer is specifically appointed as a state employee in the unclassified service,
10 the designated chief medical officer shall not be deemed a state employee for purposes of any state
11 statute, rule or policy.

12 (4)(a) Notwithstanding any other provision of law, the designated chief medical officer may su-
13 pervise physicians who are employed by the training center or who provide services at the training
14 center pursuant to a contract.

15 (b) The designated chief medical officer may delegate all or part of the authority to supervise
16 other physicians at the training center to a physician who is employed by the state, a self-employed
17 contractor or an employee of a public or private entity that contracts with the department to pro-
18 vide physician services.

19 **SECTION 7.** ORS 427.020 is amended to read:

20 427.020. (1) State training centers shall annually review the plan of care for each resident and
21 certify the resident's eligibility and need for continued residential care and training and shall pres-
22 ent each certification with clear and convincing justification for continued residential care and
23 training to the State Training Center Review Board for review and action pursuant to this section.
24 If the board does not approve of the certification or, if the resident objects to continued residential
25 care and training, the resident shall be released pursuant to ORS 427.300 or, if the Department of
26 Human Services considers release not to be in the best interest of the resident, the superintendent
27 of the state training center where the person is a resident shall initiate commitment proceedings
28 pursuant to ORS 427.235 to [427.270, 427.280 and 427.285] **427.290**. The board may require the phys-
29 ical presence of any resident during the review. However, the board shall require the physical
30 presence of each resident at least once every three years of residence in a state training center.

31 (2) The plan of care for each resident shall include, but not be limited to, the following:

32 (a) Current diagnosis;

33 (b) Level of functioning;

34 (c) Current habilitation and health programs in which the resident is participating;

35 (d) Statement as to continued eligibility and continued need for residential care;

36 (e) Statement of long-term and short-term goals for the resident; and

37 (f) Verification that the person has been advised of the facility's statement of rights and the
38 policies governing the immediate living area of the person.

39 (3) The state training center shall notify the resident orally. In addition, the resident, the
40 resident's parent, guardian or person entitled to custody shall be notified by certified mail of the
41 intent to certify the need for the resident's continued commitment. The notification shall include the
42 following:

43 (a) Time, place and location of the hearing of the State Training Center Review Board;

44 (b) Explanation of the possible consequences of the proceedings; and

45 (c) Explanation of the resident's right to appear before the board on the resident's own behalf

1 or to be represented at the proceeding by the resident's parent, guardian, the person entitled to
2 custody or other person, including counsel, of the resident's choosing.

3 (4) In the event the resident, because of severe disability, is unable to receive and acknowledge
4 the communication required by subsection (3) of this section, that fact shall be documented in the
5 resident's record and conveyed to the board.

6 **SECTION 8.** ORS 427.061 is amended to read:

7 427.061. (1) If any [*mentally retarded*] person **with an intellectual disability** is admitted to and
8 detained in a state training center under ORS 427.255, the Department of Human Services shall
9 charge to and collect from appropriate persons the costs in the same manner as it would for other
10 residents of the state training center under the provisions of ORS 179.610 to 179.770.

11 (2) If any person is adjudged [*mentally retarded*] **to be in need of commitment for residential**
12 **care, treatment and training** as provided by ORS 427.255, and the person receives care, treatment
13 and training in a state training center, the person, or other persons or agencies legally responsible
14 for the support of the person, may be required to pay the cost of the care of the person at the state
15 training center, as provided by ORS 179.610 to 179.770.

16 **SECTION 9.** ORS 427.104 is amended to read:

17 427.104. The Department of Human Services with funds appropriated for that purpose by the
18 legislature, shall establish and operate a Developmental Disability Diagnosis and Evaluation Service
19 for people with [*mental retardation or*] **intellectual disabilities or other** developmental disabilities.
20 The Developmental Disability Diagnosis and Evaluation Service shall provide all or part of diag-
21 nostic evaluations, as defined in ORS 427.105, when complete evaluations are not available through
22 community developmental disabilities programs, and the Developmental Disability Diagnosis and
23 Evaluation Service shall:

24 (1) Provide consultation and training to community developmental disabilities programs in the
25 development of local diagnosis and evaluation services;

26 (2) Develop and periodically revise department standards and procedures for diagnosis and
27 evaluation services;

28 (3) Coordinate diagnostic evaluations statewide to minimize duplication of tests and examina-
29 tions;

30 (4) Approve applications for admission to [*the*] **a state** training center;

36 (7) Process and coordinate all placements of residents from [*the*] state training [*center*]
37 **centers.**

38 **SECTION 10.** ORS 427.180 is amended to read:

39 427.180. (1) A person shall be admitted to a state training center only after:

40 (a) The person has either been committed to the Department of Human Services as a [*mentally*
41 *retarded*] person **with an intellectual disability** under ORS 427.290, or an application for admission
42 has been filed either by the person or by another in the manner set forth in ORS 427.185;

43 (b) The person has undergone a diagnostic evaluation as defined in ORS 427.105 and the com-
44 pleted evaluation has been provided to the Developmental Disability Diagnosis and Evaluation Ser-
45 vice established under ORS 427.104; and

1 (c) Either the Developmental Disability Diagnosis and Evaluation Service or, upon appeal, the

15 427.205. (1) The Director of Human Services shall appoint a State Training Center Review Board

45 427.215. [*As used in*] **For the purposes of** ORS 427.061 and 427.235 to 427.290, [*unless the context*

1 *requires otherwise, “mentally retarded person” applies only to a person who, because of mental retar-*
2 *ation, is or is alleged to be] a person with an intellectual disability is in need of commitment*
3 **for residential care, treatment and training if the person is** either:

4 (1) Dangerous to self or others; or

5 (2) Unable to provide for **the person’s** basic personal needs and not receiving care as is nec-
6 essary for the health, safety or habilitation of the person.

8 427.235. (1) Any two persons may notify the [*judge of the*] court having probate jurisdiction for
9 the county or the circuit court, if it is not the probate court but its jurisdiction has been extended
10 to include commitment of [*the mentally retarded*] **a person with an intellectual disability** under
11 ORS 3.275, that a person within the county [*is a mentally retarded person*] **has an intellec-**
12 **disability and is** in need of commitment for residential care, treatment and training. Such notice shall

14 facts sufficient to show the need for investigation. The circuit court shall forward notice to the

7 (9) "Protective services" means a service to be provided by the department directly or through
8 type B area agencies, in response to the need for protection from harm or neglect to elderly persons
9 and persons with disabilities.

10 (10) "Title XIX" means long term care and health services programs in Title XIX of the Social
11 Security Act available to elderly persons and persons with disabilities.

12 (11) "Type A area agency" means an area agency:

13 (a) For which either the local government or the area agency board does not agree to accept
14 local administrative responsibility for Title XIX; and

15 (b) That provides a service to elderly persons.

16 (12) "Type B area agency" means an area agency:

17 (a) For which the local government agrees to accept local administrative responsibility for Title
18 XIX;

19 (b) That provides a service to elderly persons or to elderly persons and persons with disabilities
20 who require services similar to those required by elderly persons; and

21 (c) That uses the term "disabled services" or "disability services" in its title to communicate the
22 fact that it provides services to both populations described in paragraph (b) of this subsection.

24 410.060. (1) It is the policy of the State of Oregon that persons with disabilities served by the
25 Department of Human Services shall also receive necessary services, as appropriate for their needs,
26 from other state agencies.

28 Services shall negotiate interagency agreements and coordinate services with the Employment De-
29 partment and the Department of Education for the provision of appropriate services to clients of the

2 (a) The individual is incapable of providing consent for the release of information;

11 person who has been so convicted is eligible under this subsection following the expiration of seven
12 years after the date of final and unconditional discharge from all imprisonment, probation and parole
13 resulting from the conviction.

14 (b) The person has not been convicted, or found guilty except for insanity under ORS 161.295,
15 of, and is not under indictment for, any felony.

16 (c) The person is not a fugitive from justice, has no outstanding warrants for arrest and is not
17 free on any form of pretrial release for any offenses listed in paragraphs (a) and (b) of this sub-
18 section.

19 (d) The person has not been determined to be mentally ill under ORS 426.130 and 430.397 to
20 430.401 or [*mentally retarded*] **to have an intellectual disability** under ORS 427.290. A person who
21 previously has been so determined is eligible under this subsection if, at the time of application for
22 such a certificate, the person produces a certified copy of a full discharge from the proper state
23 hospital. The Oregon Health Authority shall provide the State Fire Marshal with direct electronic
24 access to the authority's database of information identifying persons meeting the criteria of this

17 (a) Patients or residents of the following facilities or programs who, due to age, infirmity or

20 (B) Adult foster homes as defined in ORS 443.705;

21 (C) Residential care facilities as defined in ORS 443.400;

22 (D) Adult congregate living facilities as defined in ORS 441.525;

23 (E) Mental health residential programs administered by the Oregon Health Authority;

24 (F) Facilities for mentally ill persons, as those terms are defined in ORS 426.005;

25 (G) Facilities for persons with [*mental retardation*] **developmental disabilities**, as those terms
26 are defined in ORS 427.005;

27 (H) Local correctional facilities and juvenile detention facilities as those terms are defined in
28 ORS 169.005, regional correctional facilities as defined in ORS 169.620, youth correction facilities
