

HOUSE AMENDMENTS TO HOUSE BILL 2600

1 On page 1 of the printed bill, delete line 31.

2 On page 2, delete lines 1 and 2.

3 In line 3, delete “(5)” and insert “(4)”.

4 In line 6, delete “(6)” and insert “(5)”.

5 In line 10, delete “(7)” and insert “(6)”.

6 In line 14, delete “(8)” and insert “(7)”.

7 In line 21, delete “(9)” and insert “(8)”.

8 In line 32, delete “(10)(a)” and insert “(9)(a)”.

9 In line 41, delete “(11)” and insert “(10)”.

10 In line 45, delete “(12)” and insert “(11)”.

11 On page 3, line 2, delete “(13)” and insert “(12)”.

12 Delete lines 4 through 33 and insert:

13 **“SECTION 2. (1) Support services for adults are intended to meet the needs of adults**
14 **with developmental disabilities and to prevent or delay their need for comprehensive ser-**
15 **vices. The Department of Human Services shall establish by rule the application and eligi-**
16 **bility determination processes for support services for adults.**

17 **“(2) Support services for adults shall be provided through a support service brokerage**
18 **and pursuant to an individualized written service plan that is developed and reassessed at**
19 **least annually using a person-centered planning process.**

20 **“(3) The department shall ensure that each individual receiving support services for**
21 **adults has an active role in choosing the services, activities and purchases that will best**
22 **meet the individual’s needs and preferences and to express those choices verbally, using sign**
23 **language or by other appropriate methods of communication.**

24 **“(4) The services, activities and purchases available as support services for adults in-**
25 **clude, but are not limited to:**

26 **“(a) Community living and inclusion supports that facilitate independence and promote**
27 **community integration by supporting the individual to live as independently as possible;**

28 **“(b) Employment services;**

29 **“(c) Environmental accessibility adaptations;**

30 **“(d) Specialized supports; and**

31 **“(e) Specialized medical equipment and supplies.**

32 **“(5) Support services for adults must complement the existing formal and informal sup-**
33 **ports, services, activities and purchases available to an adult living in the adult’s own home**
34 **or the home of the adult’s family.**

35 **“(6) The department shall ensure that each individual has the opportunity to confirm**

1 **satisfaction with the support services for adults that the individual receives and to makes**
2 **changes in the services as necessary.”.**

3 Delete lines 38 through 42.

4 In line 43, delete “(3)” and insert “(2)”.

5 On page 4, line 19, after “(b)” insert “Originates in and”.

6 In line 21, delete “and”.

7 In line 22, after “to” insert “other conditions including, but not limited to,”.

8 In line 24, delete the period and insert “; and

9 “(e) Requires training and support similar to that required by an individual with an intellectual
10 disability.”.

11 In line 45, after “(10)” insert “(a)”.

12 On page 5, delete lines 1 through 3 and insert “tioning, defined as intelligence quotients under
13 70 as measured by a qualified professional and existing concurrently with significant impairment in
14 adaptive behavior, that is manifested before the individual reaches 18 years of age.

15 “(b) An individual with intelligence quotients of 70 through 75 may be considered to have an
16 intellectual disability if there is also significant impairment in adaptive behavior, as diagnosed and
17 measured by a qualified professional.

18 “(c) The impairment in adaptive behavior must be directly related to the intellectual disability.
