

HOUSE AMENDMENTS TO HOUSE BILL 2634

- 1 On page 1 of the printed bill, line 12, delete “8” and insert “9”.
- 2 On page 2, line 10, delete “8” and insert “9”.
- 3 In line 42, after “Act” insert a period and delete the rest of the line and line 43.
- 4 On page 3, after line 4, insert:
- 5 “(3) If a person contributes to the commission an aggregate total of more than \$100 in a calen-
- 6 dar year, not later than 14 calendar days after the commission receives the contribution, the com-
- 7 mission shall make available to the public on the Internet:
- 8 “(a) The name and address of the person or entity who made the contribution; and
- 9 “(b) The amount of the contribution.”
- 10 In line 5, delete “(3)” and insert “(4)”.
- 11 In line 7, delete “(4)” and insert “(5)”.
- 12 In line 37, after “shall” insert “, from moneys in the Citizens’ Initiative Review Fund”.
- 13 In line 41, delete “and”.
- 14 Delete lines 42 and 43 and insert:
- 15 “(c) Provide for costs required to convene and conduct a citizen panel; and
- 16 “(d) Transfer to the Secretary of State all moneys necessary to pay the costs of printing any
- 17 statements described in section 7 of this 2011 Act in the voters’ pamphlet.”
- 18 On page 4, line 5, delete “select” and insert “designate”.
- 19 In line 6, delete “select” and insert “designate”.
- 20 After line 8, insert:
- 21 “(d) The commission shall designate two persons who oppose the measure to provide information
- 22 in opposition to the measure.”
- 23 In line 9, delete “(d)” and insert “(e)”.
- 24 On page 5, after line 2, insert:
- 25 “(2)(a) Before a statement is filed with the Secretary of State under subsection (1) of this sec-
- 26 tion:
- 27 “(A) A person designated under section 5 (6)(c) of this 2011 Act shall be allowed to review the
- 28 statement in favor of the measure by the citizen panel and provide feedback to the panel regarding
- 29 the statement.
- 30 “(B) A person designated under section 5 (6)(d) of this 2011 Act shall be allowed to review the
- 31 statement opposed to the measure by the citizen panel and provide feedback to the panel regarding
- 32 the statement.
- 33 “(C) A person designated under section 5 (6)(c) or (d) of this 2011 Act shall be allowed to review
- 34 the statement of key findings by the citizen panel and provide feedback to the panel regarding the
- 35 statement.

1 “(b) A citizen panel may adjust any statement after receiving feedback as described in this
2 subsection.”

3 In line 3, delete “(2)” and insert “(3)”.

4 In line 8, delete “(3)” and insert “(4)”.

5 In line 9, delete “8” and insert “9”.

6 In line 20, delete “(4)” and insert “(5)”.

7 In line 26, after “commission” insert “and for expenses under section 5 (5) of this 2011 Act”.

8 After line 26, insert:

9 **“SECTION 9. (1) Not later than the date that is four months before the date of the gen-
10 eral election in an even-numbered year, the Citizens’ Initiative Review Commission shall de-
11 termine whether moneys in sufficient amount are available in the Citizens’ Initiative Review
12 Fund to carry out all the duties, functions and powers of the commission, implement sections
13 5 to 7 of this 2011 Act and pay for any statements to be printed in the voters’ pamphlet under
14 ORS 251.185.**

15 **“(2)(a) If the commission determines that the fund has sufficient moneys under sub-
16 section (1) of this section, the commission shall carry out all the duties, functions and pow-
17 ers of the commission, implement sections 5 to 7 of this 2011 Act and may submit statements
18 to be printed in the voters’ pamphlet under ORS 251.185.**

19 **“(b) If the commission determines that the fund has insufficient moneys under sub-
20 section (1) of this section, for the general election in that even-numbered year, the com-
21 mission may not carry out all the duties, functions and powers of the commission, implement
22 sections 5 to 7 of this 2011 Act or submit statements to be printed in the voters’ pamphlet
23 under ORS 251.185.”.**

24 In line 27, delete “9” and insert “10”.

25 After line 42, insert:

26 **“SECTION 11. (1) Any expenses incurred in the initial appointment and organization of
27 the Citizens’ Initiative Review Commission under section 3 of this 2011 Act shall be paid by
28 the Oregon Department of Administrative Services from moneys appropriated to the de-
29 partment.**

30 **“(2) When the Citizens’ Initiative Review Commission determines that moneys in suffi-
31 cient amount are available in the Citizens’ Initiative Review Fund, the commission shall re-
32 imburse the Oregon Department of Administrative Services, without interest, in an amount
33 equal to the amount paid by the department for expenses under subsection (1) of this
34 section.”.**

35 In line 43, delete “9” and insert “12”.
