

## HOUSE AMENDMENTS TO HOUSE BILL 2667

By COMMITTEE ON JUDICIARY

April 18

1 In line 2 of the printed bill, delete “repealing ORS 5.110” and insert “creating new provisions;  
2 amending ORS 18.075, 21.110, 21.125 and 105.113 and ORCP 7 C; and declaring an emergency”.

3 Delete line 4 and insert:

4 “**SECTION 1.** ORS 18.075 is amended to read:

5 “18.075. (1) A judgment is entered in circuit court when a court administrator notes in the reg-  
6 ister that a judgment document has been filed with the court administrator.

7 “(2) Subject to ORS 18.058 (2), when a judge files a judgment document with the court adminis-  
8 trator, the court administrator shall note in the register:

9 “(a) That the judgment document has been filed and the day, hour and minute that the judgment  
10 is entered.

11 “(b) Whether the judgment is a limited judgment, a general judgment or a supplemental judg-  
12 ment.

13 “(c) Whether the judgment includes a money award.

14 “(d) Whether the judgment creates a judgment lien under ORS 18.150.

15 “(3) If the court administrator notes in the register that a judgment creates a judgment lien, the  
16 court administrator shall note in a judgment lien record maintained by the court administrator:

17 “(a) The name of all judgment debtors.

18 “(b) The name of all judgment creditors.

19 “(c) The amount of the money award.

20 “(d) Whether the money award includes a support award or an award of restitution.

21 “(4) If the court administrator makes a notation of judgment in the judgment lien record, the  
22 court administrator shall thereafter also note in the judgment lien record:

23 “(a) The date on which any appeal is filed.

24 “(b) Whether a supersedeas undertaking, as defined in ORS 19.005, is filed.

25 “(c) The date of any decision on appeal.

26 “(d) Any execution issued by the court and the return on any execution.

27 “(e) Any satisfaction of the judgment, when entered.

28 “(f) Other such information as may be deemed necessary by court order or court rule.

29 “(5) The court administrator shall enter a judgment in the register within 24 hours after the  
30 judgment document is filed with court administrator, excluding Saturdays and legal holidays. If the  
31 court administrator is not able to enter the judgment within the time prescribed in this subsection,  
32 or fails to do so, the court administrator shall enter the judgment as soon as practicable thereafter.

33 “(6) Except as provided in ORS 18.058, [*and in ORCP 69 B(1) for judgments by default,*] the court  
34 administrator shall be subject to the direction of the court in entering judgments in the register.

35 “(7) The court administrator shall not delay entry of judgment under ORCP 68 for taxation of

1 attorney fees or costs and disbursements.

2 “(8) Administrative orders entered in the register under ORS 416.440 have the effect provided  
3 for in that section.

4 “(9) The State Court Administrator shall ensure that the register and the judgment lien record  
5 be established and maintained in a uniform manner in the circuit courts.

6 “(10) References in Oregon Revised Statutes to docketing of a judgment are equivalent to entry  
7 of a judgment as described in subsection (1) of this section.

8 “(11) This section does not apply to justice courts, municipal courts or county courts performing  
9 judicial functions.

10 “**SECTION 2.** ORS 21.125 is amended to read:

11 “21.125. (1) In any action, suit or proceeding subject to a fee under ORS 21.110, or in any civil  
12 appeal or petition subject to a fee under ORS 21.010, the Chief Justice of the Supreme Court may  
13 require that a \$50 fee be paid at the time of filing a motion identified by the Chief Justice as being  
14 subject to a fee under this section. If the Chief Justice has identified a motion as being subject to  
15 a fee under this section, the responding party must file a fee of \$35 upon the filing of a response to  
16 the motion. The Chief Justice by order shall identify motions that are subject to fees under this  
17 section.

18 “(2) The fees provided for in this section may not be collected from the state, a county, a city  
19 or a school district.

20 “(3) The fees provided for in this section may not be collected for motions for judgment by vol-  
21 untary dismissal under ORCP 54 A(1), for motions for judgment by written stipulation under ORCP  
22 67 F or for motions for entry of default judgment under ORCP 69 [B(1)].

23 “(4) The fees provided for in this section may not be collected for motions made to an arbitrator  
24 or mediator in an arbitration or mediation required or offered by a court, or to any motion relating  
25 to an arbitration or mediation required or offered by a court.

26 “(5) The clerk shall file a motion or response that is subject to a fee under this section only if  
27 the fee required by this section is paid when the motion or response is submitted for filing.

28 “**SECTION 3.** ORCP 7 C is amended to read:

29 “C(1) Contents. The summons shall contain:

30 “C(1)(a) Title. The title of the cause, specifying the name of the court in which the complaint  
31 is filed and the names of the parties to the action.

32 “C(1)(b) Direction to defendant. A direction to the defendant requiring defendant to appear and  
33 defend within the time required by subsection (2) of this section and a notification to defendant that  
34 in case of failure to do so, the plaintiff will apply to the court for the relief demanded in the com-  
35 plaint.

36 “C(1)(c) Subscription; post office address. A subscription by the plaintiff or by an active member  
37 of the Oregon State Bar, with the addition of the post office address at which papers in the action  
38 may be served by mail.

39 “C(2) Time for response. If the summons is served by any manner other than publication, the  
40 defendant shall appear and defend within 30 days from the date of service. If the summons is served  
41 by publication pursuant to subsection D(6) of this rule, the defendant shall appear and defend within  
42 30 days from the date stated in the summons. The date so stated in the summons shall be the date  
43 of the first publication.

44 “C(3) Notice to party served.

45 “C(3)(a) In general. All summonses, other than a summons referred to in paragraph (b) or (c) of

1 this subsection, shall contain a notice printed in type size equal to at least 8-point type which may  
2 be substantially in the following form:

26 evicted (the Court can give you a form);

28 • Give a copy of the Answer to your landlord (or your landlord's agent or attorney); and

30 • Pay a filing fee of \$\_\_\_\_\_ (the judge may allow payment to be deferred in certain circum-  
31 stances).

9 "SECTION 5. ORS 21.110, as amended by section 16, chapter 659, Oregon Laws 2009, section  
10 37c, chapter 885, Oregon Laws 2009, and section 29, chapter 107, Oregon Laws 2010, is amended to  
11 read:

12 "21.110. (1) Except as otherwise provided by law, at the time of filing of a complaint or other  
13 pleading or motion in the circuit court for the purpose of commencing an action or other civil pro-  
14 ceeding, the clerk of the circuit court shall collect a fee of \$78 from the party filing the pleading  
15 or motion if the amount claimed or in controversy does not exceed \$10,000, without regard to the  
16 number of parties named in the pleading or motion. The clerk shall collect the same fee for each  
17 answer or other first appearance filed in the action or proceeding.

18 "(2)(a) Except as otherwise provided by law, at the time of filing of a complaint or other plead-  
19 ing or motion in the circuit court for the purpose of commencing an action or other civil proceeding,  
20 the clerk of the circuit court shall collect the following fees:

21 "(A) If the amount claimed or in controversy is more than \$10,000, and less than \$50,000, the  
22 clerk of the circuit court shall collect a fee of \$117 for each named plaintiff, appellant or moving  
23 party. In addition, if more than one defendant or respondent is named the clerk shall collect a fee  
24 of \$117 apiece for the second, third and subsequent defendants or respondents named in the pleading.

25 "(B) If the amount claimed or in controversy is \$50,000 or more, and less than \$150,000, the clerk  
26 of the circuit court shall collect a fee of \$225 for each named plaintiff, appellant or moving party.  
27 In addition, if more than one defendant or respondent is named the clerk shall collect a fee of \$225  
28 apiece for the second, third and subsequent defendants or respondents named in the pleading.

29 "(C) If the amount claimed or in controversy is \$150,000 or more, and less than \$500,000, the  
30 clerk of the circuit court shall collect a fee of \$275 for each named plaintiff, appellant or moving  
31 party. In addition, if more than one defendant or respondent is named the clerk shall collect a fee  
32 of \$275 apiece for the second, third and subsequent defendants or respondents named in the pleading.

33 "(D) If the amount claimed or in controversy is \$500,000 or more, and less than \$1 million, the  
34 clerk of the circuit court shall collect a fee of \$325 for each named plaintiff, appellant or moving  
35 party. In addition, if more than one defendant or respondent is named the clerk shall collect a fee  
36 of \$325 apiece for the second, third and subsequent defendants or respondents named in the pleading.

37 "(E) If the amount claimed or in controversy is \$1 million or more, the clerk of the circuit court  
38 shall collect a fee of \$375 for each named plaintiff, appellant or moving party. In addition, if more  
39 than one defendant or respondent is named the clerk shall collect a fee of \$375 apiece for the sec-  
40 ond, third and subsequent defendants or respondents named in the pleading.

41 "(b) If at any time a plaintiff, appellant or moving party files an amended pleading that names  
42 one or more additional parties to a proceeding subject to a fee under paragraph (a) of this sub-  
43 section, the clerk of the circuit court shall collect an additional fee that is equal to the difference  
44 between the fee that was paid and the fee that would have been collected under paragraph (a) of  
45 this subsection if the party or parties had been named in the original pleading.

1           “(3) Except as otherwise provided by law, at the time of filing in the circuit court of an answer  
2 or other first appearance in a proceeding subject to a fee under subsection (2) of this section, the  
3 clerk shall collect the following fees:

4           “(a) If the amount claimed or in controversy is more than \$10,000, and less than \$50,000, the  
5 clerk of the circuit court shall collect a fee of \$117. If a first appearance is filed jointly for more  
6 than one defendant or respondent, the clerk shall collect a fee of \$117 for each of those defendants  
7 or respondents.

8           “(b) If the amount claimed or in controversy is \$50,000 or more, and less than \$150,000, the clerk  
9 of the circuit court shall collect a fee of \$225. If a first appearance is filed jointly for more than one  
10 defendant or respondent, the clerk shall collect a fee of \$225 for each of those defendants or re-  
11 spondents.

12           “(c) If the amount claimed or in controversy is \$150,000 or more, and less than \$500,000, the  
13 clerk of the circuit court shall collect a fee of \$275. If a first appearance is filed jointly for more  
14 than one defendant or respondent, the clerk shall collect a fee of \$275 for each of those defendants  
15 or respondents.

16           “(d) If the amount claimed or in controversy is \$500,000 or more, and less than \$1 million, the  
17 clerk of the circuit court shall collect a fee of \$325. If a first appearance is filed jointly for more  
18 than one defendant or respondent, the clerk shall collect a fee of \$325 for each of those defendants  
19 or respondents.

20           “(e) If the amount claimed or in controversy is \$1 million or more, the clerk of the circuit court  
21 shall collect a fee of \$375. If a first appearance is filed jointly for more than one defendant or re-  
22 spondent, the clerk shall collect a fee of \$375 for each of those defendants or respondents.

23           “(4) The Chief Justice of the Supreme Court by order may provide for exemptions from the fees  
24 established under subsections (2) and (3) of this section if exemptions are needed for the equitable  
25 imposition of those fees.

26           “(5) The clerk of the court shall collect the sum of \$300 as a flat and uniform filing fee from the  
27 petitioner in a proceeding under ORS 181.823 or 181.826, at the time the petition is filed. Fees  
28 collected under this subsection shall be deposited into the Judicial Department Operating Account  
29 established in ORS 1.009.

30           “(6)(a) Except as otherwise provided by law, at the time of filing in the circuit court of a com-  
31 plaint or other pleading or motion for the purpose of commencing an action or other civil proceed-  
32 ing, including an appeal, that is not subject to a fee under subsections (1) to (5) of this section, the  
33 clerk of the circuit court shall collect a fee of \$117 for each named plaintiff, appellant or moving  
34 party. In addition, if more than one defendant or respondent is named the clerk shall collect a fee  
35 of \$117 apiece for the second, third and subsequent defendants or respondents named in the pleading.

36           “(b) At the time of filing in the circuit court of an answer or other first appearance in a pro-  
37 ceeding subject to a fee under paragraph (a) of this subsection, the clerk shall collect a fee of \$117.  
38 If a first appearance is filed jointly for more than one defendant or respondent, the clerk shall col-  
39 lect a fee of \$117 for each of those defendants or respondents.

40           **“(c) The provisions of subsections (1) to (5) of this section, and of paragraphs (a) and (b)**  
41 **of this subsection, do not apply to a declaratory judgment action. At the time of filing in the**  
42 **circuit court of a complaint or other pleading for the purpose of commencing a declaratory**  
43 **judgment action, the clerk of the circuit court shall collect a filing fee of \$117 from the**  
44 **plaintiff. At the time of filing in the circuit court of an answer or other first appearance in**  
45 **the proceeding, the clerk shall collect a filing fee of \$117.**

1 “(7) For purposes of this section, the amount claimed or in controversy does not include any  
2 amount claimed as costs and disbursements or attorney fees as defined by ORCP 68 A.

3 “(8) For purposes of this section, the amount in controversy in an action or other proceeding  
4 includes:

5 “(a) The value of property claimed in actions for the recovery of specific personal property, and  
6 the damages for the detention of the property.

7 “(b) Any penalty or forfeiture provided by statute or arising out of contract.

8 “(c) The amount claimed for a lien on personal property in an action to enforce or foreclose the  
9 lien.

10 “(d) The money, or the value of property, deposited or secured in an interpleader action.

11 “(9) A pleading or other document shall be filed by the clerk only if the fee required under this  
12 section is paid by the person filing the document, or if a request for a fee waiver or deferral is  
13 granted by the court. No part of any such filing fee shall be refunded to any party. The uniform fee  
14 shall cover all services to be performed by the court or clerk in any such action, suit or proceeding,  
15 except where additional fees are specially authorized by law.

16 “(10) Any plaintiff, appellant, moving party, defendant or respondent that files an action or ap-  
17 pearance that is subject to the filing fees established under subsections (1) to (3) of this section must  
18 include in the caption of the pleading a statement of the amount claimed.

19 “(11) The fees imposed by this section do not apply to:

20 “(a) Protective proceedings under ORS chapter 125;

21 “(b) Proceedings for dissolution of marriage, annulment of marriage or separation;

22 “(c) Filiation proceedings under ORS 109.124 to 109.230;

23 “(d) Proceedings to determine custody or support of a child under ORS 109.103;

24 “(e) Probate, adoption or change of name proceedings;

25 “(f) Proceedings involving dwelling units to which ORS chapter 90 applies and for which the fee  
26 is provided by ORS 105.130; or

27 “(g) Any counterclaim, cross-claim or third-party claim filed by a party who has appeared in the  
28 action or proceeding.

29 “(12) The fees described in this section shall not be charged to a district attorney or to the  
30 Division of Child Support of the Department of Justice for the filing of any case, motion, document,  
31 stipulated order, process or other document relating to the provision of support enforcement ser-  
32 vices as described in ORS 25.080.

33 “**SECTION 6.** ORS 21.110, as amended by section 16, chapter 659, Oregon Laws 2009, section  
34 37c, chapter 885, Oregon Laws 2009, and sections 29 and 31, chapter 107, Oregon Laws 2010, is  
35 amended to read:

36 “21.110. (1) Except as otherwise provided in this section, at the time of filing in the circuit court  
37 of any civil action, suit or proceeding, including appeals, the clerk of the circuit court shall collect  
38 from the plaintiff, appellant or moving party the sum of \$107 as a flat and uniform filing fee. In ad-  
39 dition, at the time of filing any appearance in any such action, suit or proceeding by any defendant  
40 or respondent appearing separately, or upon the part of defendants or respondents appearing jointly,  
41 the clerk shall collect from the party or parties the sum of \$107 as a flat and uniform filing fee. **The**  
42 **fee imposed under this subsection applies to declaratory judgment actions.**

43 “(2) In the following actions, the clerk of the circuit court shall collect the sum of \$68 as a flat  
44 and uniform filing fee from the plaintiff, appellant or moving party at the time the action is filed,  
45 and shall collect the sum of \$68 as a flat and uniform filing fee from any defendant or respondent



1 appearing separately, or upon the part of defendants or respondents appearing jointly, at the time  
2 of filing any appearance in the action:

3 “(a) Actions for the recovery of money or damages only when the amount claimed does not ex-  
4 ceed \$10,000.

5 “(b) Actions for the recovery of specific personal property when the value of the property  
6 claimed and the damages for the detention do not exceed \$10,000.

7 “(c) Actions for the recovery of any penalty or forfeiture, whether given by statute or arising  
8 out of contract, not exceeding \$10,000.

9 “(d) Actions to enforce, marshal and foreclose liens upon personal property where the amount  
10 claimed for such liens does not exceed \$10,000.

11 “(e) Actions of interpleader, and in the nature of interpleader, when the amount of money or the  
12 value of the property involved does not exceed \$10,000.

13 “(f) Actions for injunctive relief under ORS chapter 90 when the amount of any damages claimed  
14 does not exceed \$10,000.

15 “(3) The clerk of the court shall collect the sum of \$300 as a flat and uniform filing fee from the  
16 petitioner in a proceeding under ORS 181.823 or 181.826, at the time the petition is filed. Fees  
17 collected under this subsection shall be deposited into the Judicial Department Operating Account  
18 established in ORS 1.009.

19 “(4) For purposes of this section, the amount claimed, value of property, damages or any amount  
20 in controversy does not include any amount claimed as costs and disbursements or attorney fees as  
21 defined by ORCP 68 A.

22 “(5) A pleading or other document shall be filed by the clerk only if the fee required under this  
23 section is paid by the person filing the document, or if a request for a fee waiver or deferral is  
24 granted by the court. No part of any such filing fee shall be refunded to any party. The uniform fee  
25 shall cover all services to be performed by the court or clerk in any such action, suit or proceeding,  
26 except where additional fees are specially authorized by law.

27 “(6) Any plaintiff, appellant, moving party, defendant or respondent that files an action or ap-  
28 pearance that is subject to the filing fees established under subsection (2) of this section must in-  
29 clude in the caption of the pleading the following words: ‘Claim of not more than \$10,000.’

30 “(7) The fees imposed by this section do not apply to:

31 “(a) Protective proceedings under ORS chapter 125;

32 “(b) Proceedings for dissolution of marriage, annulment of marriage or separation;

33 “(c) Filiation proceedings under ORS 109.124 to 109.230;

34 “(d) Proceedings to determine custody or support of a child under ORS 109.103;

35 “(e) Probate, adoption or change of name proceedings;

36 “(f) Proceedings involving dwelling units to which ORS chapter 90 applies and for which the fee  
37 is provided by ORS 105.130; or

38 “(g) Any counterclaim, cross-claim or third-party claim filed by a party who has appeared in the  
39 action or proceeding.

40 “(8) The fees described in this section shall not be charged to a district attorney or to the Di-  
41 vision of Child Support of the Department of Justice for the filing of any case, motion, document,  
42 stipulated order, process or other document relating to the provision of support enforcement ser-  
43 vices as described in ORS 25.080.

44 “**SECTION 7. The amendments to ORS 21.110 by section 5 of this 2011 Act apply to any**  
45 **declaratory judgment action filed on or after January 1, 2011, and before July 1, 2011. Upon**

1 request by any party that paid a filing fee or respondent's fee for a declaratory judgment  
2 action on or after January 1, 2011, and before the effective date of this 2011 Act, the clerk  
3 of the court in which the action was filed shall refund the amount of the filing fee paid by  
4 the party to the extent that the fee exceeds the filing fee under ORS 21.110, as amended by  
5 section 5 of this 2011 Act. A request under this section must be made not later than 60 days  
6 after the effective date of this 2011 Act.

7 SECTION 8. This 2011 Act being necessary for the immediate preservation of the public  
8 peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect  
9 on its passage.”
