**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes process for issuance of warrants by agencies uniform. Authorizes each specified agency to file warrant in County Clerk Lien Record and direct sheriff to act on warrant or to direct authorized agent to act on warrant.

Provides that sheriff's return of service in civil or criminal proceeding is not hearsay for purposes of Oregon Evidence Code.

Takes effect on 91st day following adjournment sine die.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 184.644 is amended to read:

7 184.644. (1) For purposes of this section, a liquidated and delinquent debt is a debt that meets  
8 one of the following conditions:

9 (a) Judgment has been entered on the debt; or

10 (b) Liability for and the amount of the debt have been established through an administrative  
11 proceeding.

12 (2) If a person fails to pay in full any liquidated and delinquent debt due the Department of  
13 Transportation, the department may issue a warrant [*under the department's official seal directed to*  
14 *the sheriff of any county of the state commanding the sheriff to levy upon and sell the real and personal*  
15 *property of the person found within that county,*] for [*payment of*] the amount due, with the added  
16 penalties or charges, interest and cost of executing the warrant[, *and to return the warrant to the*  
17 *department and pay to the department the money collected from the sale by the time specified in the*  
18 *warrant, not less than 60 days from the date of the warrant*]. **A copy of the warrant shall be mailed**  
19 **or delivered to the debtor by the department at the debtor's last-known address.**

20 [*(3) The sheriff shall, within five days after the receipt of the warrant, record with the clerk of the*  
21 *county a copy of the warrant. The clerk shall enter in the County Clerk Lien Record the name of the*  
22 *person mentioned in the warrant, the amount of the debt for which the warrant is issued and the date*  
23 *when the copy is recorded. The amount of the warrant shall become a lien upon the title to and interest*  
24 *in property of the person against whom the warrant is issued in the same manner as a judgment that*  
25 *creates a judgment lien under ORS chapter 18.*]

4 *and collected as a part of the warrant liability.]*

5        *[(5) In the discretion of the Department of Transportation, a warrant of like terms, force and effect*  
6 *to levy upon funds of the person in possession of the Department of Revenue may be issued and di-*  
7 *rected to any agent authorized by the Department of Transportation to collect liquidated and delinquent*  
8 *debts for the department, and in the execution thereof the agent shall have all of the powers conferred*  
9 *by law upon sheriffs but is entitled to no fee or compensation in excess of actual expenses paid in the*  
10 *performance of such duty.]*

11        **(3) At any time after issuing a warrant under this section, the department may record**  
12 **the warrant in the County Clerk Lien Record of any county of this state. Recording of the**  
13 **warrant has the effect described in ORS 205.125. After recording a warrant, the department**  
14 **may direct the sheriff for the county in which the warrant is recorded to levy upon and sell**  
15 **the real and personal property of the debtor found within that county, and to levy upon any**  
16 **currency of the debtor found within that county, for the application of the proceeds or cur-**  
17 **rency against the amount reflected in the warrant and the sheriff's cost of executing the**  
18 **warrant. The sheriff shall proceed on the warrant in the same manner prescribed by law for**  
19 **executions issued against property pursuant to a judgment, and is entitled to the same fees**  
20 **as provided for executions issued against property pursuant to a judgment. The fees of the**  
21 **sheriff shall be added to and collected as a part of the warrant liability.**

22        **(4) In the discretion of the department a warrant under this section may be directed to**  
23 **any agent authorized by the department to collect debts under this section, and in the exe-**  
24 **cution of the warrant the agent has all of the powers conferred by law upon sheriffs, but is**

26 **such duty.**

28        **SECTION 2.** ORS 314.430 is amended to read:

29        314.430. (1) If any tax imposed under ORS chapter 118, 316, 317 or 318 or any portion of the tax  
30 is not paid within 30 days after the date that the written notice and demand for payment required  
31 under ORS 305.895 is mailed (or within five days after the tax becomes due, in the case of the ter-  
32 mination of the tax year by the Department of Revenue under the provisions of ORS 314.440) and  
33 no provision is made to secure the payment thereof by bond, deposit or otherwise, pursuant to reg-  
34 ulations promulgated by the department, the department may issue a warrant *[directed to the sheriff*  
35 *of any county of the state commanding the sheriff to levy upon and sell the real and personal property*  
36 *of the taxpayer found within that county,]* for the payment of the amount of the tax, with the added  
37 penalties, interest[,] **and any** collection charge **incurred.** *[and the sheriff's cost of executing the*

35 *specified in the warrant, not less than 60 days from the date of the warrant*]. **A copy of the warrant**

28 *property of the person found within that county,*] for [*payment of*] the amount of the obligation and  
29 the cost of executing the warrant[, *and to return the warrant to the department and pay to the de-*  
30 *partment the money collected from the sale by the time specified in the warrant, not less than 60 days*  
31 *from the date of the warrant*]. **A copy of the warrant shall be mailed or delivered to the debtor**  
32 **by the department at the debtor's last-known address.**

23 required under ORS 305.895 is mailed, the Department of Revenue shall issue a warrant [*directed to*  
24 *the sheriff of any county of the state commanding the sheriff to levy upon and sell the real and personal*  
25 *property of the person or persons named in the warrant and liable for the tax found within the*  
26 *county,*] for the payment of the amount [*thereof*] **of the tax**, with the added penalty and the cost of  
27 executing the warrant[, *and to return the warrant to the department and pay to it the money collected*  
28 *by virtue thereof by a time to be therein specified not more than 30 days from the date of the*

41 *remedies to enforce the claim for taxes as if the people of the state had recovered judgment for the*  
42 *amount of the tax.*]

44 **the warrant in the County Clerk Lien Record of any county of this state. Recording of the**  
45 **warrant has the effect described in ORS 205.125. After recording a warrant, the department**

17 321.570. (1) If any tax imposed by ORS 321.005 to 321.185, 321.560 to 321.600 or 321.700 to  
18 321.754, or any portion of the tax, is not paid within 30 days after the date that the written notice  
19 and demand for payment required under ORS 305.895 is mailed, the Department of Revenue may is-  
20 sue a warrant[, *directed to the sheriff of any county of the state, commanding the sheriff to levy upon*  
21 *and sell the real and personal property of the taxpayer owning the same, found within that county,*] for  
22 the payment of the amount of the tax, with the added penalties, interest and cost of executing the  
23 warrant[, *and to return the warrant to the department and to pay to it the money collected from the*  
24 *sale, within 60 days after receipt of the warrant*]. A copy of the warrant shall be mailed or delivered  
25 to the taxpayer by the department at the taxpayer's last-known address.

26 [(2) *The sheriff shall, within five days after the receipt of the warrant, record a copy with the*

11 323.390. (1) If any tax imposed by ORS 323.005 to 323.482 or any portion of such tax is not paid  
12 within 30 days after notice of a deficiency determination is given pursuant to ORS 323.403 or of a  
13 tax determined under ORS 323.385, and no provision is made to secure the payment thereof by bond,  
14 deposit or otherwise, pursuant to regulations promulgated by the Department of Revenue, the de-  
15 partment shall:

16 (a) Assess a collection charge of \$5 if the sum of the tax, penalty and interest then due exceeds  
17 \$10.

18 (b) Issue a warrant [*directed to the sheriff of any county of the state commanding the sheriff to levy*  
19 *upon and sell the real and personal property of the taxpayer found within that county,*] for the payment  
20 of the amount of the tax, with the added penalties, interest, collection charge and the sheriff's cost

6 (b) A statement made by a person concerning an act of abuse as defined in ORS 107.705 or  
7 419B.005, a statement made by a person concerning an act of abuse of an elderly person, as those  
8 terms are defined in ORS 124.050, or a statement made by a person concerning a violation of ORS  
9 163.205 or 164.015 in which a person 65 years of age or older is the victim, is not excluded by ORS  
10 40.455 if the declarant either testifies at the proceeding and is subject to cross-examination, or is  
11 unavailable as a witness but was chronologically or mentally under 12 years of age when the  
12 statement was made or was 65 years of age or older when the statement was made. However, if a  
13 declarant is unavailable, the statement may be admitted in evidence only if the proponent estab-  
14 lishes that the time, content and circumstances of the statement provide indicia of reliability, and  
15 in a criminal trial that there is corroborative evidence of the act of abuse and of the alleged  
16 perpetrator's opportunity to participate in the conduct and that the statement possesses indicia of  
17 reliability as is constitutionally required to be admitted. No statement may be admitted under this  
18 paragraph unless the proponent of the statement makes known to the adverse party the proponent's  
19 intention to offer the statement and the particulars of the statement no later than 15 days before  
20 trial, except for good cause shown. For purposes of this paragraph, in addition to those situations  
21 described in ORS 40.465 (1), the declarant shall be considered "unavailable" if the declarant has a  
22 substantial lack of memory of the subject matter of the statement, is presently incompetent to tes-  
23 tify, is unable to communicate about the abuse or sexual conduct because of fear or other similar  
24 reason or is substantially likely, as established by expert testimony, to suffer lasting severe emo-  
25 tional trauma from testifying. Unless otherwise agreed by the parties, the court shall examine the  
26 declarant in chambers and on the record or outside the presence of the jury and on the record. The  
27 examination shall be conducted immediately prior to the commencement of the trial in the presence  
28 of the attorney and the legal guardian or other suitable person as designated by the court. If the  
29 declarant is found to be unavailable, the court shall then determine the admissibility of the evidence.  
30 The determinations shall be appealable under ORS 138.060 (1)(c) or (2)(a). The purpose of the ex-  
31 amination shall be to aid the court in making its findings regarding the availability of the declarant  
32 as a witness and the reliability of the statement of the declarant. In determining whether a state-  
33 ment possesses indicia of reliability under this paragraph, the court may consider, but is not limited  
34 to, the following factors:

35 (A) The personal knowledge of the declarant of the event;

36 (B) The age and maturity of the declarant or extent of disability if the declarant is a person  
37 with a developmental disability;

38 (C) Certainty that the statement was made, including the credibility of the person testifying  
39 about the statement and any motive the person may have to falsify or distort the statement;

40 (D) Any apparent motive the declarant may have to falsify or distort the event, including bias,  
41 corruption or coercion;

42 (E) The timing of the statement of the declarant;

43 (F) Whether more than one person heard the statement;

44 (G) Whether the declarant was suffering pain or distress when making the statement;

45 (H) Whether the declarant's young age or disability makes it unlikely that the declarant fabri-

1 cated a statement that represents a graphic, detailed account beyond the knowledge and experience  
2 of the declarant;

3 (I) Whether the statement has internal consistency or coherence and uses terminology appro-  
4 priate to the declarant's age or to the extent of the declarant's disability if the declarant is a person  
5 with a developmental disability;

6 (J) Whether the statement is spontaneous or directly responsive to questions; and

7 (K) Whether the statement was elicited by leading questions.

8 (c) This subsection applies to all civil, criminal and juvenile proceedings.

9 (d) This subsection applies to a child declarant, a declarant who is an elderly person as defined  
10 in ORS 124.050 or an adult declarant with a developmental disability. For the purposes of this sub-  
11 section, "developmental disability" means any disability attributable to mental retardation, autism,  
12 cerebral palsy, epilepsy or other disabling neurological condition that requires training or support  
13 similar to that required by persons with mental retardation, if either of the following apply:

14 (A) The disability originates before the person attains 22 years of age, or if the disability is at-  
15 tributable to mental retardation the condition is manifested before the person attains 18 years of  
16 age, the disability can be expected to continue indefinitely, and the disability constitutes a sub-  
17 stantial handicap to the ability of the person to function in society.

18 (B) The disability results in a significant subaverage general intellectual functioning with con-  
19 current deficits in adaptive behavior that are manifested during the developmental period.

20 (19) Reputation among members of a person's family by blood, adoption or marriage, or among  
21 a person's associates, or in the community, concerning a person's birth, adoption, marriage, divorce,  
22 death, legitimacy, relationship by blood or adoption or marriage, ancestry, or other similar fact of  
23 a person's personal or family history.

24 (20) Reputation in a community, arising before the controversy, as to boundaries of or customs  
25 affecting lands in the community, and reputation as to events of general history important to the  
26 community or state or nation in which located.

27 (21) Reputation of a person's character among associates of the person or in the community.

28 (22) Evidence of a final judgment, entered after a trial or upon a plea of guilty, but not upon a  
29 plea of no contest, adjudging a person guilty of a crime other than a traffic offense, to prove any  
30 fact essential to sustain the judgment, but not including, when offered by the government in a  
31 criminal prosecution for purposes other than impeachment, judgments against persons other than the  
32 accused. The pendency of an appeal may be shown but does not affect admissibility.

33 (23) Judgments as proof of matters of personal, family or general history, or boundaries, essen-  
34 tial to the judgment, if the same would be provable by evidence of reputation.

35 (24) Notwithstanding the limits contained in subsection (18a) of this section, in any proceeding  
36 in which a child under 12 years of age at the time of trial, or a person with a developmental disa-  
37 bility as described in subsection (18a)(d) of this section, may be called as a witness to testify con-  
38 cerning an act of abuse, as defined in ORS 419B.005, or sexual conduct performed with or on the  
39 child or person with a developmental disability by another, the testimony of the child or person with  
40 a developmental disability taken by contemporaneous examination and cross-examination in another  
41 place under the supervision of the trial judge and communicated to the courtroom by closed-circuit  
42 television or other audiovisual means. Testimony will be allowed as provided in this subsection only  
43 if the court finds that there is a substantial likelihood, established by expert testimony, that the  
44 child or person with a developmental disability will suffer severe emotional or psychological harm  
45 if required to testify in open court. If the court makes such a finding, the court, on motion of a



1 party, the child, the person with a developmental disability or the court in a civil proceeding, or on  
2 motion of the district attorney, the child or the person with a developmental disability in a criminal  
3 or juvenile proceeding, may order that the testimony of the child or the person with a developmental  
4 disability be taken as described in this subsection. Only the judge, the attorneys for the parties, the  
5 parties, individuals necessary to operate the equipment and any individual the court finds would  
6 contribute to the welfare and well-being of the child or person with a developmental disability may  
7 be present during the testimony of the child or person with a developmental disability.

8 (25)(a) Any document containing data prepared or recorded by the Oregon State Police pursuant  
9 to ORS 813.160 (1)(b)(C) or (E), or pursuant to ORS 475.235 (4), if the document is produced by data  
10 retrieval from the Law Enforcement Data System or other computer system maintained and operated  
11 by the Oregon State Police, and the person retrieving the data attests that the information was re-  
12 trieved directly from the system and that the document accurately reflects the data retrieved.

13 (b) Any document containing data prepared or recorded by the Oregon State Police that is  
14 produced by data retrieval from the Law Enforcement Data System or other computer system  
15 maintained and operated by the Oregon State Police and that is electronically transmitted through  
16 public or private computer networks under an electronic signature adopted by the Oregon State  
17 Police if the person receiving the data attests that the document accurately reflects the data re-  
18 ceived.

19 (c) Notwithstanding any statute or rule to the contrary, in any criminal case in which docu-  
20 ments are introduced under the provisions of this subsection, the defendant may subpoena the ana-  
21 lyst, as defined in ORS 475.235 (6), or other person that generated or keeps the original document  
22 for the purpose of testifying at the preliminary hearing and trial of the issue. Except as provided  
23 in ORS 44.550 to 44.566, no charge shall be made to the defendant for the appearance of the analyst  
24 or other person.

25 (26)(a) A statement that purports to narrate, describe, report or explain an incident of domestic  
26 violence, as defined in ORS 135.230, made by a victim of the domestic violence within 24 hours after  
27 the incident occurred, if the statement:

28 (A) Was recorded, either electronically or in writing, or was made to a peace officer as defined  
29 in ORS 161.015, corrections officer, youth correction officer, parole and probation officer, emergency  
30 medical technician or firefighter; and

31 (B) Has sufficient indicia of reliability.

32 (b) In determining whether a statement has sufficient indicia of reliability under paragraph (a)  
33 of this subsection, the court shall consider all circumstances surrounding the statement. The court  
34 may consider, but is not limited to, the following factors in determining whether a statement has  
35 sufficient indicia of reliability:

36 (A) The personal knowledge of the declarant.

37 (B) Whether the statement is corroborated by evidence other than statements that are subject  
38 to admission only pursuant to this subsection.

39 (C) The timing of the statement.

40 (D) Whether the statement was elicited by leading questions.

41 (E) Subsequent statements made by the declarant. Recantation by a declarant is not sufficient  
42 reason for denying admission of a statement under this subsection in the absence of other factors  
43 indicating unreliability.

44 (27) A report prepared by a forensic scientist that contains the results of a presumptive test  
45 conducted by the forensic scientist as described in ORS 475.235, if the forensic scientist attests that

1 the report accurately reflects the results of the presumptive test.

2 (28)(a) A statement not specifically covered by any of the foregoing exceptions but having  
3 equivalent circumstantial guarantees of trustworthiness, if the court determines that:

4 (A) The statement is relevant;

5 (B) The statement is more probative on the point for which it is offered than any other evidence  
6 that the proponent can procure through reasonable efforts; and

7 (C) The general purposes of the Oregon Evidence Code and the interests of justice will best be  
8 served by admission of the statement into evidence.

9 (b) A statement may not be admitted under this subsection unless the proponent of it makes  
10 known to the adverse party the intention to offer the statement and the particulars of it, including  
11 the name and address of the declarant, sufficiently in advance of the trial or hearing, or as soon as  
12 practicable after it becomes apparent that such statement is probative of the issues at hand, to  
13 provide the adverse party with a fair opportunity to prepare to meet it.

14 **SECTION 15. This 2011 Act takes effect on the 91st day after the date on which the 2011**  
15 **regular session of the Seventy-sixth Legislative Assembly adjourns sine die.**
