SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows court to extend time to execute writ for eviction upon showing of good cause by sheriff. **Requires sheriff to notify plaintiff of extension.**

Requires plaintiff requesting warrant directing sheriff to abate nuisance to pay sheriff fees and expenses of executing warrant. Allows recovery of fees and expenses from defendant without entry of supplemental judgment.

2 Relating to sheriffs; amending ORS 18.999, 105.161 and 105.510.

3 Be It Enacted by the People of the State of Oregon:

4 **SECTION 1.** ORS 105.161 is amended to read:

5 105.161. (1) Following issuance of the writ of execution of judgment of restitution and payment

of any fees required by the sheriff, the sheriff shall immediately enforce and serve the writ upon the
 defendant, along with the eviction trespass notice, as follows:

8 (a) The sheriff shall mail a copy of the writ and the eviction trespass notice by first class mail 9 to the defendant at the premises;

10 (b) The sheriff shall serve the writ and the eviction trespass notice at the premises by personal 11 delivery to the defendant or, if the defendant is not available for service, by attaching the writ and 12 notice in a secure manner to the main entrance to that portion of the premises of which the de-13 fendant has possession;

(c) Immediately following the service of the writ and the eviction trespass notice, the sheriff
 shall return possession of the premises to the plaintiff by removing the defendant or any other per son subject to the judgment; and

(d) Following the sheriff's removal of the defendant and return of possession of the premises to
the plaintiff, the plaintiff shall be responsible for removing, storing and disposing of any personal
property left by the defendant on the premises, as provided by ORS 105.165.

20 (2) Following issuance of the writ, at the plaintiff's request, the sheriff shall delay enforcement 21 and service of the writ.

22 [(3) Any writ not enforced and served within 30 days following issuance shall expire and become 23 unenforceable.]

(3) Any writ not enforced and served within 30 days following issuance expires and be comes unenforceable unless the court extends the operation of the writ before the writ expires based on a showing of good cause by the sheriff. If the court extends the operation of

1 a writ under this subsection, the sheriff shall promptly notify the plaintiff of the extension.

2 (4) A judgment may not be enforced if the parties have entered a new rental agreement or if the

3 plaintiff has accepted rent for a period of occupancy beginning after the judgment was entered.

SECTION 2. ORS 105.510 is amended to read:

 $\mathbf{5}$ 105.510. [If the order to abate provided for in ORS 105.505 is made, the clerk shall when requested by the plaintiff within six months after the order is made, issue a warrant directed to the sheriff, re-6 quiring the sheriff forthwith to abate the nuisance at the expense of the defendant and to return the 7 warrant as soon thereafter as possible, with the proceedings of the sheriff indorsed thereon. The ex-8 9 pense of abating the nuisance may be levied by the sheriff on the property of the defendant and in this respect the warrant is to be deemed an execution against property.] Not more than six months after 10 an order to abate is entered under ORS 105.505, the plaintiff may file a request with the clerk 11 12 of court for the issuance of a warrant to the sheriff that directs the sheriff to abate the nuisance. The sheriff may require that the plaintiff pay all sheriff's fees required by ORS 13 21.410 before executing the warrant, and may require that the plaintiff also pay all expenses 14 15 of the sheriff incurred in executing the warrant.

SECTION 3. ORS 18.999 is amended to read:

17 18.999. This section establishes the right of a plaintiff to recover certain moneys the plaintiff 18 has expended to recover a debt under ORS 18.854 or to enforce a judgment and establishes proce-19 dures for that recovery. The following apply to this section:

(1) When a plaintiff receives moneys under a garnishment, attachment or payment, the plaintiff
 may proceed as follows:

(a) Before crediting the total amount of moneys received against the judgment or debt, the
