SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Revises laws relating to court fees.

Establishes Legal Aid Account. Continuously appropriates moneys in account to State Court Administrator for purpose of funding Legal Services Program.

Creates Joint Committee on State Courts Revenue Structure for purpose of conducting review of all court fees and fines.

Eliminates collections and revenue management program.

Declares emergency, effective July 1, 2011.

1 **SECTION 1. Transfers to General Fund.** Except as otherwise provided by law, all amounts
2 collected as fees and charges in the Supreme Court, the Court of Appeals, the Oregon Tax
3 Court and the circuit courts shall be transferred to the State Court Administrator for de-
4 posit in the General Fund.

5 **SECTION 2.** Section 1 of this 2011 Act applies to all fees and charges collected in courts
6 on or after the effective date of this 2011 Act.

7 **SECTION 3. Legislative intent relating to funding certain programs, services and activ-**
8 **ities.** It is the intent of the Legislative Assembly that funding be provided to the following
9 entities by appropriations each biennium to fund programs, services and activities that were
10 funded through court fees before the 2011-2013 biennium:

11 (1) To the counties of this state for the purposes of funding mediation services, concil-
12 iation services and other services in domestic relations cases.

13 (2) To the counties of this state for the purposes of funding the operation of law libraries
14 or of providing law library services.

15 (3) To the Oregon University System to fund the programs and expenses of the Mark O.
16 Hatfield School of Government and the University of Oregon School of Law under ORS 36.100
17 to 36.238 and 183.502.

18 (4) To the Housing and Community Services Department for the purpose of funding pro-
19 grams that defray the cost of rent for dwelling units for very low income households.

20 (5) To the Oregon University System to fund clinical legal education programs at ac-
21 credited institutions of higher education that provide civil legal services to victims of do-
22 mestic violence, stalking or sexual assault.

23 (6) To the State Department of Agriculture for the purpose of funding mediation pro-
24 grams established by the department, other than individual farm credit mediations.

25 (7) To the Judicial Department for the purposes of funding the appellate mediation pro-
26 gram established under ORS 2.560.

27 (8) To the Department of Human Services for the funding of the Office of Children's
28 Advocate.

LEGAL AID

32 **SECTION 3a. Legal Aid Account.** (1) The Legal Aid Account is established in the General
33 Fund of the State Treasury. All moneys in the account are continuously appropriated to the
34 State Court Administrator for the purpose of the distributions required by this section. In-
35 terest earned by the account shall be credited to the General Fund.

36 (2) Each month, the State Court Administrator shall transfer to the Legal Aid Account,
37 from amounts collected by the State Court Administrator as fees and charges in the circuit
38 courts, the amounts necessary to make the distributions required by subsection (3) of this
39 section.

40 (3) Each biennium, the State Court Administrator shall distribute to the Oregon State
41 Bar \$11.9 million from the Legal Aid Account. Distributions under this section shall be made
42 by the State Court Administrator in eight quarterly installments of equal amounts, with the
43 first distribution to be made as soon as possible after July 1, 2011. Amounts distributed to
44 the Oregon State Bar under this subsection may be used only for the funding of the Legal
45 Services Program established under ORS 9.572.

CIRCUIT COURT FILING FEES

(Payment)

SECTION 4. Filing fees payable in advance. A pleading or other document may be filed by the circuit court only if the filing fee required by law is paid by the person filing the document or a request for a fee waiver or deferral is granted by the court. Filing fees are not refundable under any circumstances. Unless otherwise specifically provided by statute, the filing fee for an action or proceeding is the only fee or charge that may be collected for the filing, whether by the court or any other public body, as defined by ORS 174.109.

SECTION 5. Caption of pleading; amended pleadings. (1) The caption of any complaint or other document filed in a circuit court for the purpose of commencing an action or other civil proceeding must include a reference to the statute that establishes the filing fee for the proceeding. If the proceeding is subject to a filing fee established under section 15 of this 2011 Act, the caption must indicate the amount in controversy. If the proceeding is subject to a filing fee established under section 21 or 28 of this 2011 Act, the caption must indicate the value of the estate.

(2) If at any time a party files an amended pleading in a proceeding that is subject to a filing fee established under section 15, 21 or 28 of this 2011 Act, and the pleading increases the amount in controversy or the value of the estate in the proceeding, the caption of the pleading must note that increased amount. The court shall collect an additional filing fee from the party filing the pleading that is equal to the difference between the filing fee that was paid by the party when the original pleading was filed and the filing fee that would have been collected if the amount had been pleaded in the original pleading.

(3) If at any time the court determines that a party has failed to comply with the requirements of this section, the court may require that the party pay all fees that should have been paid at the time the document was filed.

SECTION 6. Section 5 of this 2011 Act applies only to proceedings commenced on or after October 1, 2011. Any proceeding commenced before October 1, 2011, shall continue to be governed by the law in effect immediately before October 1, 2011.

(Standard Filing Fee)

SECTION 7. ORS 21.110 is repealed.

SECTION 7a. The repeal of ORS 21.110 by section 7 of this 2011 Act becomes operative immediately after the amendments to ORS 21.110 by section 31, chapter 107, Oregon Laws 2010, become operative under section 17, chapter 659, Oregon Laws 2009, as amended by section 143 of this 2011 Act.

SECTION 8. Standard filing fee. (1) Unless a specific fee is provided by other law for a proceeding, a circuit court shall collect a filing fee of \$240 when a complaint or other document is filed for the purpose of commencing an action or other civil proceeding and when an answer or other first appearance is filed in the proceeding.

(2) The filing fee established by this section applies to:

(a) Proceedings in which only equitable remedies are sought.

(b) Appeals from a conviction of a violation in justice or municipal courts as provided in

2 (c) **Interpleader actions.**

3 (d) **Adoptions under ORS chapter 109.**

4 (e) **Actions relating to a trust.**

5 (f) **Proceedings for judicial review of an agency order.**

6 (g) **Declaratory judgment actions.**

7 (h) **Any other action or proceeding that is statutorily made subject to the fee established**
8 **by this section and any other civil proceeding for which a specific filing fee is not provided.**

9 **SECTION 9. Section 8 of this 2011 Act applies only to proceedings commenced on or after**
10 **October 1, 2011.**

14 **SECTION 10. ORS 21.111 and 108.130 are repealed.**

15 **SECTION 11. Domestic relations filing fee. A circuit court shall collect a filing fee of \$260**
16 **when a complaint or other document is filed for the purpose of commencing one of the fol-**
17 **lowing proceedings and when an answer or other first appearance is filed in the proceeding:**

18 (1) **Proceedings for dissolution of marriage, annulment of marriage or separation.**

19 (2) **Filiation proceedings under ORS 109.124 to 109.230.**

20 (3) **Proceedings under ORS 108.110, 109.100 and 109.103.**

21 **SECTION 12. Section 11 of this 2011 Act applies only to proceedings commenced on or**
22 **after October 1, 2011.**

26 **SECTION 13. Simple proceeding filing fee. In the following proceedings, a circuit court**
27 **shall collect a filing fee of \$105 when a complaint or other document is filed for the purpose**
28 **of commencing an action or other proceeding and at the time of filing an answer or other**
29 **first appearance in the proceeding:**

30 (1) **Applications for change of name under ORS 33.410.**

31 (2) **Applications for a legal change of sex under ORS 33.460.**

32 (3) **Guardianship proceedings under ORS chapter 125.**

33 (4) **Any other action or proceeding that is statutorily made subject to the fee established**
34 **by this section.**

35 **SECTION 14. Section 13 of this 2011 Act applies only to proceedings commenced on or**
36 **after October 1, 2011.**

38 (Tort and Contract Actions)

40 **SECTION 15. Filing fee for tort and contract actions. (1) A circuit court shall collect the**
41 **following filing fees when a complaint or other document is filed for the purpose of com-**
42 **mencing an action or other civil proceeding based on a tort or contract and when an answer**
43 **or other first appearance is filed in the proceeding:**

44 (a) **If the amount claimed is \$10,000 or less, the court shall collect a filing fee of \$150.**

45 (b) **If the amount claimed is more than \$10,000 and less than \$50,000, the court shall**

1 collect a filing fee of \$240.

2 (c) If the amount claimed is more than \$50,000, and less than \$1 million, the court shall
3 collect a filing fee of \$505.

4 (d) If the amount claimed is \$1 million or more and less than \$10 million, the court shall
5 collect a fee of \$755.

6 (e) If the amount claimed is \$10 million or more, the court shall collect a filing fee of
7 \$1,005.

8 (2) The filing fees provided by this section apply to proceedings for the foreclosure of a
9 mortgage, lien or other security interest. For the purposes of such proceedings, the amount
10 claimed is the amount of the debt secured by the mortgage, lien or other security interest
11 that is owing as of the date that the proceeding is filed.

12 (3) The filing fees provided by this section apply to proceedings for specific performance
13 of a contract. For the purposes of such proceedings, the amount claimed is the amount owing
14 under the contract on the date that the proceeding is filed.

15 (4) A court shall collect the filing fees provided by this section when an appeal from a
16 justice court is filed under ORS 53.005 to 53.125 or a case is transferred from a justice court
17 under ORS 52.320.

18 (5) For purposes of this section, the amount claimed in a proceeding does not include any
19 amount claimed as attorney fees or as costs and disbursements.

20 (6) For purposes of this section, the amount claimed in a proceeding includes any penalty
21 or forfeiture provided by statute or arising out of contract.

22 **SECTION 16.** Section 15 of this 2011 Act applies only to proceedings commenced on or
23 after October 1, 2011.

27 **SECTION 16a.** The filing fees described sections 8, 11, 13 and 15 of this 2011 Act may not
28 be charged to a district attorney or to the Division of Child Support of the Department of

30 vices as described in ORS 25.080.

34 **SECTION 17.** ORS 21.114 is repealed.

35 **SECTION 18.** ORS 419B.529 is amended to read:

36 419B.529. (1) Notwithstanding ORS 109.309, a prospective adoptive parent is not required to file
37 a petition for adoption when:

38 (a) A juvenile court that is a circuit court has entered an order of permanent commitment of a
39 ward to the Department of Human Services under ORS 419B.527 or the parent has signed and the
40 department has accepted a release and surrender to the department and a certificate of
41 irrevocability and waiver as provided in ORS 418.270 regarding a child;

42 (b) The department has completed a home study as defined in ORS 109.304 that finds the pro-
43 spective parent is suitable to adopt the child or ward and the department consents to the adoption
44 of the child or ward by the prospective parent;

17 **SECTION 21. Probate filing fees and accounting fees. (1) Except as provided in ORS**
18 **114.515, a probate court shall collect the following filing fees for the filing of a petition for**
19 **the appointment of personal representative:**

20 (a) If the value of the estate is less than \$50,000, \$240.

21 (b) If the value of the estate is \$50,000 or more, but less than \$1 million, \$505.

22 (c) If the value of the estate is \$1 million or more, but less than \$10 million, \$755.

23 (d) If the value of the estate is \$10 million or more, \$1,005.

24 (2) A probate court shall collect the following fees for an annual or final accounting filed
25 in a probate proceeding:

26 (a) If the value of the estate is less than \$50,000, \$30.

27 (b) If the value of the estate is \$50,000 or more, but less than \$1 million, \$255.

28 (c) If the value of the estate is \$1 million or more, but less than \$10 million, \$505.

29 (d) If the value of the estate is \$10 million or more, \$1,005.

30 (3) For the purpose of determining the value of the estate under this section, the amount
31 of a settlement in a wrongful death action brought for the benefit of the decedent's surviving
32 spouse or dependents is not part of the estate.

33 (4) A person filing an appearance in a probate proceeding must pay the fee established
34 under section 8 of this 2011 Act.

35 (5) The fees established under this section apply to county courts exercising probate ju-
36 risdiction.

37 **SECTION 22. ORS 114.515 is amended to read:**

38 114.515. (1) If the estate of a decedent meets the requirements of subsection (2) of this section,
39 any of the following persons may file an affidavit with the clerk of the probate court in any county
40 where there is venue for a proceeding seeking the appointment of a personal representative for the
41 estate:

42 (a) One or more of the claiming successors of the decedent.

43 (b) If the decedent died testate, any person named as personal representative in the decedent's
44 will.

45 (c) The Director of Human Services, the Director of the Oregon Health Authority or an attorney

1 approved under ORS 114.517, if the decedent received public assistance pursuant to ORS chapter 411
2 or 414 or received care at an institution as defined in ORS 179.010, and it appears that the assist-
3 ance or the cost of care may be recovered from the estate of the decedent.

4 (2) An affidavit under this section may be filed only if:

5 (a) The fair market value of the estate is \$275,000 or less;

6 (b) Not more than \$75,000 of the fair market value of the estate is attributable to personal
7 property; and

8 (c) Not more than \$200,000 of the fair market value of the estate is attributable to real property.

9 (3) An affidavit under this section may not be filed until 30 days after the death of the decedent.

10 (4) An affidavit filed under the provisions of this section must contain the information required
11 in ORS 114.525 and shall be made a part of the probate records. If the affiant is an attorney ap-
12 proved by the Director of Human Services or the Director of the Oregon Health Authority, a copy
13 of the document approving the attorney must be attached to the affidavit.

14 (5) In determining fair market value under this section, the fair market value of the entire in-
15 terest in the property included in the estate shall be used without reduction for liens or other debts.

16 (6) The clerk of the probate court shall charge and collect [*a fee of \$23*] **the fee established**
17 **under section 13 of this 2011 Act** for the filing of any affidavit under this section.

18 (7) Any error or omission in an affidavit filed under this section may be corrected by filing an
19 amended affidavit within four months after the filing of the affidavit.

20 (8) One or more supplemental affidavits may be filed at any time after the filing of an affidavit
21 under this section for the purpose of including property not described in the original affidavit.
22 Copies of all previously filed affidavits must be attached to the supplemental affidavit and all infor-
23 mation required in ORS 114.525 must be reflected in the supplemental affidavit. A supplemental af-
24 fidavit may not be filed if by reason of the additional property described in the supplemental
25 affidavit any limitation imposed by subsection (2) of this section is exceeded.

45 (2) The fees established under this section apply to county courts exercising probate ju-

1 jurisdiction.

2 **SECTION 28. Conservatorship filing fees and accounting fees.** (1) The court shall collect
3 the following filing fees for the filing of the initial documents in a conservatorship proceed-
4 ing:

- 5 (a) If the value of the estate is less than \$50,000, \$240.
- 6 (b) If the value of the estate is \$50,000 or more, but less than \$1 million, \$505.
- 7 (c) If the value of the estate is \$1 million or more, but less than \$10 million, \$755.
- 8 (d) If the value of the estate is \$10 million or more, \$1,005.

9 (2) The court shall collect the following fees for an annual or final accounting filed in a
10 conservatorship proceeding:

- 11 (a) If the value of the estate is less than \$50,000, \$30.

27 business of the attorney. The notice shall state the name of the testator, the date of the will and the
28 intent of the attorney to destroy the will if the testator does not contact the attorney within 90 days
29 after the date of the notice.

30 (b) If the testator fails to contact the attorney within 90 days after the date of the notice, the
31 attorney may destroy the will.

32 (c) Within 30 days after destruction of the will, the attorney shall file with the probate court in
33 the county where the notice was published an affidavit stating the name of the testator, the name
34 and relationship of each person named in the will whom the testator identified as related to the
35 testator by blood, adoption or marriage, the date of the will, proof of the publication and the date
36 of destruction.

39 (2) If a will has not been admitted to probate within 40 years following the death of the testator,

43 is living, all beneficiaries of the trust who have an interest in the subject of the agreement, any
44 acting trustee of the trust, and the Attorney General if the trust is a charitable trust subject to the
45 enforcement or supervisory powers of the state or the Attorney General under the provisions of ORS

1 128.610 to 128.750.

2 (2) Except as otherwise provided in subsection (3) of this section, interested persons may enter
3 into a binding nonjudicial settlement agreement with respect to any matter involving a trust.

4 (3) A nonjudicial settlement agreement is valid only to the extent the agreement does not violate
5 a material purpose of the trust and includes terms and conditions that could be properly approved
6 by the court under this chapter or other applicable law.

7 (4) Matters that may be resolved by a nonjudicial settlement agreement include:

8 (a) The interpretation or construction of the terms of the trust or other writings that affect the
9 trust.

10 (b) The approval of a trustee’s report or accounting.

11 (c) Direction to a trustee to refrain from performing a particular act or the grant to a trustee
12 of any necessary or desirable power.

13 (d) The resignation or appointment of a trustee and the determination of a trustee’s compen-

20 trust operates.

21 (5)(a) Any interested person may file a settlement agreement entered into under this section, or
22 a memorandum summarizing the provisions of the agreement, with the circuit court for any county
23 where trust assets are located or where the trustee administers the trust.

11 tody; (f) an order awarding you other relief the court considers necessary to provide for your or

7 **JOINT COMMITTEE ON STATE COURTS REVENUE STRUCTURE**

9 **SECTION 171.** (1) There is created a Joint Committee on State Courts Revenue Struc-

11 and three members of the House of Representatives appointed by the Speaker of the House

22 (e) The statutory fee structure and fee amounts should be uniform across this state.

23 (f) All state court revenue sources should be easily identifiable and reflected in statute.

24 (g) The court fee structure should generate biennial revenue commensurate with the
25 end-of-session revenue forecast.

26 (h) Fees and fines should be a fixed dollar amount.

27 (i) Surcharges and assessments should not be imposed on fees or fines.

28 (j) Fines for violations should be uniform in state courts, justice courts and municipal
29 court.

30 (k) Revenues from fees and fines should not be dedicated.

31 (3) In conducting the review required by subsection (2) of this section and making rec-
32 ommendations relating to the court fee structure, the committee shall give due consideration
33 to the fairness of those fees and the financial burdens placed on the parties who are ulti-
34 mately responsible for the payment of the fees.

35 (4) The committee shall identify statutes and court practices that are not in conformity
36 with the principles listed in subsection (2) of this section.

37 (5) The committee shall monitor all legislation passed by the Seventy-sixth Legislative
38 Assembly relating to court fees and fines, and evaluate the effect of the exercise of judicial
39 discretion on revenues generated by fines.

40 (6) The committee shall study funding of court security, court facilities and county law
41 libraries, and make recommendations on the manner in which court security, court facilities
42 and county law libraries should be funded.

43 (7) The committee shall issue a report not later than January 1, 2013. The report must
44 describe statutes and court practices identified by the committee as failing to conform with
45 the principles listed in subsection (2) of this section, and recommend statutory and other

1 changes. A copy of the report shall be delivered to the House Committee on Judiciary, the
2 Senate Committee on Judiciary and the Joint Committee on Ways and Means.

3 (8) A majority of the members of the Joint Committee on State Courts Revenue Struc-
4 ture constitutes a quorum for the transaction of business.

5 (9) Official action by the committee requires the approval of a majority of the members
6 of the committee.

7 (10) The President of the Senate shall designate one of the members appointed by the
8 President to serve as cochair of the committee. The Speaker of the House of Representatives
9 shall designate one of the members appointed by the Speaker to serve as cochair of the
10 committee.

11 (11) If there is a vacancy for any cause, the appointing authority shall make an appoint-
12 ment. The appointment becomes effective immediately.

13 (12) The committee shall meet at times and places specified by the call of a cochair or
14 of a majority of the members of the committee.

15 (13) The committee may adopt rules necessary for the operation of the committee.

16 (14) The Legislative Administrator, the Legislative Fiscal Office and the Legislative Re-
17 venue Office shall provide administrative support to the committee.

19 the committee in the performance of its duties and, to the extent permitted by laws relating
20 to confidentiality, to furnish such information and advice as the members of the committee
