13 chapter 659, Oregon Laws 2009; appropriating money; declaring an emergency; and providing for

“DEPOSIT OF COURT FEES AND CHARGES

18

19 “**SECTION 1. Transfers to General Fund.** Except as otherwise provided by law, all
20 amounts collected as fees and charges in the Supreme Court, the Court of Appeals, the
21 Oregon Tax Court and the circuit courts shall be transferred to the State Court Adminis-
22 trator for deposit in the General Fund.

23 “**SECTION 2.** Section 1 of this 2011 Act applies to all fees and charges collected in courts
24 on or after the effective date of this 2011 Act.

25 “**SECTION 3. Legislative intent relating to funding certain programs, services and activ-**
26 **ities.** It is the intent of the Legislative Assembly that funding be provided to the following
27 entities by appropriations each biennium to fund programs, services and activities that were
28 funded through court fees before the 2011-2013 biennium:

29 “(1) To the counties of this state for the purposes of funding mediation services, concil-
30 iation services and other services in domestic relations cases.

31 “(2) To the counties of this state for the purposes of funding the operation of law li-
32 braries or of providing law library services.

33 “(3) To the Oregon University System to fund the programs and expenses of the Mark
34 O. Hatfield School of Government and the University of Oregon School of Law under ORS
35 36.100 to 36.238 and 183.502.

1 “(4) To the Housing and Community Services Department for the purpose of funding
2 programs that defray the cost of rent for dwelling units for very low income households.

3 “(5) To the Oregon University System to fund clinical legal education programs at ac-
4 credited institutions of higher education that provide civil legal services to victims of do-
5 mestic violence, stalking or sexual assault.

6 “(6) To the State Department of Agriculture for the purpose of funding mediation pro-
7 grams established by the department, other than individual farm credit mediations.

8 “(7) To the Judicial Department for the purposes of funding the appellate mediation
9 program established under ORS 2.560.

10 “(8) To the Department of Human Services for the funding of the Office of Children’s
11 Advocate.

13 **“LEGAL AID**
14

15 **“SECTION 3a. Legal Aid Account.** (1) The Legal Aid Account is established in the General
16 Fund of the State Treasury. All moneys in the account are continuously appropriated to the
17 State Court Administrator for the purpose of the distributions required by this section. In-
18 terest earned by the account shall be credited to the General Fund.

19 “(2) Each month, the State Court Administrator shall transfer to the Legal Aid Account,
20 from amounts collected by the State Court Administrator as fees and charges in the circuit
21 courts, the amounts necessary to make the distributions required by subsection (3) of this
22 section.

23 “(3) Each biennium, the State Court Administrator shall distribute to the Oregon State
24 Bar \$11.9 million from the Legal Aid Account. Distributions under this section shall be made
25 by the State Court Administrator in eight quarterly installments of equal amounts, with the
26 first distribution to be made as soon as possible after July 1, 2011. Amounts distributed to
27 the Oregon State Bar under this subsection may be used only for the funding of the Legal
28 Services Program established under ORS 9.572.

30 **“CIRCUIT COURT FILING FEES**
31

32 **“(Payment)**
33

34 **“SECTION 4. Filing fees payable in advance.** A pleading or other document may be filed
35 by the circuit court only if the filing fee required by law is paid by the person filing the
36 document or a request for a fee waiver or deferral is granted by the court. Filing fees are
37 not refundable under any circumstances. Unless otherwise specifically provided by statute,
38 the filing fee for an action or proceeding is the only fee or charge that may be collected for
39 the filing, whether by the court or any other public body, as defined by ORS 174.109.

40 **“SECTION 5. Caption of pleading; amended pleadings.** (1) The caption of any complaint
41 or other document filed in a circuit court for the purpose of commencing an action or other
42 civil proceeding must include a reference to the statute that establishes the filing fee for the
43 proceeding. If the proceeding is subject to a filing fee established under section 15 of this 2011
44 Act, the caption must indicate the amount in controversy. If the proceeding is subject to a
45 filing fee established under section 21 or 28 of this 2011 Act, the caption must indicate the

1 value of the estate.

2 “(2) If at any time a party files an amended pleading in a proceeding that is subject to a
3 filing fee established under section 15, 21 or 28 of this 2011 Act, and the pleading increases
4 the amount in controversy or the value of the estate in the proceeding, the caption of the
5 pleading must note that increased amount. The court shall collect an additional filing fee
6 from the party filing the pleading that is equal to the difference between the filing fee that
7 was paid by the party when the original pleading was filed and the filing fee that would have
8 been collected if the amount had been pleaded in the original pleading.

9 “(3) If at any time the court determines that a party has failed to comply with the re-
10 quirements of this section, the court may require that the party pay all fees that should have
11 been paid at the time the document was filed.

12 “SECTION 6. Section 5 of this 2011 Act applies only to proceedings commenced on or af-
13 ter October 1, 2011. Any proceeding commenced before October 1, 2011, shall continue to be
14 governed by the law in effect immediately before October 1, 2011.

15
16 “(Standard Filing Fee)

17
18 “SECTION 7. ORS 21.110 is repealed.

19 “SECTION 7a. The repeal of ORS 21.110 by section 7 of this 2011 Act becomes operative
20 immediately after the amendments to ORS 21.110 by section 31, chapter 107, Oregon Laws
21 2010, become operative under section 17, chapter 659, Oregon Laws 2009, as amended by
22 section 143 of this 2011 Act.

23 “SECTION 8. Standard filing fee. (1) Unless a specific fee is provided by other law for a
24 proceeding, a circuit court shall collect a filing fee of \$240 when a complaint or other docu-
25 ment is filed for the purpose of commencing an action or other civil proceeding and when
26 an answer or other first appearance is filed in the proceeding.

27 “(2) The filing fee established by this section applies to:

28 “(a) Proceedings in which only equitable remedies are sought.

29 “(b) Appeals from a conviction of a violation in justice or municipal courts as provided
30 in ORS 21.615.

31 “(c) Interpleader actions.

32 “(d) Adoptions under ORS chapter 109.

33 “(e) Actions relating to a trust.

34 “(f) Proceedings for judicial review of an agency order.

35 “(g) Declaratory judgment actions.

36 “(h) Any other action or proceeding that is statutorily made subject to the fee estab-
37 lished by this section and any other civil proceeding for which a specific filing fee is not
38 provided.

39 “SECTION 9. Section 8 of this 2011 Act applies only to proceedings commenced on or af-
40 ter October 1, 2011.

41
42 “(Domestic Relations Filing Fee)

43
44 “SECTION 10. ORS 21.111 and 108.130 are repealed.

45 “SECTION 11. Domestic relations filing fee. A circuit court shall collect a filing fee of

1 \$260 when a complaint or other document is filed for the purpose of commencing one of the
2 following proceedings and when an answer or other first appearance is filed in the proceed-
3 ing:

4 “(1) Proceedings for dissolution of marriage, annulment of marriage or separation.

5 “(2) Filiation proceedings under ORS 109.124 to 109.230.

6 “(3) Proceedings under ORS 108.110, 109.100 and 109.103.

7 “SECTION 12. Section 11 of this 2011 Act applies only to proceedings commenced on or
8 after October 1, 2011.

9
10 “(Simple Proceeding Filing Fee)

11
12 “SECTION 13. Simple proceeding filing fee. In the following proceedings, a circuit court
13 shall collect a filing fee of \$105 when a complaint or other document is filed for the purpose
14 of commencing an action or other proceeding and at the time of filing an answer or other
15 first appearance in the proceeding:

16 “(1) Applications for change of name under ORS 33.410.

17 “(2) Applications for a legal change of sex under ORS 33.460.

18 “(3) Guardianship proceedings under ORS chapter 125.

19 “(4) Any other action or proceeding that is statutorily made subject to the fee established
20 by this section.

21 “SECTION 14. Section 13 of this 2011 Act applies only to proceedings commenced on or
22 after October 1, 2011.

23
24 “(Tort and Contract Actions)

25
26 “SECTION 15. Filing fee for tort and contract actions. (1) A circuit court shall collect the
27 following filing fees when a complaint or other document is filed for the purpose of com-
28 mencing an action or other civil proceeding based on a tort or contract and when an answer
29 or other first appearance is filed in the proceeding:

30 “(a) If the amount claimed is \$10,000 or less, the court shall collect a filing fee of \$150.

31 “(b) If the amount claimed is more than \$10,000 and less than \$50,000, the court shall
32 collect a filing fee of \$240.

33 “(c) If the amount claimed is more than \$50,000, and less than \$1 million, the court shall
34 collect a filing fee of \$505.

35 “(d) If the amount claimed is \$1 million or more and less than \$10 million, the court shall
36 collect a fee of \$755.

37 “(e) If the amount claimed is \$10 million or more, the court shall collect a filing fee of
38 \$1,005.

39 “(2) The filing fees provided by this section apply to proceedings for the foreclosure of a
40 mortgage, lien or other security interest. For the purposes of such proceedings, the amount
41 claimed is the amount of the debt secured by the mortgage, lien or other security interest
42 that is owing as of the date that the proceeding is filed.

43 “(3) The filing fees provided by this section apply to proceedings for specific performance
44 of a contract. For the purposes of such proceedings, the amount claimed is the amount owing
45 under the contract on the date that the proceeding is filed.

1 “(4) A court shall collect the filing fees provided by this section when an appeal from a
2 justice court is filed under ORS 53.005 to 53.125 or a case is transferred from a justice court
3 under ORS 52.320.

4 “(5) For purposes of this section, the amount claimed in a proceeding does not include
5 any amount claimed as attorney fees or as costs and disbursements.

6 “(6) For purposes of this section, the amount claimed in a proceeding includes any pen-
7 alty or forfeiture provided by statute or arising out of contract.

8 “SECTION 16. Section 15 of this 2011 Act applies only to proceedings commenced on or
9 after October 1, 2011.

10
11 “(Filing Fees for Support Enforcement Cases)
12

13 “SECTION 16a. The filing fees described sections 8, 11, 13 and 15 of this 2011 Act may
14 not be charged to a district attorney or to the Division of Child Support of the Department
15 of Justice for the filing of any proceeding related to the provision of support enforcement
16 services as described in ORS 25.080.

17
18 “(Adoption and Change of Name)
19

20 “SECTION 17. ORS 21.114 is repealed.

21 “SECTION 18. ORS 419B.529 is amended to read:

22 “419B.529. (1) Notwithstanding ORS 109.309, a prospective adoptive parent is not required to file
23 a petition for adoption when:

24 “(a) A juvenile court that is a circuit court has entered an order of permanent commitment of
25 a ward to the Department of Human Services under ORS 419B.527 or the parent has signed and the
26 department has accepted a release and surrender to the department and a certificate of
27 irrevocability and waiver as provided in ORS 418.270 regarding a child;

28 “(b) The department has completed a home study as defined in ORS 109.304 that finds the pro-
29 spective parent is suitable to adopt the child or ward and the department consents to the adoption
30 of the child or ward by the prospective parent;

31 “(c) A home study and a placement report requesting the juvenile court to enter a judgment of
32 adoption have been filed in the juvenile court proceeding; and

33 “(d) At the time the placement report is filed under paragraph (c) of this subsection, the pro-
34 spective adoptive parent files the adoption report form required under ORS 109.400.

35 “(2) Notwithstanding [ORS 21.114] **section 8 of this 2011 Act**, the clerk of the juvenile court
36 may not charge or collect first appearance [*or hearing*] fees for a proceeding under this section.

37 “(3) After the filing of the home study and the placement report requesting the court to enter
38 a judgment of adoption, the juvenile court that entered the order of permanent commitment may
39 proceed as provided in ORS 109.307 and 109.350 and may enter a judgment of adoption.

40 “(4) Records of adoptions filed and established under this section shall be kept in accordance
41 with, and are subject to, ORS 7.211.

42 “SECTION 19. The amendments to ORS 419B.529 by section 18 of this 2011 Act apply only
43 to proceedings commenced on or after October 1, 2011.

44
45 “(Probate)

1 **“SECTION 20. ORS 21.310 is repealed.**

2 **“SECTION 21. Probate filing fees and accounting fees. (1) Except as provided in ORS**
3 **114.515, a probate court shall collect the following filing fees for the filing of a petition for**
4 **the appointment of personal representative:**

5 **“(a) If the value of the estate is less than \$50,000, \$240.**

6 **“(b) If the value of the estate is \$50,000 or more, but less than \$1 million, \$505.**

7 **“(c) If the value of the estate is \$1 million or more, but less than \$10 million, \$755.**

8 **“(d) If the value of the estate is \$10 million or more, \$1,005.**

9 **“(2) A probate court shall collect the following fees for an annual or final accounting filed**
10 **in a probate proceeding:**

11 **“(a) If the value of the estate is less than \$50,000, \$30.**

12 **“(b) If the value of the estate is \$50,000 or more, but less than \$1 million, \$255.**

13 **“(c) If the value of the estate is \$1 million or more, but less than \$10 million, \$505.**

14 **“(d) If the value of the estate is \$10 million or more, \$1,005.**

15 **“(3) For the purpose of determining the value of the estate under this section, the**
16 **amount of a settlement in a wrongful death action brought for the benefit of the decedent’s**
17 **surviving spouse or dependents is not part of the estate.**

18 **“(4) A person filing an appearance in a probate proceeding must pay the fee established**
19 **under section 8 of this 2011 Act.**

20 **“(5) The fees established under this section apply to county courts exercising probate**
21 **jurisdiction.**

22 **“SECTION 22. ORS 114.515 is amended to read:**

23 **“114.515. (1) If the estate of a decedent meets the requirements of subsection (2) of this section,**
24 **any of the following persons may file an affidavit with the clerk of the probate court in any county**
25 **where there is venue for a proceeding seeking the appointment of a personal representative for the**
26 **estate:**

27 **“(a) One or more of the claiming successors of the decedent.**

28 **“(b) If the decedent died testate, any person named as personal representative in the decedent’s**
29 **will.**

30 **“(c) The Director of Human Services, the Director of the Oregon Health Authority or an attor-**
31 **ney approved under ORS 114.517, if the decedent received public assistance pursuant to ORS chapter**
32 **411 or 414 or received care at an institution as defined in ORS 179.010, and it appears that the as-**
33 **sistance or the cost of care may be recovered from the estate of the decedent.**

34 **“(2) An affidavit under this section may be filed only if:**

35 **“(a) The fair market value of the estate is \$275,000 or less;**

36 **“(b) Not more than \$75,000 of the fair market value of the estate is attributable to personal**
37 **property; and**

38 **“(c) Not more than \$200,000 of the fair market value of the estate is attributable to real prop-**
39 **erty.**

40 **“(3) An affidavit under this section may not be filed until 30 days after the death of the**
41 **decedent.**

42 **“(4) An affidavit filed under the provisions of this section must contain the information required**
43 **in ORS 114.525 and shall be made a part of the probate records. If the affiant is an attorney ap-**
44 **proved by the Director of Human Services or the Director of the Oregon Health Authority, a copy**
45 **of the document approving the attorney must be attached to the affidavit.**

1 “(5) In determining fair market value under this section, the fair market value of the entire in-
2 terest in the property included in the estate shall be used without reduction for liens or other debts.

3 “(6) The clerk of the probate court shall charge and collect [*a fee of \$23*] **the fee established**
4 **under section 13 of this 2011 Act** for the filing of any affidavit under this section.

5 “(7) Any error or omission in an affidavit filed under this section may be corrected by filing an
6 amended affidavit within four months after the filing of the affidavit.

7 “(8) One or more supplemental affidavits may be filed at any time after the filing of an affidavit
8 under this section for the purpose of including property not described in the original affidavit.
9 Copies of all previously filed affidavits must be attached to the supplemental affidavit and all infor-
10 mation required in ORS 114.525 must be reflected in the supplemental affidavit. A supplemental af-
11 fidavit may not be filed if by reason of the additional property described in the supplemental
12 affidavit any limitation imposed by subsection (2) of this section is exceeded.

13 “**SECTION 23. Section 21 of this 2011 Act and the amendments to ORS 114.515 by section**
14 **22 of this 2011 Act apply only to proceedings commenced on or after October 1, 2011.**

15 “**SECTION 24. Section 25 of this 2011 Act is added to and made a part of ORS 114.505 to**
16 **114.560.**

17 “**SECTION 25. (1) A person filing a petition for summary determination under ORS**
18 **114.540 or a petition for summary review of administration of estate under ORS 114.550, or**
19 **any other appearance in a proceeding under ORS 114.505 to 114.560, must pay the filing fee**
20 **established under section 8 of this 2011 Act.**

21 “**(2) If at any time after the filing of an affidavit under ORS 114.515 a petition for ap-**
22 **pointment of a personal representative is filed for the same estate, the person filing the pe-**
23 **tition must pay the fees established under section 21 of this 2011 Act.**

24 “**SECTION 26. Section 25 of this 2011 Act applies only to proceedings commenced on or**
25 **after October 1, 2011.**

26
27 “(Protective Proceedings)
28

29 “**SECTION 27. Guardianship filing fees. (1) A circuit court shall collect the filing fee es-**
30 **tablished under section 13 of this 2011 Act for the filing of the initial documents in a**
31 **guardianship proceeding and for filing an appearance in a guardianship proceeding.**

32 “**(2) The fees established under this section apply to county courts exercising probate**
33 **jurisdiction.**

34 “**SECTION 28. Conservatorship filing fees and accounting fees. (1) The court shall collect**
35 **the following filing fees for the filing of the initial documents in a conservatorship proceed-**
36 **ing:**

37 “(a) If the value of the estate is less than \$50,000, \$240.

38 “(b) If the value of the estate is \$50,000 or more, but less than \$1 million, \$505.

39 “(c) If the value of the estate is \$1 million or more, but less than \$10 million, \$755.

40 “(d) If the value of the estate is \$10 million or more, \$1,005.

41 “**(2) The court shall collect the following fees for an annual or final accounting filed in**
42 **a conservatorship proceeding:**

43 “(a) If the value of the estate is less than \$50,000, \$30.

44 “(b) If the value of the estate is \$50,000 or more, but less than \$1 million, \$255.

45 “(c) If the value of the estate is \$1 million or more, but less than \$10 million, \$505.

1 “(d) If the value of the estate is \$10 million or more, \$1,005.

2 “(3) For the purpose of determining the value of the estate under this section, the
3 amount of a settlement in a wrongful death action brought for the benefit of the decedent’s
4 surviving spouse or dependents is not part of the estate.

5 “(4) Except as provided in subsection (1) of this section, at the time of filing an appear-
6 ance in a conservatorship proceeding the party filing the appearance must pay the filing fee
7 established under section 8 of this 2011 Act.

8 “(5) The fees established by this section apply to county courts exercising probate juris-
9 diction.

10 “**SECTION 29.** ORS 112.820 is amended to read:

11 “112.820. (1) An attorney authorized to destroy a will under ORS 112.815 may proceed as follows:

12 “(a) The attorney shall first publish a notice in a newspaper of general circulation in the county
13 of the last-known address of the testator, if any, otherwise in the county of the principal place of
14 business of the attorney. The notice shall state the name of the testator, the date of the will and the
15 intent of the attorney to destroy the will if the testator does not contact the attorney within 90 days
16 after the date of the notice.

17 “(b) If the testator fails to contact the attorney within 90 days after the date of the notice, the
18 attorney may destroy the will.

19 “(c) Within 30 days after destruction of the will, the attorney shall file with the probate court
20 in the county where the notice was published an affidavit stating the name of the testator, the name
21 and relationship of each person named in the will whom the testator identified as related to the
22 testator by blood, adoption or marriage, the date of the will, proof of the publication and the date
23 of destruction.

24 “(d) The clerk of the probate court shall charge and collect [*a fee of \$17*] **the fee established**
25 **under section 13 of this 2011 Act** for filing of the affidavit.

26 “(2) If a will has not been admitted to probate within 40 years following the death of the
27 testator, an attorney having custody of the will may destroy the will without notice to any person
28 or court.

29 “**SECTION 30.** ORS 130.045 is amended to read:

30 “130.045. (1) For purposes of this section, ‘interested persons’ means any settlor of a trust who
31 is living, all beneficiaries of the trust who have an interest in the subject of the agreement, any
32 acting trustee of the trust, and the Attorney General if the trust is a charitable trust subject to the
33 enforcement or supervisory powers of the state or the Attorney General under the provisions of ORS
34 128.610 to 128.750.

35 “(2) Except as otherwise provided in subsection (3) of this section, interested persons may enter
36 into a binding nonjudicial settlement agreement with respect to any matter involving a trust.

37 “(3) A nonjudicial settlement agreement is valid only to the extent the agreement does not vio-
38 late a material purpose of the trust and includes terms and conditions that could be properly ap-
39 proved by the court under this chapter or other applicable law.

40 “(4) Matters that may be resolved by a nonjudicial settlement agreement include:

41 “(a) The interpretation or construction of the terms of the trust or other writings that affect the
42 trust.

43 “(b) The approval of a trustee’s report or accounting.

44 “(c) Direction to a trustee to refrain from performing a particular act or the grant to a trustee
45 of any necessary or desirable power.

1 “(d) The resignation or appointment of a trustee and the determination of a trustee’s compen-
2 sation.

3 “(e) Transfer of a trust’s principal place of administration.

4 “(f) Liability of a trustee for an action or failure to act relating to the trust.

5 “(g) Determining classes of creditors, beneficiaries, heirs, next of kin or other persons.

6 “(h) Resolving disputes arising out of the administration or distribution of the trust.

7 “(i) Modifying the terms of the trust, including extending or reducing the period during which
8 the trust operates.

9 “(5)(a) Any interested person may file a settlement agreement entered into under this section,
10 or a memorandum summarizing the provisions of the agreement, with the circuit court for any
11 county where trust assets are located or where the trustee administers the trust.

12 “(b) After collecting the fee provided for in subsection (7)(a) of this section, the clerk shall
13 enter the agreement or memorandum of record in the court’s register.

14 “(c) Within five days after the filing of an agreement or memorandum under this subsection, the
15 person making the filing must serve a notice of the filing and a copy of the agreement or memo-
16 randum on each person interested in the trust whose address is known at the time of the filing.
17 Service may be made personally, or by registered or certified mail, return receipt requested. The
18 notice of filing shall be substantially in the following form:

30 If you file objections within the 120-day period, the court will fix a time and place for a hearing.

41 abusing you; (b) an order directing your attacker to leave your household; (c) an order preventing
42 your attacker from entering your residence, school, business or place of employment; (d) an order
43 awarding you or the other parent custody of or parenting time with a minor child or children; (e)
44 an order restraining your attacker from molesting or interfering with minor children in your cus-
45 tody; (f) an order awarding you other relief the court considers necessary to provide for your or

1 your children’s safety, including emergency monetary assistance. Such orders are enforceable in
2 every state.

3 You may also request an order awarding support for minor children in your care or for your
4 support if the other party has a legal obligation to support you or your children.

5 You also have the right to sue for losses suffered as a result of the abuse, including medical and
6 moving expenses, loss of earnings or support, and other out-of-pocket expenses for injuries sustained
7 and damage to your property. This can be done without an attorney in the small claims department
8 of a court if the total amount claimed is under ~~[\$7,500]~~ **\$10,000**.

18 petitioner’s county of residence.

19 “(3) A person may apply once per calendar year for relief under the provisions of this section.

20 “(4)(a) A person petitioning for relief under this section shall serve a copy of the petition on:

21 “(A) The city chief of police if the court in which the petition is filed is located in a city; or

10 action or proceeding in which recovery of money or damages is sought, a prevailing party who has
11 a right to recover costs and disbursements also has a right to recover, as a part of the costs and
12 disbursements, the following additional amounts:

13 “(a) In a circuit court:

34 “(g) Any award of attorney fees made to the prevailing party as part of the judgment.

35 “(h) Such other factors as the court may consider appropriate under the circumstances of the

37 “(4) Nonprevailing parties are jointly liable for the prevailing party fees provided for in this
38 section. A court may not award more than one prevailing party fee to a prevailing party under this

41 not seek recovery of any additional amounts under the provisions of this section from any other

32 **“(i) Surcharges and assessments should not be imposed on fees or fines.**

33 **“(j) Fines for violations should be uniform in state courts, justice courts and municipal
34 court.**

35 **“(k) Revenues from fees and fines should not be dedicated.**

36 **“(3) In conducting the review required by subsection (2) of this section and making rec-
37 ommendations relating to the court fee structure, the committee shall give due consideration
38 to the fairness of those fees and the financial burdens placed on the parties who are ulti-
39 mately responsible for the payment of the fees.**

40 **“(4) The committee shall identify statutes and court practices that are not in conformity
41 with the principles listed in subsection (2) of this section.**

42 **“(5) The committee shall monitor all legislation passed by the Seventy-sixth Legislative
43 Assembly relating to court fees and fines, and evaluate the effect of the exercise of judicial
44 discretion on revenues generated by fines.**

45 **“(6) The committee shall study funding of court security, court facilities and county law**

1 libraries, and make recommendations on the manner in which court security, court facilities
2 and county law libraries should be funded.

3 “(7) The committee shall issue a report not later than January 1, 2013. The report must
4 describe statutes and court practices identified by the committee as failing to conform with
5 the principles listed in subsection (2) of this section, and recommend statutory and other
6 changes. A copy of the report shall be delivered to the House Committee on Judiciary, the
7 Senate Committee on Judiciary and the Joint Committee on Ways and Means.

8 “(8) A majority of the members of the Joint Committee on State Courts Revenue Struc-
9 ture constitutes a quorum for the transaction of business.

10 “(9) Official action by the committee requires the approval of a majority of the members
11 of the committee.

12 “(10) The President of the Senate shall designate one of the members appointed by the
13 President to serve as cochair of the committee. The Speaker of the House of Representatives
14 shall designate one of the members appointed by the Speaker to serve as cochair of the
15 committee.

16 “(11) If there is a vacancy for any cause, the appointing authority shall make an ap-
17 pointment. The appointment becomes effective immediately.

18 “(12) The committee shall meet at times and places specified by the call of a cochair or
