SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Revises laws relating to offenses.
Declares emergency, effective July 1, 2011.

7 **PRESUMPTIVE FINES FOR VIOLATIONS**

8
9 **SECTION 1. Sections 2 to 4 and 6b of this 2011 Act are added to and made a part of ORS**
10 **chapter 153.**

11 **SECTION 2. Presumptive fines; generally.** (1) Except as provided in section 3 of this 2011
12 Act, the presumptive fines for violations are:

- 13 (a) \$435 for a Class A violation.
14 (b) \$260 for a Class B violation.
15 (c) \$160 for a Class C violation.
16 (d) \$110 for a Class D violation.

17 (2) The presumptive fine for a specific fine violation is:

- 18 (a) The amount specified by statute as the presumptive fine for the violation; or
19 (b) An amount equal to the greater of 20 percent of the maximum fine prescribed for the
20 violation, or the minimum fine prescribed by statute for the violation.

21 **SECTION 3. Presumptive fines; highway work zones, school zones and safety corridors.**

22 (1) If an individual is charged with a traffic violation, as defined in ORS 801.557, and the
23 enforcement officer issuing the citation notes on the citation that the offense occurred in a
24 highway work zone and is subject to the provisions of ORS 811.230, occurred in a posted
25 school zone and is subject to the provisions of ORS 811.235, or occurred in a safety corridor
26 and is subject to the provisions of ORS 811.483, the presumptive fine for the violation is:

- 27 (a) \$870 for a Class A violation.
28 (b) \$520 for a Class B violation.
29 (c) \$320 for a Class C violation.
30 (d) \$220 for a Class D violation.

31 (2) The presumptive fine for a specific fine violation that is subject to this section is an
32 amount equal to twice the presumptive fine determined for the violation under section 2 (2)
33 of this 2011 Act.

34 (3) A court may not defer, waive, suspend or otherwise reduce the fine for a violation
35 that is subject to the presumptive fines established by this section to an amount that is less
36 than the presumptive fine established under this section.

37 **SECTION 4. Minimum fine for violations.** (1) Except as otherwise provided by law, a court
38 may not defer, waive, suspend or otherwise reduce the fine for a violation that is subject to
39 the presumptive fines established by section 2 or 3 of this 2011 Act to an amount that is less
40 than:

- 41 (a) \$220 for a Class A violation.
42 (b) \$130 for a Class B violation.
43 (c) \$80 for a Class C violation.
44 (d) \$60 for a Class D violation.

45 (2) Except as otherwise provided by law, a court may not defer, waive, suspend or oth-

1 erwise reduce the fine for a specific fine violation to an amount that is less than 20 percent
2 of the presumptive fine for the violation.

3 (3) This section does not affect the manner in which a court imposes or reduces mone-
4 tary obligations other than fines.

5 (4) The Department of Revenue or Secretary of State may audit any court to determine
6 whether the court is complying with the requirements of this section. In addition, the De-
7 partment of Revenue or Secretary of State may audit any court to determine whether the
8 court is complying with the requirements of sections 33 to 38 and 47 to 50 of this 2011 Act.
9 The Department of Revenue or Secretary of State may file an action under ORS 34.105 to
10 34.240 to enforce the requirements of this section and of sections 33 to 38 and 47 to 50 of this
11 2011 Act.

12 **SECTION 5.** ORS 153.093, 153.125, 153.128, 153.131, 153.134, 153.138, 153.142 and 153.145 are
13 repealed.

14 **SECTION 6.** Sections 2 to 4 of this 2011 Act and the repeal of ORS 153.093, 153.125,
15 153.128, 153.131, 153.134, 153.138, 153.142 and 153.145 by section 5 of this 2011 Act apply only
16 to offenses committed on or after January 1, 2012. Any offense committed before January
17 1, 2012, shall continue to be governed by ORS 153.093, 153.125, 153.128, 153.131, 153.134, 153.138,
18 153.142 and 153.145 as in effect immediately before January 1, 2012.

19 **SECTION 6a.** ORS 153.015 is amended to read:

20 153.015. (1) An offense described in the Oregon Revised Statutes that is designated as a violation
21 but does not specify the classification of the violation is an unclassified violation. An unclassified
22 violation is a Class B violation.

23 (2) A specific fine violation is any offense described in the Oregon Revised Statutes that is
24 **designated as a specific fine violation or:**

- 25 (a) Is not designated as a crime or as a class A, B, C or D violation;
26 (b) Is not punishable by a term of imprisonment as a penalty for committing the offense; and
27 (c) Is punishable by a specific fine as the penalty for committing the offense.

28 29 **REPLACEMENT FINE AMOUNT FOR UNITARY ASSESSMENT**

30
31 **SECTION 6b.** (1) In any criminal action in which a fine is imposed, the lesser of the fol-
32 lowing amounts is payable to the state before any other distribution of the fine is made:

- 33 (a) \$60; or
34 (b) The amount of the fine if the fine is less than \$60.

35 (2) A justice or municipal court shall forward the amount prescribed under subsection
36 (1) of this section to the Department of Revenue for deposit in the Criminal Fine Account.

37 38 **MAXIMUM FINES FOR VIOLATIONS**

40 **SECTION 7.** ORS 153.018 is amended to read:

41 153.018. (1) The penalty for committing a violation is a fine. The law creating a violation may
42 impose other penalties in addition to a fine but may not impose a term of imprisonment.

43 (2) *[Except as provided in this section, a sentence to pay a fine for a violation shall be a sentence*
44 *to pay an amount not exceeding]* **Except as otherwise provided by law, the maximum fine for a**
45 **violation committed by an individual is:**

1 (a) [~~\$720~~] **\$2,000** for a Class A violation.

2 (b) [~~\$360~~] **\$1,000** for a Class B violation.

3 (c) [~~\$180~~] **\$500** for a Class C violation.

4 (d) [~~\$90~~] **\$250** for a Class D violation.

5 (e) **\$2,000 for a specific fine violation, or the maximum** amount otherwise established by law
6 for [~~any~~] **the** specific fine violation.

7 (3) [*If no special corporate fine is specified in the law creating the violation, a sentence to pay a*
8 *fine for a violation committed by a corporation shall be in an amount not to exceed twice the fine es-*
9 *tablished under this section for a violation by an individual.*] If a special corporate fine is specified
10 in the law creating the violation, the sentence to pay a fine shall be governed by the law creating
11 the violation. **Except as otherwise provided by law, if a special corporate fine is not specified**
12 **in the law creating the violation, the maximum fine for a violation committed by a corpo-**
13 **ration is:**

14 (a) **\$4,000 for a Class A violation.**

15 (b) **\$2,000 for a Class B violation.**

16 (c) **\$1,000 for a Class C violation.**

17 (d) **\$500 for a Class D violation.**

18 [(4) *If a person or corporation has gained money or property through the commission of a violation,*
19 *instead of sentencing the defendant to pay the fine provided for in subsection (2) or (3) of this section,*
20 *the court may sentence the defendant to pay an amount fixed by the court, not exceeding double the*
21 *amount of the defendant's gain from the commission of the violation. For the purposes of this sub-*
22 *section, the defendant's gain is the amount of money or the value of property, as determined under ORS*
23 *164.115, derived from the commission of the violation, less the amount of money or the value of prop-*
24 *erty, as determined under ORS 164.115, returned to the victim of the violation or seized by or surren-*
25 *dered to lawful authority before the time sentence is imposed.*]

26 **SECTION 8. The amendments to ORS 153.018 by section 7 of this 2011 Act apply only to**
27 **offenses committed on or after January 1, 2012. Any offense committed before January 1,**
28 **2012, shall continue to be governed by ORS 153.018 as in effect immediately before January**
29 **1, 2012.**

33 **SECTION 9. Section 10 of this 2011 Act is added to and made a part of ORS chapter 137.**

34 **SECTION 10. Minimum fines for misdemeanors and felonies.** (1) **Unless a specific mini-**
35 **imum fine is provided by law, the minimum fine for a misdemeanor is \$100.**

36 (2) **Unless a specific minimum fine is provided by law, the minimum fine for a felony is**
37 **\$200.**

38 (3) **A court may waive payment of the minimum fine established by this section, in whole**
39 **or in part, if the court finds that requiring payment of the minimum fine would be incon-**
40 **sistent with justice in the case. In making its determination under this subsection, the court**
41 **shall consider:**

42 (a) **The financial resources of the defendant and the burden that payment of the mini-**
43 **imum fine will impose, with due regard to the other obligations of the defendant; and**

44 (b) **The extent to which that burden can be alleviated by allowing the defendant to pay**
45 **the monetary obligations imposed by the court on an installment basis or on other conditions**

1 **to be fixed by the court.**

2 **(4) This section does not affect the manner in which a court imposes or reduces mone-**
3 **tary obligations other than fines.**

4 **SECTION 11.** ORS 475.886 is amended to read:

5 475.886. (1) Except as authorized by ORS 475.005 to 475.285 and 475.840 to 475.980, it is unlawful
6 for any person to manufacture methamphetamine.

7 (2) Unlawful manufacture of methamphetamine is a Class B felony.

8 **(3) The minimum fine for unlawful manufacture of methamphetamine is \$1,000.**

9 **SECTION 12.** ORS 475.888 is amended to read:

10 475.888. (1) Except as authorized by ORS 475.005 to 475.285 and 475.840 to 475.980, it is unlawful
11 for any person to manufacture methamphetamine within 1,000 feet of the real property comprising
12 a public or private elementary, secondary or career school attended primarily by minors.

13 (2) Unlawful manufacture of methamphetamine within 1,000 feet of a school is a Class A felony.

14 **(3) The minimum fine for unlawful manufacture of methamphetamine within 1,000 feet**
15 **of a school is \$1,000.**

16 **SECTION 13.** ORS 475.890 is amended to read:

17 475.890. (1) Except as authorized by ORS 475.005 to 475.285 and 475.840 to 475.980, it is unlawful
18 for any person to deliver methamphetamine.

19 (2) Unlawful delivery of methamphetamine is a Class B felony.

20 (3) Notwithstanding subsection (2) of this section, unlawful delivery of methamphetamine is a
21 Class A felony if the delivery is to a person under 18 years of age.

22 **(4) The minimum fine for unlawful delivery of methamphetamine is \$500.**

23 **SECTION 14.** ORS 475.892 is amended to read:

24 475.892. (1) Except as authorized by ORS 475.005 to 475.285 and 475.840 to 475.980, it is unlawful
25 for any person to deliver methamphetamine within 1,000 feet of the real property comprising a public
26 or private elementary, secondary or career school attended primarily by minors.

27 (2) Unlawful delivery of methamphetamine within 1,000 feet of a school is a Class A felony.

28 **(3) The minimum fine for unlawful delivery of methamphetamine within 1,000 feet of a**
29 **school is \$500.**

30 **SECTION 15.** Section 10 of this 2011 Act and the amendments to ORS 475.886, 475.888,
31 475.890 and 475.892 by sections 11 to 14 of this 2011 Act apply only to offenses committed on
32 or after January 1, 2012.

33
34 **FINES FOR CRIMES TREATED AS CLASS A VIOLATIONS**
35 **AND FELONIES TREATED AS CLASS A MISDEMEANORS**
36

37 **SECTION 16.** ORS 161.566 is amended to read:

38 161.566. (1) Except as provided in subsection (4) of this section, a prosecuting attorney may elect
39 to treat any misdemeanor as a Class A violation. The election must be made by the prosecuting at-
40 torney orally at the time of the first appearance of the defendant or in writing filed on or before the
41 time scheduled for the first appearance of the defendant. If no election is made within the time al-
42 lowed, the case shall proceed as a misdemeanor.

43 (2) If a prosecuting attorney elects to treat a misdemeanor as a Class A violation under this
44 section, the court shall amend the accusatory instrument to reflect the charged offense as a Class
45 A violation and clearly denominate the offense as a Class A violation in any judgment entered in

1 the matter. Notwithstanding ORS 153.018, the *[maximum]* fine that a court may impose upon con-
2 viction of a violation under this section may not:

3 **(a) Be less than the presumptive fine established by section 2 of this 2011 Act for a Class**
4 **A violation; or**

5 **(b) Exceed** the amount provided in ORS 161.635 for the class of misdemeanor receiving violation
6 treatment.

7 (3) If a prosecuting attorney elects to treat a misdemeanor as a Class A violation under this
8 section, and the defendant fails to make any required appearance in the matter, the court may enter
9 a default judgment against the defendant in the manner provided by ORS 153.102. Notwithstanding
10 ORS 153.018, the *[maximum]* fine that the court may impose under a default judgment entered pur-
11 suant to ORS 153.102 *[is]* **may not:**

12 **(a) Be less than the presumptive fine established by section 2 of this 2011 Act for a Class**
13 **A violation; or**

14 **(b) Exceed** the maximum fine for the class of misdemeanor receiving violation treatment.

15 (4) A prosecuting attorney may not elect to treat misdemeanors created under ORS 811.540 or
16 813.010 as violations under the provisions of this section.

17 (5) The election provided for in this section may be made by a city attorney acting as prose-
18 cuting attorney in the case of municipal ordinance offenses, a county counsel acting as prosecuting
19 attorney under a county charter in the case of county ordinance offenses, and the Attorney General
20 acting as prosecuting attorney in those criminal actions or proceedings within the jurisdiction of the
21 Attorney General.

22 *[(6) Notwithstanding ORS 137.290 (1)(d), the unitary assessment imposed upon conviction of a vi-*
23 *olation under this section is the amount provided in ORS 137.290 for the misdemeanor receiving vio-*
24 *lation treatment.]*

25 **SECTION 17.** ORS 161.568 is amended to read:

26 161.568. (1) Except as provided in subsection (4) of this section, a court may elect to treat any
27 misdemeanor as a Class A violation for the purpose of entering a default judgment under ORS
28 153.102 if:

29 (a) A complaint or information has been filed with the court for the misdemeanor;

30 (b) The defendant has failed to make an appearance in the proceedings required by the court
31 or by law; and

32 (c) The court has given notice to the district attorney for the county and the district attorney
33 has informed the court that the district attorney does not object to treating the misdemeanor as a
34 Class A violation.

35 (2) If the court treats a misdemeanor as a Class A violation under this section, the court shall
36 amend the accusatory instrument to reflect the charged offense as a Class A violation and clearly
37 denominate the offense as a Class A violation in the judgment entered in the matter.

38 (3) Notwithstanding ORS 153.018, if the court treats a misdemeanor as a Class A violation under
39 this section, the *[maximum]* fine that the court may impose under a default judgment entered pur-

42 **A violation; or**

43 **(b) Exceed** the maximum fine for the class of misdemeanor receiving violation treatment.

44 (4) A court may not treat misdemeanors created under ORS 811.540 or 813.010 as violations
45 under the provisions of this section.

1 the conviction for which the sentence is imposed without imprisonment, [*fine*,] probationary super-
2 vision or conditions. **The judgment entered by the court shall include a monetary obligation**

12 **SECTION 21.** ORS 419C.459 is amended to read:

13 419C.459. [*In circumstances under which, if the youth offender were an adult, a fine not exceeding*
14 *a certain amount could be imposed under the Oregon Criminal Code, the court may impose such a fine*
15 *upon the youth offender. In determining whether to impose a fine and, if so, then in what amount, the*
16 *court shall consider whether the youth offender will be able to pay a fine and whether payment of a*
17 *fine is likely to have a rehabilitative effect on the youth offender. Fines ordered paid under this section*
18 *shall be collected by the clerk of the court.*] **If a youth is found to be within the jurisdiction of**
19 **the court under ORS 419C.005 by reason of committing an offense or by reason of committing**
20 **an act that would constitute an offense if committed by an adult, the youth offender is sub-**
21 **ject to the same fines, including the minimum fines established under sections 4 and 10 of**
22 **this 2011 Act, that are applicable to adults who commit the offense. In determining the**
23 **amount of the fine, the court shall consider the potential rehabilitative effect of a fine.**

24 **SECTION 22.** The amendments to ORS 419C.459 by section 21 of this 2011 Act apply only
25 to acts committed on or after January 1, 2012. Any act committed before January 1, 2012,
26 shall continue to be governed by ORS 419C.459 as in effect immediately before January 1,
27 2012.

31 **SECTION 23.** ORS 153.051 is amended to read:

32 153.051. A summons in a violation citation is sufficient if it contains the following:

33 (1) The name of the court, the name of the person cited, the date on which the citation was is-
34 sued, the name of the enforcement officer issuing the citation, and the time and place at which the
35 person cited is to appear in court.

36 (2) A statement or designation of the violation that can be readily understood by a person
37 making a reasonable effort to do so and the date, time and place at which the violation is alleged
38 to have been committed.

39 (3) A notice to the person cited that a complaint will be filed with the court based on the vio-
40 lation.

41 (4) The amount of the [*base*] **presumptive** fine, if any, fixed for the violation.

42 (5) A statement notifying the person that a monetary judgment may be entered against the per-
43 son for up to the maximum amount of fines, [*assessments*,] restitution and other costs allowed by law
44 for the violation if the person fails to make all required appearances at the proceedings.

45 **(6) A statement notifying the person that, if the person pleads no contest and delivers**

1 to the court the amount of the presumptive fine indicated on the citation, and the court
2 accepts the plea, the amount of the fine imposed against the defendant may not exceed the
3 amount of the presumptive fine indicated on the citation.

4 (7) A statement notifying the person that, if the person pleads no contest and delivers
5 to the court the amount of the presumptive fine indicated on the citation:

6 (a) The person may submit an explanation of the circumstances of the violation; and

7 (b) The court may consider the explanation in establishing the amount of the fine, but
8 in no event can the court impose a fine that is less than the minimum fine established under
9 section 4 of this 2011 Act.

10 (8) A statement notifying the person that, if the person pleads not guilty and requests a
11 trial, the court cannot impose a fine that is less than the minimum fine established under
12 section 4 of this 2011 Act unless the person is found not guilty, in which case no fine will be
13 imposed.

14 **SECTION 24.** The amendments to ORS 153.051 by section 23 of this 2011 Act apply only
15 to citations issued on or after January 1, 2012. Any citation issued before January 1, 2012,
16 shall continue to be governed by ORS 153.051 as in effect immediately before January 1, 2012.

22 (b) Make a first appearance in the manner provided in subsection [(3)] (4) of this section before
23 the time indicated in the summons.

34 of the following means:

35 (a) The defendant may submit to the court a written or oral request for a trial.

36 (b) The defendant may enter a plea of no contest by delivering to the court the summons[, **and**
37 a check or money order in the amount of the [*base*] **presumptive** fine set forth in the summons[,
38 *and a statement of matters in explanation or mitigation of the violation charged*]. The [*delivery of a*
39 *statement of matters in explanation or mitigation*] **entry of a plea** under the provisions of this para-
40 graph constitutes a waiver of trial and consent to the entry of a judgment forfeiting the [*base*]
41 **presumptive** fine [*based on the statement and any other testimony or written statements that may be*
42 *presented to the court by the citing officer or other witnesses*]. **A no contest plea under this section**
43 **is not subject to the requirements of ORS chapter 135 relating to the entry of pleas and, upon**
44 **receipt of the plea, the court may enter judgment against the defendant without taking fur-**
45 **ther evidence.**

1 *[(c) The defendant may execute the appearance, waiver of trial and plea of guilty that appears on*
2 *the summons and deliver the summons and a check or money order in the amount of the base fine set*
3 *forth in the summons to the court. The defendant may attach a statement of matters in explanation or*
4 *mitigation of the violation.]*

5 [(4) (5) The court may require that a defendant requesting a trial under subsection [(3)(a)] (4)
6 of this section deposit **an amount equal to** the [base] **presumptive** fine [specified under ORS
7 153.125 to 153.145] **established under sections 2 and 3 of this 2011 Act** or such other amount as
8 the court determines appropriate if the defendant has failed to appear in any court on one or more
9 other charges in the past. If the defendant does not deposit the amount specified by the court, the
10 defendant must personally appear in court at the time indicated in the summons. The amount de-
11 posited by the defendant may be applied against any fine imposed by the court, and any amount not
12 so applied shall be refunded to the defendant at the conclusion of the proceedings.

13 *[(5) If the defendant personally appears in court at the time indicated in the summons and enters*
14 *a plea of guilty, the judge shall consider any statement in explanation or mitigation made by the de-*
15 *fendant.]*

16 (6) The court may require a defendant to appear personally in any case, or may require that all
17 defendants appear in specified categories of cases.

18 (7) If a defendant has entered a no contest plea [*or guilty plea*] in the manner provided in sub-
19 section [(3)(b) or (c)] (4) of this section, and the court determines that the [base] **presumptive** fine
20 [amount] is not adequate by reason of previous convictions of the defendant, the nature of the of-
21 fense charged or other circumstances, the court may require that a trial be held unless an additional
22 fine amount is paid by the defendant before a specified date. Notice of an additional fine amount
23 under this subsection may be given to the defendant by mail. In no event may the court require a
24 total fine amount in excess of the maximum fine established for the violation by statute.

25 (8) If a defendant fails to make a first appearance on a citation for a traffic violation, as defined
26 by ORS 801.557, fails to make a first appearance on a citation for a violation of ORS 471.430, or fails
27 to appear at any other subsequent time set for trial or other appearance, the driving privileges of
28 the defendant are subject to suspension under ORS 809.220.

29 **SECTION 25a.** ORS 153.099 is amended to read:

30 153.099. (1) If a trial is held in a violation proceeding, the court shall enter a judgment based
31 on the evidence presented at the trial.

32 (2) If the defendant appears and enters a plea of no contest in the manner described in ORS
33 153.061 [(3)(b),] (4) and a trial is not otherwise required by the court or by law, the court shall make
34 a decision based on the citation[, *the statement filed by the defendant and any other information or*
35 *materials submitted to the court*]. **The court may consider any statement of explanation sub-**
36 **mitted with the plea.**

37 *[(3) If the defendant enters a plea of guilty in the manner described in ORS 153.061 (3)(c), a trial*
38 *is not otherwise required by the court or by law and the court accepts the plea of guilty, judgment shall*
39 *be entered against the defendant based on the violation citation.]*

40 **SECTION 26.** **The amendments to ORS 153.061 and 153.099 by sections 25 and 25a of this**
41 **2011 Act apply only to violation citations issued, and violation proceedings commenced by**
42 **citations issued, on or after January 1, 2012. Any citation issued, and violation proceeding**
43 **commenced by a citation issued, before January 1, 2012, shall continue to be governed by**
44 **ORS 153.061 as in effect immediately before January 1, 2012.**

JUDGMENTS

SECTION 27. ORS 153.090 is amended to read:

153.090. (1) Judgments entered under this chapter may include:

(a) Imposition of a sentence to pay a fine;

(b) Costs[, *assessments*] and restitution authorized by law;

[(c) A requirement that the fine, costs, assessments and restitution, if any, be paid out of any base fine;]

[(d) Remission of any balance of a base fine to the defendant or to any other person designated by the defendant; and]

(c) A requirement that the fine, costs and restitution, if any, be paid out of the presumptive fine;

(d) Remission of any balance of a presumptive fine to the defendant; and

(e) Any other provision authorized by law.

(2) Notwithstanding ORS 137.106, if the court orders restitution in a default judgment entered under ORS 153.102, a defendant may allege an inability to pay the full amount of monetary sanctions imposed, including restitution, and request a hearing to determine whether the defendant is unable to pay or to establish a payment schedule by filing a written request with the court within one year after the entry of the judgment. The court shall set a hearing on the issue of the defendant's ability to pay upon receipt of the request and shall give notice to the district attorney. The district attorney shall give notice to the victim of the date, time and place of the hearing. The court may determine a payment schedule for monetary sanctions imposed, including restitution ordered under this subsection, if the defendant establishes at the hearing that the defendant is unable to pay the ordered restitution in full.

(3) If a trial is held in a violation proceeding, or a default judgment is entered against the defendant under ORS 153.102, the court may impose any fine within the statutory limits for the violation. If a defendant pleads no contest under ORS 153.061 [(3)(b)] **(4)**[, or pleads guilty under ORS 153.061 (3)(c),] and the court accepts the plea and enters judgment against the defendant, the amount of the fine imposed against the defendant by the court may not exceed the [amount of the base] **presumptive** fine established for the violation under [ORS 153.125 to 153.145] **sections 2 and 3 of this 2011 Act.**

(4) A judge may suspend operation of any part of a judgment entered under this chapter upon condition that the defendant pay the nonsuspended portion of a fine within a specified period of time. If the defendant fails to pay the nonsuspended portion of the fine within the specified period of time, the suspended portion of the judgment becomes operative without further proceedings by the court and the suspended portion of the fine becomes immediately due and payable.

(5) The court may not recommend a suspension of the defendant's driving privileges unless a trial has been required. The failure of the defendant to appear at the trial does not prevent the court from recommending suspension of the defendant's driving privileges.

(6) Entry of a default judgment under ORS 153.102 does not preclude the arrest and prosecution of the defendant for the crime of failure to appear in a violation proceeding under ORS 153.992.

(7) If a person holds a commercial driver license, a court may not defer entry of a judgment or allow an individual to enter into a diversion program that would prevent a conviction for a traffic offense from appearing on the driving record of the holder. This subsection applies to all traffic offenses, whether committed while driving a motor vehicle or a commercial motor vehicle, but does

1 not apply to parking violations. For purposes of this subsection, a person holds a commercial driver
2 license if on the date of the commission of the offense the person holds a commercial driver license
3 issued by the Department of Transportation or the licensing agency of another jurisdiction that is:

- 4 (a) Not expired or if expired, expired less than one year; or
- 5 (b) Suspended, but not canceled or revoked.

6 **SECTION 28. The amendments to ORS 153.090 by section 27 of this 2011 Act apply only**
7 **to judgments in violation proceedings commenced by citations issued on or after January 1,**
8 **2012. Any judgment in a violation proceeding commenced by a citation issued before January**

14 subsequent prosecution for the other. However, evidence of the first conviction shall not be admis-
15 sible in any subsequent prosecution for the other offense.

16 (2) Notwithstanding ORS 43.130 and 43.160, *[no]* a plea, finding or *[proceeding upon any violation*
17 *shall]* **judgment in a violation proceeding, or the fact that a violation proceeding has been**
18 **brought against a defendant, may not** be used for the purpose of res judicata or collateral
19 estoppel, *[nor shall any plea, finding or proceeding upon any violation be admissible]* **or be admitted**
20 as evidence in any civil proceeding.

21 **SECTION 30.** ORS 41.905 is amended to read:

22 41.905. *[(1)]* A **plea to a charge of a traffic crime, as defined in ORS 801.545, and any judg-**
23 **ment of conviction or acquittal of a person charged with a traffic [offense] crime, as defined by**
24 **ORS 801.545, [is] are** not admissible in the trial of a subsequent civil action arising out of the same
25 accident or occurrence to prove or negate the facts upon which such judgment was rendered.

26 *[(2) A plea of guilty by a person to a traffic offense may be admitted as evidence in the trial of a*
27 *subsequent civil action arising out of the same accident or occurrence as an admission of the person*
28 *entering the plea, and for no other purpose.]*

40 **(Priorities for Application of Payments)**

41
42 **SECTION 32. Sections 33 to 38 of this 2011 Act are added to and made a part of ORS**
43 **chapter 137.**

44 **SECTION 33. Priorities for application of payments on judgments in criminal actions. (1)**
45 **There are five levels of priority for application of payments on judgments of conviction in**

1 criminal actions, with Level I obligations having the highest priority and Level V having the
2 lowest priority. All payments on a judgment of conviction in a criminal action shall be applied
3 first against the unpaid obligations in the level with highest priority until those obligations
4 have been paid in full, and shall then be applied against the obligations in the level with the
5 next highest level of priority, until all obligations under the judgment have been paid in full.

6 (2) Except as provided in section 35 of this 2011 Act, if there is more than one person or
7 public body to whom an obligation is payable under a level, the court shall divide each pay-
8 ment based on each person's or public body's proportionate share of the total amount of
9 obligations in that level.

10 **SECTION 34. Level I obligations.** Compensatory fines under ORS 137.101 are Level I ob-
11 ligations.

12 **SECTION 35. Level II obligations.** (1) There are two types of Level II obligations:

13 (a) Type 1 obligations include awards of restitution as defined in ORS 137.103, awards of
14 restitution under ORS 419C.450 and money awards made under ORS 811.706.

15 (b) Type 2 obligations include all fines and other monetary obligations payable to the
16 state for which the law does not expressly provide other disposition, including fines payable
17 to the state by justice and municipal courts under sections 6b, 48 and 49 of this 2011 Act.

18 (2) If a judgment contains both types of Level II obligations, the court shall apply 50
19 percent of amounts creditable to Level II obligations to Type 1 obligations and 50 percent of
20 the amounts to Type 2 obligations, until all obligations in one of the two types have been paid
21 in full. All subsequent amounts creditable to Level II obligations shall be applied against the
22 other type of obligations until those obligations have been paid in full.

23 (3) If there is more than one person for whose benefit a Type 1 money award has been
24 made, the clerk shall pay the moneys credited to Type 1 obligations in the following order
25 of priority:

26 (a) If the judgment contains a money award payable to the person or persons against
27 whom the defendant committed the offense, the clerk shall first pay all moneys credited to
28 Type 1 obligations to those persons, and shall continue to do so until all those obligations
29 are paid in full. If there is more than one person to whom an obligation is payable under this
30 paragraph, the court shall divide each payment under this paragraph based on each person's
31 proportionate share of the total amount of obligations subject to payment under this para-
32 graph.

33 (b) If the judgment contains a money award payable to the Criminal Injuries Compens-
34 ation Account, the clerk shall thereafter transfer moneys credited to Type 1 obligations to
35 the account until the award is paid in full.

36 (c) If the judgment contains a money award payable to any other victims, as defined in
37 ORS 137.103, the clerk shall thereafter pay the moneys credited to Type 1 obligations to those
38 victims until those victims are paid in full.

39 **SECTION 36. Level III obligations.** Level III obligations are fines payable to a county or
40 city.

41 **SECTION 37. Level IV obligations.** Level IV obligations are amounts that the law ex-
42 pressly directs be paid to a specific account or public body as defined in ORS 174.109.

43 **SECTION 38. Level V obligations.** Level V obligations are amounts payable for reward
44 reimbursement under ORS 131.897.

45 **SECTION 39.** Sections 33 to 38 of this 2011 Act and the repeal of ORS 137.295 by section

1 **118 of this 2011 Act apply to all payments on judgments of conviction of an offense, without**
2 **regard to whether the offense was committed before, on or after January 1, 2012.**

4 **(Application of Security Deposits Against**
5 **Child Support Obligation)**
6

7 **SECTION 40.** ORS 25.715 is amended to read:

8 25.715. (1) The court may order that the portion of a security deposit made under ORS 135.265
9 that would otherwise be returned to the person who made the deposit or the amount of child support
10 arrearages, whichever is less, be paid to an obligee or the Division of Child Support of the Depart-
11 ment of Justice if:

12 (a) The defendant is an obligor who owes child support arrearages;

13 (b) The obligee or the administrator has filed a motion requesting the court to make such an
14 order;

15 (c) The obligee or the administrator has served the defendant with a copy of the motion;

16 (d) The defendant has an opportunity to respond and request a hearing; and

17 (e) The court has determined that such an order is appropriate.

18 (2) The court may order that a portion of a security [amount] **deposit that is** forfeited under
19 ORS 135.280 be paid to the division and be applied to any unsatisfied child support judgment and
20 to provide security for child support payments in accordance with ORS 25.230 if:

21 (a) The defendant is an obligor who owes child support;

22 (b) The administrator has filed a motion requesting the court to make such an order;

23 (c) The motion specifies the amount to be applied to the child support judgment under ORS
24 135.280; and

25 (d) The court has determined that such an order is appropriate.

26 **SECTION 41.** ORS 135.280 is amended to read:

27 135.280. (1) Upon failure of a person to comply with any condition of a release agreement or
28 personal recognizance, the court having jurisdiction may, in addition to any other action provided
29 by law, issue a warrant for the arrest of the person at liberty upon a personal recognizance, condi-
30 tional or security release.

31 (2) A warrant issued under subsection (1) of this section by a municipal judge may be executed
32 by any peace officer authorized to execute arrest warrants.

33 (3) If the defendant does not comply with the conditions of the release agreement, the court
34 having jurisdiction shall enter an order declaring the entire security amount to be forfeited. Notice
35 of the order of forfeiture shall be given forthwith by personal service, by mail or by such other
36 means as are reasonably calculated to bring to the attention of the defendant and, if applicable, of
37 the sureties the order of forfeiture. If, within 30 days after the court declares the forfeiture, the
38 defendant does not appear or satisfy the court having jurisdiction that appearance and surrender
39 by the defendant was, or still is, impossible and without fault of the defendant, the court shall enter
40 judgment for the state, or appropriate political subdivision thereof, against the defendant and, if
41 applicable, the sureties for the entire security amount set under ORS 135.265 and the costs of the
42 proceedings. At any time before or after entry of the judgment, the defendant or the sureties may
43 apply to the court for a remission of the forfeiture or to modify or set aside the judgment. The court,
44 upon good cause shown, may remit the forfeiture or any part thereof or may modify or set aside the
45 judgment as in other criminal cases, except the portion of the security [amount] **deposit** that the

1 court ordered to be applied to child support under subsection (4) of this section, as the court con-
2 sidered reasonable under the circumstances of the case. The court shall adopt procedures to ensure
3 that the amount deposited under ORS 135.265 is available for a reasonable period of time for dis-
4 position under subsection (4) of this section.

5 (4) After entry of a judgment for the state, the court, upon a motion filed under ORS 25.715,
6 may order that a portion of the security [*amount*] **deposit** be applied to any unsatisfied child support
7 award owed by the defendant and to provide security for child support payments in accordance with

10 (a) Is limited to the amount deposited under ORS 135.265 (2);

11 (b) May not exceed 66 percent of the entire security amount set under ORS 135.265 **if the de-**
12 **posit has been made under ORS 135.265 (3);** and

13 (c) Does not reduce the money award in the judgment entered under subsection (3) of this sec-
14 tion that is owed to the state.

15 (5) When judgment is entered in favor of the state, or any political subdivision of the state, on
16 any security given for a release, the judgment may be enforced as a judgment in a civil action. If
17 entered in circuit court, the judgment shall be entered in the register, and the clerk of the court
18 shall note in the register that the judgment creates a judgment lien. The district attorney, county
19 counsel or city attorney may have execution issued on the judgment and deliver same to the sheriff
20 to be executed by levy on the deposit or security amount made in accordance with ORS 135.265, or

22 shall be used to satisfy the judgment and costs and paid into the treasury of the municipal corpo-

25 the offense was defined by a statute of this state and the judgment was entered by a justice court,
26 or paid over as directed by the State Court Administrator for deposit in the Criminal Fine [*and*
27 *Assessment*] Account [*created under ORS 137.300*], if the offense was defined by a statute of this
28 state and the judgment was entered by a circuit court. The provisions of this section shall not apply
29 to [*base fine*] amounts deposited upon appearance under ORS 153.061.

30 (6) When the judgment of forfeiture is entered, the security deposit or deposit with the clerk is,
31 by virtue of the judgment alone and without requiring further execution, forfeited to and may be
32 kept by the state or its appropriate political subdivision. Except as provided in subsection (4) of this
33 section, the clerk shall reduce, by the value of the deposit so forfeited, the debt remaining on the
34 judgment and shall cause the amount on deposit to be transferred to the revenue account of the
35 state or political subdivision thereof entitled to receive the proceeds of execution under this section.

36 (7) The stocks, bonds, personal property and real property shall be sold in the same manner as
37 in execution sales in civil actions and the proceeds of such sale shall be used to satisfy all court

43 general governmental expenses if the offense was defined by a statute of this state and the judgment

5 **SECTION 42.** ORS 151.487 is amended to read:

6 151.487. (1) If in determining that a person is financially eligible for appointed counsel under
7 ORS 151.485, the court finds that the person has financial resources that enable the person to pay
8 in full or in part the administrative costs of determining the eligibility of the person and the costs
9 of the legal and other services to be provided at state expense that are related to the provision of
10 appointed counsel, the court shall [*order*] **enter a limited judgment requiring that** the person
11 [*to*] pay to the Public Defense Services Account in the General Fund, through the clerk of the court,
12 the amount that it finds the person is able to pay without creating substantial hardship in providing
13 basic economic necessities to the person or the person's dependent family. The amount that a court
14 may [*order*] **require** the person to pay is subject to the guidelines and procedures issued by the
15 Public Defense Services Commission as provided in subsection (4) of this section.

16 (2) Failure to [*obey an order*] **comply with the requirements of a limited judgment entered**
17 under this section is not grounds for contempt or grounds for withdrawal by the appointed
18 attorney[, *but any part of the amount ordered under this section and not paid may be:*]

19 [*(a) Enforced against the person as if the order is a civil judgment; or*]

20 [*(b) Enforced as otherwise permitted by law.*]

21 (3) Except as authorized in this section, no person, organization or governmental agency may
22 request or accept a payment or promise of payment for assisting in the representation of a person
23 by appointment.

24 (4) The commission shall promulgate and issue guidelines and procedures:

25 (a) For the determination of persons provided with appointed counsel who have some financial
26 resources to pay in full or in part the administrative, legal and other costs under subsection (1) of
27 this section; and

28 (b) Regarding the amounts persons may be required to pay by a court under subsection (1) of
29 this section.

30 (5) The determination that a person is able to pay or partially able to pay, or that a person no
31 longer has the ability to pay the amount ordered in subsection (1) of this section, is subject to re-
32 view at any time by the court.

33 **SECTION 43.** ORS 151.505 is amended to read:

34 151.505. (1) At the conclusion of a case or matter in which the first accusatory instrument or
35 petition in the trial court was filed after January 1, 1998, and in which the court appointed counsel
36 to represent a person, a trial, appellate or post-conviction court may include in its judgment [*an*
37 *order*] **a money award requiring** that the person repay in full or in part the administrative costs
38 of determining the eligibility of the person for appointed counsel, and the costs of the legal and
39 other services that are related to the provision of appointed counsel, **that have not previously**
40 **been required to be paid under a limited judgment entered under ORS 151.487. An award un-**
41 **der this section is a monetary obligation payable to the state.**

42 (2) Costs [*repayable*] **that may be included in a money award** under this section include a
43 reasonable attorney fee for counsel appointed to represent the person and a reasonable amount for
44 expenses authorized under ORS 135.055. A reasonable attorney fee is presumed to be a reasonable
45 number of hours at the hourly rate authorized by the Public Defense Services Commission under

3 *[(3) Costs repayable under this section do not include costs imposed and paid under a previous*
4 *order under ORS 151.487, but may include costs imposed under an order under ORS 151.487 that are*
5 *unpaid at the time the judgment is filed.]*

6 *[(4) (3) The court may not [order] **require** a person to pay costs under this section unless the*
7 *person is or may be able to pay the costs. In determining the amount and method of payment of*
8 *costs, the court shall take account of the financial resources of the person and the nature of the*
9 *burden that payment of costs will impose.*

10 *[(5) (4) A person who has been [ordered] **required** to pay costs under this section and who is*
11 *not in contumacious default in the payment of the costs may at any time petition the court for re-*

25 151.225. (1) There is created a Public Defense Services Account in the General Fund. The Public

28 persons for which the commission is responsible by law.

33 (3),] 419A.211, 419B.198 (1) or 419C.203 (1) shall be deposited in a separate subaccount created in the
34 Public Defense Services Account to be used by the public defense services executive director to
35 reimburse the actual costs and expenses, including personnel expenses, incurred in administration

3 **of the wildlife laws, or a rule adopted pursuant to the wildlife laws, that does not involve the**

6 (3) **A violation of a provision of the wildlife laws, or a rule adopted pursuant to the**
7 **wildlife laws, that involves the taking of wildlife, other than nongame mammals and game**
8 **birds, is a Class A violation if the offense is committed without a culpable mental state.**

9 (4) **A violation of a provision of the wildlife laws, or a rule adopted pursuant to the**
10 **wildlife laws, that involves the taking of nongame mammals or game birds is a Class C vio-**
11 **lation if the offense is committed without a culpable mental state.**

28 tion belonging to the individual with whom the scrap metal business conducts the transaction.

29 (vii) A photograph of, or video surveillance recording depicting, a recognizable facial image of
30 the individual with whom the scrap metal business conducts the transaction.

31 (viii) A general description of the nonferrous metal property or private metal property that
32 constitutes the predominant part of the transaction. The description must include any identifiable
33 marks on the property, if readily discernible, and must specify the weight, quantity or volume of the
34 nonferrous metal property or private metal property.

35 (b) Require the individual with whom the scrap metal business conducts a transaction to sign
36 and date a declaration printed in conspicuous type, either on the record described in this subsection
37 or on a receipt issued to the individual with whom the scrap metal business conducts the trans-

1 (c) Require the employee of the scrap metal business who conducts the transaction on behalf
2 of the scrap metal business to witness the individual sign the declaration, and also to sign and date
3 the declaration in a space provided for that purpose.

4 (d) For one year following the date of the transaction, keep a copy of the record and the signed
5 and dated declaration described in this subsection. If the scrap metal business uses a video surveil-
6 lance recording as part of the record kept in accordance with this subsection, the scrap metal
7 business need not keep the video surveillance recording for one year, but shall retain the video
8 surveillance recording for a minimum of 30 days following the date of the transaction. The scrap
9 metal business shall at all times keep the copies at the current place of business for the scrap metal
10 business.

11 (2) A scrap metal business engaged in business in this state may not do any of the following:

23 (o) Drug outlets, other than pharmacies or institutional drug outlets, delinquent renewal fee,
24 which fee shall not exceed \$100.

25 *[(6) All moneys collected either as costs or fines under ORS 435.010 to 435.130, 453.175, 453.185*
26 *and 453.990 and this chapter shall be paid by the magistrate or other officer receiving them to the*
27 *treasurer of the county where the prosecution is conducted. These moneys shall be applied, first, to the*
28 *payment of the costs of such prosecution. The remainder shall be paid by the county treasurer into the*

11 (5) Violation of ORS 823.051 is [*punishable, upon conviction, by a fine of not more than \$100 or*
12 *imprisonment for not more than 30 days, or both*] a **Class C misdemeanor**. Any motor carrier or
13 railroad that knowingly permits the violation of ORS 823.051 shall forfeit, upon conviction, not more
14 than \$1,000 for each offense.

15 (6) In construing and enforcing this section, the act, omission or failure of any officer, agent or
16 other person acting for or employed by any motor carrier or railroad shall in every case be deemed
17 to be the act, omission or failure of such motor carrier or railroad. With respect to any violation
18 of any statute administered by the department regarding motor carriers or railroads, any penalty
19 provision applying to such a violation by a motor carrier or railroad shall apply to such a violation
20 by any other person.

21 (7) Except as provided in ORS 824.019 and 825.326, and except when provided by law that a
22 penalty, [*fine,*] forfeiture or other sum be paid to the aggrieved party, all penalties[, *fin*es] or forfei-
23 tures collected from persons subject to the regulatory authority of the department under ORS
24 chapters 823, 824, 825 and 826 shall be paid into the General Fund and credited to the Motor Carrier
25 Account if collected from a motor carrier and to the Railroad Fund created under ORS 824.014 (1)
26 if collected from a railroad.

27 (8) Violation of ORS 823.105 is punishable, after issuance of a final order by the department, by
28 a civil penalty of not more than \$5,000 for each offense.

29 (9) Violation of ORS 823.105 is a **specific fine** violation punishable by a fine of not more than
30 \$5,000 for each offense.

31 (10) Civil penalties under this section shall be imposed in the manner provided by ORS 183.745.

32 **SECTION 307.** ORS 824.014 is amended to read:

33 824.014. (1) The Railroad Fund is established separate and distinct from the General Fund. In-
34 terest earned, if any, shall inure to the benefit of the Railroad Fund.

35 (2) All fees, [*fin*es,] penalties and other moneys collected by the Department of Transportation
36 under ORS 824.010 and 824.012 shall be paid by the department into the State Treasury within 30
37 days after the collection thereof, and shall be placed by the State Treasurer to the credit of the
38 Railroad Fund created by subsection (1) of this section. The fees, [*fin*es,] penalties and other moneys
39 collected from railroads shall be used only for the purpose of paying the expenses of the department
40 in performing the duties imposed by law upon the department in respect to railroads.

41 **SECTION 308.** ORS 825.990 is amended to read:

42 825.990. (1) Except as otherwise provided in subsection (2) of this section, every person who vi-
43 olates or procures, aids or abets violation of this chapter and any person who refuses or fails to
44 obey any order, decision or rule, made under or pursuant to this chapter commits a Class A traffic
45 violation.

1 (2) Knowingly violating an out-of-service notice issued under authority of the Department of
2 Transportation is a Class A misdemeanor.

3 (3) A person is subject to the penalties under subsection (4) of this section if the person know-
4 ingly:

5 (a) Transports any hazardous waste listed under ORS 466.005 or rules adopted thereunder to a
6 facility that does not have appropriate authority to receive the waste under ORS 466.005 to 466.385
7 and 466.992.

8 (b) Disposes of any hazardous waste listed under ORS 466.005 or rules adopted thereunder
9 without appropriate authority under ORS 466.005 to 466.385 and 466.992.

10 (c) Materially violates terms of any permit or authority issued to the person under this chapter
11 or ORS 466.005 to 466.385 and 466.992 in the transporting or disposing of hazardous waste.

12 (d) Makes any false material statement or representation in any application, label, manifest, re-
13 cord, report, permit or other document filed, maintained or used for purposes of compliance with
14 requirements under this chapter for the safe transportation of hazardous wastes.

15 (e) Fails to include material information required under rules of the Department of Transporta-
16 tion in any application for any permit or authority to transport hazardous waste under this chapter.

17 (f) Violates any rules adopted by the Department of Transportation concerning the transporta-
18 tion of hazardous wastes.

19 (4) Subject to ORS 153.022, violation of subsection (3) of this section is [*subject to the penalty*
20 *of a fine of not more than \$10,000 for each day of violation, imprisonment of not more than six months,*
21 *or both*] a **Class B misdemeanor**.

22 **SECTION 309. ORS 165.475, 165.480, 165.485, 165.490, 165.495, 165.505, 165.510, 165.515,**
23 **165.520, 221.923 and 632.620 are repealed.**

24 **SECTION 310. The amendments to statutes by sections 151 to 308 of this 2011 Act and**
25 **the repeal of statutes by section 309 of this 2011 Act apply only to offenses committed on or**
26 **after January 1, 2012.**

31 **the convenience of the reader and do not become part of the statutory law of this state or**
32 **express any legislative intent in the enactment of this 2011 Act.**
