**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies crime of prostitution.

Creates crime of patronizing a prostitute. Punishes by maximum of one year's imprisonment, \$6,250 fine, or both, when person patronized is 18 years of age or older. Punishes by maximum of one year's imprisonment, \$20,000 fine, or both, when person patronized is under 18 years of age. Requires court to impose mandatory minimum penalties when person patronized is under 18 years of age.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 167.007 is amended to read:

6 167.007. (1) A person commits the crime of prostitution if[.]

7 [(a)] the person engages in, or offers or agrees to engage in, sexual conduct or sexual contact  
8 in return for a fee.[: or]

9 [(b) *The person pays or offers or agrees to pay a fee to engage in sexual conduct or sexual*  
10 *contact.*]

11 (2) Prostitution is a Class A misdemeanor.

12 **SECTION 2.** Section 3 of this 2011 Act is added to and made a part of ORS 167.007 to  
13 **167.017.**

14 **SECTION 3.** (1) A person commits the crime of patronizing a prostitute if the person  
15 pays, or offers or agrees to pay, a fee to engage in sexual conduct or sexual contact.

16 (2) Patronizing a prostitute is a Class A misdemeanor.

17 (3)(a) When a person convicted of violating this section is 18 years of age or older at the  
18 time the offense is committed and the person paid, or offered or agreed to pay, a fee to a  
19 minor to engage in sexual conduct or sexual contact, in addition to any other sentence that  
20 may be imposed, the court shall impose and may not suspend the sentence described in  
21 paragraph (b) of this subsection.

22 (b) Notwithstanding ORS 161.635, the mandatory minimum sentences that apply to para-  
23 graph (a) of this subsection are as follows:

24 (A) For a person's first conviction, a fine in the amount of \$10,000.

25 (B) For a person's second conviction, a fine in the amount of \$20,000 and a term of

1 **incarceration of at least seven days.**

2 **(C) For a person's third or subsequent conviction, a fine in the amount of \$20,000 and a**  
3 **term of incarceration of at least 30 days.**

4 **(c) Notwithstanding paragraphs (a) and (b) of this subsection, if the court determines**  
5 **that the person is unable to pay the full amount of the mandatory minimum fine, the court**  
6 **shall impose and may not suspend a fine in an amount the court determines the person is**  
7 **able to pay.**

8 **(d) In a prosecution in which it is alleged that this subsection applies, the state need not**  
9 **prove that the person knew the minor was under 18 years of age and it is no defense that**  
10 **the person did not know the minor's age or that the person reasonably believed the minor**  
11 **to be 18 years of age or older.**

12 **(e) As used in this subsection, "minor" means a person under 18 years of age.**

13 **SECTION 4.** ORS 12.117 is amended to read:

14 12.117. (1) Notwithstanding ORS 12.110, 12.115 or 12.160, an action based on conduct that con-  
15 stitutes child abuse or conduct knowingly allowing, permitting or encouraging child abuse that oc-  
16 curs while the person is under 18 years of age must be commenced before the person attains 40  
17 years of age, or if the person has not discovered the causal connection between the injury and the  
18 child abuse, nor in the exercise of reasonable care should have discovered the causal connection  
19 between the injury and the child abuse, not more than five years from the date the person discovers  
20 or in the exercise of reasonable care should have discovered the causal connection between the  
21 child abuse and the injury, whichever period is longer.

22 (2) As used in subsection (1) of this section, "child abuse" means any of the following:

23 (a) Intentional conduct by an adult that results in:

24 (A) Any physical injury to a child; or

25 (B) Any mental injury to a child which results in observable and substantial impairment of the  
26 child's mental or psychological ability to function caused by cruelty to the child, with due regard  
27 to the culture of the child;

28 (b) Rape of a child, which includes but is not limited to rape, sodomy, unlawful sexual pene-  
29 tration and incest, as those acts are defined in ORS chapter 163;

30 (c) Sexual abuse, as defined in ORS chapter 163, when the victim is a child; or

31 (d) Sexual exploitation of a child, including but not limited to:

32 (A) Conduct constituting violation of ORS 163.435 and any other conduct which allows, employs,  
33 authorizes, permits, induces or encourages a child to engage in the performing for people to observe  
34 or the photographing, filming, tape recording or other exhibition which, in whole or in part, depicts  
35 sexual conduct or contact; and

36 (B) Allowing, permitting, encouraging or hiring a child to engage in prostitution **or to patronize**  
37 **a prostitute**, as defined in ORS chapter 167.

38 (3) Nothing in this section creates a new cause of action or enlarges any existing cause of  
39 action.

40 **SECTION 5.** ORS 90.396 is amended to read:

41 90.396. (1) Except as provided in subsection (2) of this section, after at least 24 hours' written  
42 notice specifying the acts and omissions constituting the cause and specifying the date and time of  
43 the termination, the landlord may terminate the rental agreement and take possession as provided  
44 in ORS 105.105 to 105.168, if:

45 (a) The tenant, someone in the tenant's control or the tenant's pet seriously threatens to inflict

1 substantial personal injury, or inflicts any substantial personal injury, upon a person on the prem-  
2 ises other than the tenant;

3 (b) The tenant or someone in the tenant's control recklessly endangers a person on the premises  
4 other than the tenant by creating a serious risk of substantial personal injury;

5 (c) The tenant, someone in the tenant's control or the tenant's pet inflicts any substantial per-  
6 sonal injury upon a neighbor living in the immediate vicinity of the premises;

7 (d) The tenant or someone in the tenant's control intentionally inflicts any substantial damage  
8 to the premises or the tenant's pet inflicts substantial damage to the premises on more than one  
9 occasion;

10 (e)(A) The tenant intentionally provided substantial false information on the application for the  
11 tenancy within the past year;

12 (B) The false information was with regard to a criminal conviction of the tenant that would have  
13 been material to the landlord's acceptance of the application; and

14 (C) The landlord terminates the rental agreement within 30 days after discovering the falsity  
15 of the information; or

16 (f) The tenant, someone in the tenant's control or the tenant's pet commits any act that is out-  
17 rageous in the extreme, on the premises or in the immediate vicinity of the premises. For purposes  
18 of this paragraph, an act is outrageous in the extreme if the act is not described in paragraphs (a)  
19 to (e) of this subsection, but is similar in degree and is one that a reasonable person in that com-  
20 munity would consider to be so offensive as to warrant termination of the tenancy within 24 hours,  
21 considering the seriousness of the act or the risk to others. An act that is outrageous in the extreme  
22 is more extreme or serious than an act that warrants a 30-day termination under ORS 90.392. Acts  
23 that are "outrageous in the extreme" include, but are not limited to, the following acts by a person:

24 (A) Prostitution, **patronizing a prostitute** or [*promotion of*] **promoting** prostitution, as de-  
25 scribed in ORS 167.007 and 167.012 **and section 3 of this 2011 Act**;

26 (B) Manufacture, delivery or possession of a controlled substance, as described in ORS 475.005,  
27 but not including:

28 (i) The medical use of marijuana in compliance with ORS 475.300 to 475.346;

29 (ii) Possession of, or delivery for no consideration of, less than one avoirdupois ounce of  
30 marijuana as described in ORS 475.860 (3) or 475.864 (3); or

31 (iii) Possession of prescription drugs;

32 (C) Intimidation, as described in ORS 166.155 and 166.165; or

33 (D) Burglary as described in ORS 164.215 and 164.225.

34 (2) If the cause for a termination notice given pursuant to subsection (1) of this section is based  
35 upon the acts of the tenant's pet, the tenant may cure the cause and avoid termination of the  
36 tenancy by removing the pet from the premises prior to the end of the notice period. The notice  
37 must describe the right of the tenant to cure the cause. If the tenant returns the pet to the premises  
38 at any time after having cured the violation, the landlord, after at least 24 hours' written notice  
39 specifying the subsequent presence of the offending pet, may terminate the rental agreement and  
40 take possession as provided in ORS 105.105 to 105.168. The tenant does not have a right to cure this  
41 subsequent violation.

42 (3) For purposes of subsection (1) of this section, someone is in the tenant's control if that per-  
43 son enters or remains on the premises with the tenant's permission or consent after the tenant  
44 reasonably knows or should know of that person's act or likelihood to commit any act of the type  
45 described in subsection (1) of this section.

1 (4) An act can be proven to be outrageous in the extreme even if the act is one that does not  
2 violate a criminal statute. Notwithstanding the references to criminal statutes in subsection (1)(f)  
3 of this section, the landlord's burden of proof in an action for possession under subsection (1) of this  
4 section is the civil standard of proof by a preponderance of the evidence.

5 (5) If a good faith effort by a landlord to terminate the tenancy under subsection (1)(f) of this  
6 section and to recover possession of the rental unit under ORS 105.105 to 105.168 fails by decision  
7 of the court, the landlord may not be found in violation of any state statute or local ordinance re-  
8 quiring the landlord to remove that tenant upon threat of fine, abatement or forfeiture as long as  
9 the landlord continues to make a good faith effort to terminate the tenancy.

20 not been decontaminated and certified as fit for use under ORS 453.885 within 180 days after the  
21 determination under ORS 453.876; and

22 (d) Any place where activity involving the unauthorized delivery, manufacture or possession of  
23 a controlled substance, as defined in ORS 475.005, occurs or any place wherein are kept, stored or  
24 located any of the devices, equipment, things or substances used for unauthorized delivery, manu-  
25 facture or possession of a controlled substance. As used in this paragraph, "devices, equipment,  
26 things" does not include hypodermic syringes or needles. This paragraph does not apply to acts that  
27 constitute violations under ORS 475.860 or 475.864.

28 (2) Nothing in ORS 105.550 to 105.600, 166.715 and 167.158 applies to property to the extent that  
29 the devices, equipment, things or substances that are used for delivery, manufacture or possession  
30 of a controlled substance are kept, stored or located in or on the property for the purpose of lawful  
31 sale or use of these items.

29 (C) Any conspiracy to commit any of the foregoing crimes;

30 (d) A statement of the details, if known, of the particular crime alleged under paragraph (c) of  
31 this subsection;

32 (e) A particular description of the nature and location of the facilities from which or the place  
33 where the wire, electronic or oral communication is to be intercepted, if known;

34 (f) A particular description of the type of wire, electronic or oral communication sought to be  
35 intercepted;

36 (g) The identity of the person, if known, suspected of committing the crime and whose wire,  
37 electronic or oral communications are to be intercepted;

38 (h) A full and complete statement as to whether or not other investigative procedures have been  
39 tried and failed or why other investigative procedures reasonably appear to be unlikely to succeed  
40 if tried or are likely to be too dangerous;

41 (i) A statement of the period of time for which the interception is required to be maintained. If  
42 the nature of the investigation is such that the authorization for interception should not automat-  
43 ically terminate when the described type of wire, electronic or oral communication has been first  
44 obtained, a description of facts establishing probable cause to believe that additional communi-  
45 cations of the same type will occur thereafter;



1 (j) A statement as to whether any prior application has been made to intercept wire, electronic  
2 or oral communications from the same person and, if such prior application exists, a statement of

4 (k) Where the application is for the extension of an existing order, a statement setting forth the  
5 results thus far obtained from the interception, or a reasonable explanation of the failure to obtain  
6 such results.

7 (2) The judge may require the applicant to furnish further testimony or documentary evidence  
8 in support of the application.

9 (3) Upon examination of such application and evidence the judge may enter an ex parte order,  
10 as requested or as modified, authorizing or approving interception of wire, electronic or oral com-  
11 munications within the state if the judge determines on the basis of the facts submitted by the ap-  
12 plicant that:

13 (a) There is probable cause for belief that an individual is committing, has committed or is about  
14 to commit a particular crime described in subsection (1)(c) of this section;

15 (b) There is probable cause for belief that particular communications concerning that crime will
