

House Bill 2760

Sponsored by Representative CLEM (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates crime of trafficking in illegal aliens. Punishes by maximum of 20 years' imprisonment, \$375,000 fine, or both.

Declares emergency, effective on passage.

2 Relating to trafficking in illegal aliens; creating new provisions; amending ORS 131.602 and 161.005;

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) A person commits the crime of trafficking in illegal aliens if the person,**
6 **for consideration, intentionally:**

7 **(a) Solicits another person to reside and work in this state, knowing the other person is**
8 **not legally authorized to be present in the United States; or**

9 **(b) Transports another person into this state knowing the other person is not legally**
10 **authorized to be present in the United States.**

11 **(2) Trafficking in illegal aliens is a Class A felony.**
