

HOUSE AMENDMENTS TO HOUSE BILL 2792

1 On page 1 of the printed bill, line 2, after “166.262,” insert “166.292.”

2 On page 2, delete lines 20 through 26 and insert:

3 “**SECTION 3.** ORS 166.262 is amended to read:

4 “166.262. (1) A peace officer may not arrest or charge a person for violating ORS 166.250 (1)(a)
5 or (b) [*or*], 166.370 (1) **or 166.663, or any ordinance adopted by a city or county pursuant to**
6 **ORS 166.173**, if the person has in the person’s immediate possession:

7 “(a) A valid license to carry a firearm as provided in ORS 166.291 and 166.292; or

8 “(b) **If the person is not a resident of this state, a valid license or permit that was issued**
9 **in another state by a state or local law enforcement agency, a court or other issuing au-**
10 **thority that authorizes the person to carry a concealed handgun in the other state.**

11 “(2) **Failure of a person who carries a concealed handgun to also carry a concealed**
12 **handgun license or permit is prima facie evidence that the person does not have such a li-**
13 **cence or permit.”.**

14 On page 4, delete lines 13 through 15 and insert:

15 “**SECTION 6.** ORS 166.292 is amended to read:

16 “166.292. (1) If the application for the license is approved, the sheriff shall issue and mail or
17 otherwise deliver to the applicant at the address shown on the application, within 45 days of the
18 application, a wallet sized license bearing the photograph of the licensee. The license must be signed
19 by the licensee and carried whenever the licensee carries a concealed handgun.

20 “[2] *Failure of a person who carries a concealed handgun also to carry a concealed handgun li-*
21 *cence is prima facie evidence that the person does not have such a license.*]

22 “[3] (2) Licenses for concealed handguns shall be uniform throughout the state in substantially

“[(4)] (3) An Oregon concealed handgun license issued under ORS 166.291 and this section, unless revoked under ORS 166.293, is valid for a period of four years from the date on which it is issued.

“[(5)] (4) The sheriff shall keep a record of each license issued under ORS 166.291 and this section, or renewed pursuant to ORS 166.295.

“[(6)] (5) When a sheriff issues a concealed handgun license under this section, the sheriff shall provide the licensee with a list of those places where carrying concealed handguns is prohibited or restricted by state or federal law.

“SECTION 7. The amendments to ORS 166.173, 166.260, 166.262, 166.292, 166.370 and 166.663 by sections 1 to 6 of this 2011 Act apply to conduct occurring on or after the effective date of this 2011 Act.”.
