

House Bill 2824

Sponsored by Representative GELSER; Representatives BAILEY, BARKER, NATHANSON, READ (at the request of Pete Dunn) (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates crime of trafficking in bicycles with a destroyed or altered serial number. Punishes by maximum of 30 days' imprisonment, \$1,250 fine, or both.

Authorizes forfeiture of bicycle.

2 Relating to bicycles; creating new provisions; and amending ORS 131.602 and 819.430.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) A person commits the offense of trafficking in bicycles with a destroyed**
5 **or altered serial number if the person knowingly buys, sells, receives, disposes of, conceals**
6 **or has in the person's possession a bicycle from which the serial number has been removed,**
7 **defaced, covered, altered or destroyed for the purpose of concealing or misrepresenting the**
8 **identity of the bicycle.**

9 (2) Violation of subsection (1) of this section constitutes prohibited conduct for purposes
10 of ORS chapter 131A, and shall give rise to civil in rem forfeiture as provided in ORS chapter
11 131A. A judgment providing for forfeiture shall direct that the bicycle be destroyed.

12 (3) The offense described in this section, trafficking in bicycles with a destroyed or al-
13 tered serial number, is a Class C misdemeanor.

11 identification numbers if the person knowingly buys, sells, receives, disposes of, conceals or has in
12 the person's possession any vehicle or component from which the vehicle identification number has
13 been removed, defaced, covered, altered or destroyed for the purpose of concealing or misrepre-
14 senting the identity of the vehicle or component.

15 **(2) This section does not apply to bicycles.**

16 [(2)] **(3)** The offense described in this section, trafficking in vehicles with destroyed or altered
17 identification numbers, is a Class A misdemeanor.
