SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires Oregon Department of Administrative Services, in cooperation with other state agencies and **certain** public agencies, to establish policies, methods and means by which department, other state agencies and public agencies can acquire, share, maintain, use, repair and dispose of motor pool resources cost-effectively and efficiently.

A BILL FOR AN ACT

2 Relating to a motor pool for common use; amending ORS 283.315.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 283.315 is amended to read:

5 283.315. (1) The Oregon Department of Administrative Services shall establish a motor pool for
6 the common use of state agencies and [*for other*] public agencies that have entered into intergov-
7 ernmental agreements with the department in accordance with ORS chapter 190 **for the purpose**
8 **of establishing a motor pool for common use. The motor pool shall consist of** [*for the provision*
9 *of motor pool*] vehicles, supplies, [*and*] services, [*or any of them.*] **facilities and equipment neces-**
10 **sary to enable the department, other state agencies and public agencies to meet the**
11 **department's and the agencies' transportation and related needs. Subject to the require-**
12 **ments set forth in subsection (2) of this section,** the department may also establish in the state
13 such subsidiary **motor** pools under the direct control or under the supervision of a state agency as
14 **are** [*may be found*] necessary.

15 (2) **The department shall establish policies, methods and means by which the department,**
16 **other state agencies and public agencies described in subsection (1) of this section can ac-**
17 **quire, share, maintain, use, repair and dispose of motor pool resources cost-effectively and**
18 **efficiently, with particular attention to avoiding overuse or underuse of motor pool re-**
19 **sources. The department shall establish one or more programs with other public agencies in**
20 **which the department evaluates the effectiveness of different alternatives before adopting a**
21 **particular policy, method or means for meeting the requirements of this section. The de-**
22 **partment shall specifically consider such methods as consolidating vehicle storage and**
23 **maintenance services and increasing ridesharing opportunities among agencies for persons**
24 **who use motor pool resources.**

25 (3) **After consulting and coordinating with a public agency with which the department**
26 **has an intergovernmental agreement under ORS chapter 190 for establishing and using a**

1 **motor pool, the department may amend the intergovernmental agreement to reflect the**
2 **policies, methods and means the department establishes under subsection (2) of this section.**

3 **(4) The department shall submit a report that describes the department's actions and**
4 **evaluates the costs, benefits and effectiveness of the actions at least once each biennium to**
5 **the committees of the Legislative Assembly that the Speaker of the House of Representatives**
6 **and the President of the Senate designate.**

7 **(5) This section does not apply to the department's, a state agency's or another public**
8 **agency's procuring and equipping a motor vehicle that is used for emergency services, as**
9 **defined in ORS 401.025.**
