

HOUSE AMENDMENTS TO HOUSE BILL 2880

By COMMITTEE ON RULES

1 In line 2 of the printed bill, before the period insert “; creating new provisions; amending ORS
2 247.208; and declaring an emergency”.

3 Delete lines 4 through 10 and insert:

4 **“SECTION 1. (1) The National Voter Registration Act State Compliance Council is es-**
5 **ablished within the executive branch of state government, consisting of the following 10**
6 **members:**

7 **“(a) Five members appointed by the Governor to represent designated voter registration**
8 **agencies under ORS 247.208;**

9 **“(b) One member appointed by the Governor to represent the Governor;**

10 **“(c) Two members appointed by the President of the Oregon Association of County Clerks**
11 **to represent the association;**

12 **“(d) The Secretary of State or the designee of the secretary; and**

13 **“(e) The Director of the Elections Division of the Secretary of State’s office.**

14 **“(2) The council shall:**

15 **“(a) Assess new and developing federal guidelines regarding compliance with the National**
16 **Voter Registration Act of 1993 (P.L. 103-31);**

17 **“(b) Identify steps necessary to ensure ongoing compliance with the National Voter**
18 **Registration Act of 1993 (P.L. 103-31);**

19 **“(c) Identify barriers to and research opportunities for ensuring the accuracy, security**
20 **and efficiency of current voter registration processes at designated voter registration agen-**
21 **cies under ORS 247.208; and**

22 **“(d) Identify ways to improve use of current technology.**

23 **“(3) The council shall submit a report, and may include recommendations for legislation,**
24 **to the Legislative Assembly no later than December 1, 2011.**

25 **“(4) Staff support for the council shall be provided by the permanent staff of the office**
26 **of the Governor or the office of the Secretary of State.**

27 **“(5) The council may receive information from chief information officers from state**
28 **agencies.**

29 **“SECTION 2. ORS 247.208 is amended to read:**

30 **“247.208. (1) The Secretary of State by rule, in accordance with the requirements of the National**
31 **Voter Registration Act of 1993 (P.L. 103-31), shall designate agencies as voter registration agencies.**
32 **Agencies designated may include state, county, city or district offices and federal and nongovern-**
33 **mental offices with the agreement of the federal or nongovernmental offices.**

34 **“(2) Services required by the National Voter Registration Act of 1993 (P.L. 103-31) shall be made**
35 **available in connection with any registration card at each voter registration agency designated by**

1 the Secretary of State.

2 “(3) A person providing services referred to in subsection (2) of this section at a voter regis-
3 tration agency shall not:

4 “(a) Seek to influence the political preference or party registration of a person registering to
5 vote;

6 “(b) In accordance with provisions of the Oregon Constitution, display such political preference
7 or party allegiance;

8 “(c) Make any statement to a person registering to vote or take any action the purpose or effect
9 of which is to discourage a person from registering to vote;

10 “(d) Make any statement to a person registering to vote or take any action the purpose or effect
11 of which is to lead the person to believe that a decision to register or not to register has any
12 bearing on the availability of services or benefits; or

13 “(e) Seek to induce any person to register or vote in any particular manner.

14 “(4) Each state agency required to be designated a voter registration agency under the National
15 Voter Registration Act of 1993 (P.L. 103-31) shall, with each application for service or assistance
16 and with each recertification, renewal or change of address form relating to the service or assist-
17 ance:

18 “(a) Distribute a registration card, including all statements required under the National Voter
19 Registration Act of 1993 (P.L. 103-31); and

20 “(b) Provide a form including other information required by the National Voter Registration Act
21 of 1993 (P.L. 103-31).

22 “(5) Information relating to a declination to register to vote in connection with an application
23 made at an office described in subsection (4) of this section shall not be used for any purpose other
24 than voter registration.

25 “(6) A completed registration card accepted at a voter registration agency designated under this
26 section shall be delivered to a county clerk or the Secretary of State.

27 “(7) **At least once each biennium, the Secretary of State shall:**

28 “(a) **Assess new and developing federal guidelines regarding compliance with the National
29 Voter Registration Act of 1993 (P.L. 103-31);**

30 “(b) **Identify steps necessary to ensure ongoing compliance with the National Voter
31 Registration Act of 1993 (P.L. 103-31);**

32 “(c) **Identify barriers to and research opportunities for ensuring the accuracy, security
33 and efficiency of current voter registration processes at voter registration agencies desig-
34 nated under this section; and**

35 “(d) **Identify ways to improve use of current technology.**

36 “**SECTION 3. Section 1 of this 2011 Act is repealed on January 2, 2012.**

37 “**SECTION 4. This 2011 Act being necessary for the immediate preservation of the public
38 peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect
39 on its passage.”.**
