House Bill 2935

Sponsored by Representative HOYLE (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Requires group and individual health insurance policies covering hospital, surgical or dental services to cover medically necessary cleft palate reconstructive surgery. Requires coverage of medically necessary presurgical and post-surgical orthodontic care.

- 4 Be It Enacted by the People of the State of Oregon:
 - SECTION 1. Section 2 of this 2011 Act is added to and made a part of the Insurance Code.

- (a) "Cleft palate" includes cleft palate, cleft lip and other craniofacial anomalies associated with cleft palate.
- (b) "Reconstructive surgery" means surgery performed to correct or repair abnormal structures of the body caused by congenital defects, developmental abnormalities, trauma, infection, tumors or disease.
- (2) All group and individual health insurance policies providing coverage of hospital, surgical or dental services, except policies that limit coverage to expenses of accidents or specific diseases, shall provide coverage for cleft palate reconstructive surgery if medically necessary to improve or restore function.
- (3) Coverage required by this section includes any medically necessary presurgical or post-surgical orthodontic care.
- (4) Coverage required by this section may be subject to copayments, deductibles and coinsurance imposed on similar services by the terms of the policy.
- (5) This section does not limit or supersede any coverage required by ORS 743A.028, 743A.032 or 743A.148.
 - (6) This section is exempt from ORS 743A.001.
