House Bill 2984

Sponsored by Representative RICHARDSON (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Eliminates employer pick-up of six percent employee contribution required of members of individual account program of Public Employees Retirement System.

Requires employee contributions to individual account program only if elected by employee. Requires that employee contributions be percentage of salary, be not less than one percent of salary or more than six percent of salary, and be whole number.

Eliminates ability of public employer to make employer contributions to individual account program.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to public employee retirement; creating new provisions; amending ORS 238.229, 238.660,

238A.005, 238A.330 and 238A.340; repealing ORS 238A.335; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 SECTION 1. ORS 238A.335 is repealed.

6 **SECTION 2.** ORS 238A.330 is amended to read:

7 238A.330. (1) [A member of the individual account program must make employee contributions to

8 the individual account program of six percent of the member's salary.] A member of the individual

9 account program may elect to make employee contributions to the individual account pro-10 gram. Employee contributions must be a percentage of salary, may not be less than one

11 percent of salary or more than six percent of salary, and must be a whole number.

(2) Employee contributions made by a member of the individual account program under this
 section shall be credited by the board to the employee account established for the member under
 ORS 238A.350 (2).

SECTION 3. ORS 238.229 is amended to read:

16 238.229. (1) If a participating public employer is grouped with any other public employer for the 17 purpose of computing employer contributions under ORS 238.225 and the individual public employer 18 makes a lump sum payment that is in addition to the normal employer contribution of the public employer, the Public Employees Retirement Board shall adjust the amount of employer contributions 19 20 to be made by the individual public employer to ensure that the benefit of the lump sum payment 21accrues only to the individual public employer making the payment. An individual public employer 22that makes a lump sum payment under the provisions of this subsection shall remain grouped with 23other public employers as provided by ORS 238.227 and 238A.220 for the purpose of all liabilities of the employer that are not paid under this subsection. The board by rule may establish a minimum 24 25lump sum payment that must be made by an individual public employer before adjusting employer 26 contributions under this subsection. Notwithstanding any minimum lump sum payment established 27by the board, the board must allow an individual public employer to make a lump sum payment under this subsection if the payment is equal to the full amount of the individual public employer's 28

1 accrued unfunded liabilities under this section and ORS chapter 238A.

2 (2) The board shall establish a separate account within the Public Employees Retirement Fund for each lump sum payment made under this section by an individual public employer. The board 3 shall credit to each account all interest and other income received from investment of the account 4 funds during the calendar year. Except as provided in subsection (3) of this section, the board may $\mathbf{5}$ not collect any administrative expense or other charge from the account or from earnings on the 6 account. [Except as provided in subsections (5) and (6) of this section,] The account shall be used to 7 offset contributions to the system that the public employer would otherwise be required to make for 8 9 the liabilities against which the lump sum payment is applied.

(3) The board may charge a participating public employer expenses for administration of an account established under subsection (2) of this section in an amount not to exceed \$2,500 for the calendar year in which the account is established and for the immediately following two calendar years, and in an amount not to exceed \$1,000 per year for all subsequent years.

(4) If a participating public employer has any liabilities that are attributable to creditable service by employees of the employer before the participating public employer was grouped with other public employers under ORS 238.227, whether under this section or pursuant to board rule, any lump sum payment made under this section must be applied first against those liabilities, with the oldest liability being paid first. Any amounts remaining after application under this subsection must be deposited in a separate account established under subsection (2) of this section.

20[(5) Except as provided in subsection (6) of this section, if the board determines at any time after an actuarial study that the amounts in an account established under subsection (2) of this section ex-2122ceed the amounts necessary to fund the employer's actuarial liabilities under the system, upon request 23of the employer, the board shall apply the excess amounts to offset contributions to the individual account program that the employer has agreed to pay under ORS 238A.335 or 238A.340. The board may 2425apply excess amounts to offset contributions to the individual account program under this subsection only to the extent that the application will not result in the balance in the account being reduced to less 2627than the outstanding principal balance owed on the bonds issued to fund the account. If the request is made by a school district, the school district must attach to the request a copy of a resolution adopted 28by the district school board for the district authorizing the request. The board shall adopt rules gov-2930 erning offsets under the provisions of this subsection.]

[(6) The board shall apply any excess amounts in an account established under subsection (2) of this section to offset contributions to the individual account program pursuant to subsection (5) of this section only if the board has determined that applying the excess amounts does not cause the system or the Public Employees Retirement Fund to lose qualification as a qualified governmental retirement plan and trust under the Internal Revenue Code and under regulations adopted pursuant to the Internal Revenue Code.]

SECTION 4. ORS 238.660 is amended to read:

38 238.660. (1) The Public Employees Retirement Fund is declared to be a trust fund, separate and distinct from the General Fund, for the uses and purposes set forth in this chapter and ORS chapter 39 40 238A and ORS 237.950 to 237.980, and for no other use or purpose, except that this provision shall not be deemed to amend or impair the force or effect of any law of this state specifically authorizing 41 42the investment of moneys from the fund. Interest earned by the fund shall be credited to the fund. Except as otherwise specifically provided by law, the Public Employees Retirement Board estab-43 lished by ORS 238.630 is declared to be the trustee of the fund. Consistent with the legislative intent 44 expressed in ORS 238.601, and to the extent it is consistent with the board's fiduciary duties, the 45

board shall give equal consideration to the interests of participating public employers and the interests of members. Nothing in this subsection shall be construed to impose a fiduciary duty on the board to consider the interests of public employers, and the board shall consider the interests of public employers only with respect to matters unrelated to the board's fiduciary duties as trustee of the fund.

6 (2) Until all liabilities to members and their beneficiaries are satisfied, assets of the fund may 7 not be diverted or otherwise put to any use that is not for the exclusive benefit of members and 8 their beneficiaries. This subsection does not limit return of employer contributions for health bene-9 fits in the manner provided by ORS 238.410, 238.415 and 238.420 upon satisfaction of all liabilities 10 for health benefits under those sections.

11 (3) The State of Oregon and other public employers that make contributions to the fund have 12 no proprietary interest in the fund or in the contributions made to the fund by them. The state and 13 other public employers disclaim any right to reclaim those contributions and waive any right of reclamation they may have in the fund. This subsection does not prohibit alteration or refund of 14 15employer contributions if the alteration or refund is authorized under this chapter or ORS chapter 16 238A and is due to erroneous payment or decreased liability for employer contributions under the system. [This subsection does not prohibit the offset of contributions to the individual account program 17 18 under ORS 238.229 (5).]

(4) The board may accept gifts of money or other property from any source, given for the uses and purposes of the system. Money so received shall be paid into the fund. Money or other property so received shall be used for the purposes for which received. Unless otherwise prescribed by the source from which the money or other property is received, the money shall be considered as income of the fund and the other property shall be retained, managed and disposed of as are investments of the fund.

25(5) All moneys paid into the fund shall be deposited with the State Treasurer, who shall be custodian of the fund and pay all warrants drawn on it in compliance with law. No such warrant 2627shall be paid until the claim for which it is drawn is first approved by the director or designee and otherwise audited and verified as required by law. Monthly, each beneficiary's gross benefit shall 28be calculated; applicable deductions made for taxes, insurance and other withholdings; and the net 2930 amount paid to the beneficiary, by check or by electronic funds transfer (EFT) to the beneficiary's 31 bank. A deduction summary shall be made, by type, and a check issued for the aggregate of each 32type for transmittal to the appropriate taxing jurisdiction, vendor or institution. A voucher shall be prepared and transmitted to the Oregon Department of Administrative Services for reimbursement 33 34 of the checking account, and the department shall draw a warrant on the State Treasurer, payable to the Public Employees Retirement System, for the amount thereof. 35

(6) Any warrant, check or order for the payment of benefits or refunds under the system out of
the fund issued by the board which is canceled, declared void or otherwise made unpayable pursuant
to law because it is outstanding and unpaid for a period of more than two years, may be reissued
by the board without bond if the payee is located after such warrant, check or order is canceled,
declared void or otherwise made unpayable pursuant to law.

41 (7) All references in this chapter to checks or warrants are subject to the provisions of ORS
42 291.001.

(8) The board shall provide for an annual audit of the retirement fund and for an annual report
to the Legislative Assembly and to all members of, retirees of, and all employers participating in,
the system. The annual report must contain financial statements prepared in accordance with gen-

erally accepted accounting principles. The financial statements must include the report of any in dependent auditor.

(9) The board may review legislative proposals for changes in the benefits provided under this 3 chapter and ORS chapter 238A and may make recommendations to committees of the Legislative 4 Assembly on those proposed changes. In making recommendations under this subsection, the board 5 acts as a policy advisor to the Legislative Assembly and not as a fiduciary. In making recommen-6 dations under this subsection on the Oregon Public Service Retirement Plan established by ORS 7 chapter 238A, the board shall seek to maintain the balance between benefits and costs, and the 8 9 relative risk borne by employers and employees with respect to investment performance, reflected in ORS chapter 238A as in effect on January 1, 2004. 10

11 (10) The board shall appoint a committee to advise the board on legislative proposals for 12 changes in the benefits provided under this chapter and ORS chapter 238A. The committee must 13 have an equal number of members representing labor and management. No costs of reviewing legislative proposals and making recommendations under this subsection may be charged to the fund. 14 15 Any member of the committee who is an active member of the system shall be released by the par-16 ticipating public employer who employs the member for the purpose of conducting the official business of the committee, and the wages or salary of the member may not be reduced by the employer 17 18 during periods that the member is released from duty for the purpose of conducting the official 19 business of the committee.

(3) "Board" means the Public Employees Retirement Board.

(4) "Eligible employee" means a person who performs services for a participating public em ployer, including elected officials other than judges. "Eligible employee" does not include:

(c) An employee of the State Forestry Department who is certified by the State Forester as a

 the Oregon Public Service Retirement Plan established under ORS 238A.025.

(10) "Member" means an eligible employee who has established membership in the pension pro gram or the individual account program of the Oregon Public Service Retirement Plan and whose
 membership has not been terminated under ORS 238A.110 or 238A.310.

(11) "Participating public employer" means a public employer as defined in ORS 238.005 that
 provides retirement benefits for employees of the public employer under the system.

(12) "Pension program" means the defined benefit pension program of the Oregon Public Service

4 **SECTION 6.** ORS 238A.340 is amended to read:

5 238A.340. (1) A participating public employer may agree, by a written employment policy or 6 agreement, to make employer contributions for members of the individual account program employed 7 by the employer. The percentage of salary paid as employer contributions may not be less than one 8 percent of salary or more than six percent of salary, and must be a whole number. A participating 9 public employer may make an agreement under this section for specific groups of employees em-10 ployed by the public employer.

(2) If a participating public employer makes employer contributions under this section and the member for [which] whom the contributions are made fails to vest in the employer account under the provisions of ORS 238A.320, the Public Employees Retirement Board shall apply the contributions in the employer account against other obligations of the employer under the Oregon Public Service Retirement Plan.

(3) A participating public employer may not make employer contributions under this
 section on or after the effective date of this 2011 Act.

SECTION 7. The repeal of ORS 238A.335 by section 1 of this 2011 Act and the amendments to ORS 238.229, 238.660, 238A.005, 238A.330 and 238A.340 by sections 2 to 6 of this 2011 Act do not affect any collective bargaining agreement entered into before the effective date of this 2011 Act. Any collective bargaining agreement entered into on or after the effective date of this 2011 Act may not contain a provision requiring a public employer to pick up, assume or pay employee contributions required by ORS 238A.330.

<u>SECTION 8.</u> (1) Jurisdiction is conferred on the Supreme Court to determine in the manner provided by this section whether this 2011 Act breaches any contract between members of the Public Employees Retirement System and their employers or violates any constitutional provision, including but not limited to impairment of contract rights of members of the Public Employees Retirement System under section 21, Article I of the Oregon Constitution, or clause 1, section 10, Article I of the United States Constitution.

(2) A person who is adversely affected by this 2011 Act or who will be adversely affected
 by this 2011 Act may institute a proceeding for review by filing with the Supreme Court a
 petition that meets the following requirements:

33 (a) The petition must be filed within 60 days after the effective date of this 2011 Act.

34 (b) The petition must include the following:

35 (A) A statement of the basis of the challenge; and

(B) A statement and supporting affidavit showing how the petitioner is adversely af fected.

(3) The petitioner shall serve a copy of the petition by registered or certified mail upon
 the Public Employees Retirement Board, the Attorney General and the Governor.

40 (4) Proceedings for review under this section shall be given priority over all other mat 41 ters before the Supreme Court.

42 (5) The Supreme Court shall allow public employers participating in the Public Employees
 43 Retirement System to intervene in any proceeding under this section.

(6) In the event the Supreme Court determines that there are factual issues in the peti tion, the Supreme Court may appoint a special master to hear evidence and to prepare re-

1 commended findings of fact.

2 <u>SECTION 9.</u> This 2011 Act being necessary for the immediate preservation of the public

peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect
on its passage.
