# House Bill 3283

Sponsored by Representative BREWER; Senator STARR

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Reduces rate of tax on capital gains of personal income and corporate income and excise taxpayers if amount equal to gain is invested in certain investments during tax year. Applies to tax years beginning on or after January 1, 2011. Takes effect on 91st day following adjournment sine die.
