SUMMARY

Authorizes photo radar in City of Salem.

(b) May be used in other areas if the governing body of the city makes a finding that speeding 20 21 has had a negative impact on traffic safety in those areas. 22 (c) May not be used for more than four hours per day in any one location.

26 (A) Be on the street on which the photo radar unit is being used;

(d) May not be used on controlled access highways.

- 27 (B) Be between 100 and 400 yards before the location of the photo radar unit;
