House Bill 3637

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Designates any elective county or city office as nonpartisan.

20	under ORS chapter 268, justice of the peace, [county clerk, county assessor, county surveyor, county
21	treasurer,] sheriff, district attorney, any elected office of a county or city or any office designated

23	(8) "Prospective petition" means the information, except signatures and other identification of
24	petition signers, required to be contained in a completed petition.
25	(9) "Public office" means any national, state, county, city or district office or position, except
26	a political party office, filled by the electors.
27	(10) "State office" means Governor, Secretary of State, State Treasurer, Attorney General,
28	Commissioner of the Bureau of Labor and Industries, Superintendent of Public Instruction, judge,

(1) "Ballot" means any material on which votes may be cast for candidates or measures. In the 1 2 case of a recall election, "ballot" includes material posted in a voting compartment or delivered to an elector by mail. 3 (2) "Chief elections officer" means the: 4 (a) Secretary of State, regarding a candidate for a state office or an office to be voted on in the 5 state at large or in a congressional district, or a measure to be voted on in the state at large. 6 (b) County clerk, regarding a candidate for a county office, or a measure to be voted on in a 7 county only. 8 9 (c) City clerk, auditor or recorder, regarding a candidate for a city office, or a measure to be 10 voted on in a city only. SECTION 3. ORS 236.210 is amended to read: 39 236.210. (1) When there is a vacancy in any elective county office other than the office of county 40 judge or county commissioner, the county court or board of county commissioners shall appoint a 41 person to perform the duties of the office until the vacancy is filled by election. 42 (2) Except as provided in subsection (3) of this section, when a vacancy occurs in the [nonpar-43 tisan] office of county judge who does not exercise judicial functions or county commissioner, the 44 remaining members of the county court or board of county commissioners shall appoint a person to 45

1 perform the duties of the office until the vacancy is filled by election.

2 (3) When a vacancy occurs in the office of county judge who exercises judicial functions, the

Governor shall fill the vacancy by appointment as provided in section 16, Article V of the Oregon
Constitution.

5 (4) Before a person appointed under subsection (1) or (2) of this section takes office, the person 6 shall qualify in the same manner as required by law of the officer in whose place the person is ap-7 pointed.

8 SECTION 4. ORS 236.215 and 236.217 are repealed.

9 <u>SECTION 5.</u> The amendments to ORS 236.210, 249.002 and 254.005 by sections 1 to 3 of this 10 2011 Act and the repeal of ORS 236.215 and 236.217 by section 4 of this 2011 Act apply to 11 nominations for and appointments and elections to an elective county or city office occurring 12 on or after the effective date of this 2011 Act.
