SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Establishes Oregon Integrated and Coordinated Health Care Delivery System to replace man-aged care systems for recipients of medical assistance by January 1, 2014. Requires Oregon Health Authority to develop proposal for consideration by Legislative Assembly for coordinated care organization qualification criteria [and global budgeting process], global budgeting process and other processes related to coordinated care organizations. Requires Oregon Health Authority to seek federal approval to allow enrollment of individuals who are dually eligible for Medicare and Medicaid into coordinated care organizations. Requires coordinated care organizations to report outcome and quality measures developed by authority. Requires coordinated care organizations to use patient centered primary care homes to extent practicable. Establishes consumer protections for members of and providers in coordinated care organizations. Allows sharing of confidential information within coordinated care organization. Creates exemption from antitrust laws for activities under Oregon Integrated and Coordinated Health Care Delivery System.

Requires Oregon Health Authority to conduct study and make recommendations to Legislative

Assembly for reducing health care costs attributable to defensive medicine. Increases, for biennium beginning July 1, 2011, General Fund appropriations made to Oregon Health Authority and Department of Human Services.

Increases, for biennium beginning July 1, 2011, limitation on expenditures from certain federal funds collected or received by Oregon Health Authority.

Declares emergency, effective on passage.

13	SECTION 1. ORS 414.018 is amended to read:
14	414.018. Legislative intent. (1) It is the intention of the Legislative Assembly to achieve the
15	goals of universal access to an adequate level of high quality health care at an affordable cost.
16	(2) The Legislative Assembly finds:
17	(a) A significant level of public and private funds is expended each year for the provision of
18	health care to Oregonians;

(b) The state has a strong interest in assisting Oregon businesses and individuals to obtain 1 2 reasonably available insurance or other coverage of the costs of necessary basic health care services; 3 (c) The lack of basic health care coverage is detrimental not only to the health of individuals 4 lacking coverage, but also to the public welfare and the state's need to encourage employment 5 growth and economic development, and the lack results in substantial expenditures for emergency 6 and remedial health care for all purchasers of health care including the state; and 7 [(d) The use of managed health care systems has significant potential to reduce the growth of health 8 9 care costs incurred by the people of this state.] (d) The use of integrated and coordinated health care systems has significant potential 10 to reduce the growth of health care costs incurred by the people of this state. 11 12(3) The Legislative Assembly finds that achieving its goals of improving health, increasing 13 the quality, reliability, availability and continuity of care and reducing the cost of care requires an integrated and coordinated health care system in which: 14 15 (a) Medical assistance recipients and individuals who are dually eligible for both Medicare and Medicaid participate. 16 17(b) Health care services, other than Medicaid-funded long term care services, are deliv-18 ered through coordinated care contracts that use alternative payment methodologies to focus on prevention, improving health equity and reducing health disparities, utilizing patient 19 centered primary care homes, evidence-based practices and health information technology 20to improve health and health care. 2122(c) High quality information is collected and used to measure health outcomes, health 23care quality and costs and clinical health information. (d) Communities and regions are accountable for improving the health of their commu-24 nities and regions, reducing avoidable health gaps among different cultural groups and 25managing health care resources. 2627(e) Care and services emphasize preventive services and services supporting individuals to live independently at home or in their community. 28(f) Services are person centered, and provide choice, independence and dignity reflected 2930 in individual plans and provide assistance in accessing care and services. 31 (g) Interactions between the Oregon Health Authority and coordinated care organizations are done in a transparent and public manner. 32(h) Moneys provided by the federal government for medical education are allocated to the 33

(4) The Legislative Assembly further finds that there is an extreme need for a skilled,
 diverse workforce to meet the rapidly growing demand for community-based health care. To

(b) Provide an opportunity for frontline care providers to have a voice in their workplace
 in order to effectively advocate for quality care.

414.620. Establishment of Oregon Integrated and Coordinated Health Care Delivery Sys-6 tem. (1) There is established the Oregon Integrated and Coordinated Health Care [Cost Contain-7 ment] Delivery System. The system shall consist of state policies and actions that [encourage price 8 9 competition among health care providers, that monitor services and costs of the health care system in Oregon, and that maintain the regulatory controls necessary to assure quality and affordable health 10 services to all Oregonians. 40 <u>SECTION 4.</u> Coordinated care organizations. (1) The Oregon Health Authority shall adopt 41 by rule the criteria for a coordinated care organization and shall integrate the criteria into 42 each contract with a coordinated care organization. Coordinated care organizations may be 43 local, community-based organizations or statewide organizations with community-based par-44 ticipation in governance or any combination of the two. Coordinated care organizations may 45 contract with counties or with other public or private entities to provide services to mem-

(e) Members receive assistance in navigating the health care delivery system and in accessing community and social support services and statewide resources, including through the use of certified health care interpreters, as defined in ORS 409.615, community health workers and personal health navigators who meet competency standards established by the authority under section 11 of this 2011 Act or who are certified by the Home Care Commission under ORS 410.604.

(f) Services and supports are geographically located as close to where members reside
as possible and are, if available, offered in nontraditional settings that are accessible to
families, diverse communities and underserved populations.

(g) Each coordinated care organization uses health information technology to link ser vices and care providers across the continuum of care to the greatest extent practicable.

(h) Each coordinated care organization complies with the safeguards for members de scribed in section 8 of this 2011 Act.

(i) Each coordinated care organization convenes a community advisory council that includes representatives of the community and of county government, but with consumers
making up a majority of the membership, and that meets regularly to ensure that the health
care needs of the consumers and the community are being addressed.

(j) Each coordinated care organization prioritizes working with members who have high
 health care needs, multiple chronic conditions, mental illness or chemical dependency and
 involves those members in accessing and managing appropriate preventive, health, remedial
 and supportive care and services to reduce the use of avoidable emergency room visits and
 hospital admissions.

(k) Members have a choice of providers within the coordinated care organization's net work and that providers participating in a coordinated care organization:

(A) Work together to develop best practices for care and service delivery to reduce waste
 and improve the health and well-being of members.

(E) Include providers of specialty care. 1 2 (F) Are selected by coordinated care organizations using universal application and credentialing procedures, objective quality information and are removed if the providers fail to 3 meet objective quality standards. 4 (G) Work together to develop best practices for culturally appropriate care and service 5 delivery to reduce waste, reduce health disparities and improve the health and well-being of 6 7 members. Patient centered primary care homes. (1) The Oregon Health Authority shall establish standards for the utilization of patient centered primary care homes in coordinated 28

29care organizations.

30 (2) Each coordinated care organization shall implement, to the maximum extent feasible, 31 patient centered primary care homes, including developing capacity for services in settings that are accessible to families, diverse communities and underserved populations. The or-32ganization shall require its other health and services providers to communicate and coordi-33 34 nate care with the patient centered primary care home in a timely manner using electronic 35 health information technology.

(3) Standards established by the authority for the utilization of patient centered primary 36 37 care homes by coordinated care organizations may require the use of federally qualified 38 health centers, rural health clinics, school-based health clinics and other safety net providers that qualify as patient centered primary care homes to ensure the continued critical role of 39 those providers in meeting the needs of underserved populations. 40

(4) Each coordinated care organization shall report to the authority on uniform quality 41 measures prescribed by the authority by rule for patient centered primary care homes. 42

SECTION 7. Dually eligible individuals. (1) Subject to the Oregon Health Authority ob-

taining any necessary authorization from the Centers for Medicare and Medicaid Services
under section 17 of this 2011 Act, coordinated care organizations that meet the criteria
adopted under section 4 of this 2011 Act are responsible for providing covered Medicare and

4 Medicaid services, other than Medicaid-funded long term care services, to members who are

5 dually eligible for Medicare and Medicaid in addition to medical assistance recipients.

6 (2) An individual who is dually eligible for Medicare and Medicaid shall be permitted to 7 enroll in and remain enrolled in a:

(a) Program of all-inclusive care for the elderly, as defined in 42 C.F.R. 460.6; and

9 (b) A Medicare Advantage plan, as defined in 42 C.F.R. 422.2, until the plan is fully inte-10 grated into a coordinated care organization.

(3) Except for the enrollment in coordinated care organizations of individuals who are
 dually eligible for Medicare and Medicaid, the rights and benefits of Medicare beneficiaries
 under Title XVIII of the Social Security Act shall be preserved.

SECTION 8. Consumer and provider protections. (1) The Oregon Health Authority shall adopt by rule safeguards for members enrolled in coordinated care organizations that protect against underutilization of services and inappropriate denials of services. In addition to any other consumer rights and responsibilities established by law, each member:

(a) Must be encouraged to be an active partner in directing the member's health care
 and services and not a passive recipient of care.

(b) Must be educated about the coordinated care approach being used in the community
 and how to navigate the coordinated health care system.

(c) Must have access to advocates, including qualified peer wellness specialists where appropriate, personal health navigators, and qualified community health workers who are part of the member's care team to provide assistance that is culturally and linguistically appropriate to the member's need to access appropriate services and participate in processes affecting the member's care and services.

(d) Shall be encouraged within all aspects of the integrated and coordinated health care
delivery system to use wellness and prevention resources and to make healthy lifestyle
choices.

(e) Shall be encouraged to work with the member's care team, including providers and
 community resources appropriate to the member's needs as a whole person.

(2) The authority shall establish and maintain an enrollment process for individuals who
 are dually eligible for Medicare and Medicaid that promotes continuity of care and that al lows the member to disenroll from a coordinated care organization that fails to promptly
 provide adequate services and:

(a) To enroll in another coordinated care organization of the member's choice; or

(b) If another organization is not available, to receive Medicare-covered services on a
 fee-for-service basis.

(3) Members and their providers and coordinated care organizations have the right to
 appeal decisions about care and services through the authority in an expedited manner and
 in accordance with the contested case procedures in ORS chapter 183.

(4) A health care entity may not unreasonably refuse to contract with an organization
seeking to form a coordinated care organization if the participation of the entity is necessary
for the organization to qualify as a coordinated care organization.

45 (5) A health care entity may refuse to contract with a coordinated care organization if

1 the reimbursement established for a service provided by the entity under the contract is 2 below the reasonable cost to the entity for providing the service.

3 (6) A health care entity that unreasonably refuses to contract with a coordinated care
4 organization may not receive fee-for-service reimbursement from the authority for services
5 that are available through a coordinated care organization either directly or by contract.

6 (7) The authority shall develop a process for resolving disputes involving an entity's re-7 fusal to contract with a coordinated care organization under subsections (4) and (5) of this 8 section. The process must include the use of an independent third party arbitrator. The 9 process must be presented to the Legislative Assembly for approval in accordance with sec-10 tion 13 of this 2011 Act.

(8) A coordinated care organization may not unreasonably refuse to contract with a li censed health care provider.

(a) Monitor and enforce consumer rights and protections within the Oregon Integrated
 and Coordinated Health Care Delivery System and ensure a consistent response to com plaints of violations of consumer rights or protections.

(b) Monitor and report on the statewide health care expenditures and recommend actions
appropriate and necessary to contain the growth in health care costs incurred by all sectors
of the system.

20 SECTION 9. Section 8 of this 2011 Act is amended to read:

Sec. 8. (1) The Oregon Health Authority shall adopt by rule safeguards for members enrolled in coordinated care organizations that protect against underutilization of services and inappropriate denials of services. In addition to any other consumer rights and responsibilities established by law, each member:

(a) Must be encouraged to be an active partner in directing the member's health care and services and not a passive recipient of care.

(b) Must be educated about the coordinated care approach being used in the community and howto navigate the coordinated health care system.

(c) Must have access to advocates, including qualified peer wellness specialists where appropriate, personal health navigators, and qualified community health workers who are part of the member's care team to provide assistance that is culturally and linguistically appropriate to the member's need to access appropriate services and participate in processes affecting the member's care and services.

3 (4) A health care entity may not unreasonably refuse to contract with an organization seeking 4 to form a coordinated care organization if the participation of the entity is necessary for the or-5 ganization to qualify as a coordinated care organization.

6 (5) A health care entity may refuse to contract with a coordinated care organization if the re-7 imbursement established for a service provided by the entity under the contract is below the rea-8 sonable cost to the entity for providing the service.

9 (6) A health care entity that unreasonably refuses to contract with a coordinated care organ-10 ization may not receive fee-for-service reimbursement from the authority for services that are 11 available through a coordinated care organization either directly or by contract.

12 (7) The authority shall [develop a] maintain the process, approved by the Legislative As-13 sembly, for resolving disputes involving an entity's refusal to contract with a coordinated care or-14 ganization under subsections (4) and (5) of this section. (1) The Oregon Health Authority shall ensure the 20 appropriate use of member information by coordinated care organizations, including the use 21 of electronic health information and administrative data that is available when and where 22 the data is needed to improve health and health care through a secure, confidential health 23 information exchange.

(2) A member of a coordinated care organization must have access to the member's personal health information in the manner provided in 45 C.F.R. 164.524 so the member can share the information with others involved in the member's care and make better health care and lifestyle choices.

(3) Notwithstanding ORS 179.505, a coordinated care organization, its provider network
and programs administered by the Department of Human Services for seniors and persons
with disabilities shall use and disclose member information for purposes of service and care
delivery, coordination, service planning, transitional services and reimbursement, in order
to improve the safety and quality of care, lower the cost of care and improve the health and
well-being of the organization's members.

34 (4) A coordinated care organization and its provider network shall use and disclose sensitive diagnosis information including HIV and other health and mental health diagnoses, 35 within the coordinated care organization for the purpose of providing whole-person care. 36 37 Individually identifiable health information must be treated as confidential and privileged 38 information subject to ORS 192.518 to 192.529 and applicable federal privacy requirements. Redisclosure of individually identifiable information outside of the coordinated care organ-39 ization and the organization's providers for purposes unrelated to this section or the re-40 quirements of section 4, 5, 6, 7, 8 or 10 of this 2011 Act remains subject to any applicable 41 42federal or state privacy requirements.

(5) This section does not prohibit the disclosure of information between a coordinated

6 <u>SECTION 13.</u> Legislative approval. (1) The speed and pace of the transition to the Oregon 7 Integrated and Coordinated Health Care Delivery System will be determined by the avail-8 ability of coordinated care organizations throughout the state.

(2) Using a meaningful public process, the Oregon Health Authority shall develop:

(a) Qualification criteria for coordinated care organizations in accordance with section 4

(d) The disclosure of a coordinated care organization's holdings of real property and its
 20 largest investment holdings, if any;

(e) The disclosure by category of administrative expenses related to the provision of
 health services under the coordinated care organization's contract with the authority;

40 (f) The disclosure of the three highest executive salary and benefit packages of each co 41 ordinated care organization;

(g) The process by which a coordinated care organization will be evaluated or audited for
financial soundness and stability and the organization's ability to accept financial risk under
its contracts, which process may include the use of employed or retained actuaries;

45 (h) A description of how the required statements and the final results of evaluations and

1 audits will be made available to the public over the Internet at no cost to the public;

2 (i) A range of sanctions that may be imposed on a coordinated care organization deemed 3 to be financially unsound and the process for determining sanctions; and

4 (j) Whether a new category of license should be created for coordinated care organiza-5 tions recognizing their unique role but avoiding duplicative requirements for organizations 6 that contract with the authority but are also licensed by the Department of Consumer and 7 Business Services.

8 (4) The authority shall regularly report on the development of the plans, criteria and 9 processes described in subsections (2) and (3) of this section to the Joint Interim Committee 10 on Health Care Transformation or, if such committee has not been appointed, to another 11 appropriate interim committee of the Legislative Assembly.

(5) The authority shall present the proposals developed under this section to the Legis lative Assembly for approval no later than February 1, 2012.

(d) Establishment of criteria for evaluation and reduced utilization of services and procedures where the health of those served is not negatively impacted or necessarily improved.
(e) Identification and analysis of the benefits and impact of caps on medical liability insurance premiums as well as the benefits and potential cost saving from the extension of
coverage through the Oregon Tort Claims Act to those who serve or act as agents of the
state.

(f) A path for a cap on damages for those acting on behalf of the state and serving indi viduals who receive medical assistance or have medical coverage through other publicly
 funded programs.

(g) An examination of the possible clarifications and limitations on joint and several liability requirements for coordinated care organizations so that these organizations can assume the risk of their actions but are not liable for the actions of others within the coordinated care organization or its contracted services.

42 (h) The effectiveness of binding and nonbinding medical panels in addressing claims of

(2) The authority shall coordinate with the Department of Consumer and Business Ser vices and other appropriate agencies, including nongovernmental agencies, in order to collect

3 (3) The authority shall secure assistance and input from stakeholder organizations in an 4 effort to secure the best information available relevant to the impacts on administrative 5 costs resulting from litigation, as well as to identify cost containment or cost reduction 6 mechanisms.

(5) The authority shall present the study and recommendations for addressing health care cost containment and cost reductions to the Legislative Assembly at the same time that the coordinated care organization qualification criteria and global budgeting process are presented to the Legislative Assembly for approval under section 13 of this 2011 Act.

15 <u>SECTION 17.</u> Federal approvals. (1) To promote the adoption of alternative payment 16 methodologies and contracting with coordinated care organizations, the Oregon Health Au-17 thority shall apply to the Centers for Medicare and Medicaid Services or Center for Medicare 18 and Medicaid Innovation for any approval necessary to obtain federal financial participation 19 in the costs of activities described in sections 4 to 8, 10 to 15 and 17 of this 2011 Act. The 20 authority may seek necessary federal approval, including but not limited to:

(a) Federal approval necessary to enroll in coordinated care organizations individuals who 2122are dually eligible for Medicare and Medicaid, to integrate Medicare Advantage plans into 23coordinated care organizations and to implement the contracting procedures and blended reimbursement methods for coordinated care organizations that include members who are 2425dually eligible for Medicare and Medicaid, as provided in sections 7 and 8 of this 2011 Act. (3) The Oregon Health Authority may convene groups that include, but are not limited to, health insurance companies, health care centers, hospitals, health service organizations, employers, health care providers, health care facilities, state and local governmental entities and consumers, to facilitate the development and establishment of the Oregon Integrated and Coordinated Health Care Delivery System and health care payment reforms. Any participation by such entities and individuals shall be on a voluntary basis.
