

# House Bill 5009

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Budget and Management Division, Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Approves certain new or increased fees adopted by State Board of Licensed Social Workers.  
Declares emergency, effective July 1, 2011.

## A BILL FOR AN ACT

Relating to the financial administration of the State Board of Licensed Social Workers; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1. For the purpose of carrying out the provisions of ORS 291.055 (1)(e), the following new or increased fees for licensed clinical social workers, adopted by the State Board of Licensed Social Workers and approved by the Oregon Department of Administrative Services, are approved:**
