

# A-Engrossed House Bill 5022

Ordered by the House June 7  
Including House Amendments dated June 7

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Budget and Management Division, Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Department of Environmental Quality for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, specified bond proceeds and specified federal funds, collected or received by department.

Limits biennial expenditures from lottery moneys allocated from Parks and Natural Resources Fund to department.

Authorizes specified nonlimited expenditures.

Limits certain biennial expenditures by department from federal funds.

Declares emergency, effective July 1, 2011.

## A BILL FOR AN ACT

Relating to the financial administration of the Department of Environmental Quality; appropriating money; limiting expenditures; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1. There are appropriated to the Department of Environmental Quality, for the biennium beginning July 1, 2011, out of the General Fund, the following amounts, of which the department may expend up to 54 percent during the period beginning July 1, 2011, and ending June 30, 2012, for the following purposes:**

- (1) Air quality..... \$ 5,279,554
- (2) Water quality..... \$ 13,209,386
- (3) Land quality..... \$ 540,859
- (4) Cross program ..... \$ 666,615
- (5) Debt service ..... \$ 5,379,568

**SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2011, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, the proceeds of bonds for the Orphan Site Account and federal funds from congestion mitigation and air quality grants, drinking water protection, beach bacteria monitoring, laboratory accreditation and woodstove grants and for smoke monitoring laboratory services, but excluding lottery funds and federal funds not described in this section, collected or received by the Department of Environmental Quality, for the following purposes:**

- (1) Air quality..... \$ 40,037,109
- (2) Water quality..... \$ 22,269,315

- 1       (3) Land quality..... \$ 55,719,558
- 2       (4) Cross program ..... \$ 162,168
- 3       (5) Agency management..... \$ 21,941,682
- 4       (6) Debt service..... \$ 238,600

5       **SECTION 3.** Notwithstanding any other law limiting expenditures, the amount of  
6 \$4,503,053 is established for the biennium beginning July 1, 2011, as the maximum limit for  
7 payment of expenses from lottery moneys allocated from the Parks and Natural Resources  
8 Fund to the Department of Environmental Quality for activities and projects to implement  
9 section 4 (10), Article XV of the Oregon Constitution. The department may expend up to 54  
10 percent of the amount established under this section during the period beginning July 1, 2011,  
11 and ending June 30, 2012.

12       **SECTION 4.** For the biennium beginning July 1, 2011, the following expenditures by the  
13 Department of Environmental Quality are not limited:

- 14       (1) Expenditures for debt service and debt service administrative costs related to the  
15 Water Pollution Control Revolving Fund and the Pollution Control Fund; and
- 16       (2) Expenditures made for loans made from the Water Pollution Control Revolving Fund  
17 and loans from the Pollution Control Fund.

18       **SECTION 5.** Notwithstanding any other law limiting expenditures, the following amounts  
19 are established for the biennium beginning July 1, 2011, as the maximum limits for payment  
20 of expenses from federal funds other than those described in section 2 of this 2011 Act col-  
21 lected or received by the Department of Environmental Quality, for the following purposes:

- 22       (1) Air quality..... \$ 7,248,777
- 23       (2) Water quality..... \$ 12,117,300
- 24       (3) Land quality..... \$ 10,413,518
- 25       (4) Cross program ..... \$ 951,967

26       **SECTION 6.** This 2011 Act being necessary for the immediate preservation of the public  
27 peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect  
28 July 1, 2011.
