

HOUSE AMENDMENTS TO HOUSE BILL 5023

By JOINT COMMITTEE ON WAYS AND MEANS

1 On page 1 of the printed bill, delete lines 5 through 10 and insert:

2 **“SECTION 1. There are appropriated to the State Forestry Department, for the biennium**
3 **beginning July 1, 2011, out of the General Fund, the following amounts, of which the de-**
4 **partment may expend up to 54 percent during the period beginning July 1, 2011, and ending**
5 **June 30, 2012, for the following purposes:**

6 (1) **Fire protection..... \$ 32,726,322**

7 (2) **Private forests \$ 12,389,140**

8 (3) **Debt service \$ 2,836,524”.**

9 In line 17, delete “\$24,384,769” and insert “\$24,384,766”.

10 In line 18, delete “\$55,494,809” and insert “\$54,612,737”.

11 In line 19, delete “\$85,018,333” and insert “\$84,297,595”.

12 In line 20, delete “\$8,441,266” and insert “\$9,270,687”.

13 Delete lines 26 and 27.

14 On page 2, delete lines 1 through 3.

15 In line 4, delete “4” and insert “3”.

16 In line 5, delete “\$2,360,100” and insert “\$2,278,100”.

17 In line 8, after the period insert “The department may expend up to 54 percent of the amount
18 established under this section during the period beginning July 1, 2011, and ending June 30, 2012.”.

19 In line 9, delete “5” and insert “4”.

20 In line 13, delete “\$1,669,508” and insert “\$1,975,772”.

21 In line 14, delete “\$18,894,169” and insert “\$18,019,543”.

22 In line 15, delete “\$7,140,833” and insert “\$6,519,699”.

23 In line 16, delete “\$20,160,131” and insert “\$17,772,720”.

24 Delete lines 17 through 20.

25 In line 21, delete “7” and insert “5”.

26 After line 22, insert:

27 **“SECTION 6. (1) In addition to and not in lieu of any other appropriation, there is ap-**
28 **propriated to the Emergency Board, for the biennium beginning July 1, 2011, out of the**
29 **General Fund, the amount of \$4,781,000, to be allocated to the State Forestry Department for**
30 **fire protection expenses.**

31 **“(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**
32 **by the Emergency Board prior to December 1, 2012, the moneys remaining on that date be-**
33 **come available for any purpose for which the Emergency Board lawfully may allocate**
34 **funds.”.**

35 In line 23, delete “8” and insert “7”.
