

A-Engrossed House Bill 5041

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

- Appropriates moneys from General Fund to Secretary of State for certain biennial expenses.
- Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Secretary of State.
- Limits certain biennial expenditures by Secretary of State from federal funds.
- Declares emergency, effective July 1, 2011.

A BILL FOR AN ACT

2 Relating to the financial administration of the Secretary of State; appropriating money; limiting
3 expenditures; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Secretary of State, for the biennium beginning**
6 **July 1, 2011, out of the General Fund, the following amounts, of which the secretary may**
7 **expend up to 54 percent during the period beginning July 1, 2011, and ending June 30, 2012,**
8 **for the following purposes:**

- 9 (1) **Executive Office, Business**
- 10 **Services Division, Information**
- 11 **Systems Division and Human**
- 12 **Resources Division..... \$ 1,924,291**
- 13 (2) **Elections Division \$ 6,532,247**
- 14 (3) **Archives Division..... \$ 3,510,766**

15 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**
16 **are established for the biennium beginning July 1, 2011, as the maximum limit for payments**
17 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-**
18 **cluding lottery funds and federal funds, collected or received by the Secretary of State, for**
19 **the following purposes:**

- 20 (1) **Executive Office, Business**
- 21 **Services Division, Information**
- 22 **Systems Division and Human**
- 23 **Resources Division..... \$ 14,474,109**
- 24 (2) **Elections Division \$ 124,960**
- 25 (3) **Audits Division..... \$ 16,953,841**

3 **SECTION 3.** Notwithstanding any other law limiting expenditures, the amount of
4 \$6,925,028 is established for the biennium beginning July 1, 2011, as the maximum limit for
5 payment of expenses from federal funds collected or received by the Secretary of State.

6 **SECTION 4.** This 2011 Act being necessary for the immediate preservation of the public
7 peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect
8 July 1, 2011.
