

# A-Engrossed House Bill 5042

Ordered by the House May 17  
Including House Amendments dated May 17

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Budget and Management Division, Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Department of State Lands for certain purposes.

Limits certain biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2011.

## A BILL FOR AN ACT

Relating to the financial administration of the Department of State Lands; limiting expenditures; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

**SECTION 1.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2011, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Department of State Lands, for the following purposes:

- (1) **Common School Fund**  
programs..... \$ 20,528,449
- (2) **Oregon Removal-Fill**  
**Mitigation Fund** ..... \$ 1,791,136
- (3) **Natural Heritage Advisory**  
**Council** ..... \$ 27,770
- (4) **South Slough National**  
**Estuarine Research**  
**Reserve operations**..... \$ 3,914,909
- (5) **Capital improvements** ..... \$ 287,517

**SECTION 2.** Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2011, as the maximum limits for payment of expenses from federal funds collected or received by the Department of State Lands, for the following purposes:

- (1) **Common School Fund**  
programs..... \$ 176,268

6       **SECTION 3. For the biennium beginning July 1, 2011, expenditures by the Department**  
7 **of State Lands for unclaimed property finders fees and State Treasurer charges for**  
8 **investment-related transactions are not limited.**

9       **SECTION 4. This 2011 Act being necessary for the immediate preservation of the public**  
10 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**  
11 **July 1, 2011.**
