

HOUSE AMENDMENTS TO HOUSE BILL 5056

By JOINT COMMITTEE ON WAYS AND MEANS

June 27

1 In line 2 of the printed bill, delete “limiting expenditures;”.

2 Delete lines 5 through 16 and insert:

3 **“SECTION 1. (1) There is appropriated to the Judicial Department, for the biennium be-**
4 **ginning July 1, 2011, out of the General Fund, the amount of \$7,400,000 for the purpose of**
5 **providing conciliation and mediation services in circuit courts.**

6 **“(2) The Chief Justice of the Supreme Court shall distribute the moneys appropriated**
7 **under this section to the counties of this state to fund conciliation and mediation services**
8 **in circuit courts. The Chief Justice shall consult with the presiding judges of the circuit**
9 **courts before making the distributions.**

10 **“SECTION 2. (1) There is appropriated to the Judicial Department, for the biennium be-**
11 **ginning July 1, 2011, out of the General Fund, the amount of \$7,400,000 for the purpose of**
12 **operating law libraries or providing law library services.**

13 **“(2) The Chief Justice of the Supreme Court shall distribute the moneys appropriated**
14 **under this section to the counties of this state based on revenues received from filing fees**
15 **collected during the 2009-2011 biennium in civil actions commenced in the circuit court for**
16 **the county.**

17 **“SECTION 3. There is appropriated to the Judicial Department, for the biennium begin-**
18 **ning July 1, 2011, out of the General Fund, the amount of \$140,000 for the purpose of ad-**
19 **ministering the appellate mediation program established under ORS 2.560, including payment**
20 **of administrative costs and costs of providing mediation services to indigent parties.**

21 **“SECTION 4. There is appropriated to the Department of Human Services, for the**
22 **biennium beginning July 1, 2011, out of the General Fund, the amount of \$30,000 for the**
23 **purpose of funding the administration of ORS 417.805, 417.810 and 417.815 by the Office of**
24 **Children’s Advocate.**

25 **“SECTION 5. There is appropriated to the Housing and Community Services Department,**
26 **for the biennium beginning July 1, 2011, out of the General Fund, the amount of \$470,000 for**
27 **the purpose of providing housing for individuals and families with low incomes.**

28 **“SECTION 6. There is appropriated to the Oregon University System, for the biennium**
29 **beginning July 1, 2011, out of the General Fund, the amount of \$330,000 for the purpose of**
30 **funding clinical legal education programs at accredited institutions of higher education that**
31 **provide civil legal services to victims of domestic violence, stalking or sexual assault.**

32 **“SECTION 7. There is appropriated to the State Department of Agriculture, for the**
33 **biennium beginning July 1, 2011, out of the General Fund, the amount of \$150,000 for the**
34 **purpose of funding individual farm credit mediations.**

35 **“SECTION 8. This 2011 Act being necessary for the immediate preservation of the public**

1 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
2 **July 1, 2011.”.**
