(e) Committee chairpersons shall request fiscal and revenue impact statements for measures in 13 the chamber of origin no later than ______, 2011. (2) The rules of the Senate and House of Representatives shall apply to matters not specified in this resolution. The rules of the Senate and House of Representatives may establish timelines for priority measures, for measures approved by the presiding officers or for appropriation and fiscal measures approved by the Joint Committee on Ways and Means that are different from the timelines established in subsection (1) of this resolution.
