SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Allows State Board of Higher Education to authorize university under board control to establish university police department.

Declares emergency, effective on passage.

A BILL FOR AN ACT

Be It Enacted by the People of the State of Oregon: 8

SECTION 1. (1) The State Board of Higher Education may, at the request of a public 9 10 university under its control, authorize the university to establish a police department and commission one or more of its employees as police officers. 11

12 (2) Police officers commissioned under this section:

13 (a) Have all powers and authorities given by statute to peace officers and police officers of this state. 14

(b) Are not police officers for purposes of ORS 238.005, 243.005 or 243.736. 15

(c) Must complete training necessary for certification as police officers at an academy 16 operated or authorized by the Department of Public Safety Standards and Training. 17

(3) The board may adopt rules to carry out the provisions of this section. The rules may 18 describe the terms and conditions of employment for police officers commissioned under this 19 20 section and may include a prohibition on the possession and use of firearms in the course 21of official duty.

SECTION 2. ORS 352.385 is amended to read:

352.385. (1) The State Board of Higher Education may, at the request of [any institution] a public 2324 university under its control, authorize [that institution] the university to commission one or more of its employees as special campus security officers. [However,] The total number of special campus 25security officers commissioned at the [institutions] public universities in the Oregon University 26 27System [shall] may not exceed 50. Special campus security officers shall have stop and frisk authority as set forth in ORS 131.605 to 131.625 and probable cause arrest authority and the accom-28 29 panying immunities as set forth in ORS 133.310 and 133.315 when acting in the scope of their employment as defined by the State Board of Higher Education. Special campus security officers 30

(1) The State Board of Higher Education may enact such regulations as the board deems convenient or necessary to provide for the policing, control and regulation of traffic and parking 10 of vehicles on the property of any institution of higher education under the jurisdiction of the board. 11 12 The regulations may provide for the registration of vehicles, the designation of parking areas, and 13 the assessment and collection of reasonable fees and charges for parking, and shall be filed in accordance with the provisions of ORS chapter 183. The board may require that before a quarterly 14 15 or yearly parking privilege for any vehicle is granted to any full-time or part-time student to use 16 board property, the student must show that the vehicle is operated by a student holding a valid driver's license, that the vehicle is currently registered and that the student driving the vehicle is 17 18 insured under a motor vehicle liability insurance policy that meets the requirements described under 19 ORS 806.080 or that the student or owner of the vehicle has provided the Department of Transpor-20tation with other satisfactory proof of compliance with the financial responsibility requirements of 21this state.

22(2) The regulations enacted pursuant to subsection (1) of this section shall be enforced admin-23istratively under procedures adopted by the board for each institution of higher education under the jurisdiction of the board. Administrative and disciplinary sanctions may be imposed upon students, 24 25faculty and staff for violation of the regulations, including but not limited to, a reasonable monetary penalty which may be deducted from student deposits, and faculty or staff salaries or other funds 26in the possession of the institution. The board shall provide opportunity for hearing for the deter-27mination of controversies in connection with imposition of fines or penalties. The board may pre-28scribe procedures for such hearings despite the provisions of ORS 183.413 to 183.470. Persons other 2930 than students, faculty or staff may voluntarily submit to the hearing procedures prescribed by the 31 board, and shall be bound by the results of the hearing. The powers granted to the board by this section are supplemental to the existing powers of the board with respect to the government of ac-32tivities of students, faculty and staff and the control and management of property under its juris-33 34 diction.

(3) The regulations enacted pursuant to subsection (1) of this section may also be enforced by the impoundment of vehicles, and a reasonable fee may be enacted for the cost of impoundment and storage, if any, prior to the release of the vehicles to their owners.

38 (4) All fees and charges for parking privileges and violations are deposited in a designated ac-39 count in the Oregon University System Fund established by ORS 351.506 for the purpose of defraying the costs of constructing bicycle racks and bicycle lanes and of traffic control, enforcement of traffic 40 and parking regulations, and maintenance and operation of parking facilities and for the purpose 41 of acquiring and constructing additional parking facilities for vehicles at the various institutions, 42 departments or activities under the control of the board. Fees and charges may also be credited to 43 the account in the Oregon University System Fund designated by ORS 351.460. (8) "Operate" means to navigate or otherwise use a boat.

(9) "Operator of a boat livery" means any person who is engaged wholly or in part in the busi ness of chartering or renting boats to other persons.

(10) "Passenger" means every person on board a boat who is not the master, operator, crew
 member or other person engaged in any capacity in the business of the boat.

(11) "Peace officer" includes a member of the Oregon State Police, a sheriff or deputy sheriff,
[and] a city police officer and a university police officer commissioned under section 1 of this
2011 Act.

1 (12) "State waters" means those waters entirely within the confines of this state that have not 2 been declared navigable waters of the United States.

3 (13) "Waters of this state" means all waters within the territorial limits of this state, the mar-4 ginal sea adjacent to this state and the high seas when navigated as part of a journey or ride to 5 or from the shore of this state.

SECTION 52. Section 2, chapter 102, Oregon Laws 2010, is amended to read:

Sec. 2. (1) Except as provided in subsection (2) of this section, it is an unlawful employment practice for an employer to obtain or use for employment purposes information contained in the credit history of an applicant for employment or an employee, or to refuse to hire, discharge, demote, suspend, retaliate or otherwise discriminate against an applicant or an employee with regard to promotion, compensation or the terms, conditions or privileges of employment based on information in the credit history of the applicant or employee.

14 (a) Employers that are federally insured banks or credit unions;

(b) Employers that are required by state or federal law to use individual credit history for em ployment purposes;

(c) The employment of a public safety officer who is a member of a law enforcement unit, who is employed as a peace officer commissioned by a city, port, school district, mass transit district, county, **university under section 1 of this 2011 Act**, Indian reservation, the Criminal Justice Division of the Department of Justice, the Oregon State Lottery Commission or the Governor and who is responsible for enforcing the criminal laws of this state or laws or ordinances related to airport security; or

(d) The obtainment or use by an employer of information in the credit history of an applicant
or employee because the information is substantially job-related and the employer's reasons for the
use of such information are disclosed to the employee or prospective employee in writing.

(3) An employee or an applicant for employment may file a complaint under ORS 659A.820 for
violations of this section and may bring a civil action under ORS 659A.885 and recover the relief
as provided by ORS 659A.885 (1) and (2).

(4) As used in this section, "credit history" means any written or other communication of any
 information by a consumer reporting agency that bears on a consumer's creditworthiness, credit
 standing or credit capacity.
