

Senate Bill 141

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor John A. Kitzhaber for State Board of Examiners for Speech-Language Pathology and Audiology)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies provisions relating to State Board of Examiners for Speech-Language Pathology and Audiology and licensure of speech-language pathologists and audiologists.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to the State Board of Examiners for Speech-Language Pathology and Audiology; creating
3 new provisions; amending ORS 681.230, 681.260, 681.264, 681.300, 681.320, 681.340, 681.360 and
4 681.490; repealing ORS 681.280 and 681.365; and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 681.230 is amended to read:

7 681.230. (1) [*Nothing in this chapter prevents*] **This chapter does not apply to:**

8 (a) A person licensed in this state under any other law [*from*] **who is** engaging in the profession
9 for which the person is licensed.

10 [(2) *Nothing in this chapter restricts or prevents a person from engaging in speech-language*
11 *pathology or audiology activities or from using the official title of the position for which the person is*
12 *employed if the person.*]

13 (b) **A speech-language pathologist who:**

14 [(a)(A)] (A) Holds a valid and current teaching license with a communications disorder
15 endorsement issued by the Teacher Standards and Practices Commission; and

16 (B) Is employed by an education service district, a school district or a charter school.[: or]

17 [(b) *Is a speech-language pathologist or audiologist who is:*]

18 [(A) *Employed by a federal agency; or*]

19 [(B) *Employed by an approved college or university.*]

20 [(3) *A person who performs activities described in subsection (2) of this section who is not licensed*
21 *under this chapter must do so solely within the confines of or under the jurisdiction of the organization*
22 *in which the person is employed and may not offer to render speech-language pathology or audiology*
23 *services to the public for compensation over and above the salary the person receives for performance*
24 *of the person's official duties with organizations in which the person is employed. However,*]

25 (c) **An individual who is trained and working under the supervision of a physician licensed**
26 **under ORS chapter 677, performing audiometry testing and representing that the individual**
27 **is a medical assistant or audiology assistant.**

28 (d) **A person holding a Class A certificate issued by the Conference of Educational Ad-**
29 **ministrators of Schools and Programs for the Deaf who is performing the functions for which**
30 **the person qualifies.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.
New sections are in **boldfaced** type.

1 **(e) A person holding a license in this state as a hearing aid specialist who is consulting**
 2 **with respect to the selling of hearing aids under ORS chapter 694.**

3 **(2)** Without obtaining a license under this chapter, a person may:

4 **(a)** Consult or disseminate the person’s research findings and scientific information to other
 5 accredited academic institutions or governmental agencies[.]; **and**

6 **(b)** *[The person also may] Offer lectures to the public for a fee, monetary or otherwise[, without*
 7 *being licensed under this chapter].*

8 **[(4)] (3)** Nothing in this chapter restricts the activities and services of a student of speech-
 9 language pathology pursuing a course of study in speech-language pathology at an approved college
 10 or university or an approved clinical training facility[. *However, these] if the activities and services*
 11 *[must] constitute a part of the supervised course of study of the student [and]. A fee may not accrue*
 12 *directly or indirectly to the student. A student [shall] must be designated by a title such as*
 13 *“Speech-Language Pathology Intern,” “Speech-Language Pathology Trainee” or other title clearly*
 14 *indicating the training status appropriate to the level of training of the student.*

15 **[(5)] (4)** Nothing in this chapter restricts the activities and services of a student of audiology
 16 pursuing a course of study in audiology at an approved college or university or an approved clinical
 17 training facility[. *However, these] if the activities and services [must] constitute a part of the*
 18 *supervised course of study of the student [and]. A fee may not accrue directly or indirectly to the*
 19 *student. The student [shall] must be designated by a title such as “Audiology Intern,” “Audiology*
 20 *Trainee” or other title clearly indicating the training status appropriate to the level of training of*
 21 *the student.*

22 **[(6)]** *Nothing in this chapter restricts a person holding a Class A certificate issued by the Confer-*
 23 *ence of Executives of American Schools of the Deaf from performing the functions for which the person*
 24 *qualifies.]*

25 **[(7)]** *Nothing in this chapter restricts a person holding a license in this state as a hearing aid spe-*
 26 *cialist from consulting with respect to the selling of hearing aids under ORS chapter 694.]*

27 **[(8)] (5)** Notwithstanding subsections **(3) and (4) [and (5)]** of this section, the State Board of
 28 Examiners for Speech-Language Pathology and Audiology may adopt rules authorizing payment of
 29 a stipend to students of speech-language pathology and students of audiology who are pursuing a
 30 course of study at an approved college or university or an approved clinical training facility.

31 **SECTION 2.** ORS 681.260 is amended to read:

32 681.260. **[(1)]** An applicant is eligible for licensing by the State Board of Examiners for Speech-
 33 Language Pathology and Audiology as a speech-language pathologist if the applicant:

34 **[(a)]** *Possesses at least a master’s degree or equivalent in the area of speech-language pathology*
 35 *from an approved college or university.]*

36 **[(b)]** *Submits transcripts from one or more approved colleges or universities presenting evidence of*
 37 *the completion of at least 60 semester hours constituting a well-integrated program that includes at least*
 38 *18 semester hours in courses that provide fundamental information applicable to normal development*
 39 *and use of speech, hearing and language, and at least 42 semester hours in courses that provide in-*
 40 *formation about and training in the management of speech, hearing and language disorders and that*
 41 *provide information supplementary to these fields.]*

42 **[(c)]** *Submits evidence of the completion of a minimum of 275 clock hours of supervised, direct*
 43 *clinical experience with individuals presenting a variety of disorders of communication. The experience*
 44 *must be obtained within the training institution or in one of its cooperating programs.]*

45 **[(d)]** *Presents written evidence from a licensed or certified speech-language pathologist supervisor*

1 of nine months of full-time post-educational professional employment, or its part-time equivalent, that
 2 is pertinent to the speech-language pathologist license. For purposes of this paragraph, "full-time"
 3 means at least nine months in a calendar year and a minimum of 30 hours per week, and "part-time
 4 equivalent" means:]

5 [(A) 15 to 19 hours per week during a period of at least 72 weeks.]

6 [(B) 20 to 24 hours per week during a period of at least 60 weeks.]

7 [(C) 25 to 29 hours per week during a period of at least 48 weeks.]

8 [(e) Passes an examination approved by the board. The board shall determine the subject and scope
 9 of the examinations. Written examinations may be supplemented by oral examinations as the board
 10 determines. An applicant who fails the examination may be reexamined at a subsequent examination.]

11 [(2) Of the 42 semester hours required under subsection (1)(b) of this section:]

12 [(a) No fewer than six semester hours may be in audiology;]

13 [(b) No more than six semester hours may be in courses that provide academic credit for clinical
 14 practice;]

15 [(c) At least 24 semester hours, not including credit for thesis or dissertation, must be in courses
 16 in the field for which the license is requested; and]

17 [(d) At least 30 semester hours must be in courses acceptable toward a graduate degree by the
 18 college or university in which those courses are taken.]

19 **(1) Possesses a master's or doctoral degree in speech-language pathology from an edu-
 20 cational institution accredited by an accrediting organization approved by the board, or an
 21 equivalent degree as determined by the board;**

22 **(2) Completed all requirements for the degree required by subsection (1) of this section
 23 at an educational institution accredited by an accrediting organization approved by the
 24 board;**

25 **(3) Has completed supervised clinical experience required by the board by rule;**

26 **(4) Has passed examinations required by the board by rule; and**

27 **(5) Meets other requirements established by the board by rule.**

28 **SECTION 3.** ORS 681.264 is amended to read:

29 681.264. [(1)] An applicant is eligible for licensing by the State Board of Examiners for Speech-
 30 Language Pathology and Audiology as an audiologist if the applicant:

31 [(a) Possesses a Doctor of Audiology degree from an educational institution accredited by a body
 32 recognized by the United States Department of Education and submits transcripts from the educational
 33 institution that awarded the Doctor of Audiology degree to the applicant; or]

34 [(b) Possesses a master's degree or equivalent in the area of audiology from an approved college
 35 or university and submits all of the following to the board:]

36 [(A) Transcripts from one or more approved colleges or universities presenting evidence of the
 37 completion of at least 60 semester hours constituting a well-integrated program that includes at least
 38 18 semester hours in courses that provide fundamental information applicable to normal development
 39 and use of speech, hearing and language, and at least 42 semester hours in courses that provide in-
 40 formation about and training in the management of speech, hearing and language disorders and that
 41 provide information supplementary to those fields.]

42 [(B) Evidence of the completion of a minimum of 275 clock hours of supervised, direct clinical ex-
 43 perience with individuals presenting a variety of disorders of communication. The experience must be
 44 obtained within the training institution or in one of its cooperating programs.]

45 [(C) Written evidence from a licensed or certified audiologist supervisor of nine months of full-time

1 *post-educational professional employment, or its part-time equivalent, that is pertinent to an audiology*
 2 *license. For purposes of this subparagraph, "full-time" means at least nine months in a calendar year*
 3 *and a minimum of 30 hours per week, and "part-time equivalent" means:]*

4 *[(i) 15 to 19 hours per week during a period of at least 72 weeks.]*

5 *[(ii) 20 to 24 hours per week during a period of at least 60 weeks.]*

6 *[(iii) 25 to 29 hours per week during a period of at least 48 weeks.]*

7 *[(2) Of the 42 semester hours required under subsection (1)(b) of this section:]*

8 *[(a) No fewer than six semester hours may be in speech-language pathology;]*

9 *[(b) No more than six semester hours may be in courses that provide academic credit for clinical*
 10 *practice;]*

11 *[(c) At least 24 semester hours, not including credit for thesis or dissertation, must be in courses*
 12 *in the field for which the license is requested; and]*

13 *[(d) At least 30 semester hours must be in courses acceptable toward a graduate degree by the*
 14 *college or university in which those courses are taken.]*

15 *[(3) In addition to meeting the requirements under subsection (1) of this section, an applicant must*
 16 *pass an examination approved by the board. The board shall determine the subject and scope of the*
 17 *examinations. Written examinations may be supplemented by oral examinations as the board deter-*
 18 *mines. An applicant who fails the examination may be reexamined at a subsequent examination.]*

19 **(1) Possesses a degree from an educational institution accredited by an accrediting or-**
 20 **ganization approved by the board that meets the following requirements:**

21 **(a) If the degree was awarded on or before August 30, 2007, the applicant must possess**
 22 **a master's or doctoral degree in audiology; or**

23 **(b) If the degree was awarded after August 30, 2007, the applicant must possess a doctoral**
 24 **degree with an emphasis in audiology, or an equivalent degree as determined by the board;**

25 **(2) Completed all requirements for the degree required by subsection (1) of this section**
 26 **at an educational institution accredited by an accrediting organization approved by the**
 27 **board;**

28 **(3) Has completed supervised clinical experience required by the board by rule;**

29 **(4) Has passed examinations required by the board by rule; and**

30 **(5) Meets other requirements established by the board by rule.**

31 **SECTION 4. Section 5 of this 2011 Act is added to and made a part of ORS chapter 681.**

32 **SECTION 5. (1) The State Board of Examiners for Speech-Language Pathology and**
 33 **Audiology may adopt rules allowing for the issuance of a temporary speech-language**
 34 **pathology or audiology license or a temporary speech-language pathology assistant certif-**
 35 **icate.**

36 **(2) The board may establish fees for temporary licenses and certificates.**

37 **SECTION 6. ORS 681.300 is amended to read:**

38 **681.300.** The State Board of Examiners for Speech-Language Pathology and Audiology may waive
 39 the examination described in ORS 681.290 and grant a license to:

40 *[(1) An applicant who presents proof of a current license in a state that has standards equivalent*
 41 *to the standards of this state.]*

42 *[(2)] (1) An applicant who holds the Certificate of Clinical Competence of the American*
 43 *Speech-Language-Hearing Association in the area for which the person is applying for a license.*

44 *[(3)] (2) An audiology applicant who is certified by the American Board of Audiology.*

45 **SECTION 7. ORS 681.320 is amended to read:**

1 681.320. (1) On or before [*January 30*] **December 31** of each [*even-numbered*] **odd-numbered**
 2 year, or on or before such date as may be specified by rule of the State Board of Examiners for
 3 Speech-Language Pathology and Audiology, each licensed speech-language pathologist or audiologist
 4 shall submit to the board an application for renewal of license and pay the renewal fee established
 5 by the board. The application shall include the following:

6 (a) Evidence of participation in professional development. Participation in professional devel-
 7 opment includes continuing education or other demonstrations of professional development that the
 8 board may recognize by rule.

9 (b) Evidence of compliance with all other requirements established by the board.

10 (2) A person who applies for renewal and whose license has expired may not be required to
 11 submit to any examination as a condition to renewal if the renewal application is made within four
 12 years from the date of expiration of the license.

13 (3) A suspended license is subject to expiration and must be renewed as provided in this section,
 14 but renewal does not entitle the licensee while the license remains suspended to engage in the li-
 15 censed activity, or in any other activity or conduct that violates the order or judgment by which
 16 the license was suspended.

17 (4) A license revoked on disciplinary grounds is subject to expiration and may not be renewed.
 18 If the license is reinstated after its expiration, the licensee, as a condition of reinstatement, shall
 19 pay a reinstatement fee in an amount equal to the renewal fee in effect on the last preceding regular
 20 renewal date before the date on which it is reinstated, plus a delinquency fee, if any, accrued at the
 21 time of revocation of the license.

22 (5) A person who fails to renew a license within the four years after its expiration may not re-
 23 new the license. The license may not be restored, reissued or reinstated thereafter, but the person
 24 may reapply for and obtain a new license if the person meets the requirements of this chapter and
 25 rules adopted by the board.

26 **SECTION 8.** ORS 681.340 is amended to read:

27 681.340. (1) The State Board of Examiners for Speech-Language Pathology and Audiology may,
 28 by rule, impose fees for the following:

29 (a) License **or certificate** fee and renewal thereof.

30 (b) Delinquency fee.

31 (c) Application fee.

32 (d) Inactive license fee.

33 (e) Conditional license fee and renewal thereof.

34 **(f) Temporary license or certificate fee and renewal thereof.**

35 (2) Every person to whom a license is issued shall, as a condition precedent to its issuance, and
 36 in addition to any application, examination or other fee, pay the prescribed initial license fee. The
 37 board may, by rule, provide for waiver of such fee where the license is issued less than 45 days
 38 before the date on which it will expire.

39 (3) Fees established by the board under subsection (1) of this section shall be in accordance with
 40 ORS 291.050 to 291.060.

41 (4) The fees collected by the board are exclusive and a municipality may not require any person
 42 licensed under the provisions of this chapter to furnish any bond or pass any examination.

43 **SECTION 9.** ORS 681.360 is amended to read:

44 681.360. (1) A person may not perform the duties of a speech-language pathology assistant or
 45 use the title speech-language pathology assistant without a certificate to do so issued under this

1 section.

2 (2) To obtain a certificate to perform the duties of a speech-language pathology assistant, a
3 person shall:

4 (a) Submit an application in the form prescribed by the State Board of Examiners for Speech-
5 Language Pathology and Audiology;

6 (b) Pay the certificate fee established by the board;

7 (c) Demonstrate that the person meets the qualifications for certification established by the
8 board; and

9 (d) Comply with all other requirements for certification established by the board.

10 (3) A certificate issued under this section expires every two years. To renew a certificate to
11 perform the duties of a speech-language pathology assistant, a person shall:

12 (a) Submit the renewal application in the form prescribed by the board;

13 (b) Pay the renewal fee established by the board; and

14 (c) Comply with all other requirements for certificate renewal established by the board, includ-
15 ing but not limited to submission of evidence of participation in professional development activities.

16 (4) A person may not employ or otherwise use the services of a speech-language pathology as-
17 sistant unless the speech-language pathology assistant is certified under this section.

18 (5) The board may establish by rule [*criteria*] **qualifications and conditions** under which a
19 person not licensed under this chapter who holds a basic or standard teaching license in speech
20 impaired or an initial or continuing teaching license in communication disorders issued by the
21 Teaching Standards and Practices Commission may supervise a speech-language pathology assistant
22 working in a school.

23 (6) The board may refuse to issue a certificate, or may suspend or revoke the certificate, of any
24 certified speech-language pathology assistant pursuant to the provisions of ORS 681.350.

25 **SECTION 10.** ORS 681.490 is amended to read:

26 681.490. (1) The State Board of Examiners for Speech-Language Pathology and Audiology:

27 (a) May, upon its own motion, investigate any alleged violation of this chapter.

28 (b) Shall, upon the complaint of any resident of this state, investigate any alleged violation of
29 this chapter.

30 (2) In the conduct of investigations, the board may:

31 (a) Take evidence;

32 (b) Take the depositions of witnesses, including the person charged, in the manner provided by
33 law in civil cases;

34 (c) Compel the appearance of witnesses, including the person charged, before the board in per-
35 son the same as in civil cases;

36 (d) Require answers to interrogatories; and

37 (e) Compel the production of books, papers, accounts, documents and testimony pertaining to the
38 matter under investigation.

39 (3) In exercising its authority under subsection (2) of this section, the board may issue subpoenas
40 over the signature of the board chairperson, **vice chairperson or executive director** and the seal
41 of the board in the name of the State of Oregon.

42 (4) The board may bring a cause of action for injunction or other appropriate remedy to enforce
43 any provision of this chapter.

44 (5) In addition to or in lieu of any other sanction permitted under this chapter, the board may
45 impose a civil penalty of up to \$5,000 for each violation of the provisions of this chapter or rules

1 adopted by the board under this chapter. A civil penalty imposed under this section shall be imposed
2 in the manner provided in ORS 183.745.

3 **SECTION 11. ORS 681.280 and 681.365 are repealed.**

4 **SECTION 12. (1) The amendments to ORS 681.230 by section 1 of this 2011 Act become**
5 **operative on January 1, 2012.**

6 **(2) The State Board of Examiners for Speech-Language Pathology and Audiology may**
7 **take any action necessary before the operative date specified in subsection (1) of this section**
8 **to enable the board to exercise, on and after the operative date specified in subsection (1)**
9 **of this section, all the duties, functions and powers conferred on the board by the amend-**
10 **ments to ORS 681.230 by section 1 of this 2011 Act.**

11 **SECTION 13. The amendments to ORS 681.260 and 681.264 by sections 2 and 3 of this 2011**
12 **Act apply to applicants who submit applications to the State Board of Examiners for**
13 **Speech-Language Pathology and Audiology on or after the effective date of this 2011 Act.**

14 **SECTION 14. This 2011 Act being necessary for the immediate preservation of the public**
15 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
16 **on its passage.**
