SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Changes name of Emergency Medical Services and Trauma Systems Program to Trauma and Emergency Health Care System Program.]
[Changes name of Oregon Trauma Registry to Oregon Emergency Health Care and Trauma Registries.]
[Creates Trauma and Emergency Health Care System Advisory Board, State Trauma Advisory Board, Stroke Care Committee and State Pediatric Emergency Health Care Advisory Committee.]
[Declares emergency, effective on passage.]
Modifies terminology relating to emergency medical services providers.
Directs Oregon Health Authority to establish levels of licensure for emergency medical services providers.

8 **Be It Enacted by the People of the State of Oregon:**

9 **SECTION 1.** ORS 431.623 is amended to read:

10 431.623. (1) The Emergency Medical Services and Trauma Systems Program is created within the
11 Oregon Health Authority for the purpose of administering and regulating ambulances, training and
12 *[certifying]* **licensing** emergency medical *[technicians]* **services providers**, establishing and main-
13 taining emergency medical systems, including trauma systems, and maintaining the Oregon Trauma
14 Registry, as necessary for trauma reimbursement, system quality assurance and ensuring cost effi-
15 ciency.

16 (2) For purposes of ORS 431.607 to 431.619 and ORS chapter 682, the duties vested in the au-
17 thority shall be performed by the Emergency Medical Services and Trauma Systems program.

18 (3) The program shall be administered by a director.

19 (4) With moneys transferred to the program by ORS 442.625, the director of the program shall
20 apply those moneys to:

21 (a) Developing state and regional standards of care;

22 (b) Developing a statewide educational curriculum to teach standards of care;

- 1 (c) Implementing quality improvement programs;
- 2 (d) Creating a statewide data system for prehospital care; and
- 3 (e) Providing ancillary services to enhance Oregon's emergency medical service system.
- 4 (5) The director of the program shall adopt rules for the Oregon Trauma Registry, establishing:
- 5 (a) The information that must be reported by trauma centers;
- 6 (b) The form and frequency of reporting; and
- 7 (c) Procedures and standards for the administration of the registry.

8 **SECTION 2.** ORS 682.017 is amended to read:

9 682.017. (1) In accordance with ORS chapter 183, the Oregon Health Authority may adopt [*and*
10 *may when necessary amend or repeal such*] rules as [*are*] necessary for carrying out this chapter.

11 (2) The authority [*is authorized and directed to*] **shall** establish appropriate rules in accordance
12 with the provisions of ORS chapter 183 concerning the administration of this chapter. Such rules
13 may [*deal with*] **include**, but are not limited to[, *such matters as*]:

14 (a) [*Criteria for*] Requirements[,] **relating to the** types and numbers of emergency vehicles, in-
15 cluding supplies and equipment carried[.];

16 (b) Requirements for the operation and coordination of ambulances and other emergency care
17 systems[.];

18 (c) Criteria for the use of two-way communications[.]; **and**

19 (d) Procedures for summoning and dispatching aid [*and other necessary and proper matters*].

20 (3) **The authority shall adopt rules establishing levels of licensure for emergency medical**
21 **services providers. The lowest level of emergency medical services provider licensure must**
22 **be an emergency medical responder license.**

23 **SECTION 3.** ORS 682.025 is amended to read:

24 682.025. As used in this chapter, unless the context requires otherwise:

25 (1) "Ambulance" or "ambulance vehicle" means [*any*] **a** privately or publicly owned motor vehi-
26 cle, aircraft or watercraft that is regularly provided or offered to be provided for the emergency
27 transportation of persons who are ill or injured or who have disabilities.

28 (2) "Ambulance service" means [*any*] **a** person, governmental unit[, *corporation, partnership, sole*
29 *proprietorship*] or other entity that operates ambulances and that holds itself out as providing pre-
30 hospital care or medical transportation to persons who are ill or injured or who have disabilities.

31 [(3) "Authority" means the Oregon Health Authority.]

32 [(4) "Board" means the Oregon Medical Board.]

33 [(5)] (3) "Emergency care" means the performance of acts or procedures under emergency con-
34 ditions in the observation, care and counsel of persons who are ill or injured or who have disabili-
35 ties; in the administration of care or medications as prescribed by a licensed physician, insofar as
36 any of these acts is based upon knowledge and application of the principles of biological, physical
37 and social science as required by a completed course utilizing an approved curriculum in prehospital
38 emergency care. However, "emergency care" does not include acts of medical diagnosis or pre-
39 scription of therapeutic or corrective measures.

40 [(6)] (4) "Emergency medical [*technician*] or "EMT" **services provider**" means a person who
41 has received formal training in prehospital and emergency care, and is [*state certified*] **licensed** to
42 attend any person who is ill or injured or who has a disability. Police officers, firefighters, funeral
43 home employees and other [*personnel*] **persons** serving in a dual capacity one of which meets the
44 definition of "emergency medical [*technician*] **services provider**" are "emergency medical [*techni-*
45 *cians*] **services providers**" within the meaning of this chapter.

1 [(7) “First responder” means a person who has successfully completed a first responder training
2 course approved by the authority and:]

3 [(a) Has been examined and certified as a first responder by an authorized representative of the
4 authority to perform basic emergency and nonemergency care procedures; or]

5 [(b) Has been otherwise designated as a first responder by an authorized representative of the au-
6 thority to perform basic emergency and nonemergency care procedures.]

7 [(8)] (5) “Fraud or deception” means the intentional misrepresentation or misstatement of a
8 material fact, concealment of or failure to make known any material fact, or any other means by
9 which misinformation or false impression knowingly is given.

10 [(9)] (6) “Governmental unit” means the state or any county, municipality or other political
11 subdivision or any department, board or other agency of any of them.

12 [(10)] (7) “Highway” means every public way, thoroughfare and place, including bridges, viaducts
13 and other structures within the boundaries of this state, used or intended for the use of the general
14 public for vehicles.

15 [(11)] (8) “Nonemergency care” means the performance of acts or procedures on a patient who
16 is not expected to die, become permanently disabled or suffer permanent harm within the next 24
17 hours, including but not limited to observation, care and counsel of a patient and the administration
18 of medications prescribed by a physician licensed under ORS chapter 677, insofar as any of those
19 acts are based upon knowledge and application of the principles of biological, physical and social
20 science and are performed in accordance with scope of practice rules adopted by the Oregon Med-
21 ical Board in the course of providing prehospital care [as defined by this section].

22 [(12)] (9) “Owner” means the person having all the incidents of ownership in an ambulance
23 service or an ambulance vehicle or where the incidents of ownership are in different persons, the
24 person, other than a security interest holder or lessor, entitled to the possession of an ambulance
25 vehicle or operation of an ambulance service under a security agreement or a lease for a term of
26 10 or more successive days.

27 [(13)] (10) “Patient” means a person who is ill or injured or who has a disability and who is
28 transported in an ambulance.

29 [(14) “Person” means any individual, corporation, association, firm, partnership, joint stock com-
30 pany, group of individuals acting together for a common purpose or organization of any kind and in-
31 cludes any receiver, trustee, assignee or other similar representative thereof.]

32 [(15)] (11) “Prehospital care” means [that] care rendered by emergency medical [technicians]
33 **services providers** as an incident of the operation of an ambulance [as defined by this chapter] and
34 [that] care rendered by emergency medical [technicians] **services providers** as incidents of other
35 public or private safety duties, and includes, but is not limited to, “emergency care” [as defined by
36 this section].

37 [(16)] (12) “Scope of practice” means the maximum level of emergency or nonemergency care
38 that an emergency medical [technician] **services provider** may provide.

39 [(17)] (13) “Standing orders” means the written protocols that an emergency medical
40 [technician] **services provider** follows to treat patients when direct contact with a physician is not
41 maintained.

42 [(18)] (14) “Supervising physician” means a medical or osteopathic physician licensed under ORS
43 chapter 677, actively registered and in good standing with the board, who provides direction of
44 emergency or nonemergency care provided by emergency medical [technicians] **services providers**.

45 [(19)] (15) “Unprofessional conduct” means conduct unbecoming a person [certified in] **licensed**

1 **to perform** emergency care, or detrimental to the best interests of the public and includes:

2 (a) Any conduct or practice contrary to recognized standards of ethics of the medical profession
3 or any conduct or practice which does or might constitute a danger to the health or safety of a
4 patient or the public or any conduct, practice or condition which does or might impair an emergency
5 medical [*technician's*] **services provider's** ability safely and skillfully to practice emergency or
6 nonemergency care;

7 (b) Willful performance of any medical treatment which is contrary to acceptable medical stan-
8 dards; and

9 (c) Willful and consistent utilization of medical service for treatment which is or may be con-
10 sidered inappropriate or unnecessary.

11 **SECTION 4.** ORS 682.028 is amended to read:

12 682.028. (1) [*It is unlawful for any*] **A** person or governmental unit [*to*] **may not**:

13 (a) Intentionally make any false statement on an application for an ambulance service license,
14 ambulance vehicle license or for [*certification*] **licensure** as an emergency medical [*technician or first*
15 *responder*] **services provider** or on any other documents required by the Oregon Health Authority;
16 or

17 (b) Make any misrepresentation in seeking to obtain or retain a [*certification or*] license.

18 (2) [*Any*] **A** violation described in subsection (1) of this section is also grounds for denial, sus-
19 pension or revocation of a [*certification or*] license under ORS 682.220.

20 **SECTION 5.** ORS 682.031 is amended to read:

21 682.031. (1) As used in this section, "political subdivision" includes counties, cities, districts,
22 authorities and other public corporations and entities organized and existing under statute or
23 charter.

24 (2) An ordinance of any political subdivision regulating ambulance services or emergency med-
25 ical [*technicians shall*] **services providers may** not require less than is required under ORS 820.300
26 to 820.380, or this chapter or the rules adopted by the Oregon Health Authority under this chapter.

27 (3) When a political subdivision enacts an ordinance regulating ambulance services or emer-
28 gency medical [*technicians*] **services providers**, the ordinance must comply with the county plan for
29 ambulance services and ambulance service areas adopted under ORS 682.062 by the county in which
30 the political subdivision is situated and with the rules of the Oregon Health Authority relating to
31 such services and service areas. The **county governing body shall make the** determination of
32 whether the ordinance is in compliance with the county plan [*shall be made by the county governing*
33 *body*].

34 **SECTION 6.** ORS 682.039 is amended to read:

35 682.039. (1) The Oregon Health Authority shall appoint a State Emergency Medical Service
36 Committee composed of 18 members as follows:

37 (a) Seven physicians licensed under ORS chapter 677 whose practice consists of routinely
38 treating emergencies such as cardiovascular illness or trauma, appointed from a list submitted by
39 the Oregon Medical Board.

40 (b) Four emergency medical [*technicians*] **services providers** whose practices consist of rou-
41 tinely treating emergencies, including but not limited to cardiovascular illness or trauma, at least
42 one of whom is at the lowest level of **licensure for** emergency medical [*technician certification*]
43 **services providers** established by the authority at the time of appointment. [*EMTs*] **Emergency**
44 **medical services providers** appointed pursuant to this paragraph [*shall*] **must** be selected from
45 lists submitted by each area trauma advisory board. The lists [*shall*] **must** include nominations from

1 entities including but not limited to organizations that represent emergency care providers in
2 Oregon.

3 (c) One volunteer ambulance operator[.].

4 (d) One person representing governmental agencies that provide ambulance services [*and*].

5 (e) One person representing a private ambulance company.

6 [(d)] (f) One hospital administrator.

7 [(e)] (g) One nurse who has served at least two years in the capacity of an emergency depart-
8 ment nurse.

9 [(f)] (h) One representative of an emergency dispatch center.

10 [(g)] (i) One community college or licensed career school representative.

11 (2) The committee shall include at least one resident but no more than three residents from each
12 region served by one area trauma advisory board at the time of appointment.

13 (3) Appointments shall be made for a term of four years in a manner to preserve [*insofar*] **as**
14 **much** as possible the representation of the organization described in subsection (1) of this section.
15 Vacancies shall be filled for any unexpired term as soon as the authority can make such appoint-
16 ments. The committee shall choose its own chairperson and shall meet at the call of the chairperson
17 or the Director of the Oregon Health Authority.

18 (4) The State Emergency Medical Service Committee shall:

19 (a) Advise the authority concerning the adoption, amendment and repeal of rules authorized by
20 this chapter;

21 (b) Assist the Emergency Medical Services and Trauma Systems Program in providing state and
22 regional emergency medical services coordination and planning;

23 (c) Assist communities in identifying emergency medical service system needs and quality im-
24 provement initiatives;

25 (d) Assist the Emergency Medical Services and Trauma Systems Program in prioritizing, imple-
26 menting and evaluating emergency medical service system quality improvement initiatives identified
27 by communities;

28 (e) Review and prioritize rural community emergency medical service funding requests and pro-
29 vide input to the Rural Health Coordinating Council; and

30 (f) Review and prioritize funding requests for rural community emergency medical service
31 training and provide input to the Area Health Education Center program.

32 (5) The chairperson of the committee shall appoint a subcommittee on [*EMT certification*] **the**
33 **licensure and discipline of emergency medical services providers**, consisting of five physicians
34 and four [*EMTs*] **emergency medical services providers**. The subcommittee shall advise the au-
35 thority and the **Oregon Medical Board** on the adoption, amendment, repeal and application of rules
36 concerning ORS 682.204 to 682.220 and 682.245. The decisions of this subcommittee [*shall*] **are** not
37 [*be*] subject to the review of the full State Emergency Medical Service Committee.

38 (6) Members are entitled to compensation as provided in ORS 292.495.

39 **SECTION 7.** ORS 682.068 is amended to read:

40 682.068. (1) The Oregon Health Authority, in consultation with the State Emergency Medical
41 Service Committee, shall adopt rules specifying minimum requirements for ambulance services, and
42 for staffing and medical and communications equipment requirements for all types of ambulances.
43 The rules [*shall*] **must** define the requirements for advanced life support and basic life support units
44 of emergency vehicles, including equipment and emergency medical [*technician*] **services provider**
45 staffing of the passenger compartment when a patient is being transported in emergency circum-

1 stances.

2 (2) The authority may waive any of the requirements imposed by this chapter in medically dis-
3 advantaged areas as determined by the Director of the Oregon Health Authority, or upon a showing
4 that a severe hardship would result from enforcing a particular requirement.

5 (3) The authority shall exempt from rules adopted under this section air ambulances that do not
6 charge for the provision of ambulance services.

7 **SECTION 8.** ORS 682.089 is amended to read:

8 682.089. (1) When a city, county or district requires an ambulance service currently operating
9 within the city, county or district to be replaced by another public or private ambulance service,
10 the city, county or district shall provide that:

11 (a) [*Paramedic*] **Emergency medical services provider** staffing [*shall be*] **is** maintained at least
12 at the levels established in the local plan for ambulance services and ambulance service areas de-
13 veloped under ORS 682.062; and

14 (b) When hiring [*paramedics*] **emergency medical services providers** to fill vacant or new po-
15 sitions during the six-month period immediately following the date of replacement, the replacement
16 ambulance service shall give preference to qualified employees of the previous ambulance service
17 at comparable [*certification*] levels **of licensure**.

18 (2) As used in this section:

19 [(a) "*Ambulance*" has the meaning given that term by ORS 682.025.]

20 [(b)] (a) "*Ambulance service*" means any individual, partnership, corporation, association or
21 agency that provides transport services and emergency medical services through use of licensed
22 ambulances.

23 [(c)] (b) "*District*" has the meaning given that term by ORS 198.010.

24 [(d) "*Paramedic*" has the meaning given that term by ORS 682.025.]

25 **SECTION 9.** ORS 682.204 is amended to read:

26 682.204. (1) [*On and after September 13, 1975, it shall be unlawful:*]

27 [(a) *For any person to*] **A person may not** act as an emergency medical [*technician without being*
28 *certified*] **services provider unless the person is licensed** under this chapter.

29 [(b)] (2) [*For any*] **A person or governmental unit** which operates an ambulance [*to*] **may not**
30 authorize a person to act for it as an emergency medical [*technician without being certified*] **services**
31 **provider unless the emergency medical services provider is licensed** under this chapter.

32 [(c)] (3) [*For any*] **A person or governmental unit** [*to*] **may not** operate or allow to be operated
33 in this state any ambulance unless it is operated with at least one [*certified*] emergency medical
34 [*technician*] **services provider who is licensed at a level higher than emergency medical**
35 **responder**.

36 [(2)] (4) It is a defense to any charge under this section that there was a reasonable basis for
37 believing that the performance of services contrary to this section was necessary to preserve human
38 life, that diligent effort was made to obtain the services of a [*certified*] **licensed** emergency medical
39 [*technician*] **services provider** and that the services of a [*certified*] **licensed** emergency medical
40 [*technician*] **services provider** were not available or were not available in time as under the cir-
41 cumstances appeared necessary to preserve such human life.

42 [(3)] (5) [*Subsection (1) of this section is*] **Subsections (1) to (3) of this section are** not appli-
43 cable to any individual, group of individuals, partnership, entity, association or other organization
44 otherwise subject thereto providing a service to the public exclusively by volunteer unpaid workers,
45 nor to any person who acts as an ambulance attendant therefor, provided that in the particular

1 county in which the service is rendered, the county court or board of county commissioners has by
2 order, after public hearing, granted exemption from such *[subsection]* **subsections** to the individual,
3 group, partnership, entity, association or organization. When exemption is granted under this sec-
4 tion, any person who attends an individual who is ill or injured or who has a disability in an am-
5 bulance may not purport to be an emergency medical *[technician or use the designation "EMT."]*
6 **services provider**.

7 **SECTION 10.** ORS 682.208 is amended to read:

8 682.208. (1) *[For any]* **A person desiring** to be *[certified]* **licensed** as an emergency medical
9 *[technician or first responder,]* **services provider shall submit** an application for *[certification shall*
10 *be made]* **licensure** to the Oregon Health Authority. The application *[shall]* **must** be upon forms
11 prescribed by the authority and *[shall]* **must** contain:

12 (a) The name and address of the applicant.

13 (b) The name and location of the training course successfully completed by the applicant and
14 the date of completion.

15 (c) *[Certification]* **A statement** that to the best of the applicant's knowledge the applicant is
16 physically and mentally qualified to act as an emergency medical *[technician or first responder]*
17 **services provider**, is free from addiction to controlled substances or alcoholic beverages, or if not
18 so free, has been and is currently rehabilitated and is free from epilepsy or diabetes, or if not so
19 free, has been free from any lapses of consciousness or control *[occasioned thereby]* for a period of
20 time as prescribed by rule of the authority.

21 (d) *[Such]* Other information as the authority may reasonably require to determine compliance
22 with applicable provisions of this chapter and the rules adopted thereunder.

23 (2) The application *[shall]* **must** be accompanied by proof as prescribed by rule of the authority
24 of the applicant's successful completion of a training course approved by the authority, and if an
25 extended period of time has elapsed since the completion of the course, of a satisfactory amount of
26 continuing education.

27 (3) The authority shall adopt a schedule of minimum educational requirements in emergency and
28 nonemergency care for emergency medical *[technicians and first responders. The authority, with the*
29 *advice of the State Emergency Medical Service Committee, may establish levels of emergency medical*
30 *technician certification as may be necessary to serve the public interest.]* **services providers**. A course
31 approved by the authority *[shall]* **must** be designed to protect the welfare of out-of-hospital patients,
32 to promote the health, well-being and saving of the lives of such patients and to reduce their pain
33 and suffering.

34 **SECTION 11.** ORS 682.212 is amended to read:

35 682.212. (1) *[A nonrefundable initial application fee shall be submitted]* **An applicant for an**
36 **emergency medical services provider license shall submit a nonrefundable application fee**
37 with the initial application *[for emergency medical technician and first responder certification]*. In
38 addition, **an applicant shall submit** a nonrefundable examination fee *[shall be submitted]* for the
39 following purposes:

40 *[(a) First responder written examination;]*

41 *[(b)]* (a) Emergency medical *[technician]* **services provider** written examination;

42 *[(c)]* (b) Emergency medical *[technician]* **services provider** practical examination; and

43 *[(d)]* (c) A fee deemed necessary by the Oregon Health Authority to cover the fee charged by
44 the national examination agency or other examination service utilized by the authority for the pur-
45 pose of examining candidates for **an** emergency medical *[technician certification]* **services provider**

1 **license.**

2 (2) Subject to the review of the Oregon Department of Administrative Services, the fees and
3 charges established under this section [*shall*] **may** not exceed the cost of administering the regula-
4 tory program of the authority pertaining to the purpose for which the fee or charge is established,
5 as authorized by the Legislative Assembly for the authority's budget, as the budget may be modified
6 by the Emergency Board.

7 (3) All moneys received by the authority under this chapter shall be paid into the General Fund
8 in the State Treasury and placed to the credit of the authority account and such moneys hereby are
9 appropriated continuously **to the authority** and shall be used only for the administration and
10 enforcement of this chapter.

11 **SECTION 12.** ORS 682.216 is amended to read:

12 682.216. (1) When application has been made as required under ORS 682.208, the Oregon Health
13 Authority shall [*certify*] **license** the applicant as an emergency medical [*technician or as a first*
14 *responder*] **services provider** if it finds:

15 (a) The applicant has successfully completed a training course approved by the authority.

16 (b) The [*applicant's*] **applicant meets the** physical and mental qualifications [*have been certified*
17 *as*] required under ORS 682.208.

18 (c) No matter has been brought to the attention of the authority which would disqualify the
19 applicant.

20 (d) A nonrefundable fee has been paid to the authority pursuant to ORS 682.212.

21 (e) The applicant for **an** emergency medical [*technician certification*] **services provider license:**

22 **(A)** Is 18 years of age or older [*and the applicant for first responder*] **if the applicant is applying**
23 **for a license at a level higher than emergency medical responder; or**

24 **(B)** Is 16 years of age or older **if the applicant is applying for a license at the emergency**
25 **medical responder level.**

26 (f) The applicant has successfully completed examination as prescribed by the authority.

27 (g) The applicant meets other requirements prescribed by rule of the authority.

28 (2) The authority may provide for the issuance of a provisional [*certification*] **license** for emer-
29 gency medical [*technicians*] **services providers.**

30 (3) The authority may issue [*by indorsement certification for*] **an** emergency medical [*technician*]
31 **services provider license by indorsement** without proof of completion of an approved training
32 course to an emergency medical [*technician*] **services provider** who is licensed to practice emer-
33 gency care in another state of the United States or a foreign country if, in the opinion of the au-
34 thority, the applicant meets the requirements [*of certification*] **for licensure** in this state and can
35 demonstrate to the satisfaction of the authority competency to practice emergency care. The au-
36 thority [*shall be*] **is** the sole judge of credentials of any emergency medical [*technician*] **services**
37 **provider** applying for [*certification*] **licensure** without proof of completion of an approved training
38 course.

39 (4) [*Each*] **A** person [*holding a certificate*] **licensed** under [*ORS 682.208 and*] this section shall
40 submit, at the time of application for renewal of the [*certificate*] **license** to the authority, evidence
41 of the applicant's satisfactory completion of an authority approved program of continuing education
42 and other requirements prescribed by rule by the authority.

43 (5) The authority shall prescribe criteria and approve programs of continuing education in
44 emergency and nonemergency care to meet the requirements of this section.

45 (6) The authority shall include a fee pursuant to ORS 682.212 for late renewal and for issuance

42 cerebral palsy, epilepsy or other disabling neurological condition that requires training or support
43 similar to that required by persons with mental retardation, if either of the following apply:

44 (A) The disability originates before the person attains 22 years of age, or if the disability is at-
45 tributable to mental retardation the condition is manifested before the person attains 18 years of

1 age, the disability can be expected to continue indefinitely, and the disability constitutes a sub-
2 stantial handicap to the ability of the person to function in society.

3 (B) The disability results in a significant subaverage general intellectual functioning with con-
4 current deficits in adaptive behavior that are manifested during the developmental period.

5 (19) Reputation among members of a person's family by blood, adoption or marriage, or among
6 a person's associates, or in the community, concerning a person's birth, adoption, marriage, divorce,
7 death, legitimacy, relationship by blood or adoption or marriage, ancestry, or other similar fact of
8 a person's personal or family history.

9 (20) Reputation in a community, arising before the controversy, as to boundaries of or customs
10 affecting lands in the community, and reputation as to events of general history important to the
11 community or state or nation in which located.

12 (21) Reputation of a person's character among associates of the person or in the community.

13 (22) Evidence of a final judgment, entered after a trial or upon a plea of guilty, but not upon a
14 plea of no contest, adjudging a person guilty of a crime other than a traffic offense, to prove any
