

Senate Bill 238

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Health Care)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Limits patient data that must be reported to Oregon Health Authority by providers of mental health and addiction services. Requires authority to appoint rules advisory committee that includes specified members.

4 **Be It Enacted by the People of the State of Oregon:**

SECTION 1. (1) **As used in this section:**

6 (a) **"Patient data" means information concerning a patient or services provided to a pa-**
7 **tient that must be submitted to the authority by a provider for billing purposes.**

8 (b) **"Provider" means a person that contracts or enters into an agreement with the**
9 **Oregon Health Authority to provide mental health or addiction services.**

10 (2) **No later than January 1, 2012, the authority shall adopt by rule reporting require-**
11 **ments for patient data that require providers to submit no more than the minimum infor-**
12 **mation necessary for the authority and the provider to comply with federal requirements.**

13 (3) **The authority shall appoint an advisory committee under ORS 183.333 to advise the**
14 **authority in the development and adoption of rules under this section. The advisory com-**
15 **mittee must include individuals who contract with the authority to provide mental health**
16 **or addiction services or members of organizations that represent the interests of persons**
17 **that contract with the authority to provide mental health or addiction services.**

SECTION 2. Section 1 of this 2011 Act is amended to read:

Sec. 1. (1) **As used in this section:**

20 (a) "Patient data" means information concerning a patient or services provided to a patient that
21 must be submitted to the authority by a provider for billing purposes.

22 (b) "Provider" means a person that contracts or enters into an agreement with the Oregon
23 Health Authority to provide mental health or addiction services.

24 (2) [*No later than January 1, 2012,*] The authority shall adopt by rule reporting requirements for
25 patient data that require providers to submit no more than the minimum information necessary for
26 the authority and the provider to comply with federal requirements.

27 (3) The authority shall appoint an advisory committee under ORS 183.333 to advise the authority
28 in the [*development and*] adoption **or amendment** of rules under this section. The advisory com-
29 mittee must include individuals who contract with the authority to provide mental health or ad-
30 diction services or members of organizations that represent the interests of persons that contract
