SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates Higher Education Coordinating Commission. Grants commission authority to coordinate higher education policy with Oregon University System and community colleges. Abolishes **Office of Degree Authorization within** Oregon Student Assistance Commission and transfers functions to Higher Education Coordinating Commission. Renames Office of Degree Authorization Account to Degree Authorization Account. **Renames Oregon Student Assistance Commission to Oregon Student Access Commission.**

Redefines Oregon University System as public university system with more authority and independence to manage affairs, operations and obligations. Creates process for State Board of Higher Education to enter into performance compact with state in conjunction with biennial funding request. Eliminates requirement to seek expenditure limitation to spend other available moneys, including enrollment fees collected from students. Revises current process for setting enrollment fees by requiring student and student government participation, subject to limits set by Higher Education Coordinating Commission. Exempts Oregon University System from certain laws relating to state agencies.

Grants State Board of Higher Education power of eminent domain. Grants board authority to purchase insurance, after reporting to Legislative Assembly. Authorizes board to offer fee remissions to students. Increases membership of board. Authorizes board to purchase property and construct facilities without seeking legislative approval if purchase or construction is to be completed without appropriating General Fund moneys or using general obligation bonds. Credits all interest earned in Oregon University System Fund to Oregon University System.

[Becomes operative January 1, 2012.] Specifies operative dates.

Declares emergency, effective on passage.

14 Whereas the Legislative Assembly declares its intent to promote a system of higher education
15 in which:

16 (1) Institutions of higher education have the flexibility to make effective and efficient use of
17 human, physical and financial resources;

18 (2) Education beyond high school is accessible, regardless of each student's geographic or
19 socioeconomic position;

20 (3) High-quality research and scholarship by faculty and students is coordinated;

21 (4) Funding and metrics of accountability are aligned and measured against statewide goals and
22 benchmarks; and

23 (5) Citizens of all ages, backgrounds and income levels are enabled to participate in the search
24 for knowledge and individual development.

25 **Be It Enacted by the People of the State of Oregon:**

HIGHER EDUCATION COORDINATING COMMISSION

28

29 **SECTION 1.** (1) There is established a Higher Education Coordinating Commission, con-
30 sisting of 15 members appointed by the Governor.

31 (2) The Governor shall appoint:

32 (a) One student at a public university listed in ORS 352.002;

33 (b) One student at a community college in this state;

34 (c) At least one member from each congressional district in this state;

35 (d) At least four members who represent employers in Oregon, at least two of whom
36 represent small employers and at least two of whom represent large employers; and

37 (e) At least one member who serves on a district school board as defined in ORS 332.002.

38 (3) The Governor shall solicit recommendations from the Speaker of the House of Rep-
39 resentatives for at least three members and from the President of the Senate for at least
40 three members.

41 (4) The Governor may appoint members who satisfy more than one of the qualifications
42 for membership listed in subsection (2) of this section.

43 (5) The term of office of each member is four years, except that the term of office for
44 the two student members is two years. A member serves at the pleasure of the Governor.
45 Before the expiration of the term of a member, the Governor shall appoint a successor whose

1 term begins on July 1 next following. A member is eligible for reappointment. If there is a
2 vacancy for any cause, the Governor shall make an appointment to become immediately ef-
3 fective for the unexpired term.

4 (6) The appointment of the commission is subject to confirmation by the Senate in the
5 manner prescribed in ORS 171.562 and 171.565.

6 (7) A member of the commission is entitled to compensation and expenses as provided in
7 ORS 292.495.

8 **SECTION 2.** Notwithstanding the term of office specified by section 1 of this 2011 Act,
9 of the members first appointed to the Higher Education Coordinating Commission:

10 (1) Five, including the two student members, shall serve for a term ending June 30, 2014.

11 (2) Five shall serve for a term ending June 30, 2015.

12 (3) Five shall serve for a term ending June 30, 2016.

13 **SECTION 3.** (1) The members of the Higher Education Coordinating Commission must
14 be residents of this state who are well informed on the principles of higher education.

15 (2) A member of the State Board of Higher Education, Oregon Health and Science Uni-
16 versity Board of Directors or the governing board of a community college district may not
17 serve as a member of the Higher Education Coordinating Commission.

18 **SECTION 4.** (1) The Higher Education Coordinating Commission shall select one of its
19 members as chairperson and another as vice chairperson, for such terms and with duties and
20 powers necessary for the performance of the functions of such offices as the commission
21 determines.

22 (2) A majority of the members of the commission constitutes a quorum for the trans-
23 action of business.

24 (3) The commission shall meet at least once every three months at a place, day and hour
25 determined by the chairperson. The commission may also meet at other times and places
26 specified by the call of the chairperson or of a majority of the members of the commission.

27 **SECTION 5.** (1) The Higher Education Coordinating Commission shall appoint an execu-
28 tive officer to serve at the pleasure of the commission.

29 (2) The appointment of the executive officer must be by written order, filed with the
30 Secretary of State.

31 (3) Subject to any applicable provisions of ORS chapter 240, the executive officer shall
32 appoint all subordinate officers and employees of the commission, prescribe their duties and
33 fix their compensation.

34 **SECTION 6.** In accordance with applicable provisions of ORS chapter 183, the Higher
35 Education Coordinating Commission may adopt rules necessary for the administration of the
36 laws that the commission is charged with administering.

37 **SECTION 7.** (1) The Higher Education Coordinating Commission may establish such ad-
38 visory and technical committees as it considers necessary to aid and advise the commission
39 in the performance of its functions. These committees may be continuing or temporary
40 committees. The commission shall determine the representation, membership, terms and
41 organization of the committees and shall appoint their members.

42 (2) Members of the committees are not entitled to compensation, but at the discretion
43 of the commission may be reimbursed from funds available to the commission for actual and
44 necessary travel and other expenses incurred by them in the performance of their official
45 duties in the manner and amount provided in ORS 292.495.

SECTION 8. The Higher Education Coordinating Commission shall:

(1) Develop state goals and associated accountability measures for the state post-secondary education system, including community colleges and public universities listed in ORS 352.002, and for the Oregon Student Access Commission.

(2) Develop a strategic plan for achieving state higher education goals, identifying priority areas for attention and taking into consideration the contributions of this state's independent institutions and other organizations dedicated to helping Oregonians reach state goals. Goals should include, but need not be limited to:

(a) Increasing the educational attainment of the population;

(b) Increasing this state's global economic competitiveness and the quality of life of its citizens;

(c) Ensuring affordable access for qualified Oregon students at each college or public university; and

(d) Ensuring that public higher education in this state is provided in a cost-effective manner.

(3) Evaluate and recommend changes to statutory goals and missions described for community colleges in ORS 341.009 and for public universities in ORS 351.003 and 351.009 after receiving recommendations from the appropriate governing board. The appropriate governing board shall have decision-making authority over program offerings to implement established goals and missions.

(4) Develop a finance model for higher education aligned with the goals in the system strategic plan, including:

(a) Recommended biennial appropriations to institutions, including a component specifically tied to institutional contributions to state educational priorities;

(b) Recommended limits regarding the setting of tuition rates at public universities listed in ORS 352.002 in accordance with criteria set by the State Board of Higher Education, with the goal of encouraging tuition affordability for students;

(c) Tuition rates set by each community college governing board for community colleges in this state;

(d) Recommended biennial appropriations for student financial aid; and

(e) Recommended biennial appropriations for any future statewide higher education initiatives.

(5) Each biennium, recommend to the Governor and the Legislative Assembly a consolidated higher education budget request consistent with the finance model, including appropriations for:

(a) Ongoing operations of the Oregon Student Access Commission;

(b) Ongoing operations for the Oregon University System;

(c) Ongoing operations for community colleges;

(d) Needed new facilities or programs; and

(e) Capital improvements.

(6) Design and maintain a statewide educational data system, in collaboration with the State Board of Education.

(7) Coordinate with the Oregon Student Access Commission to maximize the effectiveness of student financial assistance programs, including the Oregon Opportunity Grant program under ORS 348.260.

1 (8) Approve and authorize degrees for the Oregon University System.

2 (9) Authorize degrees to be offered in this state in accordance with ORS 348.594 to
3 348.615, and adopt any rules to implement that authority.

4 SECTION 8a. The Higher Education Coordinating Commission may delegate any of the
5 actions listed in section 8 of this 2011 Act to its executive director.

6
7 **ABOLITION OF OFFICE OF DEGREE AUTHORIZATION**

8
9 SECTION 9. (1) The Office of Degree Authorization within the Oregon Student Assistance
10 Commission is abolished.

11 (2) All the duties, functions and powers of the Office of Degree Authorization are imposed
12 upon, transferred to and vested in the Higher Education Coordinating Commission.

13 SECTION 10. (1) The Office of Degree Authorization shall:

14 (a) Deliver to the Higher Education Coordinating Commission all records and property
15 within the jurisdiction of the Office of Degree Authorization that relate to the duties, func-
16 tions and powers transferred by section 9 of this 2011 Act; and

17 (b) Transfer to the Higher Education Coordinating Commission those employees engaged
18 primarily in the exercise of the duties, functions and powers transferred by section 9 of this
19 2011 Act.

20 (2) The executive officer of the Higher Education Coordinating Commission shall take
21 possession of the records and property, and shall take charge of the employees and employ
22 them in the exercise of the duties, functions and powers transferred by section 9 of this 2011
23 Act, without reduction of compensation but subject to change or termination of employment
24 or compensation as provided by law.

25 (3) The Governor shall resolve any dispute between the Office of Degree Authorization
26 and the Higher Education Coordinating Commission relating to transfers of records, property
27 and employees under this section, and the Governor's decision is final.

28 SECTION 11. (1) The unexpended balances of amounts authorized to be expended by the
29 Office of Degree Authorization for the biennium beginning July 1, 2011, from revenues dedi-
30 cated, continuously appropriated, appropriated or otherwise made available for the purpose
31 of administering and enforcing the duties, functions and powers transferred by section 9 of
32 this 2011 Act are transferred to and are available for expenditure by the Higher Education
33 Coordinating Commission for the biennium beginning July 1, 2011, for the purpose of admin-
34 istering and enforcing the duties, functions and powers transferred by section 9 of this 2011
35 Act.

36 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
37 expenditures by the Office of Degree Authorization remain applicable to expenditures by the
38 Higher Education Coordinating Commission under this section.

39 SECTION 12. The transfer of duties, functions and powers to the Higher Education Co-
40 ordinating Commission by section 9 of this 2011 Act does not affect any action, proceeding
41 or prosecution involving or with respect to such duties, functions and powers begun before
42 and pending at the time of the transfer, except that the Higher Education Coordinating
43 Commission is substituted for the Office of Degree Authorization in the action, proceeding
44 or prosecution.

45 SECTION 13. (1) Nothing in sections 9 to 16 of this 2011 Act or the repeal of ORS 348.599

1 by section 291 of this 2011 Act relieves a person of a liability, duty or obligation accruing
2 under or with respect to the duties, functions and powers transferred by section 9 of this
3 2011 Act. The Higher Education Coordinating Commission may undertake the collection or
4 enforcement of any such liability, duty or obligation.

5 (2) The rights and obligations of the Office of Degree Authorization, or the Oregon Stu-
6 dent Assistance Commission on behalf of the Office of Degree Authorization, legally incurred
7 under contracts, leases and business transactions executed, entered into or begun before the
8 operative date specified in section 292 of this 2011 Act are transferred to the Higher Educa-
9 tion Coordinating Commission. For the purpose of succession to these rights and obligations,
10 the Higher Education Coordinating Commission is a continuation of the Office of Degree
11 Authorization and not a new authority.

12 **SECTION 14.** Notwithstanding the transfer of duties, functions and powers by section 9
13 of this 2011 Act, the rules of the Office of Degree Authorization in effect on the operative
14 date specified in section 292 of this 2011 Act continue in effect until superseded or repealed
15 by rules of the Higher Education Coordinating Commission. References in rules of the Office
16 of Degree Authorization, or an officer or employee of that office, are considered to be ref-
17 erences to the Higher Education Coordinating Commission or an officer or employee of the
18 Higher Education Coordinating Commission.

19 **SECTION 15.** Whenever, in any uncodified law or resolution of the Legislative Assembly
20 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
21 erence is made to the Office of Degree Authorization or an officer or employee of that office,
22 the reference is considered to be a reference to the Higher Education Coordinating Com-
23 mission or an officer or employee of the Higher Education Coordinating Commission.

24 **SECTION 16.** (1) For the purpose of harmonizing and clarifying statutory law, the Leg-
25 islative Counsel may substitute for words designating the "Office of Degree Authorization"
26 or its officers or employees, wherever they occur in statutory law, words designating the
27 "Higher Education Coordinating Commission" or its officers or employees.

28 (2)(a) The amendments to ORS 348.601 by section 179 of this 2011 Act are intended to
29 change the name of the Office of Degree Authorization Account to the Degree Authorization
30 Account.

31 (b) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel
32 may substitute for words designating the "Office of Degree Authorization Account," wher-
33 ever they occur in statutory law, words designating the "Degree Authorization Account."
34

35 **OREGON UNIVERSITY SYSTEM**

36
37 **SECTION 17.** The Legislative Assembly finds that public higher education is necessary
38 to accomplish the findings in ORS 351.001 and recognizes the following as fundamental goals
39 of public higher education in this state:

40 (1) Creating an educated citizenry to support responsible roles in a democratic society
41 and provide a globally competitive workforce to drive this state's economy, while ensuring
42 access for all qualified Oregonians to a high-quality post-secondary education;

43 (2) Ensuring a high-quality learning environment that allows students to succeed;

44 (3) Creating original knowledge and advancing innovation; and

45 (4) Contributing positively to the economic, civic and cultural life of communities in all

1 regions of Oregon.

2 **SECTION 18.** Sections 19 to 21b and 23 of this 2011 Act are added to and made a part of
3 ORS 351.010 to 351.070.

4 **SECTION 19.** The Oregon University System is established as a public university system,
5 consisting of the office of the Chancellor of the Oregon University System, the public uni-
6 versities listed in ORS 352.002 and any related offices, departments or activities. The State
7 Board of Higher Education, on behalf of the Oregon University System, shall exercise and
8 carry out all of the powers, rights and duties that are expressly conferred upon the board
9 or that are implied by law or incident to such powers, rights and duties. The Oregon Uni-
10 versity System is an instrumentality of the state and a government entity performing gov-
11 ernmental functions and exercising governmental powers. Notwithstanding the status of the
12 Oregon University System as an instrumentality of the state, the Oregon University System
13 is not eligible to request or receive legal services from the Attorney General and the De-
14 partment of Justice pursuant to ORS chapter 180, except as otherwise expressly provided by
15 law. The Oregon University System is not considered a unit of local or municipal govern-
16 ment.

17 **SECTION 20.** (1) The State Board of Higher Education shall set enrollment fees for each
18 public university listed in ORS 352.002. Enrollment fees include tuition for education and
19 services and any other charges found by the State Board of Higher Education to be necessary
20 to carry out the educational program of the Oregon University System.

21 (2) The State Board of Higher Education shall, by rule, establish a process under which
22 each public university may develop and submit proposed enrollment fees for board consider-
23 ation. The process must provide for participation of enrolled students and the recognized
24 student government of the public university.

25 (3) Each public university listed in ORS 352.002 is authorized to offer fee remissions to
26 its students, including remissions offered on the basis of need, from any authorized source
27 of revenue. Moneys appropriated from the General Fund may not be used to fund fee re-
28 missions to students of the public university.

29 **SECTION 20a.** The Higher Education Coordinating Commission may set limits on the
30 enrollment fees established by the State Board of Higher Education under section 20 (1) of
31 this 2011 Act.

32 **SECTION 21.** (1) For the purposes of this section, “performance compact” means an
33 agreement between the State Board of Higher Education and the State of Oregon to achieve
34 certain performance targets in order to enhance the success of Oregon University System
35 students in exchange for consideration of the appropriations sought in a funding request
36 submitted by the State Board of Higher Education to the Oregon Department of Adminis-
37 trative Services.

38 (2)(a) On or before May 1 of each even-numbered year, the State Board of Higher Edu-
39 cation shall submit a draft funding request to the Higher Education Coordinating Commis-
40 sion for the Oregon University System, applicable to the biennium beginning on July 1 of the
41 following year. The draft funding request must include a performance compact.

42 (b) If the Higher Education Coordinating Commission approves the draft funding request
43 and performance compact, or approves the draft funding request and performance compact
44 with modifications, the commission shall take such action prior to August 15 of the same
45 even-numbered year.

1 (c) If the Higher Education Coordinating Commission rejects the draft funding request
2 and performance compact, the commission shall take such action prior to June 15 of the
3 same even-numbered year. In returning the rejected draft funding request and performance
4 compact to the State Board of Higher Education, the commission shall give specific direction
5 to the board regarding the changes necessary to earn commission approval.

6 (3) On or before September 1 of each even-numbered year, the State Board of Higher
7 Education shall submit the funding request and performance compact to the Oregon De-
8 partment of Administrative Services for the Oregon University System.

9 (4) The Governor's biennial budget submitted to the Legislative Assembly may include
10 the State Board of Higher Education's funding request submitted to the Oregon Department
11 of Administrative Services for the Oregon University System. Any funding request approved
12 by the Legislative Assembly must specify that the moneys be appropriated to the Oregon
13 Department of Administrative Services for allocation to the Oregon University System.

14 (5) The funding request must include, in addition to the performance compact, a report
15 on performance from the previous biennium's performance compact.

16 (6) The State Board of Higher Education shall, by rule, establish a framework for the
17 development of a performance compact that must accompany the funding request to the
18 Oregon Department of Administrative Services. The framework must address, among other
19 issues, the issue of tuition affordability for students.

20 **SECTION 21a.** The State Board of Higher Education is authorized to:

21 (1) Request, as part of the funding request under section 21 of this 2011 Act, appropri-
22 ations for budgetary items, including but not limited to education and general operations,
23 statewide public services, state funded debt service, capital improvements and other special
24 initiatives and investments; and

25 (2) Allocate moneys, from funds appropriated to the board and other available moneys,
26 among the office of the Chancellor of the Oregon University System, public universities listed
27 in ORS 352.002 and offices, departments and activities under the control of the board.

28 **SECTION 21b.** The State Board of Higher Education is not required to seek expenditure
29 limitation approval from the Legislative Assembly to spend any available moneys, including
30 but not limited to moneys from enrollment fees collected pursuant to section 20 of this 2011
31 Act.

32 **SECTION 22.** Sections 21 and 21a of this 2011 Act apply to biennia beginning on or after
33 July 1, 2015.

34 **SECTION 22a.** (1) On or before September 1, 2012, the State Board of Higher Education
35 shall submit a funding request and performance compact for the biennium beginning July 1,
36 2013, to the Oregon Department of Administrative Services for the Oregon University Sys-
37 tem.

38 (2) The Governor's biennial budget submitted to the Legislative Assembly for the
39 biennium beginning July 1, 2013, may include the State Board of Higher Education's funding
40 request submitted to the Oregon Department of Administrative Services for the Oregon
41 University System. Any funding request approved by the Legislative Assembly must specify
42 that the moneys be appropriated to the Oregon Department of Administrative Services for
43 allocation to the Oregon University System.

44 (3) The State Board of Higher Education shall, by rule, establish a framework for the
45 development of the performance compact that must accompany the funding request to the

1 Oregon Department of Administrative Services for the biennium beginning July 1, 2013. The
2 framework must address, among other issues, the issue of tuition affordability for students.

3 (4) The State Board of Higher Education is authorized to:

4 (a) Request, as part of the funding request under subsection (1) of this section, appro-
5 priations for budgetary items, including but not limited to education and general operations,
6 statewide public services, state funded debt service, capital improvements and other special
7 initiatives and investments; and

8 (b) Allocate moneys, from funds appropriated to the board and other available moneys,
9 among the office of the Chancellor of the Oregon University System, public universities listed
10 in ORS 352.002 and offices, departments and activities under the control of the board.

11 **SECTION 23.** The State Board of Higher Education shall:

12 (1) Review all mission statements of the public universities listed in ORS 352.002; and

13 (2) Approve all academic programs offered at the public universities, and shall ensure
14 that the academic programs:

15 (a) Are consistent with the mission statement of the respective public university;

16 (b) Do not unnecessarily duplicate academic programs offered by other public universities
17 listed in ORS 352.002; and

18 (c) Are allocated among the public universities in the Oregon University System to
19 maximize the achievement of statewide needs and requirements.

20 **SECTION 23a.** The State Board of Higher Education shall forward all mission statements
21 of the public universities listed in ORS 352.002 to the Higher Education Coordinating Com-
22 mission for approval.

23 **SECTION 24.** As used in sections 24 to 28 of this 2011 Act:

24 (1) "Bond-related costs" means:

25 (a) The costs and expenses of issuing, administering and maintaining higher education
26 revenue bonds including, but not limited to, the costs of:

27 (A) Paying or redeeming higher education revenue bonds.

28 (B) Paying amounts due in connection with credit enhancement devices or agreements
29 for exchange of interest rates.

30 (C) Paying the fees, administrative costs and expenses of the State Treasurer and the
31 Oregon University System, including the costs of consultants or advisers retained by the
32 State Treasurer or the Chancellor of the Oregon University System, for the higher education
33 revenue bonds.

34 (b) The costs of funding reserves for the higher education revenue bonds.

35 (c) Capitalized interest for the higher education revenue bonds.

36 (d) Rebates or penalties due to the United States in connection with the higher education
37 revenue bonds.

38 (e) Any other costs or expenses that the State Treasurer or the chancellor determines
39 are necessary or desirable in connection with issuing and maintaining the higher education
40 revenue bonds.

41 (2) "Higher education revenue bonds" means revenue bonds issued pursuant to section
42 25 of this 2011 Act.

43 (3) "Higher education revenues" includes:

44 (a) Tuition, fees and charges imposed or collected by the Oregon University System, or
45 by one of the public universities in the system; and

1 (b) Moneys appropriated, allocated or otherwise made available to the Oregon University
2 System, or to one of its universities, by the Legislative Assembly, if those moneys are law-
3 fully available to pay the bond-related costs of higher education revenue bonds.

4 **SECTION 25.** (1) At the request of the Chancellor of the Oregon University System, the
5 State Treasurer may issue, as provided in ORS chapter 286A, higher education revenue bonds
6 from time to time, the net proceeds of which must be used to:

7 (a) Finance projects that the State Board of Higher Education determines will assist the
8 Oregon University System in carrying out its statutory powers;

9 (b) Refund bonds issued for the projects; and

10 (c) Pay bond-related costs.

11 (2)(a) Before pledging all or a portion of higher education revenues, pursuant to ORS
12 286A.102, to secure higher education revenue bonds, higher education credit enhancement
13 devices or agreements for exchange of interest rates related to such revenue bonds or credit
14 enhancement devices, the chancellor shall reserve sufficient funds each biennium to satisfy
15 any payment or reserve requirements relating to:

16 (A) General obligation bonds or certificates of participation issued for the benefit of the
17 Oregon University System;

18 (B) Credit enhancement devices or agreements for exchange of interest rates entered
19 into in connection with obligations related to general obligation bonds or certificates of par-
20 ticipation issued for the benefit of the Oregon University System; and

21 (C) Loans to the Oregon University System funded by state general obligation bonds.

22 (b) Pursuant to ORS 286A.010, the Oregon University System shall provide cash flow
23 projections and other information requested by the State Treasurer to determine the suffi-
24 ciency of higher education revenues to satisfy the requirements of paragraph (a) of this
25 subsection and any proposed revenue bonds.

26 (c) For purposes of the issuance of bonds and ORS chapter 286A, the Oregon University
27 System shall be considered a related agency as defined in ORS 286A.001 (9).

28 (d) The chancellor shall identify the specific higher education revenues that will be
29 pledged to secure each series of higher education revenue bonds and specify the status of the
30 lien of each pledge.

31 (3) The chancellor may enter into covenants, pursuant to ORS 286A.025 (4)(c), on behalf
32 of the State of Oregon for the benefit of holders of higher education revenue bonds, providers
33 of credit enhancement for higher education revenue bonds and counterparties to agreements
34 for exchange of interest rates to:

35 (a) Adjust the rates, charges or fees that produce higher education revenues so that
36 higher education revenues equal or exceed specified levels during specified periods.

37 (b) Create only those pledges or liens on higher education revenues that are permitted
38 by the covenants authorized by this section.

39 (c) Budget and apply higher education revenues, or otherwise allow higher education re-
40 venues to be applied, in amounts that, when added to other moneys lawfully available for the
41 purpose, will be sufficient:

42 (A) To pay in full and when due the principal, interest and premium on outstanding
43 higher education revenue bonds;

44 (B) To pay amounts due in connection with agreements for exchange of interest rates
45 and credit enhancement devices for higher education revenue bonds; and

1 (C) To maintain the balance required by covenants in any debt service reserves estab-
2 lished for the higher education revenue bonds.

3 (4) The chancellor shall operate the properties of the Oregon University System in com-
4 pliance with the higher education revenue bond covenants until all higher education revenue
5 bonds are paid or defeased.

6 (5) Higher education revenue bonds are not a general obligation of the State of Oregon,
7 and neither the full faith and credit nor the taxing power of the State of Oregon may be
8 pledged to secure or pay the higher education revenue bonds.

9 (6) The State Treasurer and the Oregon University System do not have an obligation to
10 pay bond-related costs except as provided in sections 24 to 28 of this 2011 Act. A holder of
11 higher education revenue bonds issued under this section does not have the right to compel
12 the exercise of the taxing power of the State of Oregon to pay bond-related costs.

13 (7) As long as any higher education revenue bonds issued under this section are out-
14 standing, covenants related to the higher education revenue bonds are deemed to be con-
15 tracts between the State of Oregon and holders of the higher education revenue bonds. The
16 State of Oregon may not give force or effect to a statute or initiative or referendum measure
17 approved by the electors of this state if doing so would unconstitutionally impair existing
18 covenants made with the holders of existing higher education revenue bonds or would un-
19 constitutionally impair other obligations or agreements regarding the security of higher ed-
20 ucation revenue bonds to which the moneys deposited in the accounts established by sections
21 26, 27 and 28 of this 2011 Act are pledged and assigned.

22 (8) The principal, interest and any premium and any issuance costs on a financing
23 agreement under ORS 283.085 to 283.092, any general obligation bond, any revenue bond and
24 any related credit enhancement device or interest rate exchange agreement shall be paid
25 from the sources specified in the laws and documents authorizing the financing agreement,
26 bond, credit enhancement device or interest rate exchange agreement. The Oregon Univer-
27 sity System shall pay any other expenses and liabilities, including but not limited to legal
28 expenses, costs of settling claims, judgments, federal arbitrage rebates and penalties and
29 expenses arising from an inquiry, audit or other action by a federal or state regulatory body,
30 unless the expense or liability results solely from the negligence or willful misconduct of a
31 state agency.

32 (9) Pursuant to ORS chapter 180, on behalf of the State Treasurer or any other state
33 agency, the Attorney General shall appear, commence, prosecute or defend any action, suit,
34 matter, cause or proceeding arising from any financing agreement under ORS 283.085 to
35 283.092, any bond issued for the benefit of the Oregon University System and any related
36 credit enhancement device or interest rate exchange agreement.

37 **SECTION 26.** An account in the Oregon University System Fund established by ORS
38 351.506 is designated for the purposes described in section 25 (1) of this 2011 Act. The account
39 consists of net proceeds of higher education revenue bonds issued under section 25 of this
40 2011 Act and other moneys made available for the purposes described in section 25 (1) of this
41 2011 Act. Moneys in the account may be invested as provided in ORS 293.701 to 293.820, and
42 interest earned by the account must be credited to the account. Moneys in the account are
43 continuously appropriated to the Oregon University System for the purposes described in
44 section 25 (1) of this 2011 Act.

45 **SECTION 27.** (1) An account in the Oregon University System Fund established by ORS

1 351.506 is designated for the purposes of paying, when due, the principal of, the interest on
2 and the premium, if any, on outstanding higher education revenue bonds. Moneys in the
3 account may be invested as provided in ORS 293.701 to 293.820, and interest earned by the
4 account must be credited to the account. Moneys in the account are continuously appropri-
5 ated to the Oregon University System for the purposes described in this section.

6 (2) The Oregon University System shall deposit in the account:

7 (a) Capitalized or accrued interest on higher education revenue bonds;

8 (b) Amounts appropriated or otherwise made available by the Legislative Assembly for
9 deposit in the account; and

10 (c) Reserves established for the payment of higher education revenue bonds.

11 **SECTION 28.** (1) An account in the Oregon University System Fund established by ORS
12 351.506 is designated for the purpose of paying bond-related costs under sections 24 to 28 of
13 this 2011 Act. Moneys in the account may be invested as provided in ORS 293.701 to 293.820,
14 and interest earned by the account must be credited to the account. Moneys in the account
15 are continuously appropriated to the Oregon University System for payment of bond-related
16 costs under sections 24 to 28 of this 2011 Act.

17 (2) The Oregon University System shall deposit in the account:

18 (a) Proceeds of higher education revenue bonds that were issued to pay bond-related
19 costs; and

20 (b) Amounts appropriated or otherwise made available by the Legislative Assembly for
21 deposit in the account.

22 **SECTION 29.** Except for risk management and insurance functions, the State Board of
23 Higher Education and the Oregon University System shall assume responsibility, in accord-
24 ance with agreements entered into with the Department of Justice and the State Treasurer,
25 for the indemnity and defense of their officers, agents and employees or other persons des-
26 ignated by the board or the system to carry out or further their missions with regard to
27 claims asserted and actions commenced as of the operative date of this section.

28 **SECTION 29a.** For risk management and insurance functions, the State Board of Higher
29 Education and the Oregon University System shall assume responsibility, in accordance with
30 agreements entered into with the Oregon Department of Administrative Services regarding
31 its risk management function and the manager of the Insurance Fund established in ORS
32 278.425, for the indemnity and defense of their officers, agents and employees or other per-
33 sons designated by the board or the system to carry out or further their missions with re-
34 gard to claims asserted and actions commenced as of the operative date of this section.

35 **SECTION 29b.** Before the operative date of section 29 of this 2011 Act or the operative
36 date of section 29a of this 2011 Act, the State Board of Higher Education and the Oregon
37 University System shall enter into an agreement, as applicable, with the Department of
38 Justice, the Oregon Department of Administrative Services regarding its risk management
39 function, the State Treasurer and the manager of the Insurance Fund established in ORS
40 278.425 with regard to:

41 (1) The transfer of duties and responsibilities concerning legal actions and liabilities in
42 existence before the operative date of section 29 of this 2011 Act or the operative date of
43 section 29a of this 2011 Act, as applicable;

44 (2) The reimbursement of reasonable costs and expenses associated with the legal rep-
45 resentation of the State Treasurer for bonds issued for the board and the system on and

1 after the operative date of section 29 of this 2011 Act or the operative date of section 29a of
2 this 2011 Act, as applicable; and

3 (3) Any other topic necessary for the orderly transfer of duties and responsibilities inci-
4 dent to the previous statutory duty of the Department of Justice to provide legal represen-
5 tation to the board and the system and the responsibility of the Department of
6 Administrative Services to insure the board and the system.

7 **SECTION 30.** Except as otherwise provided by law, all liabilities, known and unknown,
8 of the State Board of Higher Education and the Oregon University System existing on or
9 arising after the operative date of this section or, for liabilities related to risk management
10 or insurance functions, arising after the operative date of section 29a of this 2011 Act, are
11 the sole responsibility of the board and system. Damages, costs and other expenses arising
12 out of and related to liabilities of the board and the system after the operative date of this
13 section shall be payable from the Oregon University System Fund or from insurance pur-
14 chased, a self-insurance program established or another insurance equivalent arranged for
15 under section 36a of this 2011 Act.

16 **SECTION 30a.** The State Board of Higher Education is a continuation of the former State
17 Board of Higher Education with respect to its duties, liabilities, functions and powers, and
18 is not a new authority, for the purpose of succession to all rights and obligations of the
19 former State Board of Higher Education as constituted as of the effective date of this 2011
20 Act, except as otherwise provided by law.

21 **SECTION 31.** ORS 351.001 is amended to read:

22 351.001. The Legislative Assembly finds that:

23 (1) For its **survival and** political well-being, Oregon needs wise and effective leadership and an
24 informed citizenry.

25 (2) For its **survival and** economic well-being, Oregon needs able and imaginative men and
26 women for the direction and operation of all its institutions, for the production of goods and services
27 and for the management of its fiscal affairs. Oregon also needs alert and informed consumers.

28 (3) For its cultural advancement, Oregon needs creative talent as well as appreciative and dis-
29 criminating readers, viewers and listeners. Oregon also needs people who understand the diverse
30 patterns of behavior, communication and belief that make up the common cultures of the various
31 communities in which we all must function.

32 (4) For its survival, Oregon needs citizens who understand the interdependence of human beings
33 and our shared dependence on the resources provided by our natural environment.

34 (5) Oregon needs people who, in the roles of parents and teachers and in other capacities, are
35 able to transmit the state's and the nation's ideals and heritage to future generations.

36 (6) For their personal well-being, individual Oregonians need to cultivate an advanced literacy
37 essential to leading productive and rewarding lives. This includes the capacity to think logically and
38 critically; to internalize and exemplify humane values; to write, speak and figure clearly and accu-
39 rately; to understand, in some depth, a variety of psychological, historical, cultural, aesthetic and
40 scientific concepts and theories; and to master a range of occupational, professional, avocational,
41 social and personal skills.

42 **SECTION 32.** ORS 351.010 is amended to read:

43 351.010. The Oregon University System [*is established and is organized as described in ORS*
44 *352.002. The system*] shall be conducted under the control of a board of [12] 15 directors, to be
45 known as the State Board of Higher Education. **Except as otherwise provided by law, the board**

1 **has sole authority to govern, set policy and otherwise manage the affairs of the public uni-**
 2 **versities listed in ORS 352.002.** The board shall consist of:

3 (1) Two students[,] who at the time of their appointment to the board[,] are [*admitted at*] **at-**

 9 Southern Oregon University or Western Oregon University.

10 (4) [*Eight*] **Eleven** members of the general public who are not students or faculty **members** at
 11 the time of [*their*] appointment.

12 **SECTION 33.** (1) **The directors added to the State Board of Higher Education by the**
 13 **amendments to ORS 351.010 in section 32 of this 2011 Act shall be appointed for terms be-**
 14 **ginning July 1, 2012.**

15 (2) **Notwithstanding the term of office specified in ORS 351.040, of the directors added to**
 16 **the board by the amendments to ORS 351.010 in section 32 of this 2011 Act:**

17 (a) **One shall serve for a term ending June 30, 2014;**

18 (b) **One shall serve for a term ending June 30, 2015; and**

19 (c) **One shall serve for a term ending June 30, 2016.**

20 **SECTION 34.** ORS 351.020 is amended to read:

21 351.020. (1) The directors of the State Board of Higher Education [*shall*] **must** be residents of
 22 Oregon and [*shall be*] **are** appointed by the Governor. The [*appointment is*] **appointments are** sub-
 23 ject to the confirmation of the Senate in the manner provided by ORS 171.562 and 171.565. No di-
 24 rector who is not a student or faculty member at the time of appointment may be an employee of
 25 any of the [*institutions or departments*] **public universities or offices, departments or activities**
 26 under the control of the State Board of Higher Education[, *nor shall more than seven graduates of*
 27 *or students admitted at these institutions, nor more than three graduates of or students admitted at any*
 28 *one of these institutions or departments, be members of the board at any time*]. The faculty members

13 (2) Manage, control and apply all property of whatever nature given to or appropriated for the

15 or activities under the control of the State Board of Higher Education, according to the terms and
16 conditions of such gift or appropriation. Moneys received under this section shall be deposited in a
17 designated account in the Oregon University System Fund established by ORS 351.506. Interest
18 earned by the account shall be credited to the account.

19 (3) **Design, acquire**, erect, improve, repair, maintain, **lease, renovate, demolish**, equip, [*and*]
20 furnish **and dispose of** buildings, structures and lands [*for higher education*] **necessary for carrying**
21 **out its powers, rights and duties.**

22 (4) Acquire, receive, hold, control, convey, sell, manage, operate, lease, lend, **license**, improve
23 and develop any and all property, real or personal:

24 (a) Given to any of the [*institutions*] **public universities or offices**, departments or activities
25 under the control of the State Board of Higher Education by private donors, whether such gifts are
26 made to the State Board of Higher Education or to the State of Oregon; or

27 (b) Acquired by any other method or from any source by the State Board of Higher Education
28 for the benefit of any of the [*institutions*] **public universities or offices**, departments or activities
29 under the control of the board, except for any structure, equipment or asset encumbered by a cer-

31 [*(5) Manage mineral and geothermal resource rights and proceeds therefrom acquired or held for*

34 (5) **Exercise the power of eminent domain for the condemnation of property of any kind**

37 (6) Take and hold mortgages on real and personal property acquired by way of gift or arising
38 out of transactions entered into in accordance with the powers, **rights and duties** [*and authority*

41 (7) Institute, maintain and participate in suits and actions and other judicial proceedings, in the

4 plies, materials, equipment, services and information technology, for the use, support or benefit of

6 of the **State Board of Higher Education**.

7 [*(9) Delegate any of the powers, duties or functions granted to the board under this section to any*
8 *state institution of higher education within the Oregon University System.*]

9 **(9) With the approval of the State Treasurer, request that the Oregon Department of**
10 **Administrative Services enter into financing agreements in accordance with ORS 283.085 to**
11 **283.092 on behalf of the Oregon University System. The Oregon University System shall be**
12 **considered a state agency for purposes of ORS 286A.730.**

13 **(10) Own, control and operate Oregon University System motor vehicles for use by public**
14 **universities and offices, departments and activities under the control of the State Board of**
15 **Higher Education. The board shall, by rule, establish requirements governing the use and**
16 **operation of Oregon University System motor vehicles.**

17 **(11) Hire or retain attorneys for the provision of legal services, including but not limited**
18 **to general advice, representation in litigation and representation in appellate matters. The**

33 with any certified or recognized exclusive employee representative shall be under the direction and

21 [(25)] **(26)** "Volunteer firefighter" means a firefighter whose position normally requires less than
22 600 hours of service per year.

 34 *cation*], or employees of the school operated under ORS 346.010 engaged in teaching or other school
 35 activity, who are employed under contract for a period of less than 12 consecutive months and who
 36 are entitled to sick leave with pay of less than 96 hours for a year, each hour of accumulated unused
 37 sick leave with pay shall be valued on the basis of the actual number of contract hours of employ-
 38 ment during the last year of contributing membership of an employee before retiring and the salary
 39 of the employee during the same period. This paragraph does not apply to any employee who is
 40 employed under contract for 12 consecutive months in any of the three or less years used in deter-
 41 mining the final average salary of the employee.

28 sure that state agencies' planning, acquisition and implementation activities align with and support
29 the statewide information resources management plan. The department is responsible for procuring
30 information technology fairly, competitively and in a manner that is consistent with the
31 department's rules.

32 (4)(a) The policy of the State of Oregon is that state government telecommunications networks
33 should be designed to provide state-of-the-art services where economically and technically feasible,
34 using shared, rather than dedicated, lines and facilities.

35 (b) The department shall, when procuring telecommunications network services, consider
36 achieving the economic development and quality of life outcomes set forth in the Oregon
37 benchmarks.

38 (5)(a) The department, upon request, may furnish and deliver statewide integrated
39 videoconferencing and statewide online access service to a public or private entity that primarily
40 conducts activities for the direct good or benefit of the public or community at large in providing
41 educational, economic development, health care, human services, public safety, library or other
42 public services. The department shall adopt rules with respect to furnishing the service.

2 (c) The department by rule shall restrict the department's furnishing or delivery of Internet ac-
3 cess service to private entities when the service would directly compete with two or more local

7 Public Utility Commission's regulation or authority.

8 (6)(a) There is created the Stakeholders Advisory Committee, consisting of a minimum of nine

10 transmitting video, voice and data communications.

11 (h) "Statewide online access" means electronic connectivity to information resources such as
12 computer conferencing, electronic mail, databases and Internet access.

18 (1) The community college is an educational institution that is intended to fill the institutional
19 gap in education by offering broad, comprehensive programs in academic subjects and in career and
20 technical education subjects. It is primarily designed to provide associate or certificate degree pro-
21 grams for some, serve a transitional purpose for others who will continue baccalaureate or other
22 college work, provide the ability to enter the workforce immediately and serve to determine future
23 educational needs for other students. It can provide means for continuation of academic education,
24 career and technical education or the attainment of entirely new skills as demands for old skills and
25 old occupations are supplanted by new technologies. It may also provide the means to coordinate
26 courses and programs with high schools to accommodate successful transition to college degree
27 programs.

28 (2) Each community college should be so located as to be within commuting time of a substantial
29 majority of its students. As an economical method of providing education close to the student's
30 home, the community college should remain a commuting institution.

31 (3) The community college should establish its organizational patterns to maintain a unique
32 quality of flexibility and the ability to change to meet changing needs.

33 (4) The community college is a post-high-school institution under the general supervision of the
34 State Board of Education. It should not be a "starter" institution intended to evolve into a four-year
35 baccalaureate institution. It should be concerned with programs terminating before reaching the
36 baccalaureate degree.

37 (5) The community college should continue to be prohibited by law from becoming a
38 baccalaureate degree granting institution.

39 (6) Admission to the community college should be open to high school graduates or to [*non-high*
40 *school graduates*] **persons who have not graduated from high school** who can profit from the in-
41 struction offered.

42 (7) There should be close cooperation between those directing the community college program
43 and those responsible for higher education, so that lower-division college transfer programs of the
44 community college will provide adequate preparation for entering baccalaureate degree granting
45 programs, and so that students will be able to transfer with a minimum of difficulty.

1 (8) The community college should offer as comprehensive a program as the needs and resources
2 of the area that it serves dictate. Cost to student and quality of instruction in established private
3 institutions should be among the factors in determining necessary duplication of effort.

4 (9) It should be the policy of the community college to open its facilities and make available its
5 resources to the high schools of its area on a sound contractual basis, for appropriate secondary
6 or transitional courses, either academic or as part of career and technical education, when it is
7 within its ability to provide facilities and it is determined that the high school cannot or does not
8 offer them.

9 (10) Programs designed to meet the needs of the area served should be based on the actual ed-
10 ucational and service needs of the district. Specific career and technical education courses should
11 be related not only to the employment opportunities of the area but of the state and nation as well.
12 Such determination should be made in consultation with representatives of labor, business, industry,
13 agriculture and other interested groups.

14 (11) The State Board of Education should be responsible for coordinating the community college
15 program of the state and should have general supervisory responsibilities for that program. **With**
16 **the advice of the Higher Education Coordinating Commission,** the State Board of Education
17 should prepare estimates and make the requests for legislative appropriations for a reasonable and
18 consistent basis of support and establish standards for the distribution of that support.

19 (12) The initiative for the establishment of new community colleges should come from the lo-
20 calities to be served, as a response to demonstrated educational needs of an area. However, these
21 localities must not only be willing to assume the responsibility for the institutions but must be able
22 to provide resources needed for an adequate educational and service program.

23 (13) The governing board of the community college should be charged with the policy-making
24 function. With respect to educational programming, the governing board should in cooperation with
25 the State Board of Education:

- 26 (a) Identify educational needs of the district; and
- 27 (b) Bring together the resources necessary to meet the needs.

28 (14) The state should maintain a policy of substantial state participation in community college
29 building costs and the maintenance of an adequate level of state support for operation. However,
30 no state funds should be appropriated for buildings such as dormitories or athletic facilities for
31 spectator sports. The district should provide a substantial portion of the funds for capital improve-
32 ment as well as for operation of a community college.

33 (15) State appropriations for community colleges shall be made separately from those for other
34 segments of education.

35 (16) The formula for the distribution of funds for operating costs should reflect the heavier op-
36 erating costs and capital outlay for certain career and technical education courses. Federal funds
37 received for career and technical education, adult basic education, workforce development or other
38 federal initiatives should be used for those purposes only and be distributed separately from funds
39 appropriated by the state and should be exempted from the computations of the present distribution
40 formula for operating costs.

41 (17) The cost of education to the individual should be sufficiently low to permit students of
42 low-income families to attend. This is particularly true of tuition costs. However, students should
43 pay an amount sufficient to provide an incentive to profit from the instructional program offered.

44 (18) Any eligible Oregon resident should have the right to attend a community college even
45 though not residing in a district operating one, subject to the right of the governing board to limit

1 the size of classes and to give preference to students residing in the district. Local school districts
 2 and education service districts should have the authority to negotiate the terms and conditions with
 3 the governing boards for the enrollment of students residing in such areas.

 22 and Workforce Development shall pay from funds available therefor to the state that agrees to pay
 23 and does pay its per capita state aid to eligible Oregon community colleges to the credit of the
 24 community college or comparable institution educating the Oregon resident an amount equal to the
 25 amount that would be available under ORS 341.626 if the Oregon resident were enrolled in a com-
 26 munity college in this state. From these same funds, the Department of Community Colleges and
 27 Workforce Development shall pay to the Oregon community colleges admitting approved one-for-one
 28 exchange students as provided by subsection (1)(b) of this section, from other states, an amount

19 and level claimed by the person.

20 (2)(a) A person who has been awarded a degree from a school other than a school described in
21 subsection (1) of this section may claim or represent that the person possesses an academic degree
22 if:

23 (A) The person has been awarded a degree from a school that has the legal authority to issue
24 degrees in the jurisdiction where the degree is issued; and

25 (B) The claim or representation is accompanied by a disclaimer that states: “(Name of school)
26 does not have accreditation recognized by the United States Department of Education and has not
27 been approved by the [*Office of Degree Authorization*] **Higher Education Coordinating Commis-**
28 **sion.**”

29 (b) A disclaimer allowed under this subsection shall be made in any resume, letterhead, business
30 card, announcement or advertisement in which the person is claiming or representing to have an

38 (5) A region may recommend to the Governor an alternate structure for its regional committee,
39 based on regional determination and mutually agreed to by the current public and private sector

41 must retain a private sector chairperson, appointments of the private sector members as provided
42 in subsection (3) of this section, and substantive public and private sector and other stakeholder

15 tend opportunities to other entities engaged in economic and workforce development programs and
16 services to participate in their joint or integrated strategic planning.

35 (f) Nonprofit corporations organized under Oregon law to provide dental services to rural areas

38 pliance with other applicable state and federal law.

39 (g) Nonprofit charitable corporations as described in section 501(c)(3) of the Internal Revenue

41 licensed dentists to populations with limited access to dental care at no charge or a substantially
42 reduced charge.

43 **351.090, 351.200 and 351.315 by section 291 of this 2011 Act become operative on January 1,**
44 **2012.**

45 **SECTION 293.** **The State Board of Higher Education and the Chancellor of the Oregon**

1 University System may take any action before the operative dates specified in sections 292
2 and 292a of this 2011 Act that is necessary for the board and the chancellor to exercise, on
3 and after the operative dates specified in sections 292 and 292a of this 2011 Act, all of the
4 duties, functions and powers conferred on the board and the chancellor by sections 1 to 30a,
5 33, 36a, 41a, 43 and 170b of this 2011 Act, the amendments to statutes by sections 31, 32, 34
6 to 36, 37 to 41, 42, 44 to 170a and 171 to 290a of this 2011 Act and the repeal of statutes by
7 sections 291 and 291a of this 2011 Act.

11 **SECTION 294.** The unit captions used in this 2011 Act are provided only for the conven-
12 ience of the reader and do not become part of the statutory law of this state or express any
13 legislative intent in the enactment of this 2011 Act.

15 **EMERGENCY DECLARATION**

17 **SECTION 295.** This 2011 Act being necessary for the immediate preservation of the public
18 peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect
19 on its passage.
