

Senate Bill 242

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Education and General Government for Higher Education Workgroup)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates Higher Education Coordinating Commission. Grants commission authority to coordinate higher education policy with Oregon University System and community colleges. Abolishes Oregon Student Assistance Commission and transfers functions to Higher Education Coordinating Commission. Renames Office of Degree Authorization Account to Degree Authorization Account.

Redefines Oregon University System as public university system with more authority and independence to manage affairs, operations and obligations. Creates process for State Board of Higher Education to enter into performance compact with state in conjunction with biennial funding request. Eliminates requirement to seek expenditure limitation to spend other available moneys, including enrollment fees collected from students. Revises current process for setting enrollment fees by requiring student and student government participation, subject to limits set by Higher Education Coordinating Commission. Exempts Oregon University System from certain laws relating to state agencies.

Grants State Board of Higher Education power of eminent domain. Grants board authority to purchase insurance, after reporting to Legislative Assembly. Authorizes board to offer fee remissions to students. Increases membership of board. Authorizes board to purchase property and construct facilities without seeking legislative approval if purchase or construction is to be completed without appropriating General Fund moneys or using general obligation bonds. Credits all interest earned in Oregon University System Fund to Oregon University System.

Becomes operative January 1, 2012.

Declares emergency, effective on passage.

9 Whereas the Legislative Assembly declares its intent to promote a system of higher education
 10 in which:

11 (1) Institutions of higher education have the flexibility to make effective and efficient use of
 12 human, physical and financial resources;

13 (2) Education beyond high school is accessible, regardless of each student's geographic or
 14 socioeconomic position;

15 (3) High-quality research and scholarship by faculty and students is coordinated;

16 (4) Funding and metrics of accountability are aligned and measured against statewide goals and
 17 benchmarks; and

18 (5) Citizens of all ages, backgrounds and income levels are enabled to participate in the search
 19 for knowledge and individual development.

20 **Be It Enacted by the People of the State of Oregon:**

21
 22 **HIGHER EDUCATION COORDINATING COMMISSION**
 23

24 **SECTION 1. (1) There is established a Higher Education Coordinating Commission, con-**
 25 **sisting of 15 members appointed by the Governor.**

26 (2) One of the members of the commission must be a student at a public university listed
 27 in ORS 352.002.

28 (3) One of the members of the commission must be a student at a community college in
 29 this state.

30 (4) The term of office of each member is four years, except that the term of office for
 31 the two student members is two years. A member serves at the pleasure of the Governor.
 32 Before the expiration of the term of a member, the Governor shall appoint a successor whose
 33 term begins on July 1 next following. A member is eligible for reappointment. If there is a
 34 vacancy for any cause, the Governor shall make an appointment to become immediately ef-
 35 fective for the unexpired term.

36 (5) The appointment of the commission is subject to confirmation by the Senate in the
 37 manner prescribed in ORS 171.562 and 171.565.

38 (6) A member of the commission is entitled to compensation and expenses as provided in
 39 ORS 292.495.

40 **SECTION 2. Notwithstanding the term of office specified by section 1 of this 2011 Act,**
 41 **of the members first appointed to the Higher Education Coordinating Commission:**

42 (1) Five, including the two student members, shall serve for a term ending June 30, 2013.

43 (2) Five shall serve for a term ending June 30, 2014.

44 (3) Five shall serve for a term ending June 30, 2015.

45 **SECTION 3. (1) The members of the Higher Education Coordinating Commission must**

1 be residents of this state who are well informed on the principles of higher education.

2 (2) A member of the State Board of Higher Education, Oregon Health and Science Uni-
3 versity Board of Directors or the governing board of a community college district may not
4 serve as a member of the Higher Education Coordinating Commission.

5 **SECTION 4.** (1) The Higher Education Coordinating Commission shall select one of its
6 members as chairperson and another as vice chairperson, for such terms and with duties and
7 powers necessary for the performance of the functions of such offices as the commission
8 determines.

9 (2) A majority of the members of the commission constitutes a quorum for the trans-
10 action of business.

11 (3) The commission shall meet at least once every three months at a place, day and hour
12 determined by the chairperson. The commission may also meet at other times and places
13 specified by the call of the chairperson or of a majority of the members of the commission.

14 **SECTION 5.** (1) The Higher Education Coordinating Commission shall appoint an execu-
15 tive officer to serve at the pleasure of the commission.

16 (2) The appointment of the executive officer must be by written order, filed with the
17 Secretary of State.

18 (3) Subject to any applicable provisions of ORS chapter 240, the executive officer shall
19 appoint all subordinate officers and employees of the commission, prescribe their duties and
20 fix their compensation.

21 **SECTION 6.** In accordance with applicable provisions of ORS chapter 183, the Higher
22 Education Coordinating Commission may adopt rules necessary for the administration of the
23 laws that the commission is charged with administering.

24 **SECTION 7.** (1) The Higher Education Coordinating Commission may establish such ad-
25 visory and technical committees as it considers necessary to aid and advise the commission
26 in the performance of its functions. These committees may be continuing or temporary
27 committees. The commission shall determine the representation, membership, terms and
28 organization of the committees and shall appoint their members.

29 (2) Members of the committees are not entitled to compensation, but at the discretion
30 of the commission may be reimbursed from funds available to the commission for actual and
31 necessary travel and other expenses incurred by them in the performance of their official
32 duties in the manner and amount provided in ORS 292.495.

33 **SECTION 8.** The Higher Education Coordinating Commission shall:

34 (1) Develop state goals and associated accountability measures for the state post-
35 secondary education system, including community colleges, public universities listed in ORS
36 352.002 and the Oregon Health and Science University.

37 (2) Develop a strategic plan for achieving state higher education goals, identifying prior-
38 ity areas for attention. Goals should include, but need not be limited to:

39 (a) Increasing the educational attainment of the population;

40 (b) Increasing this state's global economic competitiveness and the quality of life of its
41 citizens;

42 (c) Ensuring affordable access for qualified Oregon students at each college or public
43 university; and

44 (d) Ensuring that public higher education in this state is provided in a cost-effective
45 manner.

1 (3) Evaluate and recommend changes to statutory institutional missions after receiving
 2 recommendations from the appropriate governing board. The appropriate governing board
 3 shall have decision-making authority over program offerings to implement established
 4 missions.

5 (4) Develop a finance model for higher education aligned with the goals in the system
 6 strategic plan, including:

7 (a) Recommended biennial appropriations to institutions, including a component specif-
 8 ically tied to institutional contributions to state educational priorities;

9 (b) Recommended limits regarding the setting of tuition rates at public universities listed
 10 in ORS 352.002 and community colleges in this state, in accordance with criteria set by the
 11 community college governing boards;

12 (c) Recommended biennial appropriations for student financial aid; and

13 (d) Recommended biennial appropriations for any future statewide higher education ini-
 14 tiatives.

15 (5) Each biennium, recommend to the Governor and the Legislative Assembly a consol-
 16 idated higher education budget request consistent with the finance model, including appro-
 17 priations for:

18 (a) Student financial aid;

19 (b) Ongoing operations for the Oregon University System and the Oregon Health and
 20 Science University;

21 (c) Ongoing operations for community colleges;

22 (d) Needed new facilities or programs; and

23 (e) Capital improvements.

24 (6) Design and maintain a statewide educational data system, in collaboration with the
 25 State Board of Education.

26 (7) Administer student financial assistance programs.

27 (8) Approve and authorize degrees.

28
 29 **ABOLITION OF OREGON STUDENT ASSISTANCE COMMISSION**

30
 31 **SECTION 9.** (1) The Oregon Student Assistance Commission and the Office of Degree
 32 Authorization are abolished. On the operative date specified in section 292 of this 2011 Act,
 33 the tenure of office of the members of the Oregon Student Assistance Commission ceases.

34 (2) All the duties, functions and powers of the Oregon Student Assistance Commission
 35 and the Office of Degree Authorization are imposed upon, transferred to and vested in the
 36 Higher Education Coordinating Commission.

37 **SECTION 10.** (1) The Oregon Student Assistance Commission and the Office of Degree
 38 Authorization shall:

39 (a) Deliver to the Higher Education Coordinating Commission all records and property
 40 within the jurisdiction of the Oregon Student Assistance Commission that relate to the du-
 41 ties, functions and powers transferred by section 9 of this 2011 Act; and

42 (b) Transfer to the Higher Education Coordinating Commission those employees engaged
 43 primarily in the exercise of the duties, functions and powers transferred by section 9 of this
 44 2011 Act.

45 (2) The executive officer of the Higher Education Coordinating Commission shall take

1 possession of the records and property, and shall take charge of the employees and employ
2 them in the exercise of the duties, functions and powers transferred by section 9 of this 2011
3 Act, without reduction of compensation but subject to change or termination of employment
4 or compensation as provided by law.

5 (3) The Governor shall resolve any dispute between the Oregon Student Assistance
6 Commission and the Higher Education Coordinating Commission relating to transfers of re-
7 cords, property and employees under this section, and the Governor's decision is final.

8 **SECTION 11.** (1) The unexpended balances of amounts authorized to be expended by the
9 Oregon Student Assistance Commission and the Office of Degree Authorization for the
10 biennium beginning July 1, 2011, from revenues dedicated, continuously appropriated, appro-
11 priated or otherwise made available for the purpose of administering and enforcing the du-
12 ties, functions and powers transferred by section 9 of this 2011 Act are transferred to and
13 are available for expenditure by the Higher Education Coordinating Commission for the
14 biennium beginning July 1, 2011, for the purpose of administering and enforcing the duties,
15 functions and powers transferred by section 9 of this 2011 Act.

16 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
17 expenditures by the Oregon Student Assistance Commission or the Office of Degree Au-
18 thorization remain applicable to expenditures by the Higher Education Coordinating Com-
19 mission under this section.

20 **SECTION 12.** The transfer of duties, functions and powers to the Higher Education Co-
21 ordinating Commission by section 9 of this 2011 Act does not affect any action, proceeding
22 or prosecution involving or with respect to such duties, functions and powers begun before
23 and pending at the time of the transfer, except that the Higher Education Coordinating
24 Commission is substituted for the Oregon Student Assistance Commission or the Office of
25 Degree Authorization in the action, proceeding or prosecution.

26 **SECTION 13.** (1) Nothing in sections 9 to 16 of this 2011 Act or the repeal of ORS 348.510,
27 348.540, 348.550, 348.560 or 348.599 by section 291 of this 2011 Act relieves a person of a li-
28 ability, duty or obligation accruing under or with respect to the duties, functions and powers
29 transferred by section 9 of this 2011 Act. The Higher Education Coordinating Commission
30 may undertake the collection or enforcement of any such liability, duty or obligation.

31 (2) The rights and obligations of the Oregon Student Assistance Commission legally in-
32 curred under contracts, leases and business transactions executed, entered into or begun
33 before the operative date specified in section 292 of this 2011 Act are transferred to the
34 Higher Education Coordinating Commission. For the purpose of succession to these rights
35 and obligations, the Higher Education Coordinating Commission is a continuation of the
36 Oregon Student Assistance Commission and the Office of Degree Authorization and not a
37 new authority.

38 **SECTION 14.** Notwithstanding the transfer of duties, functions and powers by section 9
39 of this 2011 Act, the rules of the Oregon Student Assistance Commission in effect on the
40 operative date specified in section 292 of this 2011 Act continue in effect until superseded or
41 repealed by rules of the Higher Education Coordinating Commission. References in rules of
42 the Oregon Student Assistance Commission to that commission or the Office of Degree Au-
43 thorization, or an officer or employee of that commission or office, are considered to be
44 references to the Higher Education Coordinating Commission or an officer or employee of
45 the Higher Education Coordinating Commission.

1 or that are implied by law or incident to such powers, rights and duties. The Oregon Uni-
2 versity System is a governmental entity performing governmental functions and exercising
3 governmental powers. The Oregon University System is not considered a unit of local or
4 municipal government or, except as otherwise provided by law, a state agency for purposes
5 of state statutes and constitutional provisions.

6 **SECTION 20.** (1) Based upon limits set by the Higher Education Coordinating Commis-
7 sion, the State Board of Higher Education shall set enrollment fees for each public university
8 listed in ORS 352.002. Enrollment fees include tuition for education and services and any
9 other charges found by the State Board of Higher Education to be necessary to carry out the
10 educational program of the Oregon University System.

11 (2) The State Board of Higher Education shall, by rule, establish a process under which
12 each public university may develop and submit proposed enrollment fees for board consider-
13 ation. The process must provide for participation of enrolled students and the recognized
14 student government of the public university.

15 (3) Each public university listed in ORS 352.002 is authorized to offer fee remissions to
16 its students, including remissions offered on the basis of need, from any authorized source
17 of revenue. Moneys appropriated from the General Fund may not be used to fund fee re-
18 missions to students of the public university.

19 **SECTION 21.** (1) For the purposes of this section, “performance compact” means an
20 agreement between the State Board of Higher Education and the State of Oregon to achieve
21 certain performance targets in order to enhance the success of Oregon University System
22 students in exchange for consideration of the appropriations sought in a funding request
23 submitted by the State Board of Higher Education to the Oregon Department of Adminis-
24 trative Services.

25 (2)(a) On or before May 1 of each even-numbered year, the State Board of Higher Edu-
26 cation shall submit a draft funding request to the Higher Education Coordinating Commis-
27 sion for the Oregon University System, applicable to the biennium beginning on July 1 of the
28 following year. The draft funding request must include a performance compact.

29 (b) If the Higher Education Coordinating Commission approves the draft funding request
30 and performance compact, or approves the draft funding request and performance compact
31 with modifications, the commission shall take such action prior to August 15 of the same
32 even-numbered year.

33 (c) If the Higher Education Coordinating Commission rejects the draft funding request
34 and performance compact, the commission shall take such action prior to June 15 the same
35 even-numbered year. In returning the rejected draft funding request and performance com-
36 pact to the State Board of Higher Education, the commission shall give specific direction to
37 the board regarding the changes necessary to earn commission approval.

38 (3) On or before September 1 of each even-numbered year, the State Board of Higher
39 Education shall submit the funding request and performance compact to the Oregon De-
40 partment of Administrative Services for the Oregon University System.

41 (4) The department shall include the funding request as part of the Governor’s biennial
42 budget submitted to the Legislative Assembly. Any funding request approved by the Legis-
43 lative Assembly must direct the moneys appropriated to the department for allocation to the
44 Oregon University System.

45 (5) The funding request must, in addition to the proposed performance compact, include

1 a report on performance from the previous biennium's performance compact. The State
 2 Board of Higher Education shall submit the performance report on or before December 1 of
 3 each even-numbered year to the Legislative Assembly.

4 (6) The State Board of Higher Education shall, by rule, establish a framework for the
 5 development of a performance compact that must accompany the funding request to the
 6 department.

7 (7) The State Board of Higher Education is authorized to:

8 (a) Request, as part of the funding request, state appropriations for budgetary items,
 9 including but not limited to education and general operations, statewide public services, state
 10 funded debt service, capital improvements and other special initiatives and investments; and

11 (b) Allocate moneys from its state appropriations and other available moneys among the
 12 office of the Chancellor of the Oregon University System, public universities listed in ORS
 13 352.002 and offices, departments and activities under the control of the board.

14 (8) The State Board of Higher Education is not required to seek expenditure limitation
 15 approval from the Legislative Assembly to spend any available moneys, including but not
 16 limited to moneys from enrollment fees collected pursuant to section 20 of this 2011 Act.

17 **SECTION 22.** Section 21 of this 2011 Act applies to biennia beginning on or after July 1,
 18 2013.

19 **SECTION 23.** The State Board of Higher Education shall:

20 (1) Review all mission statements of the public universities listed in ORS 352.002 and
 21 forward them to the Higher Education Coordinating Commission for approval; and

22 (2) Approve all academic programs offered at the public universities, and shall ensure
 23 that the academic programs:

24 (a) Are consistent with the mission statement of the respective public university;

25 (b) Do not unnecessarily duplicate academic programs offered by other public universities
 26 listed in ORS 352.002; and

27 (c) Are allocated among the public universities in the Oregon University System to
 28 maximize the achievement of statewide needs and requirements.

29 **SECTION 24.** As used in sections 24 to 28 of this 2011 Act:

30 (1) "Bond-related costs" means:

31 (a) The costs and expenses of issuing, administering and maintaining higher education
 32 revenue bonds including, but not limited to, the costs of:

33 (A) Paying or redeeming higher education revenue bonds.

34 (B) Paying amounts due in connection with credit enhancement devices or agreements
 35 for exchange of interest rates.

36 (C) Paying the fees, administrative costs and expenses of the State Treasurer and the
 37 Oregon University System, including the costs of consultants or advisers retained by the
 38 State Treasurer or the Chancellor of the Oregon University System, for the higher education
 39 revenue bonds.

40 (b) The costs of funding reserves for the higher education revenue bonds.

41 (c) Capitalized interest for the higher education revenue bonds.

42 (d) Rebates or penalties due to the United States in connection with the higher education
 43 revenue bonds.

44 (e) Any other costs or expenses that the State Treasurer or the chancellor determines
 45 are necessary or desirable in connection with issuing and maintaining the higher education

1 revenue bonds.

2 (2) "Higher education revenue bonds" means revenue bonds issued pursuant to section
3 25 of this 2011 Act.

4 (3) "Higher education revenues" includes:

5 (a) Tuition, fees and charges imposed or collected by the Oregon University System, or
6 by one of the public universities in the system; and

7 (b) Moneys appropriated, allocated or otherwise made available to the Oregon University
8 System, or to one of its universities, by the Legislative Assembly, if those moneys are law-
9 fully available to pay the bond-related costs of higher education revenue bonds.

10 **SECTION 25.** (1) At the request of the Chancellor of the Oregon University System, the
11 State Treasurer may issue, as provided in ORS chapter 286A, higher education revenue bonds
12 from time to time, the net proceeds of which must be used to:

13 (a) Finance projects that the State Board of Higher Education determines will assist the
14 Oregon University System in carrying out its statutory powers;

15 (b) Refund bonds issued for the projects; and

16 (c) Pay bond-related costs.

17 (2)(a) After reserving sufficient funds each biennium to satisfy debt resulting from state
18 general obligation bond obligations under Article XI-F(1) and Article XI-G of the Oregon
19 Constitution and under an energy efficiency and sustainable technology loan program pur-
20 suant to ORS chapter 470, the chancellor may pledge all or a portion of the remaining
21 amount of higher education revenues, pursuant to ORS 286A.102, to secure higher education
22 revenue bonds, credit enhancement devices or agreements for the exchange of interest rates.

23 (b) The chancellor shall identify the specific higher education revenues that will be
24 pledged to secure each series of higher education revenue bonds and specify the status of the
25 lien of each pledge.

26 (3) The chancellor may enter into covenants, pursuant to ORS 286A.025 (4)(c), on behalf
27 of the State of Oregon for the benefit of holders of higher education revenue bonds, providers
28 of credit enhancement for higher education revenue bonds and counterparties to agreements
29 for exchange of interest rates to:

30 (a) Adjust the rates, charges or fees that produce higher education revenues so that
31 higher education revenues equal or exceed specified levels during specified periods.

32 (b) Create only those pledges or liens on higher education revenues that are permitted
33 by the covenants authorized by this section.

34 (c) Budget and apply higher education revenues, or otherwise allow higher education re-
35 venues to be applied, in amounts that, when added to other moneys lawfully available for the
36 purpose, will be sufficient:

37 (A) To pay in full and when due the principal, interest and premium on outstanding
38 higher education revenue bonds;

39 (B) To pay amounts due in connection with agreements for exchange of interest rates
40 and credit enhancement devices for higher education revenue bonds; and

41 (C) To maintain the balance required by covenants in any debt service reserves estab-
42 lished for the higher education revenue bonds.

43 (4) The chancellor shall operate the properties of the Oregon University System in com-
44 pliance with the higher education revenue bond covenants until all higher education revenue
45 bonds are paid or defeased.

1 (5) Higher education revenue bonds are not a debt or a general obligation of the State
2 of Oregon or the Oregon University System, and neither the full faith and credit nor the
3 taxing power of the State of Oregon may be pledged to secure or pay the higher education
4 revenue bonds.

5 (6) The State Treasurer and the Oregon University System do not have an obligation to
6 pay bond-related costs except as provided in sections 24 to 28 of this 2011 Act. A holder of
7 higher education revenue bonds issued under this section does not have the right to compel
8 the exercise of the taxing power of the State of Oregon to pay bond-related costs.

9 (7) As long as any higher education revenue bonds issued under this section are out-
10 standing, covenants related to the higher education revenue bonds are deemed to be con-
11 tracts between the State of Oregon and holders of the higher education revenue bonds. The
12 State of Oregon may not give force or effect to a statute or initiative or referendum measure

23 interest earned by the account must be credited to the account. Moneys in the account are

30 account must be credited to the account. Moneys in the account are continuously appropri-
31 ated to the Oregon University System for the purposes described in this section.

11 [(8) *Encourages cooperation with other educational institutions.*]

12 **(12) Encourages and fosters cooperation and collaboration with other universities, both
13 public and private, community colleges, schools, governmental entities and business and
14 community partners.**

 29 subsection, “costs” includes the expenses of publication, service of notices, towing, storage and
 30 servicing or maintaining the seized property under ORS 131.564.

31 (b) After costs have been paid, the seizing agency shall distribute to the victim any amount the
 32 seizing agency was ordered to distribute under ORS 131.588 (4).

33 (c) After costs have been paid and distributions under paragraph (b) of this subsection have been

 35 subdivision that operates the seizing agency.

2 (b) One-third of the total salary paid by a participating public employer to an employee who is
3 an active member of the system in the last 36 calendar months of active membership before the ef-
4 fective date of retirement of the employee.

5 (9) "Firefighter" does not include a volunteer firefighter, but does include:

6 (a) The State Fire Marshal, the chief deputy fire marshal and deputy state fire marshals; and

7 (b) An employee of the State Forestry Department who is certified by the State Forester as a
8 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
9 fires as described in ORS 477.064.

10 (10) "Fiscal year" means 12 calendar months commencing on July 1 and ending on June 30 fol-
11 lowing.

12 (11) "Fund" means the Public Employees Retirement Fund.

13 (12)(a) "Member" means a person who has established membership in the system and whose
14 membership has not been terminated as described in ORS 238.095. "Member" includes active, inac-
15 tive and retired members.

16 (b) "Active member" means a member who is presently employed by a participating public em-
17 ployer in a qualifying position and who has completed the six-month period of service required by
18 ORS 238.015.

19 (c) "Inactive member" means a member who is not employed in a qualifying position, whose
20 membership has not been terminated in the manner described by ORS 238.095, and who is not retired
21 for service or disability.

22 (d) "Retired member" means a member who is retired for service or disability.

23 (13)(a) "Member account" means the regular account and the variable account.

24 (b) "Regular account" means the account established for each active and inactive member under
25 ORS 238.250.

26 (c) "Variable account" means the account established for a member who participates in the
27 Variable Annuity Account under ORS 238.260.

28 (14) "Normal retirement age" means:

29 (a) For a person who establishes membership in the system before January 1, 1996, as described
30 in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or firefighter
31 or 58 years of age if the employee retires at that age as other than a police officer or firefighter.

32 (b) For a person who establishes membership in the system on or after January 1, 1996, as de-
33 scribed in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or
34 firefighter or 60 years of age if the employee retires at that age as other than a police officer or
35 firefighter.

36 (15) "Pension" means annual payments for life derived from contributions by one or more public
37 employers.

38 (16) "Police officer" includes:

39 (a) Employees of institutions defined in ORS 421.005 as Department of Corrections institutions
40 whose duties, as assigned by the Director of the Department of Corrections, include the custody of
41 persons committed to the custody of or transferred to the Department of Corrections and employees
42 of the Department of Corrections who were classified as police officers on or before July 27, 1989,
43 whether or not such classification was authorized by law.

44 (b) Employees of the Department of State Police who are classified as police officers by the
45 Superintendent of State Police.

1 (c) Employees of the Oregon Liquor Control Commission who are classified as enforcement of-
2 ficers by the administrator of the commission.

3 (d) Sheriffs and those deputy sheriffs or other employees of a sheriff whose duties, as classified
4 by the sheriff, are the regular duties of police officers or corrections officers.

5 (e) Police chiefs and police personnel of a city who are classified as police officers by the
6 council or other governing body of the city.

7 (f) Parole and probation officers employed by the Department of Corrections, parole and pro-
8 bation officers who are transferred to county employment under ORS 423.549 and adult parole and
9 probation officers, as defined in ORS 181.610, who are classified as police officers for the purposes
10 of this chapter by the county governing body. If a county classifies adult parole and probation offi-
11 cers as police officers for the purposes of this chapter, and the employees so classified are repres-
12 ented by a labor organization, any proposal by the county to change that classification or to cease
13 to classify adult parole and probation officers as police officers for the purposes of this chapter is
14 a mandatory subject of bargaining.

15 (g) Police officers appointed under ORS 276.021 or 276.023.

16 (h) Employees of the Port of Portland who are classified as airport police by the Board of
17 Commissioners of the Port of Portland.

18 (i) Employees of the State Department of Agriculture who are classified as livestock police of-
19 ficers by the Director of Agriculture.

20 (j) Employees of the Department of Public Safety Standards and Training who are classified by
21 the department as other than secretarial or clerical personnel.

22 (k) Investigators of the Criminal Justice Division of the Department of Justice.

23 (L) Corrections officers as defined in ORS 181.610.

24 (m) Employees of the Oregon State Lottery Commission who are classified by the Director of the
25 Oregon State Lottery as enforcement agents pursuant to ORS 461.110.

26 (n) The Director of the Department of Corrections.

27 (o) An employee who for seven consecutive years has been classified as a police officer as de-
28 fined by this section, and who is employed or transferred by the Department of Corrections to fill
29 a position designated by the Director of the Department of Corrections as being eligible for police
30 officer status.

31 (p) An employee of the Department of Corrections classified as a police officer on or prior to
32 July 27, 1989, whether or not that classification was authorized by law, as long as the employee
33 remains in the position held on July 27, 1989. The initial classification of an employee under a sys-
34 tem implemented pursuant to ORS 240.190 does not affect police officer status.

35 (q) Employees of a school district who are appointed and duly sworn members of a law
36 enforcement agency of the district as provided in ORS 332.531 or otherwise employed full-time as
37 police officers commissioned by the district.

38 (r) Employees at youth correction facilities and juvenile detention facilities under ORS 419A.050,
39 419A.052 and 420.005 to 420.915 who are required to hold valid Oregon teaching licenses and who
40 have supervisory, control or teaching responsibilities over juveniles committed to the custody of the
41 Department of Corrections or the Oregon Youth Authority.

42 (s) Employees at youth correction facilities as defined in ORS 420.005 whose primary job de-
43 scription involves the custody, control, treatment, investigation or supervision of juveniles placed
44 in such facilities.

45 (t) Employees of the Oregon Youth Authority who are classified as juvenile parole and probation

1 officers.

2 (17) "Public employer" means the state, one of its agencies, any city, county, or municipal or
3 public corporation, any political subdivision of the state or any instrumentality thereof, or an agency
4 created by one or more such governmental organizations to provide governmental services. For
5 purposes of this chapter, such agency created by one or more governmental organizations is a gov-
6 ernmental instrumentality and a legal entity with power to enter into contracts, hold property and
7 sue and be sued.

8 (18) "Prior service credit" means credit provided under ORS 238.442 or under ORS 238.225 (2)
9 to (6) (1999 Edition).

10 (19) "Qualifying position" means one or more jobs with one or more participating public em-
11 ployers in which an employee performs 600 or more hours of service in a calendar year, excluding
12 any service in a job for which a participating public employer does not provide benefits under this
13 chapter pursuant to an application made under ORS 238.035.

14 (20) "Retirement credit" means a period of time that is treated as creditable service for the
15 purposes of this chapter.

16 (21)(a) "Salary" means the remuneration paid an employee in cash out of the funds of a public
17 employer in return for services to the employer, plus the monetary value, as determined by the
18 Public Employees Retirement Board, of whatever living quarters, board, lodging, fuel, laundry and
19 other advantages the employer furnishes the employee in return for services.

20 (b) "Salary" includes but is not limited to:

21 (A) Payments of employee and employer money into a deferred compensation plan, which are
22 deemed salary paid in each month of deferral;

23 (B) The amount of participation in a tax-sheltered or deferred annuity, which is deemed salary
24 paid in each month of participation;

25 (C) Retroactive payments described in section 7, chapter 1, Oregon Laws 2010; and

26 (D) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
27 652.190.

28 (c) "Salary" or "other advantages" does not include:

29 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
30 employer;

31 (B) Payments for insurance coverage by an employer on behalf of employee or employee and
32 dependents, for which the employee has no cash option;

33 (C) Payments made on account of an employee's death;

34 (D) Any lump sum payment for accumulated unused sick leave;

35 (E) Any accelerated payment of an employment contract for a future period or an advance
36 against future wages;

37 (F) Any retirement incentive, retirement severance pay, retirement bonus or retirement
38 gratuitous payment;

39 (G) Payments for periods of leave of absence after the date the employer and employee have
40 agreed that no future services qualifying pursuant to ORS 238.015 (3) will be performed, except for
41 sick leave and vacation;

42 (H) Payments for instructional services rendered to [*institutions*] **public universities** of the
43 Oregon University System or the Oregon Health and Science University when such services are in
44 excess of full-time employment subject to this chapter. A person employed under a contract for less
45 than 12 months is subject to this subparagraph only for the months to which the contract pertains;

1 or

2 (I) Payments made by an employer for insurance coverage provided to a domestic partner of an
3 employee.

4 (22) "School year" means the period beginning July 1 and ending June 30 next following.

5 (23) "System" means the Public Employees Retirement System.

6 (24) "Vested" means being an active member of the system in each of five calendar years.

7 (25) "Volunteer firefighter" means a firefighter whose position normally requires less than 600
8 hours of service per year.

9 **SECTION 73.** ORS 238.300 is amended to read:

10 238.300. Upon retiring from service at normal retirement age or thereafter, a member of the
11 system shall receive a service retirement allowance which shall consist of the following annuity and
12 pensions:

13 (1) A refund annuity which shall be the actuarial equivalent of accumulated contributions, if
14 any, by the member and interest thereon credited at the time of retirement, which annuity shall
15 provide an allowance payable during the life of the member and at death a lump sum equal in
16 amount to the difference between accumulated contributions at the time of retirement and the sum
17 of the annuity payments actually made to the member during life shall be paid to such person, if any,
18 as the member nominates by written designation duly acknowledged and filed with the board or shall

26 to the sum of the annuity, if any, under subsection (1) of this section and the annuity, if any, pro-
27 vided on the same basis and payable from the Variable Annuity Account, both annuities considered

41 (i) The person is a member of the system, or a judge member of the system, on the day imme-
42 diately before July 1, 2003; or

43 (ii) The person performed any period of service for a participating public employer before July
44 1, 2003, that is credited to the six-month period of employment required of an employee under ORS
45 238.015 before an employee may become a member of the system.

1 (B) For a member who made contributions before August 21, 1981, the equivalent of a pension
2 computed pursuant to this subsection as it existed immediately before that date.

3 (c) As used in this subsection, "number of years of membership" means the number of full years
4 of creditable service plus any remaining fraction of a year of creditable service. Except as other-
5 wise provided in this paragraph, in determining a remaining fraction a full month shall be consid-
6 ered as one-twelfth of a year and a major fraction of a month shall be considered as a full month.
7 Membership of a school district employee, an employee of the State Board of Higher Education en-
8 gaged in teaching or other school activity at [*an institution of higher education*] **a public university**
9 **listed in ORS 352.002** or an employee of the Department of Human Services, the Oregon Youth
10 Authority, the Department of Corrections or the State Board of Education engaged in teaching or
11 other school activity at an institution supervised by the authority, board or department, for all

15 of membership of a member who received a refund of contributions as provided in ORS 237.976 (2)
16 is limited to the number of years after the day before the date on which the refund was received.
17 The number of years of membership of a member who is separated, for any reason other than death
18 or disability, from all service entitling the member to membership in the system, who withdraws the
19 amount credited to the member account of the member in the fund during absence from such service
20 and who thereafter reenters the service of an employer participating in the system but does not
21 repay the amount so withdrawn as provided in this chapter, is limited to the number of years after
22 the day before the date of so reentering.

23 (3) An additional life pension (nonrefund) for prior service credit, including military service,
24 credited to the member at the time of first becoming a member of the system, as elsewhere provided
25 in this chapter, which pension shall be provided by the contributions of the employer.

26 **SECTION 74.** ORS 238.350 is amended to read:

27 238.350. (1)(a) Upon the request by a public employer that its employees be compensated for
28 accumulated unused sick leave with pay in the form of increased retirement benefits upon service
29 or disability retirement, the board shall establish a procedure for adding to the gross amount of
30 salary used in determining final average salary the monetary value of one-half of the accumulated
31 unused sick leave with pay of each retiring employee of the requesting public employer and shall
32 establish benefits of the retiring employee on the basis of a final average salary reflecting that ad-
33 dition.

34 (b) For employees of a common school district, a union high school district, an education service
35 district or a community college, or employees of the State Board of Higher Education engaged in
36 teaching or other school activity at [*an institution of higher education*] **a public university listed**
37 **in ORS 352.002**, or employees of the school operated under ORS 346.010 engaged in teaching or
38 other school activity, who are employed under contract for a period of less than 12 consecutive
39 months and who are entitled to sick leave with pay of less than 96 hours for a year, each hour of
40 accumulated unused sick leave with pay shall be valued on the basis of the actual number of con-
41 tract hours of employment during the last year of contributing membership of an employee before
42 retiring and the salary of the employee during the same period. This paragraph does not apply to
43 any employee who is employed under contract for 12 consecutive months in any of the three or less
44 years used in determining the final average salary of the employee.

45 (c) For the purpose of this subsection, accumulated unused sick leave with pay includes unused

1 sick leave with pay accumulated by an active member of the system while in the service of any
2 public employer participating in the system that has the request described in paragraph (a) of this

4 that employer is or is not the employer of the member at the time of the member's retirement.

23 (e) Sick leave accumulated on and after July 1, 1973, may be considered only to the extent it is
24 supported by records of accumulation and use pursuant to a plan adopted formally by the public
25 employer.

26 (f) Accumulated unused sick leave for periods before July 1, 1973, may be considered as follows:

27 (A) If any department, bureau or other organizational unit of a public employer maintained
28 formal records of accumulation and use even though the public employer did not require that those
29 records be maintained, the accumulated unused sick leave shall be considered according to those
30 records.

31 (B) Where the public employer provided sick leave before July 1, 1973, but formal records of
32 accumulation and use were not required or if required, are unavailable or incomplete, or the sick
33 leave was subject to administrative limitations on total accumulation or transfer between public
34 employers, accumulated unused sick leave for periods before July 1, 1973, may be considered as
35 equal to 2.675 hours for each full month worked or an amount per month equal to the average
36 monthly accumulation by an employee during the period beginning July 1, 1973, and ending at the
37 time of retirement, whichever amount is greater, but reduced by the amount of any accumulated
38 unused sick leave credited to the employee on July 1, 1973.

39 (g) The written certification of a member or former member of the Legislative Assembly shall
40 constitute a formal record of accumulation and use in determining the amount of accumulated un-
41 used sick leave of an employee of the Legislative Assembly, either of its houses or any of its com-
42 mittees or officers for periods of employment before July 1, 1981. Sick leave accumulated on and
43 after July 1, 1981, by employees of the Legislative Assembly, either of its houses or any of its com-

29 (4) Employers with plans providing payments on account of sickness in lieu of sick leave with
30 pay may request the board to consider the monetary value of accumulated unused payments on ac-
31 count of sickness as if such payments were an equivalent amount of accumulated unused sick leave
32 with pay under the same terms and conditions specified in subsections (1) and (2) of this section.

- 9 (h) Employees of the Oregon University System who are actively participating in an optional
 10 retirement plan offered under ORS 243.800;
- 11 (i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
 12 for membership in the system under the provisions of ORS chapter 238 or other law;
- 13 (j) Any person who belongs to a class of employees who are not eligible to become members of
 14 the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);
- 15 (k) Any person who is retired under ORS 238A.100 to 238A.245 or ORS chapter 238 and who
 16 continues to receive retirement benefits while employed; and

- 18 (5) "Firefighter" means:
- 19 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
 20 duties include the fighting of fires;
- 21 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;

- 23 (c) An employee of the State Forestry Department who is certified by the State Forester as a
 24 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
 25 fires as described in ORS 477.064.
- 26 (6) "Fund" means the Public Employees Retirement Fund.
- 27 (7)(a) "Hour of service" means:
- 28 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
 29 by a participating public employer for performance of duties in a qualifying position; and
- 30 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
 31 during which an employee does not perform duties but for which the employee is directly or indi-
 32 rectly paid or entitled to payment by a participating public employer for services in a qualifying
 33 position, as long as the hour is within the number of hours regularly scheduled for the performance

11 (15) "Retired member" means a pension program member who is receiving a pension as provided
12 in ORS 238A.180 to 238A.195.

13 (16)(a) "Salary" means the remuneration paid to an active member in return for services to the
14 participating public employer, including remuneration in the form of living quarters, board or other
15 items of value, to the extent the remuneration is includable in the employee's taxable income under
16 Oregon law. Salary includes the additional amounts specified in paragraph (b) of this subsection,
17 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether
18 those amounts are includable in taxable income.

19 (b) "Salary" includes the following amounts:

20 (A) Payments of employee and employer money into a deferred compensation plan that are made

30 (b) A post-secondary education advances a citizen's ability to pursue life, liberty and happiness
31 through a wide range of employment opportunities.

32 (c) A well-educated citizenry contributes to the economic well-being of the state and nation.

33 (d) A well-trained and skilled citizenry enhances economic development of the state.

34 (e) While students have just begun their education upon completion of a formal education, a
35 lifetime pursuit of learning contributes to a well-informed citizenry and to Oregon's cherished qual-
36 ity of life.

37 (f) Citizens educated in Oregon are more likely to pursue careers in Oregon.

38 (g) It is in the interest of this state to encourage its citizens to plan and save for a post-
39 secondary education.

40 (h) An Oregon Baccalaureate Bond program that provides citizens an opportunity to save for a
41 post-secondary education for their children, themselves or any citizen is in the social and economic
42 interest of the State of Oregon.

43 (i) A systematic way to save for post-secondary education can assist all of Oregon's higher ed-
44 ucation, community college and career schools to better project enrollments, thereby permitting the
45 prudent allocation of scarce resources.

1 (4) At the request of the Oregon University System, the State Treasurer may:

2 (a) Issue bonds as Oregon Baccalaureate Bonds, to encourage investors to save for post-
3 secondary education opportunities.

4 (b) Investigate and implement the means and procedures to facilitate the participation by the
5 broadest practical range of investors in the Oregon Baccalaureate Bond program. The means and
6 procedures may include, but are not limited to, adjustments in the denominations in which the bonds
7 are issued and the frequency with which the bonds are issued.

8 (5) The purchase of an Oregon Baccalaureate Bond does not guarantee the purchaser, owner

9 (2) “At-risk student” means:

10 (a) A student who qualifies for a free or reduced lunch program; or

11 (b) An at-risk student as defined by rules adopted by the board if the board has adopted rules
12 to define an at-risk student.

13 (3) “Duplicate course” means a course with a scope that is identical to the scope of another
14 course.

15 (4)(a) “Eligible post-secondary course” means any nonsectarian course or program offered
16 through an eligible post-secondary institution if the course or program may lead to high school
17 completion, a certificate, professional certification, associate degree or baccalaureate degree.

18 (b) “Eligible post-secondary course” does not include a duplicate course offered at the student’s
19 resident school.

20 (c) “Eligible post-secondary course” includes:

21 (A) Academic courses;

22 (B) Career and technical education courses; and

23 (C) Distance education courses.

24 (5) “Eligible post-secondary institution” means:

25 (a) A community college;

26 (b) A [*state institution of higher education*] **public university** listed in ORS 352.002; and

27 (c) The Oregon Health and Science University.

28 (6)(a) “Eligible student” means a student who is enrolled in an Oregon public school and who:

29 (A) Is 16 years of age or older at the time of enrollment in a course under the Expanded Options
30 Program;

31 (B)(i) Is in grade 11 or 12 at the time of enrollment in a course under the Expanded Options
32 Program; or

33 (ii) Is not in grade 11 or 12, because the student has not completed the required number of
34 credits, but who has been allowed by the school district to participate in the program;

35 (C) Has developed an educational learning plan as described in ORS 340.025; and

36 (D) Has not successfully completed the requirements for a high school diploma as established
37 by ORS 329.451, the State Board of Education and the school district board.

38 (b) “Eligible student” does not include a foreign exchange student enrolled in a school under a

40 (7) “Expanded Options Program” means the program created under this chapter.

41 (8) “Scope” means depth and breadth of course content as evidenced through a planned course
42 statement including content outline, applicable state content standards where appropriate, course
43 goals and student outcomes.

44 **SECTION 121.** ORS 340.085 is amended to read:

45 340.085. The Department of Education shall annually report on the Expanded Options Program

1 to the [*Joint Boards of Education*] **Higher Education Coordinating Commission** and the House and
2 Senate committees relating to education. The report shall include:

3 (1) The types of accelerated college credit programs offered.

4 (2) The number of waivers of requirements granted under the Expanded Options Program and
5 the reasons for issuance of the waivers.

6 (3) The number of college and high school credits earned under the Expanded Options Program.

14 gram.

15 (8) The level of participation in the Expanded Options Program by rural communities, and the
16 number of students living in rural communities who participated in the program.

17 (9) Recommendations for changes to the Expanded Options Program to better serve students,
18 including changes to the age limit restrictions for eligible students.

19 (10) Recommendations for funding changes to better serve students who wish to participate in
20 the Expanded Options Program.

21 (11) The number of appeals of students under ORS 340.030 to the Superintendent of Public In-
22 struction or the superintendent's designee and the disposition of the students' appeals.

23 (12) The number of small school districts with more eligible students who wish to participate in
24 the program than are allowed under the credit hour caps established in ORS 340.080.

25 **SECTION 122.** ORS 341.009 is amended to read:

26 341.009. The Legislative Assembly finds that:

27 (1) The community college is an educational institution that is intended to fill the institutional
28 gap in education by offering broad, comprehensive programs in academic subjects and in career and
29 technical education subjects. It is primarily designed to provide associate or certificate degree pro-
30 grams for some, serve a transitional purpose for others who will continue baccalaureate or other
31 college work, provide the ability to enter the workforce immediately and serve to determine future
32 educational needs for other students. It can provide means for continuation of academic education,
33 career and technical education or the attainment of entirely new skills as demands for old skills and
34 old occupations are supplanted by new technologies. It may also provide the means to coordinate
35 courses and programs with high schools to accommodate successful transition to college degree
36 programs.

37 (2) Each community college should be so located as to be within commuting time of a substantial
38 majority of its students. As an economical method of providing education close to the student's
39 home, the community college should remain a commuting institution.

40 (3) The community college should establish its organizational patterns to maintain a unique
41 quality of flexibility and the ability to change to meet changing needs.

42 (4) The community college is a post-high-school institution under the general supervision of the
43 State Board of Education. It should not be a "starter" institution intended to evolve into a four-year
44 baccalaureate institution. It should be concerned with programs terminating before reaching the
45 baccalaureate degree.

1 (5) The community college should continue to be prohibited by law from becoming a
2 baccalaureate degree granting institution.

3 (6) Admission to the community college should be open to high school graduates or to *[non-high*
4 *school graduates]* **persons who have not graduated from high school** who can profit from the in-
5 struction offered.

6 (7) There should be close cooperation between those directing the community college program
7 and those responsible for higher education, so that lower-division college transfer programs of the
8 community college will provide adequate preparation for entering baccalaureate degree granting
9 programs, and so that students will be able to transfer with a minimum of difficulty.

10 (8) The community college should offer as comprehensive a program as the needs and resources
11 of the area that it serves dictate. Cost to student and quality of instruction in established private
12 institutions should be among the factors in determining necessary duplication of effort.

13 (9) It should be the policy of the community college to open its facilities and make available its
14 resources to the high schools of its area on a sound contractual basis, for appropriate secondary
15 or transitional courses, either academic or as part of career and technical education, when it is
16 within its ability to provide facilities and it is determined that the high school cannot or does not
17 offer them.

18 (10) Programs designed to meet the needs of the area served should be based on the actual ed-
19 ucational and service needs of the district. Specific career and technical education courses should
20 be related not only to the employment opportunities of the area but of the state and nation as well.
21 Such determination should be made in consultation with representatives of labor, business, industry,
22 agriculture and other interested groups.

23 (11) The State Board of Education *[should be responsible for coordinating the community college*
24 *program of the state and]* should have general supervisory responsibilities for *[that]* **the community**
25 **college** program. The *[State Board of Education]* **Higher Education Coordinating Commission**
26 should **coordinate the community college program and** prepare estimates and make the requests
27 for legislative appropriations for a reasonable and consistent basis of support and establish stan-
28 dards for the distribution of that support.

29 (12) The initiative for the establishment of new community colleges should come from the lo-

32 and Workforce Development shall pay from funds available therefor to the state that agrees to pay
33 and does pay its per capita state aid to eligible Oregon community colleges to the credit of the
34 community college or comparable institution educating the Oregon resident an amount equal to the
35 amount that would be available under ORS 341.626 if the Oregon resident were enrolled in a com-
36 munity college in this state. From these same funds, the Department of Community Colleges and
37 Workforce Development shall pay to the Oregon community colleges admitting approved one-for-one
38 exchange students as provided by subsection (1)(b) of this section, from other states, an amount

342.144. (1) As used in this section, “American Indian tribe” means an Indian tribe as that term is defined in ORS 97.740.

(2) The Legislative Assembly declares that teaching American Indian languages is essential to the proper education of American Indian children.

(3) The Teacher Standards and Practices Commission shall establish an American Indian languages teaching license.

(4) Each American Indian tribe may develop a written and oral test that must be successfully completed by an applicant for an American Indian languages teaching license in order to determine whether the applicant is qualified to teach the tribe’s native language. When developing the test, the tribe shall determine:

(a) Which dialects will be used on the test;

(b) Whether the tribe will standardize the tribe’s writing system; and

(6) The commission may not require an applicant to hold a specific academic degree, to complete a specific amount of education or to complete a teacher education program to receive an American Indian languages teaching license.

(7)(a) An American Indian languages teaching license qualifies the holder to accept a teaching position in a school district, public charter school, education service district, community college or *[state institution of higher education]* **public university listed in ORS 352.002.**

(b) A holder of an American Indian languages teaching license who does not also have a teaching license issued under ORS 342.125 may not teach in a school district or education service district any subject other than the American Indian language the holder of the license is approved to teach by the tribe.

(c) A holder of an American Indian languages teaching license who does not also have a teaching license or registration issued under ORS 342.125 may not teach in a public charter school any subject other than the American Indian language the holder of the license is approved to teach by the tribe.

(8)(a) As used in this subsection, “technical assistance program” means a program provided to an American Indian languages teacher by a licensed teacher with three or more years of teaching experience. A technical assistance program may include direct classroom observation and consultation, assistance in instructional planning and preparation, support in implementation and delivery of classroom instruction, and other assistance intended to enhance the professional performance and development of the American Indian languages teacher.

(b) The holder of an American Indian languages teaching license who does not also have an administrative license, teaching license or registration issued under ORS 342.125 and who is employed by a school district, public charter school or education service district shall participate in a technical assistance program with a person holding a teaching license issued by the commission under ORS 342.125. The technical assistance program shall meet the guidelines specified in ORS

1 329.815 (2) to (4).

2 (9) An American Indian languages teaching license shall be valid for three years and may be
3 renewed upon application from the holder of the license.

4 **SECTION 126.** ORS 342.147 is amended to read:

6 (2)(a) A person who has been awarded a degree from a school other than a school described in
7 subsection (1) of this section may claim or represent that the person possesses an academic degree
8 if:

9 (A) The person has been awarded a degree from a school that has the legal authority to issue
10 degrees in the jurisdiction where the degree is issued; and

11 (B) The claim or representation is accompanied by a disclaimer that states: "(Name of school)
12 does not have accreditation recognized by the United States Department of Education and has not
13 been approved by the [*Office of Degree Authorization*] **Higher Education Coordinating Commis-
14 sion.**"

15 (b) A disclaimer allowed under this subsection shall be made in any resume, letterhead, business
16 card, announcement or advertisement in which the person is claiming or representing to have an
17 academic degree from a school that does not meet the requirements of subsection (1) of this section.

18 (c) A person may not use a disclaimer described in this subsection for a degree received from
19 a diploma mill.

20 (d) This subsection does not alter any requirement for obtaining a license, admission into a

16 records of the Employment Department pertaining to the administration of the unemployment in-
17 surance, employment service and labor market information programs:

18 (a) Is confidential and for the exclusive use and information of the Director of the Employment
19 Department in administering the unemployment insurance, employment service and labor market
20 information programs in Oregon.

21 (b) May not be used in any court action or in any proceeding pending in the court unless the

30 disclose the information in a form and containing the information that the United States Secretary
31 of Labor may require. The information disclosed is confidential and may not be used for any other
32 purpose.

33 (c) Pursuant to section 303(a)(7) of the Social Security Act, upon request to any agency of the
34 United States charged with the administration of public works or assistance through public em-
35 ployment. Under this paragraph, the Employment Department shall disclose the name, address, or-

38 (4) The advisor shall seek input from key interested parties to help guide policy development,

44 (e) Student, teacher, parent and faculty organizations;

22 **SECTION 284.** ORS 679.020 is amended to read:

23 679.020. (1) A person may not practice dentistry without a license.

24 (2) Only a person licensed as a dentist by the Oregon Board of Dentistry may own, operate,
 25 conduct or maintain a dental practice, office or clinic in this state.

26 (3) The restrictions of subsection (2) of this section, as they relate to owning and operating a
 27 dental office or clinic, do not apply to a dental office or clinic owned or operated by any of the
 28 following:

29 (a) A labor organization as defined in ORS 243.650 and 663.005 (6), or to any nonprofit organ-
 30 ization formed by or on behalf of such labor organization for the purpose of providing dental ser-
 31 vices. Such labor organization must have had an active existence for at least three years, have a
 32 constitution and bylaws, and be maintained in good faith for purposes other than providing dental
 33 services.

34 (b) The School of Dentistry of the Oregon Health and Science University.

35 (c) [*Institutions of higher education*] **Public universities** listed in ORS 352.002.

36 (d) Local governments.

37 (e) Institutions or programs accredited by the Commission on Dental Accreditation of the
 38 American Dental Association to provide education and training.

39 (f) Nonprofit corporations organized under Oregon law to provide dental services to rural areas
 40 and medically underserved populations of migrant, rural community or homeless individuals under
 41 42 U.S.C. 254b or 254c or health centers qualified under 42 U.S.C. 1396d(1)(2)(B) operating in com-
 42 pliance with other applicable state and federal law.

43 (g) Nonprofit charitable corporations as described in section 501(c)(3) of the Internal Revenue
 44 Code and determined by the Oregon Board of Dentistry as providing dental services by volunteer
 45 licensed dentists to populations with limited access to dental care at no charge or a substantially

1 reduced charge.

2 (4) For the purpose of owning or operating a dental office or clinic, an entity described in sub-
3 section (3) of this section must:

4 (a) Name an actively licensed dentist as its dental director, who shall be subject to the pro-
5 visions of ORS 679.140 in the capacity as dental director. The dental director, or an actively licensed
6 dentist designated by the director, shall have responsibility for the clinical practice of dentistry,
7 which includes, but is not limited to:

8 (A) Diagnosis of conditions within the human oral cavity and its adjacent tissues and structures.

9 (B) Prescribing drugs that are administered to patients in the practice of dentistry.

10 (C) The treatment plan of any dental patient.

11 (D) Overall quality of patient care that is rendered or performed in the practice of dentistry.

12 (E) Supervision of dental hygienists, dental assistants or other personnel involved in direct pa-
13 tient care and the authorization for procedures performed by them in accordance with the standards
14 of supervision established by statute or by the rules of the board.

15 (F) Other specific services within the scope of clinical dental practice.

16 (G) Retention of patient dental records as required by statute or by rule of the board.

17 (H) Ensuring that each patient receiving services from the dental office or clinic has a dentist
18 of record.

19 (b) Maintain current records of the names of licensed dentists who supervise the clinical activ-
20 ities of dental hygienists, dental assistants or other personnel involved in direct patient care utilized
21 by the entity. The records must be available to the board upon written request.

22 (5) Subsections (1) and (2) of this section do not apply to a limited access permit dental hygienist
23 who renders services authorized by a limited access permit issued by the board pursuant to ORS
24 680.200.

25 (6) Nothing in this chapter precludes a person or entity not licensed by the board from:

26 (a) Ownership or leasehold of any tangible or intangible assets used in a dental office or clinic.
27 These assets include real property, furnishings, equipment and inventory but do not include dental
28 records of patients related to clinical care.

29 (b) Employing or contracting for the services of personnel other than licensed dentists.

30 (c) Management of the business aspects of a dental office or clinic that do not include the clin-
31 ical practice of dentistry.

32 (7) If all of the ownership interests of a dentist or dentists in a dental office or clinic are held
33 by an administrator, executor, personal representative, guardian, conservator or receiver of the es-
34 tate of a former shareholder, member or partner, the administrator, executor, personal represen-
35 tative, guardian, conservator or receiver may retain the ownership interest for a period of 12 months
36 following the creation of the ownership interest. The board shall extend the ownership period for
37 an additional 12 months upon 30 days' notice and may grant additional extensions upon reasonable
38 request.

39 **SECTION 285.** ORS 680.515 is amended to read:

40 680.515. (1) Subject to the provisions of ORS 676.612, upon application accompanied by payment
41 of required fees, the Oregon Health Licensing Agency shall issue a license to practice denture
42 technology to any applicant who submits proof satisfactory to the agency that the applicant has
43 completed all requirements for licensure, which include, but are not limited to:

44 (a) Providing to the agency official transcripts verifying completion of an associate degree pro-
45 gram in denture technology, or the equivalent in formal, post-secondary education, approved by the

1 agency in consultation with the [*Oregon Student Assistance Commission*] **Higher Education Coor-**
2 **ordinating Commission** and the Department of Education. The educational program shall include
3 pertinent courses in anatomy, including histology, microbiology, physiology, pharmacology,
4 pathology emphasizing periodontology, dental materials, medical emergencies, geriatrics, profes-
5 sional ethics, clinical denture technology and denture laboratory technology;

6 (b) Providing to the agency documentation of 1,000 hours of supervised clinical practice in
7 denture technology, completed while enrolled in or after having completed a course of study offered
8 in a post-secondary educational institution, or through equivalent supervised experience, as deter-
9 mined by the agency in consultation with the [*Oregon Student Assistance*] **Higher Education Co-**
10 **ordinating Commission** and the Department of Education; and

11 (c) Passing a written and a practical examination prescribed, recognized or approved by the
12 State Board of Denture Technology. An applicant who fails the practical examination must com-
13 plete additional hours of clinical and laboratory training in an approved work experience program,
14 as determined by the [*board*] **State Board of Denture Technology**, to qualify for reexamination.

15 (2) Notwithstanding subsection (1)(a) of this section, the [*board*] **State Board of Denture**
16 **Technology** may accept educational training obtained in any other state or country if, upon review

34 (d) A diploma and transcript, certified by the registrar, or other documents satisfactory to the

44 is licensed in another state and practiced chiropractic in that state, but the applicant must pass the
45 examination authorized by ORS 684.050 or by ORS 684.052.

2 685.060. (1) The minimum educational requirements for a license under the provisions of this

4 (a) At least two years' satisfactory liberal arts and sciences study, or either, in a college or
5 university accredited by either the Northwest Association of Schools and Colleges or a like regional
6 association or in a college or university in Oregon approved for granting degrees by the [*Oregon*
7 *Student Assistance Commission*] **Higher Education Coordinating Commission** as evidenced by

19 provided by the policy with respect to the service or billing of the provider of aid. The amount of

1 carrier that elects to be subject to ORS 759.405 and 759.410, including amounts deposited pursuant

5 Public Access Account to endow a telecommunications chair for the purpose of increasing research
6 and development of advanced telecommunications services applications. Only one chair may be en-

9 moneys in the Public Access Account consistent with this section and ORS 759.430.

10 (b) Community colleges, [*state institutions of higher education*] **public universities listed in ORS**
11 **352.002**, public libraries, public television corporations and rural health care providers may apply
12 to the Oregon Business Development Commission for funding from the Public Access Account under
13 this subsection.

14 (c) Funds received from the account shall be used for the purchase of advanced telecommuni-
15 cations services, equipment or recurring costs of telecommunications connectivity. Priority shall be
16 given to collaborative projects that improve access to advanced telecommunications services.

17 (d) Funds available in the Public Access Account under this subsection are continuously ap-
18 propriated to the Oregon Business Development Department for the purposes described in this sub-
19 section.

20 (6) Public libraries and rural health care providers must apply for federal universal service
21 support in order to be eligible for a grant from the Public Access Account.

22 (7) The video transport and network management services purchased with funds made available
23 under this section shall be purchased through the Oregon Department of Administrative Services.

24 (8) Any moneys deposited in the Connecting Oregon Communities Fund under subsection (1) of
25 this section pursuant to a performance assurance plan implemented by a telecommunications carrier
26 in connection with an application under 47 U.S.C. 271, as in effect on January 1, 2002, shall be
27 placed in the School Technology Account to be expended as provided in section 34, chapter 1093,
28 Oregon Laws 1999.
