

Senate Bill 249

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Education and General Government)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates Task Force on School Reform. Directs task force to study reform of kindergarten through grade 12 public education and make recommendations on how to reform kindergarten through grade 12 public education.

Declares emergency, effective July 1, 2011.

A BILL FOR AN ACT

2 Relating to education; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Task Force on School Reform is established. The task force shall:**

5 **(a) Study the reform of kindergarten through grade 12 public education; and**

6 **(b) Make recommendations about how to reform kindergarten through grade 12 public**
7 **education.**

8 **(2) The task force consists of members appointed by the Superintendent of Public In-**
9 **struction. The superintendent shall appoint members who represent administrators, teach-**
10 **ers, school district boards and other groups identified by the superintendent.**

11 **(3) A majority of the voting members of the task force constitutes a quorum for the**
12 **transaction of business.**

13 **(4) Official action by the task force requires the approval of a majority of the voting**
14 **members of the task force.**

15 **(5) The task force shall elect one of its members to serve as chairperson.**

16 **(6) If there is a vacancy for any cause, the superintendent shall make an appointment**
17 **to become immediately effective.**

18 **(7) The task force shall meet at times and places specified by the call of the chairperson**
19 **or of a majority of the voting members of the task force.**

20 **(8) The task force may adopt rules necessary for the operation of the task force.**

21 **(9) The task force shall submit a report, and may include recommendations for legis-**
22 **lation, to the interim legislative committees on education on or before October 1, 2012.**

23 **(10) The Department of Education shall provide staff support to the task force.**

24 **(11) Members of the task force are not entitled to compensation, but may be reimbursed**
25 **for actual and necessary travel and other expenses incurred by them in the performance of**
26 **their official duties in the manner and amounts provided for in ORS 292.495. Claims for ex-**
27 **penditures shall be paid out of funds appropriated to the department for purposes of the task**
28 **force.**

29 **(12) All agencies of state government, as defined in ORS 174.111, are directed to assist**

1 **the task force in the performance of its duties and, to the extent permitted by laws relating**
2 **to confidentiality, to furnish such information and advice as the members of the task force**
3 **consider necessary to perform their duties.**

4 **SECTION 2. Section 1 of this 2011 Act is repealed on the date of the convening of the 2013**
5 **legislative session.**

6 **SECTION 3. This 2011 Act being necessary for the immediate preservation of the public**
7 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
8 **July 1, 2011.**
