SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows school district to withdraw from education service district on or after July 1, 2014. Allows withdrawal for school districts in specified education service districts on or after July 1, 2012. Requires education service district to distribute to school district **percentage of** prorated amount of state funding available to education service district. Allows school district to rejoin education service district.

Establishes Regional Education Services Advisory Board and Office of Regional Educational Services for purposes related to improving regional educational service delivery systems. Requires Superintendent of Public Instruction to retain amount necessary for paying office's administrative costs from moneys to be disbursed to education service districts.

Declares emergency, effective on passage.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1. Sections 2 to 4 of this 2011 Act are added to and made a part of ORS chapter**
9 **334.**

10 **SECTION 2. (1) Notwithstanding ORS 334.010 and 334.020, one or more school districts**
11 **of an education service district may withdraw from the education service district.**

12 **(2)(a) A school district board that is considering whether to withdraw a school district**
13 **from an education service district must:**

14 **(A) Prepare a plan of withdrawal and make the plan available to the public; and**

15 **(B) Hold a public hearing and solicit comments about the plan prepared as provided by**
16 **this paragraph.**

17 **(b) Following the public hearing under paragraph (a) of this subsection, the school dis-**
18 **trict board may determine whether to withdraw the school district from the education ser-**
19 **vice district. The school district board may choose to withdraw by an affirmative vote of**
20 **two-thirds of the members of the board.**

21 **(3)(a) A school district board that chooses to withdraw a school district from the educa-**
22 **tion service district as provided in subsection (2) of this section must submit a plan of**

1 withdrawal to the board of directors of the education service district and to the school dis-
2 trict boards of the component school districts. The plan of withdrawal must describe how the
3 school district will provide the services described in ORS 334.175 (2) to the students of the
4 school district.

5 (b) A plan of withdrawal described in this subsection must be submitted no later than
6 October 1 of the year prior to the year in which the school district plans to withdraw from
7 the education service district.

8 (c) Within 120 days of receiving the plan of withdrawal, the board of directors of the ed-
9 ucation service district shall issue an order that recognizes the withdrawal of the school
10 district from the education service district.

11 (4) The withdrawal of a school district from an education service district becomes effec-
12 tive on July 1 after an order is issued by the board of directors of the education service
13 district recognizing the withdrawal.

14 **SECTION 3.** (1) Notwithstanding section 2 of this 2011 Act and except as provided in
15 subsection (2) of this section, the board of directors of an education service district may not
16 issue an order recognizing the withdrawal of a school district from the education service
17 district if the withdrawal would become effective prior to July 1, 2014.

18 (2)(a) The board of directors of an education service district shall issue an order recog-
19 nizing the withdrawal of a school district from the education service district that becomes
20 effective on or after July 1, 2012, if:

21 (A) The education service district is composed of a region described in ORS 334.020 (1)(c),
22 (m) or (p); and

23 (B) The school district complied with the procedural requirements described in section 2
24 of this 2011 Act.

25 (b) If the board of directors of an education service district issues an order recognizing
26 the withdrawal of a school district that becomes effective on July 1, 2012, as allowed under
27 this subsection, the board shall submit a report to the interim legislative committees relat-
28 ing to education prior to October 1, 2012.

29 **SECTION 4.** (1) A school district board that withdrew a school district from an education
30 service district as provided in section 2 of this 2011 Act may choose to rejoin the school
31 district to the education service district.

32 (2) A school district board that chooses to rejoin a school district to an education service
33 district as provided in subsection (1) of this section may rejoin by an affirmative vote of
34 two-thirds of the members of the board. A vote described in this subsection must occur no
35 later than October 1 of the year prior to the year in which the school district board plans
36 to rejoin the school district to the education service district.

37 (3) The school district board shall notify the board of directors of the education service
38 district prior to October 1 of the year prior to the year in which the school district board
39 plans to rejoin the school district to the education service district. Within 60 days of re-
40 ceiving the notice, the board of directors of the education service district shall issue an order
41 that recognizes the rejoining of a school district to the education service district.

42 (4) The rejoining of a school district to an education service district becomes effective
43 on July 1 after the board of directors of the education service district issues the order de-
44 scribed in subsection (3) of this section.

45 **SECTION 5.** ORS 334.003 is amended to read:

1 334.003. For purposes of this chapter:

2 (1) "Component school district" means a common school district or a union high school district
3 **that:**

4 (a) **Is located within the territory of an education service district[.]; and**

5 (b) **Is not withdrawn from the education service district as provided in section 2 of this**
6 **2011 Act.**

7 (2) "Education service district" means a district created under ORS 334.010 that provides re-
8 gional educational services to component school districts.

9 (3) "Joint school district" means a common school district or a union high school district located
10 within the territory of more than one education service district.

11 **SECTION 6.** ORS 334.025 is amended to read:

12 334.025. (1)(a) The board of directors of an education service district shall consist of [*seven, nine*
13 *or 11 members*] **five, seven or nine members.**

14 (b) **The members of the board shall be elected from among the superintendents of the**
15 **component school districts by the superintendents of the component school districts.**

16 (c) **The board of directors may by resolution increase or decrease the number of mem-**
17 **bers of the board. The board's resolution shall have no effect on the terms of any current**
18 **board members.**

19 [*(2) In education service districts, not fewer than five of the directors shall be elected, one from*
20 *each of the zones established under ORS 334.032. At the discretion of the board of directors, one or two*
21 *board members may be elected from the district at large.*]

22 [(3)] (2) On the petition of two component school districts, the board shall establish local advi-
23 sory committees to represent the interests of areas within the petitioning districts. The local advi-
24 sory committees shall advise the board on matters of concern within the advisory committee's area.
25 Local advisory committees shall represent two or more component school districts.

26 [(4) *The board of directors may by resolution increase or decrease the number of members of the*
27 *board. The board's resolution shall be entered with sufficient time for the board to give the required*
28 *information to the elections officer under ORS 255.069, and the board's resolution shall have no effect*
29 *on the terms of any current board members.*]

30 **SECTION 7.** ORS 334.032 is amended to read:

31 334.032. (1) The board of directors of an education service district shall divide the education
32 service district into not more than 11 zones as nearly equal in census population as may be practi-
33 cable, measured along common school district boundary lines except that zones may be established
34 using voting precinct boundaries in order to achieve greater equality of population. If possible, the
35 board shall establish the zones so that each county within the education service district, the ma-
36 jority of the land area of which lies within the boundaries of the education service district, has at
37 least one member on the board.

38 (2) Each county within the education service district, the majority of the land area of which lies
39 within the boundaries of the education service district, shall have at least one member on the board
40 or shall have at least one member on the budget committee of the education service district.

41 (3) The board may readjust the boundaries of the zones once each year and shall readjust the
42 boundaries of the zones immediately upon:

43 (a) Any change of the boundaries of the education service district[.];

44 (b) **The withdrawing of a school district as provided in section 2 of this 2011 Act; or**

45 (c) **The rejoining of a school district as provided in section 4 of this 2011 Act.**

1 **SECTION 8.** ORS 334.095 is amended to read:

2 334.095. (1) The education service district board shall declare the office of director vacant upon
3 the happening of any of the following:

4 (a) When an incumbent dies or resigns;

5 (b) When an incumbent is removed from office or the election thereto has been declared void
6 by the judgment of any court;

7 (c) When an incumbent ceases to be a resident of **a school district that is a component school**
8 **district of** the education service district;

9 (d) Subject to the provision of subsection (2) of this section, when an incumbent ceases to be a
10 resident of the zone from which nominated;

11 (e) When an incumbent ceases to discharge the duties of office for two consecutive months un-
12 less prevented therefrom by sickness or other unavoidable cause; or

13 (f) When an incumbent is recalled.

14 (2) A director nominated from a zone who changes permanent residence from one zone to an-
15 other zone in which another director resides shall continue to serve as director until the next reg-
16 ular election when a successor shall be elected to serve for the remainder of the unexpired term.

17 (3) A director guilty of misfeasance or malfeasance in office, by the appropriate proceeding, may
18 be removed from office by a court of competent jurisdiction.

19 (4) Members may be recalled in the manner provided in ORS 249.865 to 249.877. If the member
20 was elected by a zone, the recall petition shall be signed by electors from that zone and electors
21 from the zone are the only electors eligible to vote in the recall election. If the member was elected
22 at large, the recall petition shall be signed by electors from the district and electors from the dis-
23 trict are eligible to vote in the recall election.

24 **SECTION 9.** ORS 334.100 is amended to read:

25 334.100. (1) Each **year, the** education service district board shall meet during July and organize
26 by electing one of its members chairperson and one vice chairperson[*each of whom shall serve until*
27 *a successor is elected and qualified*]. No member shall serve as chairperson for more than two years
28 in succession.

29 (2) Regular meetings of an education service district board shall be held on meeting dates de-
30 termined by the board. Special meetings may be held on dates to be determined by the board.

31 (3) Members of the education service district board shall receive no compensation for their
32 services, but shall be reimbursed for all traveling and other expenses necessarily incurred in per-
33 forming their duties as members of the board.

34 (4) A majority of the members of the education service district board shall constitute a quorum.
35 A lesser number may meet and adjourn from time to time and compel the presence of absent mem-
36 bers. The affirmative vote of a majority of members of the board is required to transact any busi-
37 ness.

38 (5) Any duty imposed upon the education service district board as a body must be performed at
39 a regular or special meeting and must be made a matter of record. The consent to any particular
40 measure obtained of individual members when the board is not in session is not an act of the board
41 and is not binding upon the district.

42 **SECTION 10.** ORS 334.125 is amended to read:

43 334.125. (1) The education service district is a body corporate.

44 (2) The education service district board is authorized to transact all business coming within the
45 jurisdiction of the education service district and may sue and be sued.

1 (3) The education service district board shall perform all duties required by law, including but
2 not limited to:

3 (a) Distribution of such school funds as it is empowered to apportion;

4 (b) Conduct of audits;

5 (c) Duties as district boundary board;

6 (d) Budget and tax levying duties, including the levying of taxes under ORS 280.060;

7 (e) Contracting a bonded indebtedness and levying direct ad valorem taxes on all taxable prop-
8 erty within the education service district in the manner that component school districts are au-
9 thorized to issue bonds and levy taxes under ORS 328.205 to 328.304 and other laws applicable to
10 the issuance of bonds and levying of taxes by school districts; and

11 (f) Creating a county education bond district under ORS 328.304 from a county within the dis-
12 trict.

13 (4)(a) In addition to its duties under subsection (3) of this section, an education service district
14 board:

15 (A) May provide services required by the local service plan developed pursuant to ORS 334.175
16 [and];

17 (B) **Except as provided by subparagraph (C) of this paragraph,** may provide funds to a
18 component school [districts] **district** to provide services required by the local **service** plan in lieu
19 of [those school districts] **the component school district** receiving services from the education
20 service district[.];

21 (C) **Shall provide funds in the manner described in paragraph (b) of this subsection to a**
22 **component school district to provide services required by the local service plan in lieu of the**
23 **component school district receiving services from the education service district if:**

24 (i) **The school district received funds under subparagraph (B) of this paragraph for the**
25 **2010-2011 fiscal year; and**

26 (ii) **The school district requests that the funds be provided as required by this subpara-**
27 **graph;**

28 (D) **Shall provide funds as specified in ORS 327.019 (9) to a school district located within**
29 **the territory of the education service district that has withdrawn from the education service**
30 **district as provided in section 2 of this 2011 Act; and**

31 (E) **May enter into contracts with school districts that have withdrawn from the educa-**
32 **tion service district as provided in section 2 of this 2011 Act or that are located outside the**
33 **territory of the education service district for the purpose of providing services consistent**
34 **with the local service plan.**

35 (b) **If an education service district board is required to provide funds to a school district**
36 **under paragraph (a)(C) of this subsection, the education service district board shall provide**
37 **the funds as a percentage of the funds available to the education service district under ORS**
38 **334.177 that is equal to the lesser of:**

39 (A) **The percentage that the education service district board provided to the school dis-**
40 **trict in the 2010-2011 fiscal year; or**

41 (B) **The percentage requested by the school district, as provided by paragraph (a)(C) of**
42 **this subsection.**

43 (5) The education service district board may employ and fix the compensation of such personnel
44 as it considers necessary for carrying out duties of the board.

45 (6) In carrying out its duties, the education service district board:

1 (a) May locate, buy, accept by gift or lease such land, buildings and facilities as may be required
2 for district purposes. Leases authorized by this section may be for a term of up to 30 years and
3 include lease-purchase agreements whereunder the district may acquire ownership of the leased
4 property.

5 (b) May acquire personal property by a lease-purchase agreement or contract of purchase for a
6 term exceeding one year. A lease-purchase agreement is one in which the rent payable by the dis-
7 trict is expressly agreed to have been established to reflect the savings resulting from the exemption
8 from taxation, and the district is entitled to ownership of the property at a nominal or other price
9 which is stated or determinable by the terms of the agreement and was not intended to reflect the
10 true value of the property.

11 (c) May lease property or sell and convey property of the district as the board considers un-
12 necessary to its purposes.

13 (d) May purchase relocatable structures in installment transactions in which deferred install-
14 ments of the purchase price are payable over not more than 10 years from the date of delivery of
15 the property to the district and are secured by a security interest in the property. The transactions
16 may take the form of, but are not limited to, lease-purchase agreements.

17 (e) May accept money or property donated for the use or benefit of the district and use the
18 money or property for the purpose for which it was donated.

19 (7) The education service district board may adopt rules it considers necessary to carry out the
20 duties of the board.

21 (8) The education service district may contract with public and private entities for service de-
22 livery.

23 (9)(a) The education service district shall work cooperatively with component school districts
24 and review periodically with component school districts the operations of component school districts
25 and shall submit to the component school districts plans for operations that achieve economies and
26 efficiencies through consolidation of various operations of all or some of the districts. The education
27 service district and its component school districts shall submit an annual report on the effectiveness
28 of the consolidation of operations to the State Board of Education.

29 (b) As used in this subsection, "operations" means services involving transportation, payroll,
30 student records, auditing, legal services, insurance, printing, investment and other similar services.

31 **SECTION 11.** ORS 334.127 is amended to read:

32 334.127. (1) Whenever an education service district ceases to exist, its real property shall pass
33 to the successor district, which is authorized to treat [*such*] **the** property in the same manner as
34 [*its*] **did the** predecessor district [*did*].

35 **(2) Whenever a school district withdraws from an education service district as provided**
36 **in section 2 of this 2011 Act, the school district and education service district shall determine**
37 **the disposition of any real property of the education service district that is located within**
38 **the boundaries of the school district. If the school district and the education service district**
39 **are unable to agree on how to dispose of the real property, the education service district**
40 **shall retain the property.**

41 **SECTION 12.** ORS 334.175 is amended to read:

42 334.175. (1) An education service district shall provide regionalized core services to component
43 school districts. The goals of these services are to:

- 44 (a) Assist component school districts in meeting the requirements of state and federal law;
45 (b) Improve student learning;

- 1 (c) Enhance the quality of instruction provided to students;
- 2 (d) Provide professional development to component school district employees;
- 3 (e) Enable component school districts and the students who attend schools in those districts to
- 4 have equitable access to resources; and
- 5 (f) Maximize operational and fiscal efficiencies for component school districts.
- 6 (2) The services provided by an education service district shall be provided according to a local
- 7 service plan developed by the education service district and component school districts. The educa-
- 8 tion service district and component school districts shall develop the local service plan to meet the
- 9 goals specified in subsection (1) of this section. The local service plan must include services in at
- 10 least the following areas:
- 11 (a) Programs for children with special needs, including but not limited to special education ser-
- 12 vices, services for at-risk students and professional development for employees who provide those
- 13 services.
- 14 (b) Technology support for component school districts and the individual technology plans of
- 15 those districts, including but not limited to technology infrastructure services, data services, in-
- 16 structional technology services, distance learning and professional development for employees who
- 17 provide those services.
- 18 (c) School improvement services for component school districts, including but not limited to:
- 19 (A) Services designed to support component school districts in meeting the requirements of state
- 20 and federal law;
- 21 (B) Services designed to allow the education service district to participate in and facilitate a
- 22 review of the state and federal standards related to the provision of a quality education by compo-
- 23 nent school districts;
- 24 (C) Services designed to support and facilitate continuous school improvement planning;
- 25 (D) Services designed to address schoolwide behavior and climate issues;
- 26 (E) Services designed to support career and technical education; and
- 27 (F) Professional development for employees who provide the services described in this para-
- 28 graph.
- 29 (d) Administrative and support services for component school districts, including but not limited
- 30 to services designed to consolidate component school district business functions, liaison services
- 31 between the Department of Education and component school districts and registration of children
- 32 being taught by private teachers, parents or legal guardians pursuant to ORS 339.035.
- 33 (e) Other services that an education service district is required to provide by state or federal
- 34 law, including but not limited to services required under ORS 339.005 to 339.090.
- 35 (3) In addition to the services specified in subsection (2) of this section, a local service plan may
- 36 include other services that are designed to meet regional needs.
- 37 (4) A local service plan shall also contain annual performance measures for the education ser-
- 38 vice district.
- 39 (5) A local service plan must:
- 40 (a) Be adopted by the board of the education service district.
- 41 (b) After being adopted by the board of the education service district, be approved on or before
- 42 March 1 by resolution of two-thirds of the component school districts that are a part of the educa-
- 43 tion service district and that have at least a majority of the pupils included in the average daily
- 44 membership of the education service district, as determined by the reports of such school districts
- 45 for the preceding year, enrolled in the schools of the school districts.

1 (6) Notwithstanding the process for approval and adoption required by subsection (5) of this
 2 section, if the component school districts approve an amendment to a local service plan pursuant
 3 to subsection (5)(b) of this section, the board of an education service district may amend a local
 4 service plan that has been previously adopted by the board and approved by the component school
 5 districts. An amendment to a local service plan may be done at any time.

6 **(7) If a component school district determines that a local service plan, or the provision**
 7 **of services under a local service plan, does not meet the service needs of the component**
 8 **school district, then the component school district may contract with a public or private**
 9 **entity for the provision of services.**

10 [(7)] (8) An education service district may provide the services required by the local service plan
 11 directly through the staff of the district. In addition, an education service district may provide ser-
 12 vices required by the local service plan through the operation of a public school, a public charter
 13 school pursuant to ORS chapter 338, an alternative school or a preschool.

14 [(8)] (9) An education service district may provide the services required by the local service plan
 15 in cooperation with another education service district or with a school district. In addition, an ed-
 16 ucation service district may contract with a public or private entity for the provision of services.

17 **SECTION 13.** ORS 334.177 is amended to read:

18 334.177. (1) As used in this section, “local revenues of an education service district” has the
 19 meaning given that term in ORS 327.019 but does not include any local revenues distributed [*to*
 20 *component school districts*] under ORS 327.019 (8).

21 (2) An education service district board shall expend at least 90 percent of all amounts received
 22 from the State School Fund and at least 90 percent of all amounts considered to be local revenues
 23 of an education service district on services or programs that have been approved by the component
 24 school districts of the education service district through the resolution process described in ORS
 25 334.175.

26 (3) An education service district board shall expend 100 percent of all amounts received from
 27 the School Improvement Fund on services or programs that have been approved by the component
 28 school districts of the education service district through the resolution process described in ORS
 29 334.175.

30 **(4) The expenditure requirements of this section apply only to amounts retained by the**
 31 **education service district after making any distributions required under ORS 327.019 (9).**

32 **SECTION 14.** ORS 334.240 is amended to read:

33 334.240. (1) **Except as provided in subsection (2) of this section,** the education service district
 34 board shall be subject in all respects to the Local Budget Law (ORS 294.305 to 294.565)[, *except that*
 35 *in addition to other qualifications, members of the budget committee who are not members of the edu-*
 36 *cation service district board shall be members of component school district boards within the education*
 37 *service district or shall be designees of a school district board].*

38 [(2) *Notwithstanding ORS 294.336 and 294.341, a majority of the members of the budget committee*
 39 *of an education service district must consist of members of the component school district boards or*
 40 *designees of a school district board. The budget committee may meet to conduct business if the educa-*
 41 *tion service district board is unable to fill all of the positions on the budget committee.]*

42 **(2) Notwithstanding ORS 294.336 and 294.341, the members of the budget committee of**
 43 **an education service district must be members of the component school district boards.**
 44 **Preference for membership of the budget committee shall be given to members of component**
 45 **school district boards that are not represented on the board of directors of the education**

1 **service district.**

2 (3) The *[board of the education service district]* **budget committee** shall prepare *[and adopt]* a
3 budget for the operational and administrative expenses of the education service district. The budget
4 shall include amounts necessary to provide services required by the local service plan of the district
5 developed under ORS 334.175. **The budget must be adopted by the board of the education ser-**
6 **vice district.**

7 (4) **The board of the education service district shall ensure that an annual audit of the**
8 **accounts of the education service district is prepared in accordance with the Municipal Audit**
9 **Law, as provided in ORS 297.405 to 297.555 and 297.990.**

10 **SECTION 15.** ORS 334.730 is amended to read:

11 334.730. *[(1)]* Immediately after the order to join two or more education service districts to-
12 gether, the boards of directors of all education service districts within the boundaries of the new
13 district shall meet together upon the call of the chairperson of the board of the most populous dis-
14 trict. *[Notwithstanding ORS 334.025 or ORS chapter 255, the joint board of directors shall divide the*
15 *new district into as many zones as the board considers necessary, but not fewer than seven nor more*
16 *than 11. The zones shall be as nearly equal in population as may be practicable. If possible, the joint*
17 *board shall establish the zones so that each county within the new education service district, the ma-*
18 *jority of the land area of which lies within the boundaries of the education service district, has at least*
19 *one member on the board.]*

20 *[(2)]* Within 90 days after the zones required in subsection (1) of this section are established, the
21 joint board of directors shall call a special election in the new district for the purpose of electing di-

29 district. Expenditures of the board under this section shall be paid from the budgets of the compo-
30 nent education service districts on a prorated basis.

36 erative on June 30, *[2013]* **2012.**

37 **SECTION 18.** **The term of office of a director who serves on the board of directors of an**
38 **education service district terminates on June 30, 2012.**

39 **SECTION 19.** ORS 327.019 is amended to read:

40 327.019. (1) As used in this section:

41 (a) "Education service district extended ADMw" means the sum of the extended ADMw of the
42 *[component]* school districts **located within the territory** of the education service district as com-
43 puted under ORS 327.013.

44 (b) "Local revenues of an education service district" means the total of the following:

45 (A) The amount of revenue offset against local property taxes as determined by the Department

1 of Revenue under ORS 311.175 (3)(a)(A);

- 31 under ORS chapter 190, agrees to be individually liable for the payment of any compensation and
- 32 other amounts due to the department under this chapter incurred by the employer during the period
- 33 of group self-insurance;
- 34 (e) The director finds that the employer group is organized as a corporation or cooperative
- 35 pursuant to ORS chapter 60, 62 or 65, is an intergovernmental entity created under ORS 190.003 to
- 36 190.130 and the bylaws require the governing group to obtain fidelity bonds;
- 37 (f) The director finds that the employer group has designated an entity within or for the group
- 38 responsible for centralized claims processing, payroll records, safety requirements, recording and
- 39 submitting assessments and contributions and making such other reports as the director may re-
- 40 quire; and
- 41 (g) The employer has presented a method approved by the director to notify the department of:
- 42 (A) The commencement or termination of membership by employers in the group, and the effect
- 43 thereof on the net worth of the employers in the group; and
- 44 (B) Whether an employer who terminates membership in the group continues to be a subject
- 45 employer.

1 (8) A self-insured employer must have excess insurance coverage appropriate for the employer's
2 potential liability under this chapter with an insurer authorized to do business in this state. A self-
3 insured employer certified prior to November 1, 1981, must have excess insurance coverage appro-
4 priate for the employer's potential liability under this chapter either with an insurer authorized to
5 do business in this state or with any other insurer from whom such insurance can be obtained pur-
6 suant to ORS 744.305 to 744.405 (1985 Replacement Part). Evidence of such coverage must be sub-
7 mitted at the time application is made for self-insured certification in the form of an insurance
8 binder providing the appropriate coverage effective the date of certification. The policy providing
9 such coverage must be filed with the director not later than 30 days after the date the coverage is
10 effective. Any changes in the insurer or the coverage must be filed with the department not later
11 than 30 days after the effective date of the change. With respect to such coverage:

12 (a) The policy must include a provision, approved by the director, for reimbursement to the de-
13 partment of all expenses paid by the department on behalf of the employer pursuant to ORS 656.614
14 (1) and 656.443 in the same manner as if the department were the insured employer, subject to the
15 policy limitations on amounts and limits of liability to the insured employer; and

16 (b) The period of coverage must be continuous and remain in effect until the certification is
17 revoked or canceled.

18 (9) Notwithstanding ORS 656.440, the director may revoke the certification of any self-insured
19 employer after giving 30 days' written notice if the employer:

20 (a) Fails to comply with subsection (8) of this section; or

21 (b) In the case of an employer described in subsection (7) of this section, fails to comply with
22 that subsection.

23 (10) A self-insured employer must have an occupational safety and health loss control program
24 as required by ORS 654.097.

25 (11) The director, by rule shall:

26 (a) Prescribe methods for determining and approving net worth.

27 (b) Prescribe the types and approve the retention and limitation levels of excess insurance pol-
28 icies.

29 (c) Establish reporting requirements.

30 (d) Prescribe information to be submitted in applications for self-insured employer certifications.

31 (e) Prescribe the form and manner of reporting commencement or termination in a self-insured
32 employer group.

33 (f) Prescribe the form, amount and manner for establishing and operating a common claims fund.

34 (g) Prescribe such other requirements as the director considers necessary so that employers
35 certified as self-insured employers will meet the financial responsibilities under this chapter.

36 (12) For the purpose of certification as a self-insured employer group, cities, counties, special
37 districts created under ORS 198.010, intergovernmental agencies created under ORS 225.050, school
38 districts as defined in ORS 255.005 (9), **education service districts organized under ORS chapter**
39 **334**, public housing authorities created under ORS chapter 456 and regional councils of governments
40 created under ORS chapter 190 shall be considered by the director to be of the same industry.

41 (13) Notwithstanding subsection (8) of this section, a public utility with assets of more than \$500
42 million may obtain excess insurance coverage from an eligible surplus lines insurer. As used in this
43 subsection, "public utility" has the meaning given that term in ORS 757.005.

44 **SECTION 29.** ORS 757.612 is amended to read:

45 757.612. (1) There is established an annual public purpose expenditure standard for electric

1 companies and Oregon Community Power to fund new cost-effective local energy conservation, new
2 market transformation efforts, the above-market costs of new renewable energy resources and new
3 low-income weatherization. The public purpose expenditure standard shall be funded by the public
4 purpose charge described in subsection (2) of this section.

5 (2)(a) Beginning on the date an electric company or Oregon Community Power offers direct ac-
6 cess to its retail electricity consumers, except residential electricity consumers, the electric com-
7 pany or Oregon Community Power shall collect a public purpose charge from all of the retail
8 electricity consumers located within its service area until January 1, 2026. Except as provided in
9 paragraph (b) of this subsection, the public purpose charge shall be equal to three percent of the
10 total revenues collected by the electric company, Oregon Community Power or the electricity ser-
11 vice supplier from its retail electricity consumers for electricity services, distribution, ancillary
12 services, metering and billing, transition charges and other types of costs included in electric rates
13 on July 23, 1999.

14 (b) For an aluminum plant that averages more than 100 average megawatts of electricity use
15 per year, beginning on March 1, 2002, the electric company or Oregon Community Power whose
16 territory abuts the greatest percentage of the site of the aluminum plant shall collect from the alu-
17 minum company a public purpose charge equal to one percent of the total revenue from the sale of
18 electricity services to the aluminum plant from any source.

19 (3)(a) The Public Utility Commission shall establish rules implementing the provisions of this
20 section relating to electric companies and Oregon Community Power.

21 (b) Subject to paragraph (e) of this subsection, funds collected by an electric company or Oregon
22 Community Power through public purpose charges shall be allocated as follows:

23 (A) Sixty-three percent for new cost-effective conservation and new market transformation.

24 (B) Nineteen percent for the above-market costs of constructing and operating new renewable
25 energy resources with a nominal electric generating capacity, as defined in ORS 469.300, of 20
26 megawatts or less.

27 (C) Thirteen percent for new low-income weatherization.

28 (D) Five percent shall be transferred to the Housing and Community Services Department
29 Electricity Public Purpose Charge Fund established by ORS 456.587 (1) and used for the purpose of
30 providing grants as described in ORS 458.625 (2).

31 (c) The costs of administering subsections (1) to (6) of this section for an electric company or
32 Oregon Community Power shall be paid out of the funds collected through public purpose charges.
33 The commission may require that an electric company or Oregon Community Power direct funds
34 collected through public purpose charges to the state agencies responsible for implementing sub-
35 sections (1) to (6) of this section in order to pay the costs of administering such responsibilities.

36 (d) The commission shall direct the manner in which public purpose charges are collected and
37 spent by an electric company or Oregon Community Power and may require an electric company
38 or Oregon Community Power to expend funds through competitive bids or other means designed to
39 encourage competition, except that funds dedicated for low-income weatherization shall be directed
40 to the Housing and Community Services Department as provided in subsection (7) of this section.
41 The commission may also direct that funds collected by an electric company or Oregon Community
42 Power through public purpose charges be paid to a nongovernmental entity for investment in public
43 purposes described in subsection (1) of this section. Notwithstanding any other provision of this
44 subsection:

45 (A) At least 80 percent of the funds allocated for conservation shall be spent within the service

1 area of the electric company that collected the funds; or

2 (B) If Oregon Community Power collected the funds, at least 80 percent of the funds allocated
3 for conservation shall be spent within the service area of Oregon Community Power.

4 (e)(A) The first 10 percent of the funds collected annually by an electric company or Oregon
5 Community Power under subsection (2) of this section shall be distributed to education service dis-
6 tricts, as described in ORS 334.010, that are located in the service territory of the electric company
7 or Oregon Community Power. The funds shall be distributed to individual education service districts
8 according to the weighted average daily membership (ADMw) of the [*component*] school districts
9 **located within the territory** of the education service district for the prior fiscal year as calculated
10 under ORS 327.013. The commission shall establish by rule a methodology for distributing a
11 proportionate share of funds under this paragraph to education service districts that are only par-
12 tially located in the service territory of the electric company or Oregon Community Power.

13 (B) An education service district that receives funds under this paragraph shall use the funds
14 first to pay for energy audits for school districts located within the education service district. An
15 education service district may not expend additional funds received under this paragraph on a
16 school district facility until an energy audit has been completed for that school district. To the
17 extent practicable, an education service district shall coordinate with the State Department of En-
18 ergy and incorporate federal funding in complying with this paragraph. Following completion of an
19 energy audit for an individual school district, the education service district may expend funds re-
20 ceived under this paragraph to implement the energy audit. Once an energy audit has been con-
21 ducted and completely implemented for each school district within the education service district, the
22 education service district may expend funds received under this paragraph for any of the following
23 purposes:

24 (i) Conducting energy audits. A school district shall conduct an energy audit prior to expending
25 funds on any other purpose authorized under this paragraph unless the school district has performed
26 an energy audit within the three years immediately prior to receiving the funds.

27 (ii) Weatherization and upgrading the energy efficiency of school district facilities.

28 (iii) Energy conservation education programs.

29 (iv) Purchasing electricity from environmentally focused sources and investing in renewable
30 energy resources.

31 (f) The commission may not establish a different public purpose charge than the public purpose
32 charge described in subsection (2) of this section.

33 (g) If the commission directs funds collected through public purpose charges to a nongovern-
34 mental entity, the entity shall:

35 (A) Include on the entity's board of directors an ex officio member designated by the commis-
36 sion, who shall also serve on the entity's nominating committee for filling board vacancies.

37 (B) Require the entity's officers and directors to provide an annual disclosure of economic in-
38 terest to be filed with the commission on or prior to April 15 of each calendar year for public review
39 in a form similar to the statement of economic interest required for public officials under ORS
40 244.060.

41 (C) Require the entity's officers and directors to declare actual and potential conflicts of interest
42 at regular meetings of the entity's governing body when such conflicts arise, and require an officer
43 or director to abstain from participating in any discussion or vote on any item where that officer
44 or director has an actual conflict of interest. For the purposes of this subparagraph, "actual conflict
45 of interest" and "potential conflict of interest" have the meanings given those terms in ORS 244.020.

1 (D) Arrange for an independent auditor to audit the entity's financial statements annually, and
2 direct the auditor to file an audit opinion with the commission for public review.

3 (E) File with the commission annually the entity's budget, action plan and quarterly and annual
4 reports for public review.

5 (F) At least once every five years, contract for an independent management evaluation to review
6 the entity's operations, efficiency and effectiveness, and direct the independent reviewer to file a
7 report with the commission for public review.

8 (h) The commission may remove from the board of directors of a nongovernmental entity an of-
9 ficer or director who fails to provide an annual disclosure of economic interest or declare actual
10 or potential conflict of interest, as described in paragraph (g)(B) and (C) of this subsection, in con-
11 nection with the allocation or expenditure of funds collected through public purpose charges and
12 directed to the entity.

13 (4)(a) An electric company that satisfies its obligations under this section shall have no further
14 obligation to invest in conservation, new market transformation or new low-income weatherization
15 or to provide a commercial energy conservation services program and is not subject to ORS 469.631
16 to 469.645 and 469.860 to 469.900.

17 (b) Oregon Community Power, for any period during which Oregon Community Power collects
18 a public purpose charge under subsection (2) of this section:

19 (A) Shall have no other obligation to invest in conservation, new market transformation or new
20 low-income weatherization or to provide a commercial energy conservation services program; and

21 (B) Is not subject to ORS 469.631 to 469.645 and 469.860 to 469.900.

22 (5)(a) A retail electricity consumer that uses more than one average megawatt of electricity at
23 any site in the prior year shall receive a credit against public purpose charges billed by an electric
24 company or Oregon Community Power for that site. The amount of the credit shall be equal to the
25 total amount of qualifying expenditures for new energy conservation, not to exceed 68 percent of the
26 annual public purpose charges, and the above-market costs of purchases of new renewable energy
27 resources incurred by the retail electricity consumer, not to exceed 19 percent of the annual public
28 purpose charges, less administration costs incurred under this subsection. The credit may not ex-
29 ceed, on an annual basis, the lesser of:

30 (A) The amount of the retail electricity consumer's qualifying expenditures; or

31 (B) The portion of the public purpose charge billed to the retail electricity consumer that is
32 dedicated to new energy conservation, new market transformation or the above-market costs of new
33 renewable energy resources.

34 (b) To obtain a credit under this subsection, a retail electricity consumer shall file with the
35 State Department of Energy a description of the proposed conservation project or new renewable
36 energy resource and a declaration that the retail electricity consumer plans to incur the qualifying
37 expenditure. The State Department of Energy shall issue a notice of precertification within 30 days
38 of receipt of the filing, if such filing is consistent with this subsection. The credit may be taken after
39 a retail electricity consumer provides a letter from a certified public accountant to the State De-
40 partment of Energy verifying that the precertified qualifying expenditure has been made.

41 (c) Credits earned by a retail electricity consumer as a result of qualifying expenditures that
42 are not used in one year may be carried forward for use in subsequent years.

43 (d)(A) A retail electricity consumer that uses more than one average megawatt of electricity at
44 any site in the prior year may request that the State Department of Energy hire an independent
45 auditor to assess the potential for conservation investments at the site. If the independent auditor

1 determines there is no available conservation measure at the site that would have a simple payback
2 of one to 10 years, the retail electricity consumer shall be relieved of 54 percent of its payment
3 obligation for public purpose charges related to the site. If the independent auditor determines that
4 there are potential conservation measures available at the site, the retail electricity consumer shall
5 be entitled to a credit against public purpose charges related to the site equal to 54 percent of the
6 public purpose charges less the estimated cost of available conservation measures.

7 (B) A retail electricity consumer shall be entitled each year to the credit described in this sub-
8 section unless a subsequent independent audit determines that new conservation investment oppor-
9 tunities are available. The State Department of Energy may require that a new independent audit
10 be performed on the site to determine whether new conservation measures are available, provided
11 that the independent audits shall occur no more than once every two years.

12 (C) The retail electricity consumer shall pay the cost of the independent audits described in this
13 subsection.

14 (6) Electric utilities and retail electricity consumers shall receive a fair and reasonable credit
15 for the public purpose expenditures of their energy suppliers. The State Department of Energy shall
16 adopt rules to determine eligible expenditures and the methodology by which such credits are ac-
17 counted for and used. The rules also shall adopt methods to account for eligible public purpose
18 expenditures made through consortia or collaborative projects.

19 (7)(a) In addition to the public purpose charge provided under subsection (2) of this section, an
20 electric company or Oregon Community Power shall collect funds for low-income electric bill pay-
21 ment assistance in an amount determined under paragraph (b) of this subsection.

22 (b) The commission shall establish the amount to be collected by each electric company in cal-
23 endar year 2008 from retail electricity consumers served by the company, and the rates to be
24 charged to retail electricity consumers served by the company, so that the total anticipated col-
25 lection for low-income electric bill payment assistance by all electric companies in calendar year
26 2008 is \$15 million. In calendar year 2009 and subsequent calendar years, the commission may not
27 change the rates established for retail electricity consumers, but the total amount collected in a
28 calendar year for low-income electric bill payment assistance may vary based on electricity usage
29 by retail electricity consumers and changes in the number of retail electricity consumers in this
30 state. In no event shall a retail electricity consumer be required to pay more than \$500 per month
31 per site for low-income electric bill payment assistance.

32 (c) Funds collected by the low-income electric bill payment assistance charge shall be paid into
33 the Housing and Community Services Department Low-Income Electric Bill Payment Assistance
34 Fund established by ORS 456.587 (2). Moneys deposited in the fund under this paragraph shall be
35 used by the Housing and Community Services Department for the purpose of funding low-income
36 electric bill payment assistance. The department's cost of administering this subsection shall be paid
37 out of funds collected by the low-income electric bill payment assistance charge. Moneys deposited
38 in the fund under this paragraph shall be expended solely for low-income electric bill payment as-
39 sistance. Funds collected from an electric company or Oregon Community Power shall be expended
40 in the service area of the electric company or Oregon Community Power from which the funds are
41 collected.

42 (d) The Housing and Community Services Department, in consultation with the federal Advisory
43 Committee on Energy, shall determine the manner in which funds collected under this subsection
44 will be allocated by the department to energy assistance program providers for the purpose of pro-
45 viding low-income bill payment and crisis assistance, including programs that effectively reduce

1 service disconnections and related costs to retail electricity consumers and electric utilities. Priority
2 assistance shall be directed to low-income electricity consumers who are in danger of having their
3 electricity service disconnected.

4 (e) Interest on moneys deposited in the Housing and Community Services Department Low-
5 Income Electric Bill Payment Assistance Fund established by ORS 456.587 (2) may be used to pro-
6 vide heating bill payment and crisis assistance to electricity consumers whose primary source of
7 heat is not electricity.

8 (f) Notwithstanding ORS 757.310, the commission may allow an electric company or Oregon
9 Community Power to provide reduced rates or other payment or crisis assistance or low-income
10 program assistance to a low-income household eligible for assistance under the federal Low Income
11 Home Energy Assistance Act of 1981, as amended and in effect on July 23, 1999.

12 (8) For purposes of this section, "retail electricity consumers" includes any direct service in-
13 dustrial consumer that purchases electricity without purchasing distribution services from the elec-
14 tric utility.

15 (9) For purposes of this section, amounts collected by Oregon Community Power through public
16 purpose charges are not considered moneys received from electric utility operations.

17 **SECTION 30. Sections 31 and 32 of this 2011 Act are added to and made a part of ORS**
18 **chapter 334.**

19 **SECTION 31. (1) As used in this section:**

20 (a) "Obligations" means all contractual obligations, employment and service contracts
21 and collective bargaining agreements.

22 (b) "Reorganized" means a change in:

23 (A) The boundaries of an education service district, including a merger; or

24 (B) The governance structure of an education service district.

25 (2) Employees who are employed by an education service district that is reorganized and
26 who are employed in duties that, after the reorganization, are to be performed by the new
27 education service district shall be considered employees of the new education service district.
28 The new education service district shall succeed the previous education service district as
29 party to any employment contracts.

30 (3) Employees in the new education service district shall retain any seniority and accu-
31 mulated sick leave and vacation leave from the previous education service district.

32 (4) All real and personal property belonging to an education service district that is reor-
33 ganized is considered property of the new education service district.

34 (5) All obligations of an education service district that is reorganized are considered ob-
35 ligations of the new education service district.

36 **SECTION 32. (1) A school district that withdraws from an education service district as**
37 **provided by section 2 of this 2011 Act shall hire a person who:**

38 (a) Was employed by the education service district prior to the withdrawal of the school
39 district; and

40 (b) Will be employed by the school district in duties similar to the duties the person
41 performed while employed by the education service district.

42 (2) Nothing in this section requires a school district to hire a person who had been em-
43 ployed by an education service district if the school district does not have a vacant position.

44 (3) The hiring requirement described in this section does not apply to the superintendent
45 of the education service district or to any other administrators, as defined in ORS 342.120,

1 of the education service district.

2 (4) A person hired as required by this section shall retain any seniority and accumulated
3 sick leave and vacation leave from the person's previous employment by the education ser-
4 vice district.

5 (5) The hiring requirement described in this section applies only during the 12 calendar
6 months immediately following the effective date of the withdrawal of the school district from
7 the education service district.

8 **SECTION 33.** (1) The Regional Education Services Advisory Board is established. The
9 duties of the board are to:

10 (a) Advise the Director of the Office of Regional Educational Services for the purpose of
11 assisting the director in fulfilling the statutory requirements imposed by section 35 of this
12 2011 Act;

13 (b) Provide to the Director of the Office of Regional Educational Services recommen-
14 dations for changes in statute or rule for the purpose of assisting the director in fulfilling
15 the statutory requirements imposed on the Office of Regional Educational Services by sec-
16 tion 35 of this 2011 Act; and

17 (c) Assist the Superintendent of Public Instruction in selecting the Director of the Office
18 of Regional Educational Services, including developing or modifying a proposed position de-
19 scription, screening candidates and making a recommendation for the position.

20 (2) The board shall consist of nine members appointed by the Governor and confirmed
21 by the Senate in the manner provided by ORS 171.562 and 171.565. The term of office of each
22 member is four years, but a member serves at the pleasure of the Governor.

23 (3) The Governor shall appoint the members of the board from among the school district
24 superintendents of this state in a manner that ensures the representation of school districts
25 of a variety of sizes and geographic locations.

26 (4) Members of the board may not receive compensation for their services, but shall be
27 paid for their necessary and actual expenses in accordance with ORS 292.495.

28 **SECTION 34.** Notwithstanding the term of office specified by section 33 of this 2011 Act,
29 of the members first appointed to the Regional Education Services Advisory Board:

30 (1) Two shall serve for a term ending July 1, 2012.

31 (2) Two shall serve for a term ending July 1, 2013.

32 (3) Two shall serve for a term ending July 1, 2014.

33 (4) Three shall serve for a term ending July 1, 2015.

34 **SECTION 35.** (1) The Office of Regional Educational Services is established for the pur-
35 poses of coordinating the efforts of and providing leadership for regional educational service
36 delivery systems. The office shall function under the direction and control of the State Board
37 of Education.

38 (2)(a) The Director of the Office of Regional Educational Services shall serve as the ad-
39 ministrative officer of the Office of Regional Educational Services. The Superintendent of
40 Public Instruction shall select the director after considering the recommendation made by
41 the Regional Education Services Advisory Board established in section 33 of this 2011 Act.

42 (b) The director shall perform the duties, powers and functions of the office:

43 (A) Under the supervision and subject to the direction of the Superintendent of Public
44 Instruction; and

45 (B) In cooperation with the Regional Education Services Advisory Board.

1 **(3) The Office of Regional Educational Services shall:**

2 **(a) Establish best practice policies and conduct an ongoing analysis of the effectiveness**
3 **of education service districts, including determining the direct cost of services to school**
4 **districts that are assessed by education service districts.**

5 **(b) Establish benchmarks for education service districts that allow the education service**
6 **districts to make improvements in the operation of the education service districts and to**
7 **demonstrate that improvements are being made in the operation of education service dis-**
8 **tricts.**

9 **(c) Conduct ongoing evaluations of the systems and procedures of education service dis-**
10 **tricts.**

11 **(d) Ensure that each education service district has an annual audit of the accounts of**
12 **the education service district prepared in accordance with the Municipal Audit Law, as pro-**
13 **vided in ORS 297.405 to 297.555 and 297.990, and review the audit.**

14 **(e) Request a performance audit of an education service district if the office has reason**
15 **to believe that an education service district is nonstandard as provided by ORS 334.217.**

16 **(f) Recommend to the Superintendent of Public Instruction any sanctions to impose on**
17 **an education service district that are consistent with ORS 334.217 and recommend any stat-**
18 **utory changes required to impose effective sanctions on education service districts.**

19 **(g) Recommend to the Superintendent of Public Instruction and the State Board of Edu-**
20 **cation any statutory or rule changes that may improve the operations or administration of**
21 **education service districts.**

22 **(h) Recommend to the board of directors of an education service district or to the su-**
23 **perintendent of an education service district any changes that may improve the operations**
24 **or administration of the education service district.**

25 **(i) Recommend to the Superintendent of Public Instruction and the State Board of Edu-**
26 **cation any changes in education service district boundaries that may reduce costs and in-**
27 **crease the quality of services provided by education service districts.**

28 **(j) Recommend to the board of directors of an education service district or to the su-**
29 **perintendent of an education district any changes in service delivery regions that may reduce**
30 **costs and increase the quality of services provided by the education service district.**

31 **(k) Provide training and related support for boards of directors of education service dis-**
32 **tricts and superintendents of education service districts.**

33 **(L) Gather information regarding the cost of services within education service districts**
34 **and across education service districts, identify unusually high cost services and provide the**
35 **gathered information to education service districts, the Superintendent of Public Instruction**
36 **and the State Board of Education.**

37 **(4) The State Board of Education, in collaboration with the Superintendent of Public In-**
38 **struction and the Director of the Office of Regional Educational Services, may adopt any**
39 **rules necessary for the purposes of this section.**

40 **SECTION 36.** ORS 334.217 is amended to read:

41 334.217. (1) The State Board of Education by rule shall establish standards to determine the
42 adequacy of services and facilities provided by the education service districts. In establishing such
43 standards, the state board shall consider the most economic method of providing services and facil-
44 ities, the quality of the services and facilities according to the best educational standards, and the
45 needs of the students.

1 (2) When the Superintendent of Public Instruction determines pursuant to rule that an education
2 service district is nonstandard, the district designated nonstandard shall file a plan to meet stan-
3 dards over a specified period of time. The Superintendent **of Public Instruction** may accept, reject
4 or modify the plan and order the nonstandard district to comply with the plan as approved by the
5 superintendent. Once a plan is approved, the district shall be conditionally standard until all defi-
6 ciencies are corrected. If a district corrects all deficiencies, the district shall be designated as
7 standard. The district shall have 180 days from the date the plan is accepted to make all corrections.
8 After that time, the Superintendent **of Public Instruction** may impose sanctions on the district if
9 the district has not made the necessary corrections.

10 (3) The state board shall establish by rule appropriate sanctions for noncompliance. The sanc-
11 tions may include:

12 (a) Mandatory merger of the nonstandard education service district with a contiguous education
13 service district that is standard[.];

14 (b) The sanctions described in ORS 342.173, if applicable[, *or*];

15 (c) The withholding of funds from the State School Fund[.];

16 (d) **The removal of the superintendent of the education service district;**

17 (e) **The temporary governance of the education service district by the state board; or**

18 (f) **Dissolution of the education service district.**

19 **SECTION 37. ORS 334.032, 334.035, 334.045, 334.090, 334.095, 334.740 and 334.750 and section**
20 **5, chapter 59, Oregon Laws 2010, are repealed.**

21 **SECTION 38. The amendments to ORS 255.005, 267.380, 332.136, 334.025, 334.100, 334.240,**
22 **334.730, 334.760 and 656.430 and section 15, chapter 828, Oregon Laws 2005, by sections 6, 9,**
23 **14 to 17, 24, 25, 27 and 28 of this 2011 Act and the repeal of ORS 334.032, 334.035, 334.045,**
24 **334.090, 334.095, 334.740 and 334.750 and section 5, chapter 59, Oregon Laws 2010, by section**
25 **37 of this 2011 Act become operative July 1, 2012.**

26 **SECTION 39. This 2011 Act being necessary for the immediate preservation of the public**
27 **peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect**
28 **on its passage.**
