

Senate Bill 269

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Rules)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires investment officers and assistant investment officers in Investment Division of office of State Treasurer to file statement of economic interest.

A BILL FOR AN ACT

2 Relating to government ethics; creating new provisions; and amending ORS 244.050.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 244.050 is amended to read:

5 244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon
6 Government Ethics Commission a verified statement of economic interest as required under this
7 chapter:

8 (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the
9 Bureau of Labor and Industries, Superintendent of Public Instruction, district attorneys and mem-
10 bers of the Legislative Assembly.

11 (b) Any judicial officer, including justices of the peace and municipal judges, except any pro tem
12 judicial officer who does not otherwise serve as a judicial officer.

13 (c) Any candidate for a public office designated in paragraph (a) or (b) of this subsection.

14 (d) The Deputy Attorney General.

15 (e) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the
16 Secretary of the Senate and the Chief Clerk of the House of Representatives.

17 (f) The Chancellor and Vice Chancellors of the Oregon University System and the president and
18 vice presidents, or their administrative equivalents, in each institution under the jurisdiction of the
19 State Board of Higher Education.

20 (g) The following state officers:

21 (A) Adjutant General.

22 (B) Director of Agriculture.

23 (C) Manager of State Accident Insurance Fund Corporation.

24 (D) Water Resources Director.

25 (E) Director of Department of Environmental Quality.

26 (F) Director of Oregon Department of Administrative Services.

39 (r) Every member of the board of commissioners of a port governed by ORS 777.005 to 777.725

41 (s) Every member of the board of directors of an authority created under ORS 441.525 to 441.595.

42 (2) By April 15 next after the date an appointment takes effect, every appointed public official
 43 on a board or commission listed in subsection (1) of this section shall file with the Oregon Govern-
 44 ment Ethics Commission a statement of economic interest as required under ORS 244.060, 244.070
 45 and 244.090.

1 (3) By April 15 next after the filing deadline for the primary election, each candidate described
2 in subsection (1) of this section shall file with the commission a statement of economic interest as
3 required under ORS 244.060, 244.070 and 244.090.

4 (4) Within 30 days after the filing deadline for the general election, each candidate described in
5 subsection (1) of this section who was not a candidate in the preceding primary election, or who
6 was nominated for public office described in subsection (1) of this section at the preceding primary
7 election by write-in votes, shall file with the commission a statement of economic interest as re-
8 quired under ORS 244.060, 244.070 and 244.090.

9 (5) Subsections (1) to (4) of this section apply only to persons who are incumbent, elected or
10 appointed public officials as of April 15 and to persons who are candidates on April 15. Subsections
11 (1) to (4) of this section also apply to persons who do not become candidates until 30 days after the
12 filing deadline for the statewide general election.

13 (6) If a statement required to be filed under this section has not been received by the commis-
14 sion within five days after the date the statement is due, the commission shall notify the public of-
15 ficial or candidate and give the public official or candidate not less than 15 days to comply with the
16 requirements of this section. If the public official or candidate fails to comply by the date set by the
17 commission, the commission may impose a civil penalty as provided in ORS 244.350.

18 **SECTION 2. The amendments to ORS 244.050 by section 1 of this 2011 Act apply to**
19 **statements of economic interest required to be filed on or after the effective date of this 2011**
20 **Act.**
