SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law. [*Maintains December 31, 2009, connection date for bonus depreciation and section 179 expensing for tax years beginning on or after January 1, 2010, and before January 1, 2011.*]

For provisions related to bonus depreciation, section 179 expensing and cancellation of indebtedness income, restores connection to Internal Revenue Code for tax years beginning on or after January 1, 2011. Clarifies provisions relating to disconnection from federal law for tax years beginning on or after January 1, 2009, and before January 1, 2011.

For decedents dying after December 31, 2009, and before December 17, 2010, allows nine-month extension to file inheritance tax return in conformity with extension provided under federal law. Requires payment of inheritance tax as provided in existing state law without regard to extension provided in federal law.

Takes effect on 91st day following adjournment sine die.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 238A.005, as amended by section 9, chapter 1, Oregon Laws 2010, and section
9 1, chapter 82, Oregon Laws 2010, is amended to read:

10 238A.005. For the purposes of this chapter:

11 (1) "Active member" means a member of the pension program or the individual account program
12 of the Oregon Public Service Retirement Plan who is actively employed in a qualifying position.

13 (2) "Actuarial equivalent" means a payment or series of payments having the same value as the
14 payment or series of payments replaced, computed on the basis of interest rate and mortality as-
15 sumptions adopted by the board.

16 (3) "Board" means the Public Employees Retirement Board.

17 (4) "Eligible employee" means a person who performs services for a participating public em-
18 ployer, including elected officials other than judges. "Eligible employee" does not include:

19 (a) Persons engaged as independent contractors;

20 (b) Aliens working under a training or educational visa;

1 (c) Persons, other than workers in the Industries for the Blind Program under ORS 346.190,
2 provided sheltered employment or make-work by a public employer;

3 (d) Persons categorized by a participating public employer as student employees;

4 (e) Any person who is an inmate of a state institution;

5 (f) Employees of foreign trade offices of the Oregon Business Development Department who live
6 and perform services in foreign countries under the provisions of ORS 285A.075 (1)(g);

7 (g) An employee actively participating in an alternative retirement program established under
8 ORS 353.250 or an optional retirement plan established under ORS 341.551;

9 (h) Employees of the Oregon University System who are actively participating in an optional
10 retirement plan offered under ORS 243.800;

11 (i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
12 for membership in the system under the provisions of ORS chapter 238 or other law;

13 (j) Any person who belongs to a class of employees who are not eligible to become members of
14 the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

15 (k) Any person who is retired under ORS 238A.100 to 238A.245 or ORS chapter 238 and who
16 continues to receive retirement benefits while employed; and

17 (L) Judges.

18 (5) "Firefighter" means:

19 (a) A person employed by a local government, as defined in ORS 174.116, whose primary job
20 duties include the fighting of fires;

21 (b) The State Fire Marshal, the chief deputy state fire marshal and deputy state fire marshals;
22 and

23 (c) An employee of the State Forestry Department who is certified by the State Forester as a
24 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
25 fires as described in ORS 477.064.

26 (6) "Fund" means the Public Employees Retirement Fund.

27 (7)(a) "Hour of service" means:

28 (A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment
29 by a participating public employer for performance of duties in a qualifying position; and

30 (B) An hour of vacation, holiday, illness, incapacity, jury duty, military duty or authorized leave
31 during which an employee does not perform duties but for which the employee is directly or indi-
32 rectly paid or entitled to payment by a participating public employer for services in a qualifying
33 position, as long as the hour is within the number of hours regularly scheduled for the performance
34 of duties during the period of vacation, holiday, illness, incapacity, jury duty, military duty or au-
35 thorized leave.

36 (b) "Hour of service" does not include any hour for which payment is made or due under a plan
37 maintained solely for the purpose of complying with applicable workers' compensation laws or un-
38 employment compensation laws.

39 (8) "Inactive member" means a member of the pension program or the individual account pro-
40 gram of the Oregon Public Service Retirement Plan whose membership has not been terminated, who
41 is not a retired member and who is not employed in a qualifying position.

42 (9) "Individual account program" means the defined contribution individual account program of
43 the Oregon Public Service Retirement Plan established under ORS 238A.025.

44 (10) "Member" means an eligible employee who has established membership in the pension pro-
45 gram or the individual account program of the Oregon Public Service Retirement Plan and whose

1 membership has not been terminated under ORS 238A.110 or 238A.310.

2 (11) "Participating public employer" means a public employer as defined in ORS 238.005 that
3 provides retirement benefits for employees of the public employer under the system.

4 (12) "Pension program" means the defined benefit pension program of the Oregon Public Service
5 Retirement Plan established under ORS 238A.025.

6 (13) "Police officer" means a police officer as described in ORS 238.005.

7 (14) "Qualifying position" means one or more jobs with one or more participating public em-
8 ployers in which an eligible employee performs 600 or more hours of service in a calendar year,
9 excluding any service in a job for which benefits are not provided under the Oregon Public Service
10 Retirement Plan pursuant to ORS 238A.070 (2).

11 (15) "Retired member" means a pension program member who is receiving a pension as provided
12 in ORS 238A.180 to 238A.195.

13 (16)(a) "Salary" means the remuneration paid to an active member in return for services to the
14 participating public employer, including remuneration in the form of living quarters, board or other
15 items of value, to the extent the remuneration is includable in the employee's taxable income under
16 Oregon law. Salary includes the additional amounts specified in paragraph (b) of this subsection,
17 but does not include the amounts specified in paragraph (c) of this subsection, regardless of whether
18 those amounts are includable in taxable income.

19 (b) "Salary" includes the following amounts:

20 (A) Payments of employee and employer money into a deferred compensation plan that are made
21 at the election of the employee.

22 (B) Contributions to a tax-sheltered or deferred annuity that are made at the election of the
23 employee.

24 (C) Any amount that is contributed to a cafeteria plan or qualified transportation fringe benefit
25 plan by the employer at the election of the employee and that is not includable in the taxable in-
26 come of the employee by reason of 26 U.S.C. 125 or 132(f)(4), as in effect on December 31, [2009]
27 **2010**.

28 (D) Any amount that is contributed to a cash or deferred arrangement by the employer at the
29 election of the employee and that is not included in the taxable income of the employee by reason
30 of 26 U.S.C. 402(e)(3), as in effect on December 31, [2009] **2010**.

31 (E) Retroactive payments described in section 7, chapter 1, Oregon Laws 2010.

32 (F) The amount of an employee contribution to the individual account program that is paid by
33 the employer and deducted from the compensation of the employee, as provided under ORS 238A.335
34 (1) and (2)(a).

35 (G) The amount of an employee contribution to the individual account program that is not paid
36 by the employer under ORS 238A.335.

37 (H) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
38 652.190.

39 (c) "Salary" does not include the following amounts:

40 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
41 employer.

42 (B) Payments made on account of an employee's death.

43 (C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paid
44 leave.

45 (D) Any severance payment, accelerated payment of an employment contract for a future period

1 or advance against future wages.

2 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

3 (F) Payment for a leave of absence after the date the employer and employee have agreed that
4 no future services in a qualifying position will be performed.

5 (G) Payments for instructional services rendered to institutions of the Oregon University System
6 or the Oregon Health and Science University when those services are in excess of full-time em-
7 ployment subject to this chapter. A person employed under a contract for less than 12 months is
8 subject to this subparagraph only for the months covered by the contract.

9 (H) The amount of an employee contribution to the individual account program that is paid by
10 the employer and is not deducted from the compensation of the employee, as provided under ORS
11 238A.335 (1) and (2)(b).

12 (I) Any amount in excess of \$200,000 for a calendar year. If any period over which salary is
13 determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a
14 fraction, the numerator of which is the number of months in the determination period and the de-
15 nominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate
16 cost-of-living adjustments authorized by the Internal Revenue Service.

17 (17) "System" means the Public Employees Retirement System.

18 **SECTION 2.** ORS 238A.125, as amended by section 2, chapter 82, Oregon Laws 2010, is amended
19 to read:

20 238A.125. (1) Upon retiring at normal retirement age, a vested pension program member shall
21 be paid an annual pension for the life of the member as follows:

22 (a) For service as a police officer or firefighter, 1.8 percent of final average salary multiplied
23 by the number of years of retirement credit attributable to service as a police officer or firefighter.

24 (b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
25 multiplied by the number of years of retirement credit attributable to service as other than a police
26 officer or firefighter.

27 (2) Notwithstanding any provision of ORS 238A.100 to 238A.245, the annual benefit payable to
28 a member under the pension program and under any other tax-qualified defined benefit plan main-
29 tained by the participating public employer may not exceed the applicable limitations set forth in
30 26 U.S.C. 415(b), as in effect on December 31, [2009] **2010**. The Public Employees Retirement Board
31 shall adopt rules for the administration of this limitation, including adjustments in the annual dollar
32 limitation to reflect cost-of-living adjustments authorized by the Internal Revenue Service.

33 (3) The board shall make no actuarial adjustment in a member's pension calculated under this
34 section by reason of the member's retirement after normal retirement age.

35 **SECTION 3.** ORS 238A.150, as amended by section 3, chapter 82, Oregon Laws 2010, is amended
36 to read:

37 238A.150. (1) Notwithstanding any other provision of ORS 238A.100 to 238A.245, an eligible em-
38 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
39 vices, and who subsequently returns to employment with a participating public employer with
40 reemployment rights under federal law, is entitled to accrue retirement credit, credit toward the
41 probationary period required by ORS 238A.100 and credit toward the vesting requirements of ORS
42 238A.115 under rules adopted by the Public Employees Retirement Board pursuant to subsection (2)
43 of this section.

44 (2) The board shall adopt rules establishing benefits and service credit for any period of service
45 in the uniformed services by an employee described in subsection (1) of this section. For the purpose

1 of adopting rules under this subsection, the board shall consider and take into account all federal
2 law relating to benefits and service credit for any period of service in the uniformed services, in-
3 cluding 26 U.S.C. 414(u), as in effect on December 31, [2009] **2010**. Benefits and service credit under
4 rules adopted by the board pursuant to this subsection may not exceed benefits and service credit
5 required under federal law for periods of service in the uniformed services.

6 **SECTION 4.** ORS 238A.170, as amended by section 4, chapter 82, Oregon Laws 2010, is amended
7 to read:

8 238A.170. (1) An active member of the pension program who is 70-1/2 years of age or older must
9 retire not later than April 1 of the calendar year following the calendar year in which the member
10 terminates employment with all participating public employers. An inactive member of the pension
11 program must retire not later than April 1 of the calendar year following the calendar year in which
12 the member attains 70-1/2 years of age.

13 (2) Notwithstanding any other provision of ORS 238A.100 to 238A.245, the entire interest of a
14 member of the pension program must be distributed over a time period commencing no later than
15 the required beginning date set forth in subsection (1) of this section, and must be distributed in a
16 manner that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regu-
17 lations implementing that section, as in effect on December 31, [2009] **2010**. The Public Employees
18 Retirement Board shall adopt rules implementing those minimum distribution requirements.

19 **SECTION 5.** ORS 238A.230, as amended by section 5, chapter 82, Oregon Laws 2010, is amended
20 to read:

21 238A.230. (1) If a member of the pension program who is vested dies before the member's effec-
22 tive date of retirement, the Public Employees Retirement Board shall pay the death benefit provided
23 for in this section to the spouse of the member or to any other person who is constitutionally re-
24 quired to be treated in the same manner as a spouse for the purpose of retirement benefits.

25 (2)(a) The death benefit to be paid under this section shall be for the life of the spouse or other
26 person who is constitutionally required to be treated in the same manner as a spouse, and shall be
27 the actuarial equivalent of 50 percent of the pension that would otherwise have been paid to the
28 deceased member.

29 (b) For the purpose of paragraph (a) of this subsection, the amount of the pension that would
30 otherwise have been paid to the deceased member shall be calculated:

31 (A) As of the date of death if the member dies after the earliest retirement date for the member
32 under ORS 238A.165; or

33 (B) As if the member became an inactive member on the date of death and thereafter retired
34 at the earliest retirement date if the member dies before the earliest retirement date for the member
35 under ORS 238A.165.

36 (3) The death benefit provided under this section is first effective on the first day of the month
37 following the date of death of the member. The surviving spouse or other person entitled to the
38 death benefit may elect to delay payment of the death benefit, but payment must commence no later
39 than December 31 of the calendar year in which the member would have reached 70-1/2 years of age.

40 (4) Notwithstanding any other provision of ORS 238A.100 to 238A.245, distributions of death
41 benefits under the pension program must comply with the minimum distribution requirements of 26
42 U.S.C. 401(a)(9) and the regulations implementing that section, as in effect on December 31, [2009]
43 **2010**. The board shall adopt rules implementing those minimum distribution requirements.

44 **SECTION 6.** ORS 238A.370, as amended by section 6, chapter 82, Oregon Laws 2010, is amended
45 to read:

1 238A.370. Notwithstanding any other provision of ORS 238A.300 to 238A.415, the annual addition
2 to the employee and employer accounts of a member of the individual account program for a cal-
3 endar year, together with the annual additions to the accounts of the member under any other de-
4 fined contribution plan maintained by the participating public employer for a calendar year, may
5 not exceed the lesser of \$40,000, or 100 percent of the member's compensation for that calendar year.
6 For purposes of this section, "annual addition" has the meaning given that term in 26 U.S.C.
7 415(c)(2), as in effect on December 31, [2009] **2010**, and "compensation" has the meaning given the
8 term "participant's compensation" in 26 U.S.C. 415(c)(3), as in effect on December 31, [2009] **2010**.
9 The Public Employees Retirement Board shall adopt rules for the administration of this limitation,
10 including adjustments in the annual dollar limitation to reflect cost-of-living adjustments authorized
11 by the Internal Revenue Service.

12 **SECTION 7.** ORS 238A.400, as amended by section 7, chapter 82, Oregon Laws 2010, is amended
13 to read:

14 238A.400. (1) Upon retirement on or after the earliest retirement date, as described in ORS
15 238A.165, a member of the individual account program shall receive in a lump sum the amounts in
16 the member's employee account, rollover account and employer account to the extent the member
17 is vested in those accounts under ORS 238A.320.

18 (2) In lieu of a lump sum payment under subsection (1) of this section, a member of the individ-
19 ual account program may elect to receive the amounts in the member's employee account and em-
20 ployer account, to the extent the member is vested in those accounts under ORS 238A.320, in
21 substantially equal installments paid over a period of 5, 10, 15 or 20 years, or over a period that is
22 equal to the anticipated life span of the member as actuarially determined by the Public Employees
23 Retirement Board. Installments may be made on a monthly, quarterly or annual basis. In no event
24 may the period selected by the member exceed the time allowed by the minimum distribution re-
25 quirements described in subsection (5) of this section. The board shall by rule establish the manner
26 in which installments will be adjusted to reflect investment gains and losses on the unpaid balance
27 during the payout period elected by the member under this subsection. The board by rule may es-
28 tablish minimum monthly amounts payable under this subsection. The board may require that a
29 lump sum payment, or an installment schedule different than the schedules provided for in this
30 subsection, be used to pay the vested amounts in the member's accounts if those amounts are not
31 adequate to generate the minimum monthly amounts specified by the rule.

32 (3) A member of the individual account program electing to receive installments under sub-
33 section (2) of this section must designate a beneficiary or beneficiaries. In the event the member dies
34 before all amounts in the employee and vested employer accounts are paid, all remaining installment
35 payments shall be made to the beneficiary or beneficiaries designated by the member. A beneficiary
36 may elect to receive a lump sum distribution of the remaining amounts.

37 (4) A member who is entitled to receive retirement benefits under ORS chapter 238 may receive
38 vested amounts in the member's employee account, rollover account and employer account in the
39 manner provided by this section when the member retires for service under the provisions of ORS
40 chapter 238.

41 (5) Notwithstanding any other provision of ORS 238A.300 to 238A.415, the entire interest of a
42 member of the individual account program must be distributed over a time period commencing no
43 later than the latest retirement date set forth in ORS 238A.170, and must be distributed in a manner
44 that satisfies all other minimum distribution requirements of 26 U.S.C. 401(a)(9) and regulations im-
45 plementing that section, as in effect on December 31, [2009] **2010**. The board shall adopt rules im-

1 plementing those minimum distribution requirements.

2 **SECTION 8.** ORS 238A.410, as amended by section 8, chapter 82, Oregon Laws 2010, is amended
3 to read:

4 238A.410. (1) If a member of the individual account program dies before retirement, the amounts
5 in the member's employee account, rollover account and employer account, to the extent the member
6 is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the beneficiary or
7 beneficiaries designated by the member for the purposes of this section.

8 (2) If a member of the individual account program is married at the time of death, or there exists
9 at the time of death any other person who is constitutionally required to be treated in the same
10 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the
11 beneficiary for purposes of the death benefit payable under this section unless the spouse or other
12 person consents to the designation of a different beneficiary or beneficiaries before the designation
13 has been made and the consent has not been revoked by the spouse or other person as of the time
14 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a
15 notary public, and submitted to the Public Employees Retirement Board in accordance with rules
16 adopted by the board. If the member's spouse is designated as the member's beneficiary and the
17 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as
18 predeceasing the member for purposes of this section, unless the member expressly designates the
19 former spouse as beneficiary after the effective date of the dissolution or the former spouse is re-
20 quired to be designated as a beneficiary under the provisions of ORS 238.465.

21 (3) For purposes of this section and ORS 238A.400 (3), if a member fails to designate a benefi-
22 ciary, or if the person or persons designated do not survive the member, the death benefit provided
23 for in this section shall be paid to the following person or persons, in the following order of priority:

24 (a) The member's surviving spouse or other person who is constitutionally required to be treated
25 in the same manner as a spouse;

26 (b) The member's surviving children, in equal shares; or

27 (c) The member's estate.

28 (4) The entire amount of a deceased member's vested accounts must be distributed by December
29 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other
30 provision of this chapter, distributions of death benefits under the individual account program must
31 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-
32 plementing that section, as in effect on December 31, [2009] 2010. The Public Employees Retirement
33 Board shall adopt rules implementing those minimum distribution requirements.

34 **SECTION 9.** ORS 238A.415, as amended by section 9, chapter 82, Oregon Laws 2010, is amended
35 to read:

36 238A.415. (1) Notwithstanding any other provision of ORS 238A.300 to 238A.415, an eligible em-
37 ployee who leaves a qualifying position for the purpose of performing service in the uniformed ser-
38 vices, and who subsequently returns to employment with a participating public employer with
39 reemployment rights under federal law, is entitled to credit toward the probationary period required
40 by ORS 238A.300, credit toward the vesting requirements of ORS 238A.320 and contributions under
41 rules adopted by the Public Employees Retirement Board pursuant to subsection (2) of this section.

42 (2) The board shall adopt rules establishing contributions and service credit for any period of
43 service in the uniformed services by an employee described in subsection (1) of this section. For the
44 purpose of adopting rules under this subsection, the board shall consider and take into account all
45 federal law relating to benefits and service credit for any period of service in the uniformed ser-

1 vices, including 26 U.S.C. 414(u), as in effect on December 31, [2009] **2010**. Contributions and service
2 credit under rules adopted by the board pursuant to this subsection may not exceed contributions
3 and service credit required under federal law for periods of service in the uniformed services.

4 **SECTION 10.** ORS 238A.430, as amended by section 10, chapter 82, Oregon Laws 2010, is
5 amended to read:

6 238A.430. (1) To the extent required by law, and except as otherwise provided by rules adopted
7 by the Public Employees Retirement Board under subsection (4) of this section, any portion of a
8 distribution of benefits described in subsection (2) of this section shall, at the election of and in lieu
9 of distribution to the distributee, be paid directly to an eligible retirement plan specified by the
10 distributee.

11 (2) The provisions of subsection (1) of this section apply to a distribution of any benefit under
12 the pension program or the individual account program except:

13 (a) A distribution that is one of a series of substantially equal periodic payments made at least
14 annually for the life or life expectancy of the distributee, or for the joint lives or life expectancies
15 of the distributee and a designated beneficiary;

16 (b) A distribution that is one of a series of substantially equal periodic payments made at least
17 annually for a specified period of 10 years or more; and

18 (c) A distribution to the extent that the distribution is required under 26 U.S.C. 401(a)(9).

19 (3) The provisions of subsection (1) of this section apply to any portion of a distribution of
20 benefits under the pension program or the individual account program even though the portion
21 consists of after-tax employee contributions that are not includable in gross income. Any portion of
22 a distribution that consists of after-tax employee contributions that are not includable in gross in-
23 come may be transferred only to an individual retirement account or annuity described in 26 U.S.C.
24 408(a) or (b), or to a qualified defined contribution or defined benefit plan described in 26 U.S.C.
25 401(a) or 403(b) that agrees to account separately for amounts transferred, including accounting
26 separately for the portion of the distribution that is includable in gross income and the portion of
27 the distribution that is not includable in gross income. The amount transferred shall be treated as
28 consisting first of the portion of the distribution that is includable in gross income, determined
29 without regard to 26 U.S.C. 402(c)(1).

30 (4) The board shall adopt rules implementing the direct rollover requirements of 26 U.S.C.
31 401(a)(31) and the regulations implementing that section, and may adopt administrative exceptions
32 to the direct rollover requirements to the extent permitted by 26 U.S.C. 401(a)(31) and the regu-
33 lations implementing that section.

34 (5) All references in this section to federal laws and regulations are to the laws and regulations
35 in effect on December 31, [2009] **2010**.

36 (6) For purposes of this section:

37 (a) "Distributee" means a member, a member's surviving spouse or a member's alternate payee
38 under ORS 238.465.

39 (b) "Eligible retirement plan" means:

40 (A) An individual retirement account described in 26 U.S.C. 408(a);

41 (B) An individual retirement annuity described in 26 U.S.C. 408(b), other than an endowment
42 contract;

43 (C) A qualified trust under 26 U.S.C. 401(a), that is a defined contribution or defined benefit plan
44 and permits the acceptance of rollover contributions;

45 (D) An annuity plan described in 26 U.S.C. 403(a);

1 (E) An eligible deferred compensation plan described in 26 U.S.C. 457(b) that is maintained by
2 an eligible governmental employer described in 26 U.S.C. 457(e)(1)(A) and that agrees to account
3 separately for amounts transferred into such plan from the distributing plan; or

36 viding goods or services to a property or property owner includes the average cost or an allocated
37 portion of the total amount of the actual cost of making a good or service available to the property
38 or property owner, whether stated as a minimum, fixed or variable amount. “Actual cost” includes,
39 but is not limited to, the costs of labor, materials, supplies, equipment rental, property acquisition,
40 permits, engineering, financing, reasonable program delinquencies, return on investment, required
41 fees, insurance, administration, accounting, depreciation, amortization, operation, maintenance, re-
42 pair or replacement and debt service, including debt service payments or payments into reserve ac-
43 counts for debt service and payment of amounts necessary to meet debt service coverage
44 requirements.

45 (2) “Assessment for local improvement” means any tax, fee, charge or assessment that does not

1 exceed the actual cost incurred by a unit of government for design, construction and financing of
2 a local improvement.

3 (3) "Bonded indebtedness" means any formally executed written agreement representing a
4 promise by a unit of government to pay to another a specified sum of money, at a specified date or
5 dates at least one year in the future.

6 (4) "Capital construction":

7 (a) For bonded indebtedness issued prior to December 5, 1996, and for the proceeds of any
8 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
9 contractually obligated to be spent prior to June 20, 1997, means the construction, modification,
10 replacement, repair, remodeling or renovation of a structure, or addition to a structure, that is ex-
11 pected to have a useful life of more than one year, and includes, but is not limited to:

12 (A) Acquisition of land, or a legal interest in land, in conjunction with the capital construction
13 of a structure.

14 (B) Acquisition, installation of machinery or equipment, furnishings or materials that will be-
15 come an integral part of a structure.

16 (C) Activities related to the capital construction, including planning, design, authorizing, issuing,
17 carrying or repaying interim or permanent financing, research, land use and environmental impact
18 studies, acquisition of permits or licenses or other services connected with the construction.

19 (D) Acquisition of existing structures, or legal interests in structures, in conjunction with the
20 capital construction.

21 (b) For bonded indebtedness issued on or after December 5, 1996, except for the proceeds of any

37 is functionally related and subordinate to real property, machinery, equipment or furnishings having
38 a useful life longer than one year.

39 (b) For bonded indebtedness issued on or after December 5, 1996, except for the proceeds of any
40 bonded indebtedness approved by electors prior to December 5, 1996, that were spent or
41 contractually obligated to be spent before June 20, 1997, has the meaning given that term in para-
42 graph (a) of this subsection, except that "capital improvements":

43 (A) Includes public safety and law enforcement vehicles with a projected useful life of five years
44 or more; and

45 (B) Does not include:

1 (i) Maintenance and repairs, the need for which could be reasonably anticipated;

2 (ii) Supplies and equipment that are not intrinsic to the structure; or

3 (iii) Furnishings, unless the furnishings are acquired in connection with the acquisition, con-

6 (6) "Direct consequence of ownership" means that the obligation of the owner of property to pay
7 a tax arises solely because that person is the owner of the property, and the obligation to pay the
8 tax arises as an immediate and necessary result of that ownership without respect to any other in-
9 tervening transaction, condition or event.

10 (7)(a) "Exempt bonded indebtedness" means:

11 (A) Bonded indebtedness authorized by a specific provision of the Oregon Constitution;

12 (B) Bonded indebtedness incurred or to be incurred for capital construction or capital improve-
13 ments that was issued as a general obligation of the issuing governmental unit on or before No-
14 vember 6, 1990;

15 (C) Bonded indebtedness incurred or to be incurred for capital construction or capital improve-

25 a property owner that does not exceed the actual cost of providing goods or services and that can
26 be controlled or avoided by the property owner because:

29 (B) The goods or services are provided only on the specific request of the property owner; or

41 a local government, pursuant to ORS 223.387 to 223.399, or pursuant to a local ordinance or resol-

43 improvement upon the lots that have been benefited by all or a part of the improvement:

44 (A) That provides a special benefit only to specific properties or rectifies a problem caused by
45 specific properties;

1 (B) The costs of which are assessed against those properties in a single assessment upon the
2 completion of the project; and

3 (C) For which the property owner may elect to make payment of the assessment plus appropriate
4 interest over a period of at least 10 years.

5 (b) For purposes of paragraph (a) of this subsection, the status of a capital construction project
6 as a local improvement is not affected by the accrual of a general benefit to property other than the
7 property receiving the special benefit.

8 (10) "Maintenance and repairs, the need for which could be reasonably anticipated":

9 (a) Means activities, the type of which may be deducted as an expense under the provisions of
10 the federal Internal Revenue Code, as amended and in effect on December 31, [2009] 2010, that keep
11 the property in ordinarily efficient operating condition and that do not add materially to the value
12 of the property nor appreciably prolong the life of the property;

13 (b) Does not include maintenance and repair of property that is required by damage, destruction
14 or defect in design, or that was otherwise not reasonably expected at the time the property was
15 constructed or acquired, or the addition of material that is in the nature of the replacement of
16 property and that arrests the deterioration or appreciably prolongs the useful life of the property;
17 and

18 (c) Does not include street and highway construction, overlay and reconstruction.

19 (11) "Projected useful life" means the useful life, as reasonably estimated by the unit of gov-
20 ernment undertaking the capital construction or capital improvement project, beginning with the
21 date the property was acquired, constructed or reconstructed and based on the property's condition
22 at the time the property was acquired, constructed or reconstructed.

23 (12) "Routine obligations of ownership" means a standard of operation, maintenance, use or care
24 of property established by law, or if established by custom or common law, a standard that is rea-
25 sonable for the type of property affected.

26 (13) "Single assessment" means the complete assessment process, including preassessment, as-
27 sessment or reassessment, for any local improvement authorized by ORS 223.387 to 223.399, or a
28 local ordinance or resolution that provides the procedure to be followed in making local assessments

31 (14) "Special benefit only to specific properties" shall have the same meaning as "special and

1 (18) "Tax on property" means any tax, fee, charge or assessment imposed by any government
2 unit upon property or upon a property owner as a direct consequence of ownership of that property,
3 but does not include incurred charges or assessments for local improvements. As used in this sub-
4 section, "property" means real or tangible personal property, and intangible property that is part
5 of a unit of real or tangible personal property to the extent that such intangible property is subject
6 to a tax on property.

9 310.630. As used in ORS 310.630 to 310.706:

10 (1) "Contract rent" means rental paid to the landlord for the right to occupy a homestead, in-
11 cluding the right to use the personal property located therein. "Contract rent" does not include
12 rental paid for the right to occupy a homestead that is exempt from taxation, unless payments in lieu
13 of taxes of 10 percent or more of the rental exclusive of fuel and utilities are made on behalf of the
14 homestead. "Contract rent" does not include advanced rental payments for another period and rental

20 (2) "Department" means the Department of Revenue.

21 (3) "Fuel and utility payments" includes payments for heat, lights, water, sewer and garbage
22 made solely to secure those commodities or services for the homestead of the taxpayer. "Fuel and
23 utility payments" does not include telephone service.

24 (4) "Gross rent" means contract rent paid plus the fuel and utility payments made for the
25 homestead in addition to the contract rent, during the calendar year for which the claim is filed.

26 (5) "Homestead" means the taxable principal dwelling located in Oregon, either real or personal
27 property, rented by the taxpayer, and the taxable land area of the tax lot upon which it is built.

28 (6) "Household" means the taxpayer, the spouse of the taxpayer and all other persons residing
29 in the homestead during any part of the calendar year for which a claim is filed.

30 (7) "Household income" means the aggregate income of the taxpayer and the spouse of the tax-

- 16 (iii) Direct or indirect reimbursement of expenses paid or incurred for participation in work or

- 18 (P) Nontaxable dividends.
- 19 (Q) Nontaxable interest not included in federal adjusted gross income.
- 20 (R) Rental allowance paid to a minister that is excluded from federal gross income.

- 23 (A) The amount of the net loss, in excess of \$1,000, from all dispositions of tangible or intangible

- 26 (C) The amount of the net loss, in excess of \$1,000, from all operations of a trade or business,

43 (a) An individual or individuals who own a dwelling, participate in an owner-occupied commu-
44 nity rehabilitation program and are certified by the local government or its designated agent as
45 having an income level when the loan is made of less than 80 percent of the area median income;

- 1 (b) A qualified borrower who:
- 2 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
3 of housing; and
- 4 (B) Provides a written certification executed by the Housing and Community Services Depart-
5 ment that the:
- 6 (i) Housing created by the loan is or will be occupied by households earning less than 80 percent
7 of the area median income; and
- 8 (ii) Full amount of savings from the reduced interest rate provided by the lending institution is
9 or will be passed on to the tenants in the form of reduced housing payments, regardless of other
10 subsidies provided to the housing project;
- 11 (c) Subject to subsection (14) of this section, a qualified borrower who:
- 12 (A) Uses the loan proceeds to finance construction, development, acquisition or rehabilitation
13 of housing consisting of a manufactured dwelling park; and
- 14 (B) Provides a written certification executed by the Housing and Community Services Depart-
15 ment that the housing will continue to be operated as a manufactured dwelling park during the pe-
16 riod for which the tax credit is allowed; or

31 and Community Services Department must execute a written certification for the qualified loan that:

6 the fiduciary organization.
