A BILL FOR AN ACT

Adjusts sunset for long term tax credit for rural enterprise zone. Adjusts sunset for certain designations and authorizations related to enterprise zones. Takes effect on 91st day following adjournment sine die.

(1) Notwithstanding any other provision of ORS 285C.050 to 285C.250: 17 (a) An area may not be designated as an enterprise zone after June 30, [2013] ___ 18 (b) A business firm may not obtain authorization under ORS 285C.140 after June 30, [2013] 19 20 _; and (c) An enterprise zone, except for a reservation enterprise zone or a reservation partnership 21 zone, that is in existence on June 29, [2013] _____, is terminated on June 30, [2013] ____ 22 (2) Notwithstanding subsection (1) of this section: 23 24 (a) A reservation enterprise zone may be designated, and a reservation partnership zone may be cosponsored, under ORS 285C.306 after June 30, [2013] _____; and 25 (b) A business firm may obtain authorization under ORS 285C.140 after June 30, [2013] 26 27 28 (A) If located in a reservation enterprise zone or a reservation partnership zone; or 29 (B) As allowed under ORS 285C.245 (1)(b).
