

SENATE AMENDMENTS TO SENATE BILL 396

- 1 On page 1 of the printed bill, line 9, after “shall” insert “immediately”.
- 2 In line 16, before “enter” insert “immediately”.
- 3 On page 2, line 13, after “shall” insert “immediately”.
- 4 In line 32, before the comma insert “by telephonic facsimile or electronic mail”.
- 5 In line 34, after the period insert “For purposes of this subsection, ‘electronic communication
- 6 device’ means a device by which any kind of electronic communication can be made, including but
- 7 not limited to communication by telephonic facsimile and electronic mail.”.
- 8 On page 3, delete lines 2 through 5 and insert:
- 9 “(3) The county sheriff shall personally serve the other party with a request under subsection
- 10 (1)(a) of this section, unless the party requesting the modification under subsection (1)(a) of this
- 11 section elects to have the other party personally served by a private party or unless otherwise or-
- 12 dered by the court.”.
- 13 In line 9, after the period delete the rest of the line and lines 10 through 16 and insert:
- 14 “(6)(a) The county sheriff shall serve a copy of an order of modification:
- 15 “(A) Entered under subsection (1)(a) of this section by personal service on the nonrequesting
- 16 party.
- 17 “(B) Entered under subsection (1)(b) of this section by mailing a copy of the order to the
- 18 nonrequesting party by first class mail.
- 19 “(b) If the order of modification recites that the respondent appeared in person before the court,
- 20 the necessity for service of the order and an affidavit of proof of service is waived.”.
- 21 In line 28, before the comma insert “by telephonic facsimile or electronic mail”.
- 22 In line 30, after the period insert “For purposes of this subsection, ‘electronic communication
- 23 device’ means a device by which any kind of electronic communication can be made, including but
- 24 not limited to communication by telephonic facsimile and electronic mail.”.
- 25 In line 35, after “shall” insert “immediately”.
- 26 In line 42, before “enter” insert “immediately”.
- 27 On page 4, line 14, after “shall” insert “immediately”.
- 28 In line 28, after “shall” insert “immediately”.
- 29 In line 33, before “enter” insert “immediately”.
- 30 On page 5, line 9, after “shall” insert “immediately”.
- 31 On page 6, line 20, restore the bracketed material.
- 32 In line 36, delete “promptly” and insert “immediately”.
- 33 On page 7, line 13, before the comma insert “by telephonic facsimile or electronic mail”.
- 34 In line 15, after the period insert “For purposes of this subsection, ‘electronic communication
- 35 device’ means a device by which any kind of electronic communication can be made, including but

1 not limited to communication by telephonic facsimile and electronic mail.”
