SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Provides **authorized** tribal police officers with certain powers and protections provided to Oregon law enforcement officers.

Declares emergency, effective on passage.

5 and declaring an emergency.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1. As used in sections 1 to 4 of this 2011 Act:**

8 **(1) "Authorized tribal police officer" means a tribal police officer who is acting:**

9 **(a) In accordance with sections 1 to 4 of this 2011 Act;**

10 **(b) While employed by a tribal government that is in compliance with sections 1 to 4 of**
11 **this 2011 Act; and**

12 **(c) Within the scope of employment as a tribal police officer.**

13 **(2) "Tribal government" means a federally recognized sovereign tribal government whose**
14 **borders lie within this state or an intertribal organization formed by two or more of those**
15 **governments.**

16 **(3) "Tribal police officer" means an employee of a tribal government whose duties include**
17 **the enforcement of criminal law.**

18 **SECTION 2. The Legislative Assembly finds and declares that the purpose of sections 1**
19 **to 4 of this 2011 Act is to provide authorized tribal police officers with the ability to exercise**
20 **all of the powers of, and to receive the same authority and protections provided to, law**
21 **enforcement officers under the laws of this state, without incurring any additional costs or**
22 **loss of revenue to the State of Oregon or a political subdivision of the State of Oregon.**

23 **SECTION 3. (1) A tribal police officer is eligible to act as an authorized tribal police of-**
24 **ficer if the officer:**

25 **(a) Is certified as a police officer under the provisions of ORS 181.610 to 181.712;**

26 **(b) Is in compliance with any rules adopted by the Department of Public Safety Standards**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 and Training under sections 1 to 4 of this 2011 Act; and

2 (c) Is employed by a tribal government that:

3 (A) Is in compliance with the requirements of ORS 181.610 to 181.712 applicable to a law
4 enforcement unit as defined in ORS 181.610;

5 (B) Is in compliance with any rules adopted by the department under sections 1 to 4 of
6 this 2011 Act;

7 (C) Has submitted to the department the resolution and documents described in section
8 4 of this 2011 Act; and

9 (D) Has adopted a provision of tribal law that waives sovereign immunity, in a manner
10 similar to the waiver expressed in ORS 30.260 to 30.300, as to tort claims asserted in the
11 tribal government's court that arise from the conduct of an authorized tribal police officer.
12 The waiver described in this subparagraph:

13 (i) Must apply to the conduct of an authorized tribal police officer that occurs while the
14 provision of tribal law is in effect;

15 (ii) Must allow for recovery against the tribal government in an amount equal to or
16 greater than the amounts described in ORS 30.260 to 30.300 that are applicable to a local
17 public body;

18 (iii) May require that the claim be asserted in accordance with any applicable tort claims
19 procedures of the tribal government; and

20 (iv) May exclude claims that could be brought in federal court under the Federal Tort
21 Claims Act.

22 (2) When an authorized tribal police officer issues a citation for the commission of an
23 offense for which the State of Oregon has jurisdiction and the tribal government employing
24 the officer does not have jurisdiction, the citation must:

25 (a) Summon the person cited to appear in the circuit court of the county in which the
26 offense was committed; and

27 (b) Be submitted to the district attorney of the county in which the offense was com-
28 mitted.

29 (3) For purposes of ORS 30.260 to 30.300, an authorized tribal police officer is not an of-
30 ficer, employee or agent of the State of Oregon or of any other public body as defined in ORS
31 174.109. A public body or an officer, employee or agent of a public body is not liable for cer-
32 tifying a tribal police officer under ORS 181.610 to 181.712, for accepting for filing the resol-
33 ution and documents described in section 4 of this 2011 Act or for the acts or omissions of
34 an authorized tribal police officer.

35 (4) Nothing in sections 1 to 4 of this 2011 Act:

36 (a) Affects the authority of a county sheriff to appoint duly commissioned police officers
37 as deputy sheriffs authorized to enforce the criminal and traffic laws of the State of Oregon;

38 (b) Affects the existing status and sovereignty of tribal governments whose traditional
39 lands and territories lie within the borders of the State of Oregon as established under the
40 laws of the United States; or

41 (c) Authorizes a tribal government to receive funds from, or in lieu of, the State of
42 Oregon or a political subdivision of the state of Oregon.

43 (5) A tribal government or tribal police department is not a seizing agency for purposes
44 of ORS 131.550 to 131.600 or ORS chapter 131A.

45 (6) The department may adopt rules to carry out the provisions of sections 1 to 4 of this

1 2011 Act. The rules must require tribal governments that employ authorized tribal police
2 officers to reimburse the department for any costs incurred in carrying out the provisions
3 of sections 1 to 4 of this 2011 Act.

4 **SECTION 4.** (1) A tribal government that employs tribal police officers may submit to the
5 Department of Public Safety Standards and Training a resolution declaring that the tribal
6 government is self-insured or has purchased and maintains in force:

7 (a) Public liability and property damage insurance for vehicles operated by authorized
8 tribal police officers; and

9 (b) Police professional liability insurance from a company licensed to sell insurance in
10 this state.

11 (2) The tribal government shall attach the following documents to the resolution sub-
12 mitted to the department:

13 (a) A declaration that the tribal government has complied with the requirements of
14 sections 1 to 4 of this 2011 Act; and

15 (b)(A) A full copy of the public liability and property damage insurance policy for vehicles
16 operated by the tribal government's authorized tribal police officers and a full copy of the
17 police professional liability insurance policy from a company licensed to sell insurance in this
18 state; or

19 (B) A description of the tribal government's self-insurance program.

20 (3) A self-insurance program or insurance policy described in subsection (1) or (2) of this
21 section must provide:

22 (a) That the self-insurance program or insurance policy is available to satisfy settlements
23 and judgments arising from the tortious conduct of authorized tribal police officers in an
24 amount equal to or greater than the amounts described in ORS 30.260 to 30.300 that are ap-
25 plicable to a local public body; and

26 (b) That the tribal government and the insurance carrier will not raise the defense of
27 sovereign immunity for claims that are asserted in the tribal government's court and involve
28 the tortious conduct of an authorized tribal police officer, provided that the claims:

29 (A) Are asserted in accordance with any applicable tort claims procedures of the tribal
30 government; and

31 (B) Could not be brought in federal court under the Federal Tort Claims Act.

32 (4) If, after making a submission described in this section, there is a material change in
33 the tribal government's self-insurance program or insurance policy, the tribal government
34 shall file with the department a written description of the change within 30 days of the ef-
35 fective date of the change.

36 (5) The department shall maintain a file of submissions made by tribal governments un-
37 der this section. The department shall permit inspection and copying of the submissions in
38 accordance with ORS 192.410 to 192.505.

39 **SECTION 5.** ORS 40.275 is amended to read:

40 40.275. (1) As used in this section, "unit of government" means:

41 (a) The federal government or any state or political subdivision thereof; or

42 (b) A tribal government as defined in section 1 of this 2011 Act, if the information relates
43 to or assists in an investigation conducted by an authorized tribal police officer as defined
44 in section 1 of this 2011 Act.

45 (2) A unit of government has a privilege to refuse to disclose the identity of a person who has

1 furnished information relating to or assisting in an investigation of a possible violation of law to a
2 law enforcement officer or member of a legislative committee or its staff conducting an investi-
3 gation.

4 (3) The privilege created by this section may be claimed by an appropriate representative of the
5 unit of government if the information was furnished to an officer thereof.

6 (4) No privilege exists under this section:

7 (a) If the identity of the informer or the informer's interest in the subject matter of the com-
8 munication has been disclosed to those who would have cause to resent the communication by a
9 holder of the privilege or by the informer's own action, or if the informer appears as a witness for
10 the unit of government.

11 (b) If it appears from the evidence in the case or from other showing by a party that an informer
12 may be able to give testimony necessary to a fair determination of the issue of guilt or innocence
13 in a criminal case or of a material issue on the merits in a civil case to which the unit of govern-
14 ment is a party, and the unit of government invokes the privilege, and the judge gives the unit of
15 government an opportunity to show in camera facts relevant to determining whether the informer
16 can, in fact, supply that testimony. The showing will ordinarily be in the form of affidavits, but the
17 judge may direct that testimony be taken if the judge finds that the matter cannot be resolved sat-
18 isfactorily upon affidavit. If the judge finds that there is a reasonable probability that the informer
19 can give the testimony, and the unit of government elects not to disclose identity of the informer,
20 the judge on motion of the defendant in a criminal case shall dismiss the charges to which the tes-
21 timony would relate, and the judge may do so on the judge's own motion. In civil cases, the judge
22 may make any order that justice requires. Evidence submitted to the judge shall be sealed and pre-
23 served to be made available to the appellate court in the event of an appeal, and the contents shall
24 not otherwise be revealed without consent of the unit of government. All counsel and parties shall
25 be permitted to be present at every stage of proceedings under this paragraph except a showing in
26 camera, at which no counsel or party shall be permitted to be present.

27 (c) If information from an informer is relied upon to establish the legality of the means by which
28 evidence was obtained and the judge is not satisfied that the information was received from an in-
29 former reasonably believed to be reliable or credible. The judge may require the identity of the
30 informer to be disclosed. The judge shall, on request of the unit of government, direct that the dis-
31 closure be made in camera. All counsel and parties concerned with the issue of legality shall be
32 permitted to be present at every stage of proceedings under this paragraph except a disclosure in
33 camera, at which no counsel or party shall be permitted to be present. If disclosure of the identity
34 of the informer is made in camera, the record thereof shall be sealed and preserved to be made
35 available to the appellate court in the event of an appeal, and the contents shall not otherwise be
36 revealed without consent of the unit of government.

37 **SECTION 6.** ORS 90.440 is amended to read:

38 90.440. (1) As used in this section:

39 (a) "Group recovery home" means a place that provides occupants with shared living facilities
40 and that meets the description of a group home under 42 U.S.C. 300x-25.

41 (b) "Illegal drugs" includes controlled substances or prescription drugs:

42 (A) For which the tenant does not have a valid prescription; or

43 (B) That are used by the tenant in a manner contrary to the prescribed regimen.

44 (c) "Peace officer" means a sheriff, constable, marshal or deputy, [or] a member of a state or
45 city police force **or an authorized tribal police officer as defined in section 1 of this 2011 Act.**

1 (2) Notwithstanding ORS 90.375 and 90.435, a group recovery home may terminate a tenancy and
2 peaceably remove a tenant without complying with ORS 105.105 to 105.168 if the tenant has used
3 or possessed alcohol or illegal drugs within the preceding seven days. For purposes of this sub-
4 section, the following are sufficient proof that a tenant has used or possessed alcohol or illegal
5 drugs:

6 (a) The tenant fails a test for alcohol or illegal drug use;

7 (b) The tenant refuses a request made in good faith by the group recovery home that the tenant
8 take a test for alcohol or illegal drug use; or

9 (c) Any person has personally observed the tenant using or possessing alcohol or illegal drugs.

10 (3) A group recovery home that undertakes the removal of a tenant under this section shall
11 personally deliver to the tenant a written notice that:

12 (a) Describes why the tenant is being removed;

13 (b) Describes the proof that the tenant has used or possessed alcohol or illegal drugs within the
14 seven days preceding delivery of the notice;

15 (c) Specifies the date and time by which the tenant must move out of the group recovery home;

16 (d) Explains that if the removal was wrongful or in bad faith the tenant may seek injunctive
17 relief to recover possession under ORS 105.121 and may bring an action to recover monetary dam-
18 ages; and

19 (e) Gives contact information for the local legal services office and for the Oregon State Bar's
20 Lawyer Referral Service, identifying those services as possible sources for free or reduced-cost legal
21 services.

22 (4) A written notice in substantially the following form meets the requirements of subsection (3)
23 of this section:

26 This notice is to inform you that you must move out of _____ (insert address of group
27 recovery home) by _____ (insert date and time that is not less than 24 hours after delivery
28 of notice).

29 The reason for this notice is _____ (specify use or possession of alcohol or illegal drugs,
30 as applicable, and dates of occurrence).

31 The proof of your use or possession is _____ (specify facts).

32 If you did not use or possess alcohol or illegal drugs within the seven days before delivery of
33 this notice, if this notice was given in bad faith or if your group recovery home has not substantially
34 complied with ORS 90.440, you may be able to get a court to order the group recovery home to let
35 you move back in. You may also be able to recover monetary damages.

36 You may be eligible for free legal services at your local legal services office _____ (in-
37 sert telephone number) or reduced fee legal services through the Oregon State Bar at 1-800-452-7636.

40 (5) Within the notice period, a group recovery home shall allow a tenant removed under this
41 section to follow any emergency departure plan that was prepared by the tenant and approved by
42 the group recovery home at the time the tenancy began. If the removed tenant does not have an
43 emergency departure plan, a representative of the group recovery home shall offer to take the re-
44 moved tenant to a public shelter, detoxification center or similar location if existing in the commu-
45 nity.

1 (6) The date and time for moving out specified in a notice under subsection (3) of this section
2 must be at least 24 hours after the date and time the notice is delivered to the tenant. If the tenant
3 remains on the group recovery home premises after the date and time for moving out specified in
4 the notice, the tenant is a person remaining unlawfully in a dwelling as described in ORS 164.255
5 and not a person described in ORS 105.115. Only a peace officer may forcibly remove a tenant who
6 remains on the group recovery home premises after the date and time specified for moving out.

7 (7) A group recovery home that removes a tenant under this section shall send a copy of the
8 notice described in subsection (3) of this section to the Oregon Health Authority no later than 72
9 hours after delivering the notice to the tenant.

10 (8) A tenant who is removed under subsection (2) of this section may obtain injunctive relief to
11 recover possession and may recover an amount equal to the greater of actual damages or three
12 times the tenant's monthly rent if:

13 (a) The group recovery home removed the tenant in bad faith or without substantially complying
14 with this section; or

15 (b) If removal is under subsection (2)(c) of this section, the removal was wrongful because the
16 tenant did not use or possess alcohol or illegal drugs.

17 (9) Notwithstanding ORS 12.125, a tenant who seeks to obtain injunctive relief to recover pos-
18 session under ORS 105.121 must commence the action to seek relief not more than 90 days after the
19 date specified in the notice for the tenant to move out.

20 (10) In any court action regarding the removal of a tenant under this section, a group recovery
21 home may present evidence that the tenant used or possessed alcohol or illegal drugs within seven
22 days preceding the removal, whether or not the evidence was described in the notice required by
23 subsection (3) of this section.

24 (11) This section does not prevent a group recovery home from terminating a tenancy as pro-
25 vided by any other provision of this chapter and evicting a tenant as provided in ORS 105.105 to
26 105.168.

27 **SECTION 7.** ORS 131.605 is amended to read:

28 131.605. As used in ORS 131.605 to 131.625, unless the context requires otherwise:

29 (1) "Crime" has the meaning provided for that term in ORS 161.515.

30 (2) "Dangerous weapon," "deadly weapon" and "person" have the *[meaning provided for]*
31 **meanings given** those terms in ORS 161.015.

32 (3) "Frisk" is an external patting of a person's outer clothing.

33 (4) "Is about to commit" means unusual conduct that leads a peace officer reasonably to con-
34 clude in light of the officer's training and experience that criminal activity may be afoot.

35 **(5) "Peace officer" has the meaning given that term in ORS 133.005.**

36 *[(5)]* **(6)** "Reasonably suspects" means that a peace officer holds a belief that is reasonable under
37 the totality of the circumstances existing at the time and place the peace officer acts as authorized
38 in ORS 131.605 to 131.625.

39 *[(6)]* **(7)** A "stop" is a temporary restraint of a person's liberty by a peace officer lawfully pres-
40 ent in any place.

41 **SECTION 8.** ORS 133.005 is amended to read:

42 133.005. As used in ORS 133.005 to 133.381 and 133.410 to 133.450, unless the context requires
43 otherwise:

44 (1) "Arrest" means to place a person under actual or constructive restraint or to take a person
45 into custody for the purpose of charging that person with an offense. A "stop" as authorized under

1 ORS 131.605 to 131.625 is not an arrest.

2 (2) "Federal officer" means a special agent or law enforcement officer employed by a federal
3 agency who is empowered to effect an arrest with or without a warrant for violations of the United
4 States Code and who is authorized to carry firearms in the performance of duty.

5 (3) "Peace officer" means:

6 (a) A member of the Oregon State Police; *or*

7 (b) A sheriff, constable, marshal[,] **or** municipal police officer[.];

8 (c) **An** investigator of a district attorney's office if the investigator is or has been certified as
9 a peace officer in this or any other state[, *or*];

10 (d) An investigator of the Criminal Justice Division of the Department of Justice of the State
11 of Oregon; **or**

12 (e) **An authorized tribal police officer as defined in section 1 of this 2011 Act.**

14 **SECTION 10.** ORS 133.033 is amended to read:

15 133.033. (1) Except as otherwise expressly prohibited by law, any peace officer of this state[, *as*
16 *defined in ORS 133.005,*] is authorized to perform community caretaking functions.

17 (2) As used in this section, "community caretaking functions" means any lawful acts that are
18 inherent in the duty of the peace officer to serve and protect the public. "Community caretaking
19 functions" includes, but is not limited to:

20 (a) The right to enter or remain upon the premises of another if it reasonably appears to be
21 necessary to:

22 (A) Prevent serious harm to any person or property;

23 (B) Render aid to injured or ill persons; or

24 (C) Locate missing persons.

25 (b) The right to stop or redirect traffic or aid motorists or other persons when such action
26 reasonably appears to be necessary to:

27 (A) Prevent serious harm to any person or property;

28 (B) Render aid to injured or ill persons; or

29 (C) Locate missing persons.

30 (3) Nothing contained in this section shall be construed to limit the authority of a peace officer
31 that is inherent in the office or that is granted by any other provision of law.

32 **SECTION 11. ORS 133.318 is added to and made a part of ORS 133.005 to 133.381.**

33 **SECTION 12.** ORS 133.318 is amended to read:

34 133.318. (1) Any person who provides to a peace officer a copy of a writing purporting to be a
35 foreign restraining order as defined by ORS 24.190 knowing that no valid foreign restraining order
36 is in effect shall be guilty of a Class A misdemeanor.

37 (2) Any person who represents to a [*police*] **peace** officer that a foreign restraining order is the
38 most recent order in effect between the parties or that the person restrained by the order has been
39 personally served with a copy of the order or has actual notice of the order knowing that the rep-
40 resentation is false commits a Class A misdemeanor.

41 **SECTION 13. ORS 133.400 is added to and made a part of ORS 133.005 to 133.381.**

42 **SECTION 14.** ORS 133.525 is amended to read:

43 133.525. As used in ORS 133.525 to 133.703, unless the context requires otherwise:

44 (1) "Judge" means any judge of the circuit court, the Court of Appeals, the Supreme Court, any
45 justice of the peace or municipal judge authorized to exercise the powers and perform the duties

1 of a justice of the peace.

2 (2) "Police officer" means:

3 (a) **A member of the Oregon State Police;**

4 (b) **A sheriff[,] or municipal police officer[, member of the Oregon State Police,] or an authorized**
5 **tribal police officer as defined in section 1 of this 2011 Act;**

6 (c) **An** investigator of a district attorney's office if the investigator is or has been certified as
7 a peace officer in this or any other state[,]; or

8 (d) An investigator of the Criminal Justice Division of the Department of Justice.

9 **SECTION 15.** ORS 133.721 is amended to read:

10 133.721. As used in ORS 41.910 and 133.721 to 133.739, unless the context requires otherwise:

11 (1) "Aggrieved person" means a person who was a party to any wire, electronic or oral com-
12 munication intercepted under ORS 133.724 or 133.726 or a person against whom the interception was
13 directed and who alleges that the interception was unlawful.

14 (2) "Contents," when used with respect to any wire, electronic or oral communication, includes
15 any information concerning the identity of the parties to such communication or the existence,
16 substance, purport or meaning of that communication.

17 (3) "Electronic communication" means any transfer of signs, signals, writing, images, sounds,
18 data or intelligence of any nature transmitted in whole or in part by a radio, electromagnetic,
19 photoelectronic or photo-optical system, or transmitted in part by wire, but does not include:

20 (a) Any oral communication or any communication that is completely by wire; or

21 (b) Any communication made through a tone-only paging device.

22 (4) "Electronic, mechanical or other device" means any device or apparatus that can be used
23 to intercept a wire, electronic or oral communication other than:

24 (a) Any telephone or telegraph instrument, equipment or facility, or any component thereof that
25 is furnished to the subscriber or user by a telecommunications carrier in the ordinary course of its
26 business and that is being used by the subscriber or user in the ordinary course of its business or
27 being used by a telecommunications carrier in the ordinary course of its business, or by an investi-
28 gative or law enforcement officer in the ordinary course of official duties; or

29 (b) A hearing aid or similar device being used to correct subnormal hearing to not better than
30 normal.

31 (5) "Intercept" means the acquisition, by listening or recording, of the contents of any wire,
32 electronic or oral communication through the use of any electronic, mechanical or other device.

33 [(6) "*Investigative or law enforcement officer*" means an officer or other person employed by a
34 county sheriff or municipal police department, the Oregon State Police, Attorney General, a district
35 attorney or the Department of Corrections, and officers or other persons employed by law enforcement
36 agencies of other states or the federal government, to investigate or enforce the law.]

37 (6) "**Investigative or law enforcement officer**" means:

38 (a) **An officer or other person employed to investigate or enforce criminal laws by:**

39 (A) **A county sheriff or municipal police department;**

40 (B) **The Oregon State Police, the Department of Corrections, the Attorney General or a**
41 **district attorney; or**

42 (C) **Law enforcement agencies of other states or the federal government; or**

43 (b) **An authorized tribal police officer as defined in section 1 of this 2011 Act.**

44 (7) "Oral communication" means:

45 (a) Any oral communication, other than a wire or electronic communication, uttered by a person

1 exhibiting an expectation that such communication is not subject to interception under circum-
2 stances justifying such expectation; or

3 (b) An utterance by a person who is participating in a wire or electronic communication, if the
4 utterance is audible to another person who, at the time the wire or electronic communication oc-
5 curs, is in the immediate presence of the person participating in the communication.

6 (8) "Telecommunications carrier" means:

7 (a) A telecommunications utility as defined in ORS 759.005; or

8 (b) A cooperative corporation organized under ORS chapter 62 that provides telecommunications
9 services.

10 (9) "Telecommunications service" has the meaning given that term in ORS 759.005.

11 (10) "Wire communication" means any communication made in whole or in part through the use
12 of facilities for the transmission of communications by the aid of wire, cable or other like connection
13 between the point of origin and the point of reception, whether furnished or operated by a public
14 utility or privately owned or leased.

15 **SECTION 16.** ORS 133.726 is amended to read:

16 133.726. (1) Notwithstanding ORS 133.724, under the circumstances described in this section, a
17 law enforcement officer is authorized to intercept an oral communication to which the officer or a
18 person under the direct supervision of the officer is a party, without obtaining an order for the in-
19 terception of a wire, electronic or oral communication under ORS 133.724.

20 (2) For purposes of this section and ORS 133.736, a person is a party to an oral communication
21 if the oral communication is made in the person's immediate presence and is audible to the person
22 regardless of whether the communication is specifically directed to the person.

23 (3) An ex parte order for intercepting an oral communication in any county of this state under
24 this section may be issued by any judge as defined in ORS 133.525 upon written application made
25 upon oath or affirmation of the district attorney or a deputy district attorney authorized by the
26 district attorney for the county in which the order is sought or upon the oath or affirmation of any
27 peace officer as defined in ORS 133.005. The application shall include:

28 (a) The name of the applicant and the applicant's authority to make the application;

23 enforcement services under ORS 451.010, [*Indian reservation*,] **tribal government as defined in**
24 **section 1 of this 2011 Act that employs authorized tribal police officers as defined in section**
25 **1 of this 2011 Act, the** Criminal Justice Division of the Department of Justice, the Department of
26 Corrections, the Oregon State Lottery Commission or common carrier railroad whose primary duty,
27 as prescribed by law, ordinance or directive, is any one or more of the following:

28 (A) Detecting crime and enforcing the criminal laws of this state or laws or ordinances relating
29 to airport security;

30 (B) The custody, control or supervision of individuals convicted of or arrested for a criminal
31 offense and confined to a place of incarceration or detention other than a place used exclusively for
32 incarceration or detention of juveniles; or

33 (C) The control, supervision and reformation of adult offenders placed on parole or sentenced

4 (B) Investigating adult offenders on parole or probation or being considered for parole or pro-

7 (A) Is certified and has been employed as a full-time parole and probation officer for more than
8 one year;

9 (B) Is employed part-time by the Department of Corrections, a county or a court; and

10 (C) Is charged with and performs the duty of:

12 ferrals to reformative services for adult parolees or probationers or offenders on post-prison super-
13 vision; or

14 (ii) Investigating adult offenders on parole or probation or being considered for parole or pro-

16 (14) "Police officer" means an officer, member or employee of a law enforcement unit who is
17 employed full-time as a peace officer commissioned by a city, port, school district, mass transit dis-
18 trict, county, county service district authorized to provide law enforcement services under ORS
19 451.010, [*Indian reservation*,] **tribal government as defined in section 1 of this 2011 Act**, the
20 Criminal Justice Division of the Department of Justice, the Oregon State Lottery Commission or the
21 Governor or who is a member of the Department of State Police and who is responsible for enforcing
22 the criminal laws of this state or laws or ordinances relating to airport security or is an investigator
23 of a district attorney's office if the investigator is or has been certified as a peace officer in this
24 or any other state **or is an authorized tribal police officer as defined in section 1 of this 2011**
25 **Act**.

26 (15) "Public or private safety agency" means any unit of state or local government, a special
27 purpose district or a private firm which provides, or has authority to provide, fire fighting, police,
28 ambulance or emergency medical services.

29 (16) "Public safety personnel" and "public safety officer" include corrections officers, youth
30 correction officers, emergency medical dispatchers, parole and probation officers, police officers,
31 certified reserve officers, telecommunicators and fire service professionals.

32 (17) "Reserve officer" means an officer or member of a law enforcement unit:

33 (a) Who is a volunteer or who is employed less than full-time as a peace officer commissioned
34 by a city, port, school district, mass transit district, county, county service district authorized to

1 (19) "Youth correction officer" means an employee of the Oregon Youth Authority who is
2 charged with and primarily performs the duty of custody, control or supervision of youth offenders
3 confined in a youth correction facility.

5 348.270. (1) In addition to any other scholarships provided by law, the Oregon Student Assist-
6 ance Commission shall award scholarships in any state institution under the State Board of Higher
