## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Creates crime of failure to identify oneself. Punishes by maximum of 30 days' imprisonment, \$1,250 fine, or both.

## A BILL FOR AN ACT

- 2 Relating to crime; creating new provisions; and amending ORS 161.005.
- 3 Be It Enacted by the People of the State of Oregon:
- 4 SECTION 1. (1) A person commits the crime of failure to identify oneself if:
  - (a) The person is the subject of a lawful stop;
  - (b) The peace officer conducting the stop lawfully directs the person to disclose the person's name; and
  - (c) The person knowingly fails to state the person's true name or communicate the person's true name to the officer by other means.
    - (2) Failure to identify oneself is a Class C misdemeanor.
    - (3) As used in this section, "stop" has the meaning given that term in ORS 131.605.
