

Senate Bill 446

Sponsored by Senator PROZANSKI (at the request of Oregon Coordinate Reference System Technical Development Team) (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies requirements for use of Oregon Coordinate System for land surveying. Directs Department of Transportation to adopt rules implementing Oregon Coordinate System.
Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to Oregon Coordinate System for land surveying; creating new provisions; amending ORS
3 209.130, 209.155, 209.250 and 390.770; repealing ORS 93.320, 93.330, 93.350, 93.360, 93.370 and
4 93.380; and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. (1) A description of land that contains coordinates associated with the posi-**
7 **tion of a point on a land boundary must:**

8 (a) **Use the Oregon Coordinate System;**

9 (b) **Use one specified zone and system for the entire description;**

10 (c) **Include coordinate system datum with epoch and zone designation;**

11 (d) **Use coordinates established by a survey connection to the National Spatial Reference**
12 **System;**

13 (e) **Reference a survey of record that reports the accuracy of _____ at a 95 percent**
14 **level; and**

15 (f) **Include distances, bearings, areas and other boundary elements.**

16 (2) **The Department of Transportation shall adopt rules implementing the Oregon Coor-**
17 **ordinate System.**

18 **SECTION 2. ORS 209.130 is amended to read:**

19 209.130. (1) In the establishment or reestablishment of a public land survey corner, the county
20 surveyor shall set a monument of durable quality. When a monument cannot be set at the exact
21 corner position or it is not practicable to set a monument, then a witness corner monument shall
22 be set.

23 (2) Section corners, Donation Land Claim corners, center corners and quarter-section corners
24 shall be witnessed by at least four references. Meander corners, angle point corners or other ap-
25 proved public land survey corners shall be witnessed by at least two references. References shall
26 be of durable quality. All references shall be carefully described, and their bearings and distances
27 noted in the report or on the survey.

28 (3) For the purpose of providing an additional reference, the county surveyor may, when main-
29 taining or reestablishing survey corners, establish coordinates on public land survey corners using
30 an Oregon Coordinate System pursuant to [*ORS 93.320 or another coordinate system, adopted by the*

1 appropriate public agency, that can be referenced directly to a geodetic control monument] **section 1**
 2 **of this 2011 Act.**

3 **SECTION 3.** ORS 209.155 is amended to read:

4 209.155. (1) Notwithstanding ORS 209.150, when a recorded survey monument, other than a
 5 public land survey corner, is removed, destroyed or disturbed as a result of construction or recon-
 6 struction of a public road, the survey monument does not have to be replaced if:

7 (a) The original location of the recorded survey monument is within the new right of way; and

8 (b) The person or public agency responsible for the construction or reconstruction causes a
 9 registered professional land surveyor to locate any survey monuments that are subject to removal,
 10 destruction or disturbance and to file a map, prior to the beginning of construction, with the county
 11 surveyor that identifies all existing recorded monuments, the existing right of way and controlling
 12 centerline and the survey control used to comply with this section.

13 (2) The newly defined right of way may be delineated by either of the following methods:

14 (a) All control points that define the right of way centerline are monumented or referenced with
 15 monuments. The right of way boundary is monumented at all angle points, points of curve, points
 16 of tangency and at least every 1,000 feet on long curves and tangents. A survey that identifies the
 17 survey control and the new right of way and controlling centerline shall be filed with the county
 18 surveyor within 180 days after completion of construction.

19 (b) A permanent survey control point network is established referencing the new right of way
 20 and controlling centerline. The network shall consist of at least three control monuments and must
 21 span the length of the project. Each control monument shall be intervisible with at least two other
 22 control monuments. At least two monuments on the network must be part of the original control
 23 used to locate the monuments described in subsection (1)(b) of this section. A map identifying the
 24 control network and the new right of way and controlling centerline shall be filed with the county
 25 surveyor within 180 days after completion of construction.

26 (3) The types of monuments shall be as described in ORS 92.060.

27 (4) The survey maps required by this section shall comply with ORS 209.250 and any other re-
 28 quirement of law.

29 (5) For the purpose of complying with subsection (1)(b) of this section, locating a survey monu-
 30 ment may consist of establishing coordinates on the monument[. *These coordinates may be Oregon*
 31 *State Plane coordinates*] **using the Oregon Coordinate System pursuant to section 1 of this 2011**
 32 **Act, Local Datum Plane coordinates that scale Oregon State Plane coordinates of the Oregon**
 33 **Coordinate System to a plane close to the ground elevation of a survey project** or other co-
 34 ordinates compatible with those coordinates shown on the survey.

35 (6) For the purpose of complying with this section, the date of completion of construction [*shall*
 36 *be considered*] **is deemed** to be the date when all substantial road improvements are completed.

37 **SECTION 4.** ORS 209.250 is amended to read:

38 209.250. (1) A registered professional land surveyor making a survey of lands within this state
 39 wherein the surveyor establishes or reestablishes a boundary monument shall, within 45 days
 40 thereafter, submit for filing a permanent map of the survey to the county surveyor for review. When
 41 filed, the map is a permanent public record in the office of the county surveyor. In establishing or
 42 reestablishing a public land survey corner, the surveyor shall comply with ORS 209.070 (4), 209.130
 43 and 209.200. If the surveyor is unable to complete the survey and submit a permanent map within
 44 45 days, the surveyor shall, within 45 days of establishing or reestablishing a boundary monument,
 45 provide written notice to the county surveyor containing the reasons for the delay, an estimate of

1 the amount of time reasonably necessary to complete the survey but not exceeding 180 days, and a
2 temporary map showing the position of monuments established or reestablished.

3 (2) The permanent map must have a written narrative that may be on the face of the map. If the
4 narrative is a separate document, the map and narrative must be referenced to each other. The
5 map and narrative must be made on a suitable drafting material in the size required by the county
6 surveyor. The lettering on the map and narrative must be of sufficient size and clarity to be re-
7 produced clearly. The narrative must explain the purpose of the survey and how the boundary lines
8 or other lines were established or reestablished and must state which deed records, deed elements,
9 survey records, found survey monuments, plat records, road records or other pertinent data were
10 controlling when establishing or reestablishing the lines. If the narrative is a separate document, the
11 narrative must also contain the following:

12 (a) Location of survey by one-fourth section, Township and Range.

13 (b) The date of survey.

14 (c) The surveyor's seal and original signature.

15 (d) The surveyor's business name and address.

16 (3) A permanent map must show the following:

17 (a) Location of survey by one-fourth section, Township and Range.

18 (b) The date of survey.

19 (c) Scale of drawing and North Arrow.

20 (d) The distance and course of all lines traced or established, giving the basis of bearing and the
21 measured distance and course to a monumented section corner, one-quarter corner, one-sixteenth
22 corner or Donation Land Claim corner in Township and Range, or to a monumented lot or parcel
23 corner or boundary corner of a recorded subdivision, partition or condominium.

24 (e) Measured bearings, angles and distances that are used as a basis for establishing or rees-
25 tablishing lines or monuments separately indicated from those of record together with the recording
26 reference. Metric measurements may be used if a conversion to feet is provided.

27 (f) Monuments set and their relation to older monuments found. A detailed description of mon-
28 uments found and set must be included and monuments set must be separately indicated from those
29 found.

30 (g) The surveyor's seal and original signature.

31 (h) The surveyor's business name and address.

32 (4)(a) Within 30 days of receiving a permanent map under this section, the county surveyor shall
33 review the map to determine if it complies with subsections (1), (2) and (3) of this section and ap-
34 plicable local ordinances. A map must be indexed by the county surveyor within 30 days following
35 a determination that the map is in compliance with this section. A survey prepared by the county
36 surveyor in an official or private capacity must comply with subsections (1), (2) and (3) of this sec-
37 tion.

38 (b) A survey map found not to be in compliance with subsection (1), (2) or (3) of this section
39 must be returned within 30 days of receipt for correction to the surveyor who prepared the map.
40 The surveyor shall return the corrected survey map to the county surveyor within 30 days of receipt
41 of the survey map from the county surveyor.

42 (c) A map that is not corrected within the specified time period must be forwarded to the State
43 Board of Examiners for Engineering and Land Surveying for action, as provided in subsection (11)
44 of this section.

45 (d) An action may not be maintained against the county surveyor for recording a survey map

1 that does not comply with this section.

2 (e) An action may not be maintained against the county surveyor for refusal to file a survey
3 map that does not comply with this section.

4 (5)(a) When a survey within this state is funded entirely or in part by public funds and the
5 survey results in the establishment of horizontal or vertical monuments for geodetic control, the
6 registered professional land surveyor performing the survey, within 45 days after completion of the
7 survey, shall file a report of the survey with the county surveyors of those counties where the newly
8 established monuments are located.

9 (b) Notwithstanding paragraph (a) of this subsection, the governing body of a county may, by
10 resolution or order, waive the filing of the report of the survey.

11 (6) A report required by subsection (5)(a) of this section may include maps or diagrams. The
12 maps or diagrams, if included, must be referenced to each other. The report must contain the fol-
13 lowing:

14 (a) The name and number of each newly established geodetic control monument.

15 (b) Location of newly established geodetic control monuments by Section, Township and Range.

16 (c) Location of the horizontal component of geodetic control monuments by the Oregon Coordi-
17 nate System as [*described in ORS 93.320 and 93.330*] **referenced in section 1 of this 2011 Act**, in-
18 cluding the scale factor, combined scale factor, convergence and geographic or geodetic coordinates,
19 indicating datum used.

20 (d) Location of the vertical component of geodetic control monuments by orthometric height,
21 ellipsoidal height and geoidal separation, indicating datum used.

22 (e) The date of survey.

23 (f) The business name and address of the surveyor.

24 (g) A description of all monuments set or found, including narrative or graphic information suf-
25 ficient to locate the monuments.

26 (h) A statement explaining the purpose of the survey, the equipment and procedures used, in-
27 cluding the geoid model and reference ellipsoid used, and the names or numbers of the found record
28 control monuments used and their source.

29 (i) The scale of drawing and North Arrow if a map or diagram is included.

30 (j) The seal and original signature of the surveyor.

31 (k) For geodetic control, a statement regarding the network accuracy and local accuracy of the
32 survey, categorized by horizontal position, ellipsoidal height and orthometric height, relative to the
33 National Spatial Reference System. The statement shall include the accuracy classification at the
34 95 percent confidence level for both network and local classifications in accordance with Standards
35 for Geodetic Control Networks, Part 2 of the federal Geospatial Positioning Accuracy Standards
36 (FGDC 1998) for the newly established monuments.

37 (7) The county surveyor shall file and index reports that comply with subsections (5) and (6) of
38 this section within 30 days of determining compliance.

39 (8) A monument set by a registered professional land surveyor to mark or reference a point on
40 a property or land line or to mark or reference a geodetic control survey point must be durably and
41 visibly marked or tagged with the registered business name or the letters "L.S." followed by the
42 registration number of the surveyor in charge or, if the monument is set by a public officer, the
43 monument must be marked with the official title of the office.

44 (9) If, in the performance of a survey, a registered professional land surveyor finds or makes
45 changes in a public land survey corner or its accessories as described in an existing corner record

1 or survey map in the office of the county surveyor, the surveyor shall complete and submit to the
 2 county surveyor a record of the changes found or made to a corner or accessories to the corner.
 3 The record must be submitted within 45 days of the corner visits, and must include the surveyor's
 4 seal and original signature, business name and address, and be on stable base reproducible material
 5 in the form required by the county surveyor.

6 (10) The signature and stamp of a registered professional land surveyor on a permanent survey
 7 map or plat constitutes certification that the map or plat complies with the applicable provisions
 8 of this chapter.

9 (11) A registered professional land surveyor failing to comply with the provisions of subsections
 10 (1) to (9) of this section, ORS 92.050 to 92.080 or a county ordinance establishing standards for sur-
 11 veys or plats is subject to disciplinary action by the State Board of Examiners for Engineering and
 12 Land Surveying.

13 (12) A federal or state agency, board or commission, special district or municipal corporation
 14 making a survey of lands within this state shall comply with this section.

15 **SECTION 5.** ORS 390.770 is amended to read:

16 390.770. Except for the areas described by ORS 390.760, ORS 390.640 applies to all the land lo-
 17 cated along the Pacific Ocean between the Columbia River and the Oregon-California boundary be-
 18 tween extreme low tide and the lines of vegetation as established and described according to the
 19 Oregon Coordinate System, [*as defined by ORS 93.330,*] as follows:

20 Beginning near the south jetty of the Columbia River in section 35 of township 9 north, range
 21 11 west of the Willamette Meridian in Clatsop County, Oregon, at a point on the Oregon Coordinate
 22 System, north zone, located at y-coordinate 951,840 and x-coordinate 1,112,374, hereby designated
 23 point number Cl-7-1; thence from point number Cl-7-1 southerly along the Pacific Coast by a series
 24 of straight lines connecting the following designated, numbered and described points in consecutive
 25 order to the Oregon-California boundary line near the section line between section 26 of township
 26 41 south, range 13 west of the Willamette Meridian in Curry County, Oregon, and section 32 of
 27 township 19 north, range 1 west of the Humboldt Meridian in Del Norte County, California, at a
 28 point on the Oregon Coordinate System, south zone, located at y-coordinate 143,339 and x-coordinate
 29 991,832, hereby designated point number Cu-7-634.
